This supplement (the "**Supplement**") to the prospectus dated 21 March 2025, as supplemented by the supplementary prospectuses dated 1 May 2025 and 24 July 2025 which together comprise a base prospectus (the "**Prospectus**") for the purposes of Regulation (EU) 2017/1129 as it forms part of domestic law by virtue of the European Union (Withdrawal) Act 2018 (the "**UK Prospectus Regulation**"), constitutes a supplementary prospectus for the purposes of Article 23 of the UK Prospectus Regulation, and is prepared in connection with the £25,000,000,000 Euro Medium Term Note Programme (the "**Programme**") established by Lloyds Banking Group plc (the "**Company**").

This Supplement is supplemental to, and should be read in conjunction with, the Prospectus and the documents incorporated by reference therein. Capitalised terms used in this Supplement but not defined herein shall have the meanings ascribed to them in the Prospectus.

The Company accepts responsibility for the information contained in this Supplement. To the best of the knowledge of the Company the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

**Purpose of this Supplement**

The purpose of this Supplement is to update the disclosure in the Prospectus relating to motor finance matters following the Supreme Court judgment in Wrench, Johnson and Hopcraft.

**(a) Documents Incorporated by Reference**

By virtue of this Supplement, the Company's announcement which was published via RNS on 4 August 2025 (RNS Number 8013T) entitled "*Motor Finance Update*" (the "**4 August 2025 Announcement**") shall be deemed to be incorporated in, and form part of, the Prospectus and supplement the section entitled "*Documents Incorporated by Reference*" on pages 14 to 16 of the Prospectus.
