# Bank of America Corporation U.S. \$65,000,000,000 Euro Medium-Term Note Program

This supplement (the "**Supplement**"), which supplements the Base Prospectus dated May 12, 2022 (the "**Original Base Prospectus**") (as supplemented by the Supplementary Base Prospectuses dated July 19, 2022, August 1, 2022, October 18, 2022, November 1, 2022, January 16, 2023, February 23, 2023, and April 19, 2023, the "**Base Prospectus**"), which together comprise a base prospectus for the purposes of Article 8 of Regulation (EU) 2017/1129 as it forms part of domestic law of the United Kingdom by virtue of the European Union (Withdrawal) Act 2018 (the "**EUWA**") and the regulations made under the EUWA (as amended, the "**UK Prospectus Regulation**"), constitutes a supplementary prospectus for the purposes of Article 23 of the UK Prospectus Regulation and is prepared in connection with the U.S. \$65,000,000,000 Euro Medium-Term Note Program (the "**Program**") of Bank of America Corporation (the "**Issuer**"). Terms defined in the Base Prospectus have the same meaning when used in this Supplement.

This Supplement is supplemental to, and shall be read in conjunction with, the Base Prospectus. To the extent that there is any inconsistency between any statement in this Supplement and any other statement in or incorporated by reference into the Base Prospectus, the statements in this Supplement will prevail.

This Supplement has been approved by the United Kingdom Financial Conduct Authority (the "**FCA**"), as competent authority under the UK Prospectus Regulation. The FCA only approves this Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the UK Prospectus Regulation and such approval should not be considered as an endorsement of the Issuer that is the subject of this Supplement.

The purpose of this Supplement is to incorporate by reference the Issuer's quarterly report on Form 10-Q dated May 1, 2023 (the "**May 1, 2023 Form 10-Q** ") for the three months ended March 31, 2023.

The Issuer accepts responsibility for the information contained in this Supplement. To the best of the knowledge of the Issuer, the information contained in this Supplement is in accordance with the facts and this Supplement makes no omission likely to affect its import.

Save as disclosed in this Supplement or in the document incorporated by reference in, and forming part of, this Supplement, no other significant new factor, material mistake or inaccuracy relating to information included in the Base Prospectus has arisen or been noted, as the case may be, since the publication of the Base Prospectus as supplemented from time to time.

## Incorporation by reference of the May 1, 2023 Form 10-Q

The May 1, 2023 Form 10-Q was filed with the United States Securities and Exchange Commission (the "SEC") on May 1, 2023 and with the Financial Conduct Authority. Pages 1 to 97 of the May 1, 2023 Form 10-Q shall be deemed to be incorporated by reference into, and form part of this Supplement. For the purposes of the UK Prospectus Regulation and this Supplement, any information or other documents incorporated by reference, either expressly or implicitly, into the May 1, 2023 Form 10-Q, or not deemed to have been filed as part of the May 1, 2023 Form 10-Q under the rules of the SEC, do not form part of this Supplement. Information in the May 1, 2023 Form 10-Q which is not incorporated by reference into the Base Prospectus is either not relevant for the investor or is covered elsewhere in the Base Prospectus.

As of March 31, 2023, the issued and outstanding common stock of the Issuer equalled 7,972,438,148 shares, \$0.01 par value, fully paid, which shares and additional paid in capital equalled approximately \$57.264 billion. As at the date of this Base Prospectus, the authorized common stock of the Issuer is 12,800,000,000 shares.

As of March 31, 2023, the issued and outstanding preferred stock of the Issuer equalled 4,088,099 shares, \$0.01 par value, fully paid, with an aggregate liquidation preference of approximately \$28.397 billion. The authorized preferred stock of the Issuer is 100,000,000 shares."
