THESE AMENDED AND RESTATED FINAL TERMS DATED 18 AUGUST 2026 AMEND AND RESTATE THE FINAL TERMS DATED 25 MAY 2023 (THE "ORIGINAL FINAL TERMS"), UNDER WHICH THE NOTES DESCRIBED HEREIN (THE "NOTES") WERE ORIGINALLY ISSUED. THESE AMENDED AND RESTATED FINAL TERMS HAVE BEEN CREATED SOLELY AS A MATTER OF RECORD TO RECORD THE CURRENT FINAL TERMS OF THE NOTES AS AMENDED AND RESTATED WITH EFFECT FROM 18 AUGUST 2026 BY A SUPPLEMENTAL TRUST DEED DATED 18 AUGUST 2026 MADE BETWEEN VODAFONE GROUP PLC AND THE LAW DEBENTURE TRUST CORPORATION P.L.C. (THE "SUPPLEMENTAL TRUST DEED"). NOTHING IN THESE AMENDED AND RESTATED FINAL TERMS AFFECTS ANY OBLIGATIONS EXISTING PRIOR TO THE DATE OF THEIR AMENDMENT OR RESTATEMENT.
