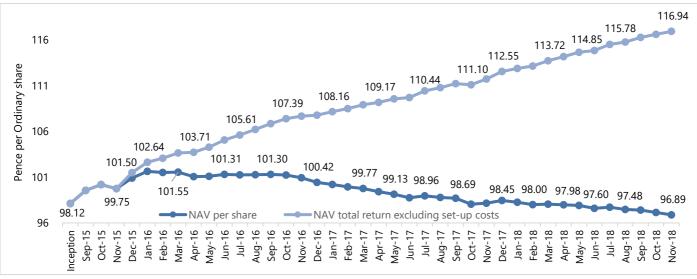

NAV & NAV Total Return



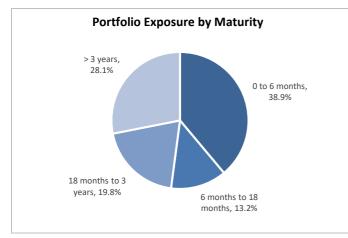
