This supplement (the **"Supplement"**) to the base prospectus of Australia and New Zealand Banking Group Limited (**"ANZBGL"**) dated 13 May 2022 (the **"Base Prospectus"**), constitutes a supplementary prospectus for the purposes of Article 23 of Regulation (EU) 2017/1129 as it forms part of UK domestic law by virtue of the European Union (Withdrawal) Act 2018, as amended (the **"EUWA"**) (the **"UK Prospectus Regulation"**) and is prepared in connection with the US\$30,000,000 ANZ Global Covered Bond Programme established by ANZBGL.

This Supplement has been approved by the United Kingdom Financial Conduct Authority (the "FCA"), as competent authority under the UK Prospectus Regulation. The FCA only approves this Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the UK Prospectus Regulation and such approval should not be considered as an endorsement of the Issuer nor as an endorsement of the quality of any Covered Bonds that are the subject of the Base Prospectus. Investors should make their own assessment as to the suitability of investing in any such Covered Bonds.

The purpose of this Supplement is to:

- (a) incorporate by reference into the Base Prospectus:
 - ANZBGL's audited annual consolidated financial statements (including the auditor's report thereon and the notes thereto) for the year ended 30 September 2022 (as set out on pages 107 to 240 of the 2022 Annual Report of the Group) (the "2022 Financial Statements"); and
 - ANZBGL's 2022 Basel III Pillar 3 Disclosure as at 30 September 2022 (the "Basel III Disclosure").

(b) update the section entitled "General Information" of the Base Prospectus.

Terms defined in the Base Prospectus have the same meaning when used in this Supplement.

This Supplement is supplemental to, and should be read and construed together with, the Base Prospectus.

ANZBGL accepts responsibility for the information contained in this Supplement and to the best of the knowledge of ANZBGL, the information contained in this Supplement is in accordance with the facts and this Supplement makes no omission likely to affect its import.

(1) ANZBGL 2022 Financial Statements and Basel III Disclosure

On 3 November 2022, ANZBGL released its 2022 Financial Statements and Basel III Disclosure. Copies of the 2022 Financial Statements and the Basel III Disclosure have been filed with the National Storage Mechanism and will be available for inspection at https://data.fca.org.uk/#/nsm/nationalstoragemechanism. By virtue of this Supplement, the 2022 Financial Statements and the Basel III Disclosure shall be deemed to be incorporated into, and form part of, the Base Prospectus.

Information in the 2022 Financial Statements or the Basel III Disclosure which is not incorporated by reference into the Base Prospectus is either not relevant for the investor or is covered elsewhere in the Base Prospectus.

(a) The first paragraph under the sub-section entitled "Significant or Material Change" shall be updated as follows:
