Manager's Commentary

Market Conditions

The Africa Opportunity Fund ("AOF" or the "Company" or the "Fund") NAV gained 2.6% in June 2023 while its share price gained 9.1%. As a reference, with the exception of Nigeria which declined 33.3% due to currency devaluation, other major African indices recorded gains in June 2023: Morocco gained 8.5%, South Africa gained 6.6%, Egypt gained 2.3% and Kenya gained 1.9%. Key Africa-focused ETFs recorded mixed performances: Van Eck Africa Index (AFK US) declined 0.9% while DBX MSCI Africa Top 50 (XMAF LN) gained 7.3% and Lyxor Pan African (LGQM GY) gained 7.4%.

Portfolio Highlights


AOF's net asset value increased 2.6% in June due to investment gains from Zimbabwean holdings. First Mutual Properties and Mashonaland Holdings gained 22% and 4% respectively, as local investors took refuge from a collapse of the Zimbabwe Dollar in the stock market. Our in-house Zimbabwe Dollar/US Dollar model depreciated 52% in June.
