NOTICE IS HEREBY GIVEN THAT, pursuant to the terms of the above-described subordinated debentures (the “**Subordinated Debentures**”) and the terms of the Supplemental Indenture, dated as of September 5, 2007, to the Indenture For Subordinated Debentures, dated as of September 1, 2006, among General Electric Company, as successor to General Electric Capital Corporation, as Issuer (the “**Issuer**”), The Bank of New York Mellon as successor to JPMorgan Chase Bank, N.A., as Trustee (the “**Trustee**”), the Issuer will redeem any and all of the outstanding Subordinated Debentures on September 15, 2017 (the “**Redemption Date**”) at a redemption price equal to 100.00% of the outstanding principal amount of the Subordinated Debentures plus accrued and unpaid interest to, but excluding, the Redemption Date (the “**Redemption Price**”). On and after the Redemption Date, any interest on the Subordinated Debentures so redeemed shall cease to accrue unless there is a default in the payment of the Redemption Price.

Payment of the Redemption Price for the Subordinated Debentures will be made, subject to receipt of the required funds, by The Bank of New York Mellon, as paying Agent (the “**Paying Agent**”) upon presentation and surrender of said Subordinated Debentures to the Paying Agent, as follows:
