

Monthly Market Commentary

On 10th June, NAVF held its AGM in London. The whole Board and two representatives from RSM, as well as advisors from Sanne and the Company's audiors, were able to attend in person. RSM's AGM report and a new video describing our recent visit to Japan were subsequently posted to the Company's website.

Textile manufacturer Sankyo Seiko announced a 6.74% buyback programme. While only roughly 2/3 of the 10% RSM had proposed, we still deem it to be a good start.

Discussions continue with several banks in Tokyo over funding options for future corporate actions, while purchases of several counters already owned by Dalton Securities has begun under the new cross shareholding MOU agreed between both parties.

Two of RSM's principals recorded a short video for the NAVF AGM.
