The undersigned DOES HEREBY CERTIFY as follows:

- 1. Resolutions were adopted by the Securities Committee of the Board of Directors of Wells Fargo & Company, a Delaware corporation (the "Company"), which resolutions are set forth in a Certificate of Designations filed with the Secretary of State of the State of Delaware on December 17, 2013, providing for and authorizing the issuance of 34,500 shares of the Company's 6.625% Fixed-to-Floating Rate Non-Cumulative Perpetual Class A Preferred Stock, Series R (the "Series R Preferred Stock");
- All 33,600 outstanding shares of Series R Preferred Stock were redeemed by the Company on March 15, 2024 and none of the
 authorized shares of the Company's Series R Preferred Stock are outstanding and none will be issued subject to the Certificate of
 Designations previously filed on December 17, 2013 with the Secretary of State of the State of Delaware with respect to such
 series;
- 3. The following resolutions were duly adopted by Securities Committee I of the Board of Directors of the Company pursuant to the written consent of Securities Committee I duly adopted on February 5, 2024:

WHEREAS, resolutions were adopted by the Securities Committee of the Board of Directors (the "Board") of Wells Fargo & Company, a Delaware corporation (the "Company"), which resolutions are set forth in a Certificate of Designations (the "Series R Certificate of Designations") filed with the Secretary of State of the State of Delaware on December 17, 2013 providing for and authorizing the issuance of 34,500 shares of the Company's 6.625% Fixed-to-Floating Rate Non-Cumulative Perpetual Class A, Series R Preferred Stock (the "Series R Preferred Stock") of which 33,600 were issued;

WHEREAS, on March 15, 2024, all 33,600 issued and outstanding shares of the Series R Preferred Stock will be redeemed by the Company (the "Series R Redemption").

NOW THEREFORE BE IT

RESOLVED that, after the Series R Redemption, no shares of the Series R Preferred Stock are outstanding and none will be issued subject to the Series R Certificate of Designations.

RESOLVED that, after the Series R Redemption, all matters set forth in the Series R Certificate of Designations with respect to the Series R Preferred Stock be eliminated from the Certificate of Incorporation of the Company.

RESOLVED that, after the Series R Redemption, the President, any Senior Executive Vice President, any Executive Vice President, any Senior Vice President, the Treasurer, any Assistant Treasurer, the Secretary and any Assistant Secretary of the Company, and each of them, are hereby authorized and directed to file a Certificate with the office of the Secretary of State of the State of Delaware setting forth a copy of these resolutions whereupon all matters set forth in the Series R Certificate of Designations with respect to the Series R Preferred Stock shall be eliminated from the Certificate of Incorporation of the Company.
