This supplement (the "**2nd Supplementary Registration Document**") to the registration document dated 16 March 2026 (as supplemented, the "**Registration Document**"), which constitutes a registration document for the purposes of the Prospectus Rules: Admission to Trading on a Regulated Market sourcebook ("**PRM**") made in accordance with the Public Offers and Admissions to Trading Regulations 2024, constitutes a supplementary registration document for the purposes of PRM 10.

Terms defined in the Registration Document have the same meanings when used in this 2nd Supplementary Registration Document.

This 2nd Supplementary Registration Document is supplemental to, and should be read in conjunction with, the Registration Document and the documents incorporated by reference therein.

This 2nd Supplementary Registration Document has been approved by the United Kingdom Financial Conduct Authority (the "**FCA**"). The FCA only approves this 2nd Supplementary Registration Document as meeting the standards of completeness, comprehensibility and consistency imposed by the rules in the PRM. Such approval should not be considered as an endorsement of the Issuer that is the subject of this 2nd Supplementary Registration Document. With effect from the date of this 2nd Supplementary Registration Document the information appearing in, or incorporated by reference into, the Registration Document shall be supplemented in the manner described below.

NatWest Markets Plc (the "**Issuer**" or "**NatWest Markets**" and, together with its consolidated subsidiaries, the "**NWM Group**") accepts responsibility for the information contained in this 2nd Supplementary Registration Document. To the best of the knowledge of the Issuer such information is in accordance with the facts and makes no omission likely to affect its import.

The distribution of this 2nd Supplementary Registration Document and the offer or sale of any securities of the Issuer may be restricted by law in certain jurisdictions. Persons into whose possession this 2nd Supplementary Registration Document or any securities of the Issuer come must inform themselves about, and observe, any such restrictions.

Any securities to be issued by the Issuer in connection with this 2nd Supplementary Registration Document and the Registration Document have not been and will not be registered under the Securities Act or with any securities regulatory authority of any state or other jurisdiction of the US. - (a) incorporate by reference into the Registration Document the Fitch Ratings Upgrade Announcement (as defined below); and
- (b) update certain information relating to ratings.

By virtue of this 2nd Supplementary Registration Document the announcement entitled "NatWest Group plc notes rating actions by Fitch" (the "**Fitch Ratings Upgrade Announcement**") which was published via the regulatory news service of the London Stock Exchange on 13 May 2026, which has been (1) previously published and (2) filed with the Financial Conduct Authority, shall be incorporated in, and form part of, the Registration Document.
