Manager's Commentary

Market Conditions

The Africa Opportunity Fund ("AOF" or the "Company" or the "Fund") NAV declined 0.8% in October 2023 while its share price declined 7.2%. As a reference, other major African indices recorded mixed performances: Kenya and South Africa declined 8.5% and 2.4% respectively, while Egypt gained 17.0%, Morocco gained 1.5% and Nigeria gained 0.5%. Key Africa-focused ETFs recorded losses in October 2023: Van Eck Africa Index (AFK US) declined 6.1%, DBX MSCI Africa Top 50 (XMAF LN) declined 1.6% and Lyxor Pan African (LGQM GY) declined 6.9%.

Portfolio Highlights

AOF's net asset value decreased 0.8% in October due to investment losses from Enterprise Group and Kenya Power.


