This Prospectus Supplement n° 2 (the “**Prospectus Supplement**”) supplements the Base Prospectus dated 12 July 2017 as amended by the Prospectus Supplement n° 1 dated 24 August 2017 (as so amended, the “**Base Prospectus**”) and constitutes a prospectus supplement for the purposes of Article 16 of Directive 2003/71/EC of the European Parliament and the Council, as amended (the “**Prospectus Directive**”). This Prospectus Supplement has been prepared to incorporate by reference the Issuer’s consolidated financial statements for the year ended 31 December 2017 and auditors’ report thereon.

This Prospectus Supplement constitutes a supplement to, and should be read in conjunction with the Base Prospectus. Except where the context otherwise requires, the terms defined in the Base Prospectus have the same meaning when used in this Prospectus Supplement.

Saint-Gobain accepts responsibility for the information contained in this Prospectus Supplement. To the best of its knowledge (having taken all reasonable care to ensure that such is the case) the information contained in this Prospectus Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information. Saint-Gobain’s legal name is Compagnie de Saint-Gobain.
