Dear Sir,

I, CS K.V.S. Subramanyam, Partner of Ahalada Rao. V and Associates, Company Secretaries, Hyderabad, Practising Company Secretary holding Membership No. F5400 and Certificate of Practice No. 4815, was appointed as the Scrutinizer by the Board of Directors of Axis Bank Limited ("the Bank") for the purpose of scrutinizing the postal ballot process conducted through remote electronic voting in respect of the resolutions set out in the Notice of Postal Ballot dated December 18, 2025, in accordance with the provisions of the Companies Act, 2013, the rules made thereunder, the circulars issued by the Ministry of Corporate Affairs from time to time, and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

The management of the Bank is responsible for ensuring compliance with the applicable provisions of the Companies Act, 2013, the Companies (Management and Administration) Rules, 2014, the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Banking Regulation Act, 1949, the directions and guidelines issued by the Reserve Bank of India, and the MCA circulars, with respect to the conduct of the postal ballot through electronic mode, maintenance of proper records, provision of remote e-voting facility, and disclosure of the voting results in the manner prescribed under law.

Our responsibility as Scrutinizer was limited to scrutinizing the votes cast through remote e-voting, verifying their validity in a fair and transparent manner, and submitting this report of the results of such voting. We have not verified or expressed any opinion on the merits of the resolutions or on any other matter beyond the scope of my appointment.



The Bank had fixed Friday, December 12, 2025, as the cut-off date for determining the eligibility of members to vote on the resolutions proposed in the postal ballot. Only those members whose names appeared in the Register of Members or in the list of beneficial owners furnished by the depositories as on the said cut-off date were entitled to cast their votes.

The Bank provided the facility of remote e-voting through National Securities Depository Limited ("NSDL"). The remote e-voting period commenced at 9:00 A.M. on Saturday, December 20, 2025 and concluded at 5:00 P.M. on Sunday, January 18, 2026. After the conclusion of the remote e-voting period, the e-voting facility was disabled by NSDL in accordance with the applicable rules.

At 05.01. P.M., Sunday January 18, 2026, The votes cast through remote e-voting were unblocked by me in the presence of two witnesses not in the employment of the Bank, and the data relating to votes cast was downloaded from the NSDL e-voting system. I have scrutinised the remote e-voting data and verified the same with reference to the records maintained by the Bank and the information provided by NSDL, including verification of voting rights as on the cut-off date..


