Capital Research and Management Company ("CRMC") is a U.S.-based investment adviser that manages the American Funds family of mutual funds. CRMC does not own shares of the companies it invests in for its own account. Rather, the shares reported in this disclosure are owned by mutual funds under the discretionary investment management of CRMC. CRMC is filing solely with respect to shares over which it exercises voting rights.
