This Supplement (the "**Supplement**") to the Base Prospectus dated 17 March 2022 (the "**Base Prospectus**") (as supplemented by the supplementary prospectus dated 8 August 2022) constitutes a supplementary base prospectus for the purposes of Article 23 of Regulation (EU) 2017/1129 as it forms part of domestic law by virtue of the European Union (Withdrawal) Act 2018 (the "**UK Prospectus Regulation**") and is prepared in connection with the £25,000,000,000 Euro Medium Term Note Programme (the "**Programme**") established by B.A.T. International Finance p.I.c. ("**BATIF**"), B.A.T Capital Corporation ("**BATCAP**") and B.A.T. Netherlands Finance B.V. ("**BATNF**") (each, in their capacities as issuers under the Programme, an "**Issuer**" and together referred to as the "**Issuers**") and unconditionally and irrevocably guaranteed by British American Tobacco p.I.c. ("**BAT**") and each of BATIF, BATCAP and BATNF except where it is the relevant Issuer (together, the "**Guarantors**"). Other than as expressly set out herein, terms defined in the Base Prospectus have the same meaning when used in this Supplement.

This Supplement is supplemental to, and should be read in conjunction with, the Base Prospectus and any other supplements to the Base Prospectus issued by the Issuers.

Each of BAT, BATIF, BATNF and BATCAP accepts responsibility for the information contained in this Supplement and Reynolds American Inc. ("**RAI**" or the "**Additional Guarantor**") accepts responsibility for the information relating to RAI contained in this Supplement. To the best of the knowledge of BAT, BATIF, BATNF, BATCAP and RAI, each of the foregoing declares that the information (or in the case of RAI, as such information relates to it) contained in this Supplement is in accordance with the facts and that the Supplement makes no omission likely to affect its import.

## Purpose of this Supplement

The purpose of this Supplement is to:

- (A) incorporate by reference in the Base Prospectus:
  - (i) BAT's preliminary results for its consolidated group for the year ended 31 December 2022 (the "2022 Preliminary Results"), which can be found in the announcement titled "Preliminary Results – British American Tobacco p.l.c. – Year Ended 31 December 2022" (the "2022 Preliminary Announcement"); and
  - (ii) BATIF's consolidated audited annual financial information as at and for the year ended 31 December 2022, together with the audit report thereon (the "BATIF 2022 Results", and together with the 2022 Preliminary Results, the "2022 Results"), which can be found in BATIF's Annual Report 2022 (the "BATIF Annual Report 2022", and together with the 2022 Preliminary Announcement, the "2022 Financial Statements"); and
- (B) update the no significant or material change paragraph contained in the section headed "General Information" in the Base Prospectus.

## Incorporation by Reference

BAT has published its 2022 Preliminary Announcement, which contains its 2022 Preliminary Results. BATIF has made available its audited annual financial statements as at and for the financial year ended 31 December 2022. Copies of the 2022 Financial Statements have been filed with the Financial Conduct Authority and, by virtue of this Supplement, the following sections are incorporated by reference in, and form part of, the Base Prospectus:

- in the case of BAT, the 2022 Preliminary Results set out on page 3, pages 15 to 23 (except for the section titled "*External Recognition in Respect of Sustainability*" on page 23) and pages 25 to 54 of the 2022 Preliminary Announcement (*https://www.bat.com/group/sites/UK\_9D9KCY.nsf/vwPagesWebLive/DOCNUNN9/\$file/FY\_2022\_Announcement.pdf*); and
- (ii) in the case of BATIF, the BATIF 2022 Results set out on pages 8 to 45 of the BATIF Annual Report 2022 (https://www.bat.com/group/sites/uk\_9tvmh3.nsf/vwPagesWebLive/DO9TVMT5/\$FILE/medMDC NVCCV.pdf?openelement).

Any information included in the 2022 Financial Statements, but not forming part of the 2022 Results, does not form part of the Base Prospectus as it is either not relevant for prospective investors in the Notes or is covered elsewhere in the Base Prospectus.

The financial information contained in the 2022 Preliminary Results has been properly prepared on the basis stated in the notes to the financial information included in the 2022 Preliminary Results, and, as described in Accounting Policies and Basis of Preparation in the 2022 Preliminary Results, on a basis consistent with the current IFRS accounting policies of BAT.

## No Significant or Material Adverse Change

The following statement updates paragraph 5 on pages 161 to 162 of the Base Prospectus:

"There has been no significant change in the financial performance or financial position of (i) BATNF, BATCAP or RAI and their respective subsidiaries taken as a whole since 31 December 2021 and (ii) BAT and BATIF and their respective subsidiaries taken as a whole since 31 December 2022. There has been no material adverse change in the prospects of (i) BAT, BATNF, BATCAP or RAI and their respective subsidiaries taken as a whole since 31 December 2021 and (ii) BATIF and its subsidiaries taken as a whole since 31 December 2022."

Save as disclosed in this Supplement, no other significant new factor, material mistake or inaccuracy relating to information included in the Base Prospectus has arisen or been noted, as the case may be, since the publication of the Base Prospectus.
