Nature of the Event: Update regarding a distribution from the profits of Q3 18

1. Bank Hapoalim B. M. ("the Bank") respectfully advises that in the framework of Note 10. C. of the financial statements for the third quarter of the year 2018 (Reference No. 2018-01-103354), that were released today ("the Financial Statements"), a note dealing with the investigation by the United States authorities in connection with American clients (page 190), an update was included that shortly before the date of approval of the financial statements, the Supervision of Banks notified the Bank, that in light of the substantive uncertainty with respect to the investigation of the US authorities, and for reasons of caution and conservatism, the Supervision of Banks is of the opinion that at this time dividend should not be distributed by the Bank. Accordingly, the Board of Directors of the Bank did not declare the distribution of a dividend from the profits of the third quarter of 2018, and this without changing the Bank's dividend distribution policy. For further details, see Note 10.C. and 9.B. of the Financial Statements.
