

Monthly Market Commentary

During May RSM sent proposals to the AGMs of 11 NAVF companies. These consisted pricipally in our requesting the allotment of amounts of Restricted Stock to senior managers and other employees in line with Japanese government Corporate Guidance recommendations and that each company undertake a 10% buyback of its listed shares in the next financial year.

A expected, all companies rejected these proposals but three introduced shareholder-friendly measures sufficient to allow us to withdraw our proposals before the AGMs took place. We did this for Teikoku Electric, Ihara Science and Mitsuboshi Belting. Following Mitsuboshi Belting's announcement that it would move to 100% dividend payouts for at least the next two years and the intention to target an 8% ROE, the company's shares have rallied over 40%.
