Tokyo/Hanoi, January 12, 2016 - The ANA Group, Japan's largest airline group and Vietnam

Airlines, the leading airline in Vietnam have entered into a Memorandum of Understanding (MOU) for

the ANA Group to acquire a stake in Vietnam Airlines of approximately 8.8% worth 2,431 billion

Vietnamese dong (US\$108 million).

The partnership will also provide for the ANA Group and Vietnam Airlines to enable both to take

maximum advantage of the increasing demand for air services in the Asian market and, in particular,

in the Cambodia-Laos-Myanmar-Vietnam group of countries which has one of the highest growth

potentials in the region.

Group as we expand our international footprint and Vietnam Airlines makes the ideal partner for us
