Manager's Commentary

Market Conditions

The Africa Opportunity Fund ("AOF" or the "Company" or the "Fund") NAV increased 0.3% in November 2024 to \$1.373/share while its share price increased 8% to \$0.650/share. As a reference, major African indices recorded mixed performances: Morocco gained 3.1% whilst Nigeria declined 2.1%, Kenya declined 5.5%, South Africa declined 2.9%, and Egypt declined 3.1%. Key Africa-focused ETFs recorded negative performances in November 2024: Amundi Pan African (LGQM GY) declined 1.0%, DBX MSCI Africa Top 50 (XMAF LN) declined 0.9%, and Van Eck Africa Index (AFK US) declined 1.8%.

Portfolio Highlights

AOF's net asset value increased 0.3% as investment gains from Enterprise Group and First Mutual Properties were partially offset by losses from Kenya Power.


