Manager's Commentary

Market Conditions

The Africa Opportunity Fund ("AOF" or the "Company" or the "Fund") NAV increased 5.9% in August 2024 to \$0.901/share while its share price declined 8% to \$0.598/share. As a reference, other major African indices recorded gains: Nigeria gained 3.6%, Kenya gained 0.1%, Morocco gained 1.4%, South Africa gained 3.5% and Egypt gained 4.6%. Key Africa-focused ETFs recorded positive performances in August 2024: Amundi Pan African (LGQM GY) gained 1.5%, DBX MSCI Africa Top 50 (XMAF LN) gained 7.6% and Van Eck Africa Index (AFK US) gained 0.5%.

Portfolio Highlights

AOF's net asset value increased 5.9% in August largely due to investment gains from Mashonaland Holdings and Enterprise Group. The share price of Mashonaland Holdings appreciated 21% whilst Enterprise's share price recovered 6% as financial markets gained on expectations of easing monetary policies.


