
Third Quarter Performance Review

- US\$ Equity share price declined from \$0.88 to \$0.74 during the quarter


During the third quarter, JPEL received \$1.1 mm of distributions and did not fund any capital calls. Notable distributions include \$1.1mm from JPEL's investment in Placid Holdings.

Portfolio Update

As referenced in JPEL's audited financial statements, JPEL's subsidiary entered into a two year Put Option Agreement (the "Option") relating to its investment in the Tax Advisory Services company. The Option provides JPEL the right, but not the obligation, to sell its investment in the company after 24 October 2025 at the 30 June 2024 valuation. The Option is subject to customary closing conditions that, if not satisfied or waived, could result in some or all investment not being sold. The purpose of entering into the Option is to preserve the current carrying value while allowing for potential investment value upside through to 24 October 2026. In addition, if the Option is exercised in one year, JPEL believes it could accelerate liquidity for its largest investment by up to 24 months.







JPEL Private Equity Limited ("JPEL" or the "Company") is a Guernsey registered and incorporated, London Stock Exchange-listed, closed-ended investment company (LSE: JPEL). JPEL focuses on concentrated secondary deals, secondary directs, fund recapitalizations and special situation investments. The Company's capital structure consists of Equity Shares.

About the Manager

JPEL Private Equity Limited is managed by FCF JPEL Management LLC, an affiliate of Fortress Investment Group LLC ("Fortress"). Founded in 1998, Fortress manages assets on behalf of over 1,750 institutional clients and private investors worldwide across a range of credit, real estate, permanent capital and private equity investment strategies. On May 14, 2024, Fortress and Mubadala Investment Company, through its wholly-owned asset management subsidiary Mubadala Capital ("Mubadala Capital"), completed the previously announced acquisition of 90.01% of the equity of Fortress that was held by SoftBank Group Corp. and the remaining 9.99% held by another affiliate of Mubadala Capital. With the close of the transaction, Fortress management and employees own 32% of the equity of Fortress, own a class of equity entitling Fortress management to appoint the majority of seats of Fortress's board of directors. Fortress co-CEOs Drew McKnight and Josh Pack, Managing Partner Jack Neumark, and co-Chairman Pete Briger are the largest individual investors in the buy-out and were joined by approximately 150 members of the firm. A consortium led by Mubadala Capital now owns the remaining 68% of the equity of Fortress.
