

Capital Call and Distribution Activity

During the three months ending 30 September 2019, JPEL received distributions of \$51.6 million and funded capital calls of \$0.5 million.

Notable distributions include: \$15.8 million from the sale of RCR Industrial, \$8.9 mm in the second of two payments from the sale of Grupo Zena, \$7.4 million as part of a dividend recapitalization from Swania, \$1.4 million from Black Diamond and \$1.3 million from Global Buyout Fund. Also during the quarter, JPEL exited its investment in Leeds Equity Partners V, L.P. and received \$15.0 million in proceeds.


Post Quarter Activity

On 22 October 2019, JPEL completed its sixth mandatory redemption and returned \$65 million to US\$ Equity Shareholders. Inclusive of this Mandatory Redemption, JPEL has returned \$299.2 million to US\$ Equity Shareholders, or approximately 62% of the Company's 31 October 2016 NAV, the prevailing NAV at the time of the Company's first mandatory redemption.



In December 2017, SoftBank Group Corp. ("SoftBank") completed the acquisition of Fortress. Fortress operates within SoftBank as an independent business headquartered in New York. Fortress Principals Pete Briger, Wes Edens and Randy Nardone continue to lead Fortress.
