Network International Holdings Plc. (LSE: **NETW**) (the “Company”) announces that on 13 January 2023, it has purchased its own ordinary shares through its broker Citigroup Global Markets Limited as detailed below:

These share purchases form a part of the share buyback programme of up to an aggregate purchase price of USD 100 million announced on 11 August 2022 (the “Buyback Programme”). The Buyback Programme, which started on 15 August 2022, is based on the authorisation granted by the Company’s Annual General Meeting on 19 May 2022.

The Company will hold the repurchased shares in treasury. Following the above transactions, the Company holds 11,903,769 of its ordinary shares in treasury and has 549,197,921 ordinary shares in issue (excluding treasury shares), which corresponds to the total number of voting rights.

This figure for the total number of voting rights may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure Guidance and Transparency Rules.
