Capitalised terms not defined in this notice shall have the meanings ascribed to them in the trust deed dated 18 December 2009 (as supplemented, amended and restated from time to time) pursuant to which each Series of the Notes was issued.

Wells Fargo Securities, LLC, as calculation agent for each Series of the Notes (the "**Calculation Agent**"), hereby notifies Noteholders that, in the event any Series of the Notes becomes due and payable in accordance with item 23 of the Final Terms relating to such Series of Notes, the Calculation Agent will, in accordance with its obligation to act in good faith and on such basis as it considers in its sole and absolute discretion to be fair and reasonable in the circumstances, determine the Early Termination Amount or Early Redemption Amount (Tax) due in respect of the relevant Notes to be the higher of:

- (i) the fair market value of such Notes immediately prior to the date fixed for redemption or (as the case may be) the date upon which the Notes become due and payable, plus or minus any related hedging gains or losses; and
- (ii) an amount equal to the sum of:
 - (A) the Reference Price; and
 - (B) the product of the Accrual Yield (compounded annually) being applied to the Reference Price on the basis of the Day Count Fraction from (and including) the Issue Date to (but excluding) the date fixed for redemption or (as the case may be) the date upon which such Series of Notes becomes due and payable.

The Issuer hereby notifies the Noteholders that it concurs with the Calculation Agent in the matters set out above.

This notice is for information purposes and no amendment to the Conditions in respect of any Series of Notes is intended or effected by this notice. No action is required to be taken by holders of the Notes in connection with this notice.
