This Supplement is supplemental to, and should be read in conjunction with, the Prospectuses and any other supplements to the Prospectuses issued by The Royal Bank of Scotland plc (the **Issuer**).

The Issuer accepts responsibility for the information contained in this Supplement. To the best of the knowledge of the Issuer (which has taken all reasonable care to ensure that such is the case) the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

*Madoff Investment Securities*

In each of the Programme Prospectuses (as defined in the Schedule hereto), the following paragraph shall be inserted at the end of the description of the Issuer in the section headed, in the case of the Programme Prospectus dated 14 May 2008, “Summary of the Programme and Terms and Conditions of the Notes” and, in the Programme Prospectus dated 26 September 2008, “Summary of the Programme”:

“The Group has announced that it has exposure through trading and collateralised lending to funds of hedge funds invested with Bernard L Madoff Investment Securities LLC. If as a result of the alleged fraud the value of the assets of these hedge funds is nil, the Group’s potential loss could amount to approximately £400 million.”.

*Ratings Information*

In each of the Programme Prospectuses (as defined in the Schedule hereto), the following paragraph shall be added at the end of the section headed “General Information”:

“Ratings Information

Standard & Poor’s is expected to rate: senior notes issued by RBS with a maturity of one year or more “A+”; senior notes issued by RBS with a maturity of less than one year “A-1”; dated subordinated notes issued by RBS “A”; and undated tier 2 notes issued by RBS “BBB+”, all with a stable outlook.”.

In each of the Structured Note Programme Prospectuses and Certificate and Warrant Programme Prospectuses (each as defined in the Schedule hereto), a new section headed “Ratings Information” shall be added before the section headed “Form of Final Terms” to read as follows:

“Ratings Information

Standard & Poor’s is expected to rate: senior notes issued by RBS with a maturity of one year or more “A+”; senior notes issued by RBS with a maturity of less than one year “A-1”; dated subordinated notes issued by RBS “A”; and undated tier 2 notes issued by RBS “BBB+”, all with a stable outlook.”.

If any document which is incorporated by reference into any of the Prospectuses by this Supplement itself incorporates any information or other documents therein, either expressly or implicitly, such information or other documents will not form part of any of the Prospectuses or this Supplement for the purposes of the Prospectus Directive except where such information or other documents are specifically incorporated by reference into any of the Prospectuses by this Supplement, or attached to this Supplement.

To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference into each of the Prospectuses by this Supplement and (b) any other statement in or incorporated by reference in any of the Prospectuses, the statements in (a) above will prevail.

Save as disclosed in this Supplement or any document incorporated by reference into each of the Prospectuses by this Supplement, there has been no other significant new factor, material mistake or inaccuracy relating to information included in each of the Prospectuses since the publication of each of the Prospectuses.
