This supplementary prospectus (the "**Supplement**") to the base prospectus of Australia and New Zealand Banking Group Limited ("**ANZBGL**") dated 23 May 2023, as supplemented by the supplementary prospectuses dated 7 August 2023, 17 August 2023, 13 November 2023, 12 February 2024 and 20 February 2024 (the "**Base Prospectus**"), constitutes a supplementary prospectus for the purposes of Article 23 of Regulation (EU) 2017/1129 as it forms part of UK domestic law by virtue of the European Union (Withdrawal) Act 2018, as amended (the "**EUWA**") (the "**UK Prospectus Regulation**") and is prepared in connection with the US\$30,000,000,000 ANZ Global Covered Bond Programme established by ANZBGL.

This Supplement has been approved by the United Kingdom Financial Conduct Authority (the "**FCA**"), as competent authority under the UK Prospectus Regulation. The FCA only approves this Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the UK Prospectus Regulation and such approval should not be considered as an endorsement of the Issuer nor as an endorsement of the quality of any Covered Bonds that are the subject of the Base Prospectus. Investors should make their own assessment as to the suitability of investing in any such Covered Bonds.

The purpose of this Supplement is to update the sub-section entitled "Recent Developments" in the section entitled "Australia and New Zealand Banking Group Limited and its Subsidiaries" of the Base Prospectus with information regarding Moody's upgrade to ANZBGL's senior and subordinated debt ratings.

Terms defined in the Base Prospectus have the same meaning when used in this Supplement.

This Supplement is supplemental to, and should be read and construed together with, the Base Prospectus.

ANZBGL accepts responsibility for the information contained in this Supplement and to the best of the knowledge of ANZBGL, the information contained in this Supplement is in accordance with the facts and this Supplement makes no omission likely to affect its import.

The sub-section entitled "Recent Developments" in the section entitled "Australia and New Zealand Banking Group Limited and its Subsidiaries" on page 242 of the Base Prospectus shall be supplemented by inserting the below at the end of the abovementioned section:

**"Moody's upgrades ANZBGL's Senior and Subordinated Debt Ratings**

On 6 March 2024, ANZBGL announced that Moody's has upgraded the following key debt ratings for ANZBGL:

Moody's has reaffirmed ANZBGL's 'Stable' outlook.

The upgrade of ANZBGL's ratings resulted from the application of Moody's Advanced Loss Given Failure analysis to certain Australian banks, including ANZBGL, following the publication of Moody's updated banks methodology on 5 March 2024."
