### **Proposed record date in connection with the payment of 2012 final dividend**

The Stock Exchange of Hong Kong Limited (the "Stock Exchange") granted a waiver to Standard Chartered PLC (the "Company") on 7 December 2011 from strict compliance with Rule 13.66(2) of the Rules Governing The Listing of Securities on the Stock Exchange and Note 3 thereunder relating to record dates for the Company's final dividends.

- (2) any person who has acquired shares registered on the Hong Kong Branch Register but who has not lodged the share transfer with Computershare Hong Kong Investor Services Limited at Shops 1712-1716, 17th Floor, Hopewell Centre, 183 Queen's Road East, Wan Chai, Hong Kong should do so **before 4.30pm (Hong Kong time) on Thursday 14 March 2013** in order to receive the 2012 final dividend.
