This Supplement (the "**Supplement**") to the prospectus dated 28 March 2024 which comprises a base prospectus (the "**Prospectus**") for the purposes of Regulation (EU) 2017/1129 as it forms part of domestic law by virtue of the European Union (Withdrawal) Act 2018 (the "**UK Prospectus Regulation**"), constitutes a supplementary prospectus for the purposes of Article 23 of the UK Prospectus Regulation, and is prepared in connection with the £35,000,000,000 Euro Medium Term Note Programme (the "**Programme**") established by Lloyds Bank plc (the "**Bank**").

This Supplement is supplemental to, and should be read in conjunction with, the Prospectus and the documents incorporated by reference therein. Capitalised terms used in this Supplement but not defined herein shall have the meanings ascribed to them in the Prospectus.

The Bank accepts responsibility for the information contained in this Supplement. To the best of the knowledge of the Bank the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

Purpose of this Supplement

The purpose of this Supplement is to:

- (a) incorporate by reference into the Prospectus, the Bank's Q1 2024 Interim Management Statement (as defined in this Supplement), which was published via the RNS on 24 April 2024;
- (b) update the section of the Prospectus headed "*Use of Proceeds*"; and
- (c) update the no significant change statement of the Bank and its subsidiary and associated undertakings (the "**Lloyds Bank Group**").

(a) Documents Incorporated by Reference

By virtue of this Supplement, the Bank's unaudited Q1 2024 Interim Management Statement for the three months ended 31 March 2024 (RNS Number 8562L) and available at <https://www.lloydsbankinggroup.com/assets/pdfs/investors/financial-performance/lloyds-bank-plc/2024/q1/2024-lb-q1-results.pdf> (the "**Q1 2024 Interim Management Statement**"), which has previously been filed with the Financial Conduct Authority shall be deemed to be incorporated in, and form part of, the Prospectus and supplement the section entitled "*Documents Incorporated by Reference*" on pages 14 to 17 of the Prospectus.

Any documents themselves incorporated by reference in the Q1 2024 Interim Management Statement shall not form part of the Prospectus, unless specified otherwise here.

(b) Use of Proceeds Section

On 24 April 2024 Lloyds Banking Group published a new Sustainable Bond Framework. As a result, the "Use of Proceeds" section on page 122 of the Prospectus shall be amended as follows:

- i. The term "Sustainability Bond Framework" in the second paragraph of the "Use of Proceeds" section shall be deleted in its entirety and replaced with the term "Sustainable Bond Framework".
- ii. The fourth paragraph shall be deleted in its entirety and replaced as set out below:

"In connection with the Framework, Lloyds Banking Group has appointed a sustainability specialist to issue an opinion confirming that the Framework is credible and impactful, and aligns with the International Capital Market Association's Green Bond Principles and Social Bond Principles (the "**Second Party Opinion**")."

(c) No significant change of the Lloyds Bank Group

The no significant change statement of the Lloyds Bank Group at paragraph 3 on page 180 of the Prospectus shall be deleted in its entirety and replaced as set out below:

"There has been no significant change in the financial position or financial performance of the Lloyds Bank Group since 31 March 2024, the date to which the Lloyds Bank Group's last published unaudited financial information (as set out in the Bank's Q1 2024 Interim Management Statement) was prepared."

Save as disclosed in this Supplement, no other significant new factor, material mistake or material inaccuracy relating to information included in the Prospectus has arisen or been noted, as the case may be, since the publication of the Prospectus.
