## Profile of Mr. Girish Paranipe

Apart from Axis Bank Limited, Girish Paranjpe also serves as an independent director of CRISIL Limited (a publicly listed subsidiary of S&P Global), an independent director of Max Life Insurance Company Limited and a director and audit committee chairman at IBS Software Pte Ltd., Singapore.

He is a commerce graduate and member of the Institute of Chartered Accountants of India (ICAI) and Institute of Cost and Works Accountants of India (ICWAI).
