Registration Document

This supplement (the "**3rd Supplementary Registration Document**") to the registration document dated 13 May 2020 (as supplemented, the "**Registration Document**"), which constitutes a registration document for the purposes of Article 6(3) of Regulation (EU) 2017/1129 (the "**Prospectus Regulation**"), constitutes a supplementary prospectus for the purposes of Article 23 of the Prospectus Regulation.

Terms defined in the Registration Document have the same meanings when used in this 3rd Supplementary Registration Document.

This 3rd Supplementary Registration Document is supplemental to, and should be read in conjunction with, the Registration Document and the documents incorporated by reference therein.

NatWest Markets Plc (the "**Issuer**" or "**NatWest Markets**" and, together with its consolidated subsidiaries, the "**NWM Group**") accepts responsibility for the information contained in this 3rd Supplementary Registration Document. To the best of the knowledge of the Issuer such information is in accordance with the facts and makes no omission likely to affect its import.

The distribution of this 3rd Supplementary Registration Document and the offer or sale of any securities of the Issuer may be restricted by law in certain jurisdictions. Persons into whose possession this 3rd Supplementary Registration Document or any securities of the Issuer come must inform themselves about, and observe, any such restrictions.

Any securities to be issued by the Issuer in connection with this 3rd Supplementary Registration Document and the Registration Document have not been and will not be registered under the Securities Act or with any securities regulatory authority of any state or other jurisdiction of the US. Accordingly, any such securities may not be offered, sold, pledged or otherwise transferred within the US or to or for the account or benefit of US persons except pursuant to an exemption from, or in a transaction not subject to, the registration requirements of the Securities Act and any applicable state securities laws. There will be no public offering of securities in the United States.

Purpose of the Supplementary Registration Document

The purpose of this 3rd Supplementary Registration Document is to:

- (a) incorporate by reference into the Registration Document the NWM Group Q3 2020 IMS (as defined below);

- (b) following the publication of the NWM Group Q3 2020 IMS, update the statements of no significant change and of no material adverse change; and
- (c) update certain information relating to legal proceedings, litigation and investigations.

Incorporation of Information by Reference

By virtue of this 3rd Supplementary Registration Document the unaudited NWM Group Q3 2020 Interim Management Statement (the "**NWM Group Q3 2020 IMS**"), which was published via the regulatory news service of the London Stock Exchange plc on 30 October 2020 which has been (1) previously published and (2) filed with the Financial Conduct Authority, shall be incorporated in, and form part of, the Registration Document.

If a document which is incorporated by reference in the Registration Document by virtue of this 3rd Supplementary Registration Document itself incorporates any information or other documents therein, either expressly or implicitly, such information or other documents will not form part of the Registration Document except where such information or other documents are specifically incorporated by reference in, or attached to, the Registration Document by virtue of this 3rd Supplementary Registration Document.

Statements of No Significant Change and of No Material Adverse Change

There has been no significant change in the financial position of the NWM Group taken as a whole since 30 September 2020 (the end of the last financial period for which the latest unaudited interim financial information of the NWM Group has been published).

Save as disclosed in the sections entitled (a) "*Risk Factors - Economic and political risk - The direct and indirect effects of the Covid-19 pandemic are having an adverse impact on NWM Group's business and results of operations, which is likely to be material if conditions worsen or are prolonged, and may affect its ability to meet its targets and achieve its strategic objectives.*" on pages 28 to 30 of the Registration Document, (b) "*The impact of COVID-19*" on pages 3 to 4, "*Outlook*" on page 4 and "*Capital and risk management – Credit risk – Banking activities*" on pages 19 to 24 of the NatWest Markets Group Interim Results 2020 and (c) "*Financial Review - The impact of Covid-19*" on pages 2 and 3 and "*Outlook*" on page 3 of the NWM Group Q3 2020 IMS, there has been no material adverse change in the prospects of NatWest Markets since 31 December 2019 (the last date to which the latest audited published financial information of NatWest Markets was prepared).

Updating the legal proceedings disclosure set out in the Registration Document

The section entitled "*Legal and Arbitration Proceedings*" at pages 113 to 120 of the Registration Document shall be updated to include the section entitled "*Litigation, investigations and reviews*" in the "*Notes*" on page 12 of the NWM Group Q3 2020 IMS as referred to in, and incorporated by reference into, this Registration Document.

Other than as referred to in (i) the section entitled "*Legal and Arbitration Proceedings*" at pages 113 to 120 of the Registration Document, (ii) the 2nd Supplementary Registration Document and (iii) this 3rd Supplementary Registration Document, there are no governmental, legal or arbitration proceedings (including any such proceedings which are pending or threatened of which the Issuer is aware), which may have or have had during the 12 months preceding the date of this 3rd Supplementary Registration Document, a significant effect on the financial position or profitability of NatWest Markets and/or the NWM Group.
