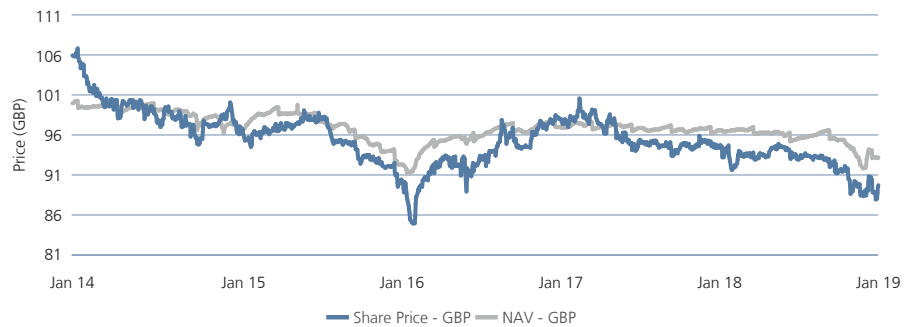

## SHARE PRICE MOVEMENT

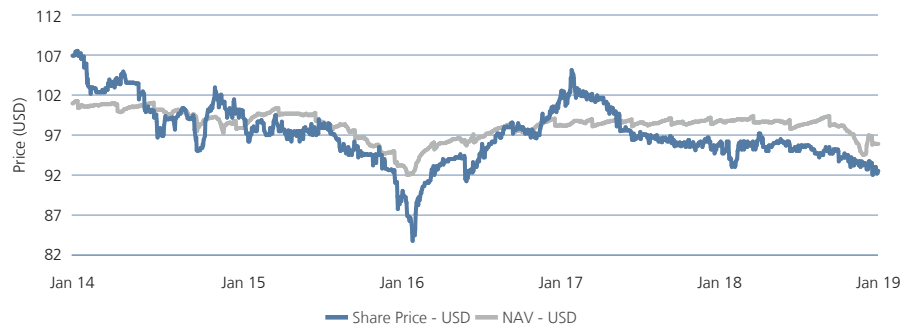


Share price and Net Asset Value (NAV) movement is representative of GBP.

## RISK CONSIDERATIONS
