Standard Chartered completes the consolidation of its business in Singapore into Standard Chartered Bank (Singapore) Limited

Standard Chartered Bank (the "**Bank**") has announced that it has completed the transfer of all its businesses in Singapore from the Bank's Singapore Branch into its locally incorporated subsidiary, Standard Chartered Bank (Singapore) Limited ("**SCBSL**").

The Bank's Singapore Branch intends to return its full banking licence. After the return of the licence, the Singapore Branch will remain part of the Bank but will have a non-licensed bank structure.

Securities issued by Standard Chartered Bank, acting through its Singapore Branch, under the U.S.\$ 15,000,000,000 Notes, Certificates and Warrants Programme

Standard Chartered Bank (the "**Issuer**"), acting through its Singapore Branch, has issued the Securities listed in the Annex hereto under its U.S.\$ 15,000,000,000 Notes, Certificates and Warrants Programme (the "**Programme**") which are listed on Euronext Dublin and which have been admitted to trading on the Main Securities Market of Euronext Dublin.

The Issuer believes there would not be any withholding tax impact on the Securities due to the return of the Singapore Branch's banking licence and the Issuer intends to continue to meet obligations of its Singapore Branch in full.
