### REDEMPTION NOTICE FOR WESTPAC CAPITAL NOTES 3

Thank you for your investment in Westpac Capital Notes 3 (**WCN 3**). I am writing to let you know that on 22 March 2021, the optional conversion/redemption/transfer date for WCN 3, Westpac Banking Corporation (**Westpac**) will redeem all outstanding WCN 3 on issue. The accompanying Redemption Notice is issued in accordance with clauses 7.1(a)(i) and 7.2(a) of the WCN 3 terms (as amended) (**the Terms**).

#### What this means for you

On 22 March 2021, you will be paid the redemption proceeds of \$100 for each WCN 3 you hold on that date. You will also be paid the final WCN 3 distribution of \$0.6921 per WCN 3, fully franked, for the period from 23 December 2020 to 22 March 2021 (inclusive) on any WCN 3 that you hold as at 7.00pm (Sydney time) on the record date of 12 March 2021, provided the distribution payment conditions in the Terms are satisfied.

These payments will be made in the same way your WCN 3 distribution payments have previously been paid. You do not need to do anything in response to this notice unless you wish to update your account details which you can do online via the Registrar's investor centre at [www.linkmarketservices.com.au](http://www.linkmarketservices.com.au) (if your single holding has a market value less than \$50,000 or portfolio holding has a market value less than \$1,000,000) or call the **Westpac Capital Notes 3 Information Line** on +61 1300 206 701 to request a form be mailed to you. Payments can only be made by direct credit into an Australian dollar account. Any changes must be made before 5.00pm (Sydney time) on 12 March 2021.

#### Selling your WCN 3

You may sell your WCN 3 on ASX at the prevailing market price (which may be higher or lower than the redemption proceeds of \$100 per WCN 3) on or before 12 March 2021, which is expected to be the last day of trading in WCN 3. If you sell your WCN 3 on ASX on or before 12 March 2021, you will not be entitled to the redemption proceeds. You may be required to pay brokerage if you choose to sell WCN 3 on ASX. It is also expected that off-market transfers of WCN 3 will not be accepted after 12 March 2021.

Westpac Banking Corporation (**Westpac**) notifies holders of Westpac Capital Notes 3 (**WCN 3**) that on 22 March 2021, all WCN 3 on issue will be redeemed by Westpac in accordance with clause 7.1(a)(i) of the WCN 3 terms (as amended) (**the Terms**). WCN 3 holders will be paid \$100 for each WCN 3 held on 22 March 2021. On 22 March 2021, a final Distribution of \$0.6921 per WCN 3, fully franked, will also be paid to all registered holders of WCN 3 as at 7.00pm (Sydney time) on 12 March 2021, provided the Distribution payment conditions in the Terms are satisfied, including Distributions being at the absolute discretion of Westpac.
