Reference is made to that certain (i) Indenture, dated as of April 25, 2013 (as further amended, modified or supplemented, the "Original Indenture"), by and among VOYA CLO 2013-2, LTD., as Issuer (the "Issuer"), VOYA CLO 2013-2, LLC, as Co-Issuer (the "Co-Issuer", and together with the Issuer, the "Co-Issuers") and U.S. BANK NATIONAL ASSOCIATION, as Trustee (the "Trustee") and (ii) the First Supplemental Indenture, dated as of March 29, 2018 (the "First Supplemental Indenture", and together with the Original Indenture, the "Indenture"), by and among the Co-Issuers and the Trustee. Capitalized terms used but not defined herein shall have the meanings given to them in the Indenture.

THIS SUPPLEMENTAL INDENTURE (this "<u>Supplemental Indenture</u>"), dated as of March 29, 2018, among VOYA CLO 2013-2, Ltd., an exempted company incorporated with limited liability under the laws of the Cayman Islands (the "<u>Issuer</u>"), VOYA CLO 2013-2, LLC, a limited liability company formed under the laws of the State of Delaware (the "<u>Co-Issuer</u>" and, together with the Issuer, the "<u>Co-Issuers</u>"), and U.S. Bank National Association, as trustee (herein, together with its permitted successors and assigns in the trusts hereunder, the "<u>Trustee</u>"), hereby amends the Indenture, dated as of April 25, 2013, as amended from time to time (the "<u>Indenture</u>"), among the Issuer, the Co-Issuer and the Trustee. Capitalized terms used in this Supplemental Indenture that are not otherwise defined herein have the meanings assigned thereto in the Indenture.

#### WITNESSETH

WHEREAS, the Co-Issuers desire to enter into this Supplemental Indenture to refinance the Class A-1 Notes, the Class A-2a Notes, the Class A-2b Notes, the Class B Notes, the Class C Notes, the Class D Notes and the Class E Notes outstanding prior to the effectiveness of this Supplemental Indenture (the "Redeemed Notes") in accordance with Section 9.2 of the Indenture;

WHEREAS, pursuant to Section 8.1(viii)(B) and Section 8.1(xiii) of the Indenture and subject to certain conditions set forth in the Indenture, the Trustee and the Co-Issuers may amend the Indenture in order to effect a Refinancing in accordance with Section 9.2(d) of the Indenture with no further consent for such amendment other than from a Majority of the Subordinated Securities;

WHEREAS, pursuant to Section 8.2(a) of the Indenture and subject to certain conditions set forth in the Indenture, the Trustee and the Co-Issuers may execute one or more supplemental indentures for the purpose of adding any provisions to, or changing in any manner or eliminating any of the provisions of, the Indenture or of modifying in any manner the rights of the Holders of each Class under the Indenture with the consent of a Majority of each Class materially and adversely affected thereby;

WHEREAS, the Co-Issuers desire to enter into this Supplemental Indenture to make changes to the Indenture necessary to effect a Refinancing of the Secured Notes pursuant to Section 9.2(a) and Section 9.2(d) of the Indenture through issuance on the date of this Supplemental Indenture of the Refinancing Notes (as defined below) and make certain other amendments to the Indenture in accordance with Section 8.2(a) as set forth in Section 1 below;

WHEREAS, by purchasing a Refinancing Note, each initial holder thereof is deemed to have consented to this Supplemental Indenture and no action on the part of such holders is required to evidence such consent;

WHEREAS, the Co-Issuers have obtained the consent of the Investment Manager and a Majority of the Subordinated Securities to the amendments set forth herein (except as set forth in Section 4(b) below) (the "Requisite Consents");

WHEREAS, the execution of this Supplemental Indenture is in accordance with Articles VIII and IX of the Indenture;

WHEREAS, the conditions set forth in Article VIII and Sections 9.2 of the Indenture have been satisfied as of the date hereof;

WHEREAS, the Redeemed Notes issued on the original Closing Date are being redeemed and the Refinancing Notes (as defined below) are being issued simultaneously with the execution of this Supplemental Indenture by the Co-Issuers and the Trustee; and

WHEREAS, this Supplemental Indenture has been duly authorized by all necessary corporate or other actions, as applicable, on the part of each of the Co-Issuers, and the Co-Issuers have obtained the Requisite Consents to the amendments set forth herein;

NOW, THEREFORE, based upon the above Recitals, the mutual premises and agreements contained herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned, intending to be legally bound, hereby agree as follows:

#### SECTION 1. Amendments to the Indenture.

- (a) As of the date hereof, the Indenture is hereby amended to delete the stricken text (indicated textually in the same manner as the following example: stricken text) and to add the bold and double-underlined text (indicated textually in the same manner as the following example: bold and double-underlined text) as set forth on the pages of the Indenture attached as Appendix A hereto:
- (b) As of the date hereof, each of Exhibits A1 through A6 to the Indenture is amended by:
- (i) replacing all references to "Class A-1 Floating Rate Notes," "Class A-2a Floating Rate Notes," "Class A-2b Fixed Rate Notes," "Class B Deferrable Floating Rate Notes," "Class C Deferrable Floating Rate Notes," "Class D Deferrable Floating Rate Notes" and "Class E Deferrable Floating Rate Notes" set forth therein with "Class A-1-R Floating Rate Notes," "Class A-2a-R Floating Rate Notes," "Class A-2b-R Floating Rate Notes," "Class B-R Deferrable Floating Rate Notes," "Class C-R Deferrable Floating Rate Notes," "Class D-R Deferrable Floating Rate Notes" and "Class E-R Deferrable Floating Rate Notes," respectively;
- (ii) replacing each CUSIP, ISIN and common code set forth therein with blank brackets ("[ ]");
- (iii) deleting each instance of "commencing in October 2013" and inserting in its place "commencing in July 2018";
- (iv) replacing the interest rate set forth in each such exhibit with the spread rate specified for the applicable Class of Refinancing Notes in Section 2.3 of the Indenture (as amended by this Supplemental Indenture);
- (v) making such additional changes as are reasonably acceptable to the Trustee and the Investment Manager in order to make such Exhibits consistent with the terms of the Refinancing Notes.

#### SECTION 2. Terms of the Refinancing Notes.

- (a) The Co-Issuers will issue the Class A-1-R Floating Rate Notes, the Class A-2a-R Floating Rate Notes, the Class A-2b-R Floating Rate Notes, the Class B-R Deferrable Floating Rate Notes, the Class C-R Deferrable Floating Rate Notes, the Class D-R Deferrable Floating Rate Notes, the Class E-R Deferrable Floating Rate Notes and the additional principal amount of the Subordinated Notes indicated in Section 2.3 of the Indenture (as amended by this Supplemental Indenture) (the "Refinancing Notes") the proceeds of which shall be used to redeem the Redeemed Notes. The Refinancing Notes shall have the designations, original principal amounts and other characteristics as set forth in Section 2.3 of the Indenture (as in effect immediately after this Supplemental Indenture).
  - (b) The Refinancing Notes shall be issuable in minimum denominations of

U.S.\$250,000 and integral multiples of U.S.\$1 in excess thereof;

- (c) The issuance date of the Refinancing Notes shall be March 29, 2018 (the "**Refinancing Effective Date**") and the Redemption Date of the Redeemed Notes shall also be March 29, 2018;
- (d) Payments on the Refinancing Notes issued on the Refinancing Effective Date will be made on each Payment Date, commencing on the Payment Date in July 2018.

# SECTION 3. <u>Refinancing Amendments; Issuance and Authentication of the Class Refinancing</u> Notes; Cancellation of the Redeemed Notes.

- (a) The Co-Issuers hereby direct the Trustee (i) to deposit in the Collection Account or Payment Account the proceeds of the Refinancing Notes received on the Refinancing Effective Date, (ii) to pay the Redemption Price of the Redeemed Notes and (iii) to pay any reasonable expenses, fees, costs, charges and expenses to be paid on the Refinancing Effective Date in accordance with the Priority of Payments.
- (b) The Refinancing Notes shall be issued as Rule 144A Global Securities and Regulation S Global Securities and shall be executed by the Co-Issuers and delivered to the Trustee for authentication and thereupon the same shall be authenticated and delivered to the Issuer by the Trustee upon Issuer Order and upon receipt by the Trustee of the following:
  - (i) Officers' Certificates of the Co-Issuers Regarding Corporate Matters. An Officer's certificate of each of the Co-Issuers (A) evidencing the authorization by Resolution of the execution of this Supplemental Indenture and the execution, authentication and delivery of the Refinancing Notes (as applicable) and specifying the Stated Maturity, principal amount and, in the case of the Secured Notes, the Interest Rate of the notes applied for by it and (B) certifying that (1) the attached copy of the Resolution is a true and complete copy thereof, (2) such resolutions have not been rescinded and are in full force and effect on and as of the date of issuance and (3) the Officers authorized to execute and deliver such documents hold the offices and have the signatures indicated thereon.
  - (ii) Officers' Certificates of Co-Issuers Regarding Indenture. An Officer's certificate of each of the Co-Issuers stating that, to the best of the signing Officer's knowledge, the relevant Co-Issuer is not in default under the Indenture and that the issuance of the Refinancing Notes will not result in a default or a breach of any of the terms, conditions or provisions of, or constitute a default under, its organizational documents, any indenture or other agreement or instrument to which it is a party or by which it is bound, or any order of any court or administrative agency entered in any Proceeding to which it is a party or by which it may be bound or to which it may be subject; that all conditions precedent provided in the Indenture and this Supplemental Indenture relating to the authentication and delivery of such notes have been complied with; and that all expenses due or accrued with respect to the offering of such notes or relating to actions taken on or in connection with the additional issuance have been paid or reserves therefor have been made. The Officer's certificate of the Issuer shall also state that all of its representations and warranties contained in the Indenture are true and correct as of the Refinancing Effective Date.
  - (iii) <u>Evidence of Required Consents</u>. Satisfactory evidence of the consent of a Majority of the Subordinated Securities to such issuance and this Supplemental Indenture.

- (iv) Officer's Certificate of the Investment Manager. An Officer's certificate of the Investment Manager dated as of the Refinancing Effective Date stating that the Refinancing to be effected by this Supplemental Indenture meets the requirements for a Refinancing specified in Section 9.2 of the Indenture.
- (v) <u>Officer's Certificate of the Issuer</u>. An Officer's certificate of the Issuer dated as of the Refinancing Effective Date as to whether the interests of any Class of Notes would be materially and adversely affected by this Supplemental Indenture.
- (vi) Rating Letters. An Officer's certificate of the Issuer to the effect that attached thereto is a true and correct copy of (x) a letter signed by Fitch confirming that the Class A-1-R Notes have been assigned a rating of at least "AAAsf" and (y) a letter signed by S&P confirming that (A) the Class A-1-R Notes have been assigned a rating of "AAA (sf)," (B) the Class A-2a-R Notes and the Class A-2b-R Notes have been assigned a rating of at least "AA (sf)," (C) the Class B-R Notes have been assigned a rating of at least "A (sf)," (D) the Class C-R Notes have been assigned a rating of at least "BB- (sf), (E) the Class D-R Notes have been assigned a rating of at least "B- (sf)."
- (vii) <u>Opinions</u>. Opinions of (i) Cadwalader, Wickersham & Taft LLP, special U.S. counsel to the Co-Issuers, (ii) Nixon Peabody LLP, counsel to the Trustee, and (iii) Maples and Calder, Cayman Islands counsel to the Issuer, in each case dated the Refinancing Effective Date and in form and substance satisfactory to the Issuer.
- (c) On the Refinancing Effective Date specified above, the Trustee, as custodian, shall cause the Redeemed Notes to be cancelled in accordance with Section 2.10 of the Indenture.
- SECTION 4. <u>Effectiveness of the Supplemental Indenture</u>. This Supplemental Indenture shall become effective on the Refinancing Effective Date and subject to satisfaction of the conditions set forth in Section 3 hereto and the consent of the Majority of the Subordinated Securities and the Investment Manager.

#### SECTION 5. Effect of Supplemental Indenture.

- (a) Upon execution of this Supplemental Indenture, the Indenture shall be, and be deemed to be, modified and amended in accordance herewith and the respective rights, limitations, obligations, duties, liabilities and immunities of the Issuer and the Co-Issuer shall hereafter be determined, exercised and enforced subject in all respects to such modifications and amendments, and all the terms and conditions of this Supplemental Indenture shall be deemed to be part of the terms and conditions of the Indenture for any and all purposes. Except as modified and expressly amended by this Supplemental Indenture, the Indenture is in all respects ratified and confirmed, and all the terms, provisions and conditions thereof shall be and remain in full force and effect.
- (b) Except as expressly modified herein, the Indenture shall continue in full force and effect in accordance with its terms. Upon issuance and authentication of the Refinancing Notes and redemption in full of the Redeemed Notes, all references in the Indenture to Notes and Securities shall apply <u>mutatis mutandis</u> to the Refinancing Notes. All references in the Indenture to the Indenture or to "this Indenture" shall apply <u>mutatis mutandis</u> to the Indenture as modified by this Supplemental Indenture. The Trustee shall be entitled to all rights, protections, immunities and indemnities set forth in the Indenture as fully as if set forth in this Supplemental Indenture.
  - (c) Notwithstanding anything herein to the contrary, this Supplemental Indenture

shall only be construed to effect the Refinancing of the Redeemed Notes and effect the changes set forth in Section 1 above, and shall not be construed to modify the provisions of the Indenture to have any other effect.

(d) The Issuer reaffirms the lien Granted on the Assets to the Trustee under the Indenture for the benefit of the Secured Parties, which lien was intended to secure the obligations of the Issuer as amended from time to time, including any refinancings thereof, and which lien shall continue in full force and effect to secure the obligations incurred by the Issuer under the Refinancing Notes. The Trustee acknowledges the continuing effect of such Grant for the benefit of the Secured Parties, including the Holders of the Refinancing Notes.

#### SECTION 6. Binding Effect.

The provisions of this Supplemental Indenture shall be binding upon and inure to the benefit of the Issuer, the Co-Issuer, the Trustee, the Investment Manager, the Collateral Administrator, the Noteholders and each of their respective successors and assigns.

#### SECTION 7. Acceptance by the Trustee.

The Trustee accepts the amendments to the Indenture as set forth in this Supplemental Indenture and agrees to perform the duties of the Trustee upon the terms and conditions set forth herein and in the Indenture set forth therein. Without limiting the generality of the foregoing, the Trustee assumes no responsibility for the correctness of the recitals contained herein, which shall be taken as the statements of the Co-Issuers and the Trustee shall not be responsible or accountable in any way whatsoever for or with respect to the validity, execution or sufficiency of this Supplemental Indenture and makes no representation with respect thereto.

## SECTION 8. Execution, Delivery and Validity.

The Co-Issuers represent and warrant to the Trustee that this Supplemental Indenture has been duly and validly executed and delivered by the Co-Issuers and constitutes their legal, valid and binding obligation, enforceable against the Co-Issuers in accordance with its terms.

#### SECTION 9. GOVERNING LAW.

THIS SUPPLEMENTAL INDENTURE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.

#### SECTION 10. Severability of Provisions.

If any one or more of the provisions or terms of this Supplemental Indenture shall be for any reason whatsoever held invalid, then such provisions or terms shall be deemed severable from the remaining provisions or terms of this Supplemental Indenture and shall in no way affect the validity or enforceability of the other provisions or terms of this Supplemental Indenture.

# SECTION 11. Section Headings.

The section headings herein are for convenience of reference only, and shall not limit or otherwise affect the meaning hereof.

#### SECTION 12. Counterparts.

This Supplemental Indenture may be executed in several counterparts, each of which shall be an original and all of which shall constitute but one and the same instrument.

# SECTION 13. <u>Limited Recourse; Non-Petition</u>.

The parties hereto agree to the provisions set forth in Sections 2.8(i) and 5.4(d) of the Indenture, and such provisions are incorporated in this Supplemental Indenture, *mutatis mutandis*.

## SECTION 14. Direction.

By their signatures hereto, the Issuer and Co-Issuer hereby direct the Trustee to execute this Supplemental Indenture.

INDENTURE, dated as of April 25, 2013, among ING IMVOYA CLO 2013-2, LTD., an exempted company incorporated with limited liability under the laws of the Cayman Islands (the "Issuer"), ING IMVOYA CLO 2013-2, LLC, a limited liability company formed under the laws of the State of Delaware (the "Co-Issuer" and, together with the Issuer, the "Co-Issuers"), and U.S. BANK NATIONAL ASSOCIATION, a national banking association, as trustee (herein, together with its permitted successors in the trusts hereunder, the "Trustee").

#### PRELIMINARY STATEMENT

The Co-Issuers are duly authorized to execute and deliver this Indenture to provide for the Notes issuable as provided in this Indenture. Except as otherwise provided herein, all covenants and agreements made by the Co-Issuers herein are for the benefit of the Holders, the Trustee, the Collateral Administrator and each Hedge Counterparty and security of the Secured Parties. The Co-Issuers are entering into this Indenture, and the Trustee is accepting the trusts created hereby, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged.

All things necessary to make this Indenture a valid agreement of the Co-Issuers in accordance with the agreement's terms have been done.

#### **GRANTING CLAUSE**

The Issuer hereby Grants to the Trustee, for the benefit and security of the Holders of the Secured Notes, the Trustee, the Collateral Administrator, the Fiscal Agent, the Administrator and each Hedge Counterparty (collectively, the "Secured Parties"), all of its right, title and interest in, to and under the following property, in each case, whether now owned or existing, or hereafter acquired or arising, and wherever located, (a) the Collateral Obligations and all payments thereon or with respect thereto, (b) each of the Accounts (subject, in the case of each Hedge Counterparty Collateral Account, to the terms of the applicable Hedge Agreement), any Eligible Investments purchased with funds on deposit therein, and all income from the investment of funds therein, (c) the equity interest in any Tax Subsidiary and all payments and rights thereunder, (d) the Issuer's right under the Investment Management Agreement as set forth in Article XV hereof, the Hedge Agreements, the Collateral Administration Agreement, the Fiscal Agency Agreement, the Registered Office Agreement and the Administration Agreement, (e) all Cash or Money delivered to the Trustee (or its bailee) for the benefit of the Secured Parties, (f) all accounts, chattel paper, deposit accounts, financial assets, general intangibles, payment intangibles, instruments, investment property, letter-of-credit rights and supporting obligations (as such terms are defined in the UCC), (g) any other property otherwise delivered to the Trustee by or on behalf of the Issuer (whether or not constituting Collateral Obligations or Eligible Investments), and (h) all proceeds (as defined in the UCC) and products, in each case, with respect to the foregoing (the assets referred to in (a) through (h) are collectively referred to as the "Assets" or "Collateral"); provided, that such Grant shall not include (i) the U.S.\$250 transaction fee paid to the Issuer in consideration of the issuance of the Securities, (ii) the funds attributable to the issuance and allotment of the Issuer's ordinary shares, (iii) the bank account in the Cayman Islands in which such funds are deposited (or any interest thereon), (iv) the membership interests of the Co-Issuer and (v) the Preferred Shares Payment Account and any

funds deposited in or credited to such account (the assets referred to in (i) through (v), collectively, the "Excepted Property").

- II. The above Grant is made in trust to secure the Secured Notes and the Issuer's obligations to the Secured Parties under this Indenture and each Hedge Agreement. Except as set forth in the Priority of Payments and Article XIII of this Indenture, the Secured Notes are secured equally and ratably without prejudice, priority or distinction between any Secured Note and any other Secured Note by reason of difference in time of issuance or otherwise, except as expressly provided in this Indenture. The above Grant is made to secure, in accordance with the priorities set forth in the Priority of Payments, (i) the payment of all amounts due on the Secured Notes in accordance with their terms, (ii) the payment of all other sums payable under this Indenture and all amounts payable under each Hedge Agreement, and (iii) compliance with the provisions of this Indenture and each Hedge Agreement, all as provided in this Indenture and each Hedge Agreement, respectively. The foregoing Grant shall, for the purpose of determining the property subject to the lien of this Indenture, be deemed to include any securities and any investments granted to the Trustee by or on behalf of the Issuer, whether or not such securities or investments satisfy the criteria set forth in the definitions of Collateral Obligation or Eligible Investments, as the case may be.
- III. The Trustee acknowledges such Grants, accepts the trusts hereunder in accordance with the provisions hereof, and agrees to perform its duties expressly stated herein in accordance with the provisions hereof.

#### **ARTICLE I**

#### **DEFINITIONS**

- Section 1.1 <u>Definitions</u>. Except as otherwise specified herein or as the context may otherwise require, the following terms have the respective meanings set forth below for all purposes of this Indenture.
- "Accountants' Certificate": A certificate of the firm or firms appointed by the Issuer pursuant to Section 10.8(a). For the avoidance of doubt, notwithstanding anything to the contrary set forth herein, no Accountants' Certificate shall be provided to or otherwise shared with any Rating Agency.
- "Account Agreement": An agreement dated as of the Closing Date among the Issuer, the Trustee and the Bank, as securities intermediary, as amended from time to time.
- "Accounts": Each of (i) the Payment Account, (ii) the Collection Account, (iii) the Ramp-Up Account, (iv) the Expense Reserve Account, (v) the Interest Reserve Account, (vi) the Custodial Account, (vii) the Unfunded Exposure Account, and (viii) the LC Reserve Account, and (ix) each Hedge Counterparty Collateral Account (if any).
- "<u>Accredited Investor</u>": Any Person that, at the time of its acquisition, purported acquisition or proposed acquisition of Securities, is an accredited investor as defined in Regulation D under the Securities Act.
  - "Act" and "Act of Holders": The respective meanings specified in Section 14.2.
- "<u>Additional Securities</u>": Any notes or preferred shares issued or permitted to be issued pursuant to <u>Section 2.4</u>.
- "Additional Securities Closing Date": The closing date for the issuance of any Additional Securities pursuant to Section 2.4 as set forth in an indenture supplemental to this Indenture pursuant to Section 8.1.
  - "Adjusted Class Break-even Default Rate": The meaning specified in Schedule 5.
  - "Adjusted Collateral Principal Amount": As of any date of determination,
  - (a) the Aggregate Principal Balance of the Collateral Obligations, excluding (i) Defaulted Obligations, (ii) Discount Obligations—and, (iii) Collateral Obligations that mature after the Stated Maturity of the Notes and (iv) Excepted Current Pay Obligations; plus
  - (b) without duplication, amounts (including Eligible Investments) on deposit (i) in the Collection Account and (ii) in the Ramp-Up Account, in each case representing Principal Proceeds; *plus*

- (c) for all Defaulted Obligations that have been Defaulted Obligations for less than three years, the lesser of (i) the S&P Collateral Value thereof and (ii) the Moody's S&P Collateral Value thereof; plus
- (d) with respect to each Discount Obligation, its Discount Obligation Principal Balance; *minus* 
  - (e) the Excess CCC/Caa Adjustment Amount; *plus*
- (f) with respect to Collateral Obligations that mature after the Stated Maturity of the Notes, 70% of the Aggregate Principal Balance of such Collateral Obligations; *plus*
- (g) with respect to each Excepted Current Pay Obligation, the S&P Recovery Amount thereof:

provided that any Collateral Obligation that would be subject to more than one of the definitions under clauses (c) through (fg) above will, for the purposes of this definition, be treated as belonging to the category of Collateral Obligations which results in the lowest Adjusted Collateral Principal Amount on any date of determination; provided, further, that with respect to any Tax Subsidiary Asset held by a Tax Subsidiary, for purposes of this definition and the calculation of any Overcollateralization Ratio, such Tax Subsidiary Asset will be treated in the same manner as if it were held directly by the Issuer. For the avoidance of doubt, (x) the value of equity warrants attached to any Collateral Obligation will not constitute part of the Principal Balance thereof for purposes of this definition and (y) the Issuer cannot purchase Collateral Obligations that mature after the Stated Maturity of the Notes.

"Administration Agreement": An agreement between the Administrator and the Issuer relating to the various corporate management functions the Administrator will perform on behalf of the Issuer, including communications with shareholders and the general public, and the provision of certain clerical, administrative and other services in the Cayman Islands, as such agreement may be amended, supplemented or varied from time to time.

"Administrative Expense Cap": An amount equal on any Payment Date (when taken together with any Administrative Expenses paid in the order of priority contained in the definition thereof during the period since the preceding Payment Date or, in the case of the first Payment Date, the Closing Date) to the sum of

- (a) (a) -0.02% per annum (prorated for the related Interest Accrual Period on the basis of a 360-day year and the actual number of days elapsed) of the Fee Basis Amount on the Determination Date relating to the immediately preceding Payment Date (or, for purposes of calculating this clause (a) in connection with the first Payment Date, on the Closing Date) and
- (b) (b)-U.S.\$200,000 per annum (prorated for the related Interest Accrual Period on the basis of a 360-day year comprised of twelve 30-day months);

- (i) (i)—if the amount of Administrative Expenses paid pursuant to Section 11.1(a)(i)(A) (including any excess applied in accordance with this proviso) on the three immediately preceding Payment Dates or during the related Collection Periods is less than the stated Administrative Expense Cap (without regard to any excess applied in accordance with this proviso) in the aggregate for such three preceding Payment Dates, the excess may be applied to the Administrative Expense Cap with respect to the then-current Payment Date;
- (ii) (ii) in respect of each of the first three Payment Dates from the Closing Date, such excess amount shall be calculated based on the Payment Dates, if any, preceding such Payment Date; and
- (iii) after giving effect to the application of such excess amount on any Payment Date pursuant to the preceding proviso, sufficient Interest Proceeds remain for the payment of accrued interest on the Class A-1 Notes and Class A-2 Notes due and payable on such Payment Date (after giving effect to any other payments required to be made on such date prior to such interest payments in accordance with the Priority of Payments).

"Administrative Expenses": The fees, expenses (including indemnities) and other amounts due or accrued with respect to any Payment Date and payable in the following order by the Issuer or the Co-Issuer:

first, to make any capital contribution to a Tax Subsidiary necessary to pay any taxes, governmental fees or registered office fees owing by such Tax Subsidiary,

*second*, to the Trustee for its fees and expenses (including indemnities) in each of its capacities pursuant hereto,

third, to the Collateral Administrator and the Fiscal Agent for its fees and expenses (including indemnities) under the Collateral Administration Agreement and the Fiscal Agency Agreement, respectively, and then

fourth, on a pro rata basis to:

- (i) (i)—the Independent accountants, agents (other than the Investment Manager) and counsel of the Issuer for fees and expenses;
- (ii) the Rating Agencies for fees and expenses (including surveillance fees) in connection with any rating of Notes or in connection with the rating of (or provision of credit estimates in respect of) any Collateral Obligations;
- (iii) (iii) the Investment Manager under this Indenture and the Investment Management Agreement, including without limitation reasonable expenses of the Investment Manager (including (x) actual fees incurred and paid

by the Investment Manager for its accountants, agents, counsel and administration and (y) out-of-pocket travel and other miscellaneous expenses incurred and paid by the Investment Manager in connection with the Investment Manager's management of the Collateral Obligations (including without limitation expenses related to the workout of Collateral Obligations), which shall be allocated among the Issuer and other clients of the Investment Manager to the extent such expenses are incurred in connection with the Investment Manager's activities on behalf of the Issuer and such other clients) actually incurred and paid in connection with the purchase or sale of any Collateral Obligations and any other expenses actually incurred and paid in connection with the Collateral Obligations pursuant to the Investment Management Agreement but excluding the Management Fees;

- (iv) the Administrator pursuant to the Administration Agreement and the Registered Office Agreement; and
- expenses permitted under this Indenture and the documents delivered pursuant to or in connection with this Indenture (including expenses incurred in connection with setting up and administering Tax Subsidiaries, the payment of facility rating fees, any FATCA Compliance Costs and all legal and other fees and expenses incurred in connection with the purchase or sale of any Collateral Obligations and any other expenses incurred in connection with the Collateral Obligations, including any Excepted Advances) and the Notes, including but not limited to, amounts owed to the Co-Issuer pursuant to Section 7.1, any amounts due in respect of the listing of the Securities on any stock exchange or trading system, any costs associated with producing Certificated Securities;

# provided that

- (x) amounts due in respect of actions taken on or before the Closing Date shall not be payable as Administrative Expenses but shall be payable only from the Expense Reserve Account pursuant to Section 10.3(d),
- (y) amounts that are specified as payable under the Priority of Payments that are not specifically identified therein as Administrative Expenses (including, without limitation, interest and principal in respect of the Notes and amounts owing to Hedge Counterparties) shall not constitute Administrative Expenses and
- (z) the Investment Manager may direct the payment of Rating Agency fees (only out of amounts available pursuant to clause (b) of the definition of Administrative Expense Cap) other than in the order required above, if, in the Investment Manager's commercially reasonable judgment such payments are necessary to avoid the withdrawal of any currently assigned rating on any Outstanding Class of Secured Notes.

"Administrator": MaplesFS Limited.

"Affiliate" or "Affiliated": With respect to a Person, (a) any other Person who, directly or indirectly, is in control of, or controlled by, or is under common control with, such Person or (b) any other Person who is a director, officer or employee (i) of such Person, (ii) of any subsidiary or parent company of such Person or (iii) of any Person described in clause (a) above; provided that neither the Administrator nor any special purpose entity for which it acts as share trustee or administrator shall be deemed to be an Affiliate of the Issuer or the Co-Issuer solely because the Administrator or any of its Affiliates serves as administrator or share trustee for the Issuer or the Co-Issuer. For the purposes of this definition, control of a Person shall mean the power, direct or indirect, (x) to vote more than 50% of the securities having ordinary voting power for the election of directors of any such Person or (y) to direct or cause the direction of the management and policies of such Person whether by contract or otherwise; provided that no special purpose company to which the Investment Manager provides investment advisory services shall be considered an Affiliate of the Investment Manager; provided, further, that no entity to which the Administrator provides shares trustee and/or administration services, including the provision of directors, will be considered to be an Affiliate of the Issuer solely by reason thereof.

"Agent Members": Members of, or participants in, DTC, Euroclear or Clearstream.

"Aggregate Outstanding Amount": With respect to any of the (i) Notes as of any date, the aggregate principal amount of such Notes Outstanding on such date and (ii) Preferred Shares, the notional amount represented by such Outstanding Preferred Shares, assuming a notional amount of \$1,000 per share.

"Aggregate Principal Balance": When used with respect to all or a portion of the Collateral Obligations or the Pledged Obligations, the sum of the Principal Balances of all or of such portion of the Collateral Obligations or Pledged Obligations, respectively.

"Aggregate Ramp-Up Par Amount": An amount equal to U.S.\$-450,000,000.447,000,000.

"Aggregate Ramp-Up Par Condition": A condition satisfied as of the Refinancing Effective Date if the Issuer has purchased, or entered into binding commitments to purchase, Collateral Obligations, including Collateral Obligations acquired by the Issuer on or prior to the Closing Amendment Date together with Eligible Investments constituting Principal Proceeds (other than (i) Principal Proceeds in the Ramp-Up Account or the Collection Account that have been or will be designated as Interest Proceeds after the Refinancing Effective Date and on or prior to the first Determination Date after the Amendment Date and (ii) Principal Proceeds needed to settle binding commitments to purchase Collateral Obligations), having an Aggregate Principal Balance that in the aggregate equals or exceeds the Aggregate Ramp-Up Par Amount, without regard totaking into account prepayments, maturities, or redemptions or sales; provided that (i) the Principal Balance of any Defaulted Obligation shall be the lower of its S&P Collateral Value and its Moody's Collateral Value(ii) the amount of Eligible Investments constituting Principal Proceeds included in determining whether the Aggregate Ramp-Up Par Condition is satisfied must not exceed 10% of the Aggregate Ramp-Up Par Amount.

"AI/QP": Any Person that, at the time of its acquisition, purported acquisition or proposed acquisition of Securities is both an Accredited Investor and a Qualified Purchaser.

"Applicable Advance Rate": For each Collateral Obligation and for the applicable number of Business Days between the certification date for a sale or participation connection with a Redemption by Liquidation and the expected date of such sale or participation, the percentage specified below: Amendment Date": March 29, 2018.

"Amendment Date Certificate": Any certificate of an Officer of the Issuer delivered pursuant to the supplemental indenture entered into by the Co-Issuers and the Trustee on the Amendment Date.

"Asset Quality Matrix Combination": The applicable row/column combination of the Asset Quality Matrix chosen by the Investment Manager with notice to the Collateral Administrator (or the linear interpolation between two adjacent rows and/or two adjacent columns, as applicable) in accordance with this Indenture.

"Assets": The meaning specified in Granting Clause I.

"Assigned Moody's Rating": The monitored publicly available rating or the estimated rating expressly assigned to a debt obligation (or facility) by Moody's that addresses the full amount of the principal and interest promised.

"Assumed Reinvestment Rate": The then-current rate of interest being paid by the Bank on time deposits in the Bank having a scheduled maturity of the date prior to the next Payment Date (as determined on the most recent Interest Determination Date relating to an Interest Accrual Period beginning on a Payment Date or the Closing Date, as applicable).

"<u>Authenticating Agent</u>": With respect to the Notes, the Person designated by the Trustee to authenticate such Notes on behalf of the Trustee pursuant to <u>Section 6.14</u>.

"Authorized Officer": With respect to the Issuer or the Co-Issuer, any Officer or any other Person who is authorized to act for the Issuer or the Co-Issuer, as applicable, in matters relating to, and binding upon, the Issuer or the Co-Issuer. With respect to the Investment Manager, any Officer, employee, member or agent of the Investment Manager who is authorized to act for the Investment Manager in matters relating to, and binding upon, the Investment Manager with respect to the subject matter of the request, certificate or order in question. With respect to the Collateral Administrator, any Officer, employee or agent of the Collateral Administrator who is authorized to act for the Collateral Administrator in matters relating to, and binding upon, the Collateral Administrator with respect to the subject matter of the request or certificate in question. With respect to the Trustee or any other bank or trust company acting as trustee of an express trust or as custodian, a Trust Officer. Each party may receive and accept a certification of the authority of any other party as conclusive evidence of the authority of any person to act, and such certification may be considered as in full force and effect until receipt by such other party of written notice to the contrary.

"Average Life": On any date of determination with respect to any Collateral Obligation, the quotient obtained by dividing (i) the sum of the products of (a) the number of years (rounded to the nearest one hundredth thereof) from such date of determination to the respective dates of each successive Scheduled Distribution of principal of such Collateral Obligation and (b) the respective amounts of principal of such Scheduled Distributions by (ii) the sum of all successive Scheduled Distributions of principal on such Collateral Obligation.

"Balance": On any date, with respect to Cash or Eligible Investments in any account, the aggregate (i) current balance of Cash, demand deposits, time deposits, certificates of deposit and federal funds; (ii) principal amount of interest-bearing corporate and government securities, money market accounts and repurchase obligations; and (iii) purchase price (but not greater than the face amount) of non-interest-bearing government and corporate securities and commercial paper.

"<u>Bank</u>": U.S. Bank National Association, a national banking association (including any organization or entity succeeding to all or substantially all of its corporate trust business), in its individual capacity and not as Trustee, and any successor thereto.

# "Bankruptcy Event": Either:

- (a) (a) the entry of a decree or order by a court having competent jurisdiction adjudging the Issuer or the Co-Issuer as bankrupt or insolvent, or approving as properly filed a petition seeking reorganization, arrangement, adjustment or composition of or in respect of the Issuer or the Co-Issuer under the Bankruptcy Law or any other applicable law, or appointing a receiver, liquidator, assignee, or sequestrator (or other similar official) of the Issuer or the Co-Issuer or of any substantial part of its property, respectively, or ordering the winding up or liquidation of its affairs, and the continuance of any such decree or order unstayed and in effect for a period of 60 consecutive days; or
- (b) the institution by the shareholders of the Issuer or the Co-Issuer of proceedings to have the Issuer or Co-Issuer, as the case may be, adjudicated as bankrupt

or insolvent, or the consent by the shareholders of the Issuer or the Co-Issuer to the institution of bankruptcy or insolvency proceedings against the Issuer or Co-Issuer, or the filing by the Issuer or the Co-Issuer of a petition or answer or consent seeking reorganization or relief under the Bankruptcy Law or any other similar applicable law, or the consent by the Issuer or the Co-Issuer to the filing of any such petition or to the appointment in a proceeding of a receiver, liquidator, assignee, trustee or sequestrator (or other similar official) of the Issuer or the Co-Issuer or of any substantial part of its property, respectively, or the making by the Issuer or the Co-Issuer in writing of its inability to pay its debts generally as they become due, or the taking of any action by the Issuer or the Co-Issuer in furtherance of any such action.

"Bankruptcy Exchange": The exchange of a Defaulted Obligation (without the payment of any additional funds other than reasonable and customary transfer costs) for another debt obligation issued by another obligor which, but for the fact that such debt obligation does not satisfy the criteria identified in clause (iii), (x), (xii) or (xx) of the definition of "Collateral Obligation," would otherwise qualify as a Collateral Obligation, if (i) in the Investment Manager's reasonable business judgment, at the time of the exchange, such debt obligation received on exchange has a better likelihood of recovery than the Defaulted Obligation to be exchanged, (ii) as determined by the Investment Manager, at the time of the exchange, the debt obligation received on exchange is no less senior in right of payment vis-à-vis such obligor's other outstanding indebtedness than the Defaulted Obligation to be exchanged vis-à-vis its obligor's other outstanding indebtedness, (iii) as determined by the Investment Manager, both prior to and after giving effect to such exchange, each of the Coverage Tests is satisfied or, if any Coverage Test was not satisfied prior to such exchange, the coverage ratio relating to such test will be at least as close to being satisfied after giving effect to such exchange as it was before giving effect to such exchange, (iv) as determined by the Investment Manager, after giving effect to such exchange, the Aggregate Principal Balance of obligations received in a Bankruptcy Exchange since the Amendment Date does not exceed 10% of the Aggregate Ramp-Up Par Amount, (v) the period for which the Issuer held the Defaulted Obligation to be exchanged will be included for all purposes in the Indenture when determining the period for which the Issuer holds the debt obligation received on exchange, (vi) the obligation received on exchange may not (x) be a Long-Dated Obligation unless, after giving effect to such exchange, the Aggregate Principal Balance of all Long-Dated Obligations held by the Issuer will not exceed 2.5% of the Collateral Principal Amount and (y) have an Underlying Asset Maturity later than two years after the Stated Maturity of the Notes, (vii) with respect to each such transaction after the third Bankruptcy Exchange, the Bankruptcy Exchange Test is satisfied and (viii) such exchanged Defaulted Obligation was not acquired in a Bankruptcy Exchange.

"Bankruptcy Exchange Test": A test that is satisfied if, in the Investment Manager's reasonable business judgment, the projected internal rate of return of the obligation obtained as a result of a Bankruptcy Exchange is greater than the projected internal rate of return of the Defaulted Obligation exchanged in such Bankruptcy Exchange, calculated by the Investment Manager by aggregating all cash and the market value of any Collateral Obligation subject to such Bankruptcy Exchange at the time of such Bankruptcy Exchange.

"Bankruptcy Law": The federal Bankruptcy Code, Title 11 of the United States Code, as amended from time to time, Part V of the Companies Law (20122018 Revision) of the Cayman Islands, as amended from time to time, the Bankruptcy Law (1997 Revision) of the Cayman Islands, as amended from time to time, and the Foreign Bankruptcy Proceedings (International Cooperation) Rules 2008, 2018 of the Cayman Islands, as amended from time to time.

"Benefit Plan Investor": (a) Any "employee benefit plan" (as defined in Section 3(3) of Title I of ERISA) that is subject to the fiduciary responsibility provisions of Title I of ERISA, (b) any "plan" as defined in Section 4975(e) of the Code that is subject to Section 4975 of the Code, or (c) any entity whose underlying assets include "plan assets" (within the meaning of 29 C.F.R. §2510.3-101 as modified by Section 3(42) of ERISA) by reason of any such employee benefit plan's or plan's investment in the entity, or otherwise (an entity described in clause (c), a "Plan Asset Entity").

"Bridge Loan": Any obligation or debt securityloan incurred or issued in connection with a merger, acquisition, consolidation, sale of all or substantially all of the assets of a person or entity, restructuring or similar transaction, which obligation or securityloan by its terms is required to be repaid within one year of the incurrence thereof with proceeds from additional borrowings or other refinancings (other than any additional borrowing or refinancing if one or more financial institutions has provided the issuer of such obligation or security with a binding written commitment to provide the same, so long as (i) such commitment is equal to the outstanding principal amount of the Bridge Loan and (ii) such committed replacement facility has a maturity of at least one year and cannot be extended beyond such one year maturity pursuant to the terms thereof).

"Business Day": Any day other than (i) a Saturday or a Sunday or (ii) a day on which commercial banks are authorized or required by applicable law, regulation or executive order to close in New York, New York or in the city in which the principal Corporate Trust Office of the Trustee is located or, for any final payment of principal, in the relevant place of presentation. Except as otherwise expressly provided herein, any reference in this Indenture to a date that is not a Business Day shall be deemed to refer to the next succeeding Business Day.

"<u>Caa Collateral Obligation</u>": A Collateral Obligation (other than a Defaulted Obligation) with a Moody's Rating of "Caa1" or lower.

"Calculation Agent": The meaning specified in Section 7.15.

"Cash": Such coin or currency of the United States of America as at the time shall be legal tender for payment of all public and private debts.

"<u>CCC Collateral Obligation</u>": A Collateral Obligation (other than a Defaulted Obligation) with an S&P Rating of "CCC+" or lower.

"CCC/Caa Excess": The excess, if any, of (x) the greater of (i) the Aggregate:

- (a) the amount equal to the excess of the Principal Balance of all-Collateral Obligations that are Caa Collateral Obligations or (ii) the Aggregate over an amount equal to 7.5% of the Collateral Principal Amount as of the current Determination Date; and
- (b) the amount equal to the excess of the Principal Balance of all-Collateral Obligations that are CCC Collateral Obligations, over (y)an amount equal to 7.5% of the Collateral Principal Amount as of the current Determination Date;

"Certificate of Authentication": The meaning specified in Section 2.1.

"Certificated Security": Any Security issued in the form of a definitive, fully registered security without coupons registered in the name of the owner or nominee thereof (including, in the case of a transfer or exchange the context requires, Preferred Shares).

"Class": In the case of (a) the Secured Notes, all of the Secured Notes having the same Interest Rate, Stated Maturity and designation, (b) the Subordinated Notes, all of the Subordinated Notes and (c) the Preferred Shares, all of the Preferred Shares. For the purpose of exercising any rights to consent, give direction or otherwise vote, Class A Notes will be treated as a single Class, except as expressly provided herein, and the Subordinated Securities will vote as a single class.

"Class A Coverage Tests": The Overcollateralization Ratio Test and the Interest Coverage Test, each as applied with respect to the Class A Notes.

"Class A Notes": The Class A-1 Notes and the Class A-2 Notes.

"Class A-1 Notes": The Class A-1\_R Floating Rate Notes issued pursuant to this Indenture and having the characteristics specified in Section 2.3.

"Class A-2 Notes": The Class A-2a Notes and the Class A-2b Notes.

"Class A-2a Notes": The Class A-2a-R Floating Rate Notes issued pursuant to this Indenture and having the characteristics specified in Section 2.3.

"Class A-2b Notes": The Class A-2b—Fixed\_R Floating Rate Notes issued pursuant to this Indenture and having the characteristics specified in Section 2.3.

"Class B Coverage Tests": The Overcollateralization Ratio Test and the Interest Coverage Test, each as applied with respect to the Class B Notes.

"Class B Notes": The Class B\_R Deferrable Floating Rate Notes issued pursuant to this Indenture and having the characteristics specified in Section 2.3.

"Class Break-even Default Rate": With respect to each Class of Secured Notes, the maximum percentage of defaults, as determined at any time through application of the S&P CDO Monitor that is applicable to the portfolio of Collateral Obligations, that the Current Portfolio or the Proposed Portfolio, as applicable, can sustain, which, after giving effect to assumptions on recoveries, defaults and timing and to the Priority of Payments, will result in sufficient funds remaining for the payment of such Class or Classes of Notes in full. The meaning specified in Schedule 5.

Upon request from the Investment Manager, S&P will provide the Investment Manager with the Class Break-even Default Rates for each S&P CDO Monitor determined by the Investment Manager (with notice to the Collateral Administrator) pursuant to the definition thereof and Section 7.17(f).

"Class C Coverage Tests": The Overcollateralization Ratio Test and the Interest Coverage Test, each as applied with respect to the Class C Notes.

"Class C Notes": The Class C-R Deferrable Floating Rate Notes issued pursuant to this Indenture and having the characteristics specified in Section 2.3.

"Class D Coverage Tests": The Overcollateralization Ratio Test and the Interest Coverage Test, each as applied with respect to the Class D Notes.

"Class D Notes": The Class D-R Deferrable Floating Rate Notes issued pursuant to this Indenture and having the characteristics specified in Section 2.3.

"Class Default Differential": With respect to each Class of Secured Notes, at any time, the rate calculated by subtracting the Class Scenario Default Rate for such Class or Classes of Notes at such time from the Class Break even Default Rate for such Class or Classes of Notes at such time. The meaning specified in Schedule 5.

"<u>Class E Coverage Test</u>": The Overcollateralization Ratio Test, as applied with respect to the Class E Notes.

"Class E Notes": The Class E-R Deferrable Floating Rate Notes issued pursuant to this Indenture and having the characteristics specified in Section 2.3.

"Class Scenario Default Rate": With respect to each Class of Secured Notes, at any time, an estimate of the cumulative default rate for the Current Portfolio or the Proposed Portfolio, as applicable, consistent with S&P's Initial Rating of such Class or Classes of Notes, determined by application by the Investment Manager and the Collateral Administrator of the S&P CDO Monitor at such time. The meaning specified in Schedule 5.

"Clean-Up Call Redemption": The meaning specified in Section 9.10(a).

"Clean-Up Call Redemption Price": The meaning specified in Section 9.10(b).

"Clearing Agency": An organization registered as a "clearing agency" pursuant to Section 17A of the Exchange Act.

"Clearing Corporation": Each of (i) Clearstream, (ii) DTC, (iii) Euroclear and (iv) any entity included within the meaning of "clearing corporation" under Section 8-102(a)(5) of the UCC.

"Clearing Corporation Security": Securities which are in the custody of or maintained on the books of a Clearing Corporation or a nominee subject to the control of a Clearing Corporation and, if they are "certificated securities" (as defined in Article 8 of the UCC) in registered form, properly endorsed to or registered in the name of the Clearing Corporation or such nominee.

"Clearstream": Clearstream Banking, *société anonymé*, a corporation organized under the laws of the Duchy of Luxembourg.

"Closing Date": April 25, 2013.

"Closing Date Certificate": Any certificate of an Officer of the Issuer delivered under Section 3.1.

"Code": The United States Internal Revenue Code of 1986, as amended from time to time.

"<u>Co-Issued Securities</u>": The Secured Notes for which the Issuer and the Co-Issuer are the Applicable Issuers.

"Co-Issuer": ING-IMVoya CLO 2013-2, LLC, until a successor Person shall have become the Co-Issuer pursuant to the applicable provisions of this Indenture, and thereafter "Co-Issuer" shall mean such successor Person.

"Co-Issuers": The Issuer and the Co-Issuer.

"Collateral": The meaning specified in Granting Clause I.

"Collateral Administration Agreement": An agreement dated as of the Closing Date among the Issuer, the Investment Manager and the Collateral Administrator, as amended from time to time.

"Collateral Administrator": The Bank, in its capacity as such under the Collateral Administration Agreement, and any successor thereto.

"Collateral Interest Amount": As of any date of determination, without duplication, the aggregate amount of Interest Proceeds that has been received or that is expected

to be received in Cash (other than Interest Proceeds expected to be received from Defaulted Obligations, but including Interest Proceeds actually received from Defaulted Obligations (in accordance with the definition of Interest Proceeds), in each case during the Collection Period (and, if such Collection Period does not end on a Business Day, the next succeeding Business Day) in which such date of determination occurs (or after such Collection Period but on or prior to the related Payment Date if such Interest Proceeds would be treated as Interest Proceeds with respect to such Collection Period).

- (xv) does not have an "f," "r," "p," "pi," "q," "sf" or "t" subscript assigned by S&P; is purchased at a price at least equal to 50% of its principal balance;
- (xvi) will not require the Issuer, the Co-Issuer or the pool of collateral to be registered as an investment company under the Investment Company Act;
- (xvii) is not subject to a tender offer, voluntary redemption, exchange offer, conversion or other similar action for a price less than its purchase price *plus* all accrued and unpaid interest;
- (xviii) is issued by a Non-Emerging Market Obligor that is not Domiciled in a Group IV Country or Spain and if Domiciled in Ireland, the country in which a substantial portion of its operations is located or from which a substantial portion of its revenue is derived (directly or through subsidiaries) is not Ireland;
- (xix) is not a Zero-Coupon Security, a Step-Up Obligation or a Step-Down Obligation;
- (xx) does not mature after the Stated Maturity of the Notes; include an attached warrant or similar interest;

"Cov-Lite Loan": A loan that: (a) does not contain any financial covenants; or (b) requires the underlying obligor to comply with one or more Incurrence Covenants, but Senior Secured Loan that is part of a credit facility which facility does not require the underlying obligor to comply with a Maintenance Covenant any financial maintenance covenant (including a financial maintenance covenant that applies only upon the funding of any portion of such credit facility); provided that, for all purposes other than the determination of the determining an S&P Recovery Rate for such loan, a loan described in clause (a) or (b) above which, any such Senior Secured Loan which (as of the date of its acquisition) either contains a cross-default (or cross-acceleration) provision to, or is pari passu with, another loan of the underlying obligor-forming part of the same loan facility that requires the underlying obligor to comply with both an Incurrence Covenant and a Maintenance Covenant shall be deemed not to financial maintenance covenant (including a financial maintenance covenant that applies only upon the funding of any portion of such credit facility) will not be a Cov-Lite Loan.

"Coverage Tests": The Class A Coverage Tests, the Class B Coverage Tests, the Class C Coverage Tests, the Class D Coverage Tests and the Class E Coverage Test.

"Credit Improved Obligation": (a)(a) So long as a Restricted Trading Period is not in effect, any Collateral Obligation that in the Investment Manager's commercially reasonable business judgment has significantly improved in credit quality from the condition of its credit at the time of purchase which judgment may (but need not) be based on one or more of the following facts:

- (i) (i) it has a market price that is greater than the price that is warranted by its terms and credit characteristics, or improved in credit quality since its acquisition by the Issuer;
- (ii) (ii) the issuer of such Collateral Obligation has shown improved financial results since the published financial reports first produced after it was purchased by the Issuer;
- (iii) the obligor of such Collateral Obligation since the date on which such Collateral Obligation was purchased by the Issuer has raised significant equity capital or has raised other capital that has improved the liquidity or credit standing of such obligor; or
- (iv) with respect to which one or more of the following criteria applies:
  - (A) such Collateral Obligation has been upgraded or put on a watch list for possible upgrade by either of the Rating Agencies S&P. Fitch or Moody's since the date on which such Collateral Obligation was acquired by the Issuer;
  - (B) if such Collateral Obligation is a loan or a bond, the Disposition Proceeds (excluding Disposition Proceeds that constitute Interest Proceeds) of such loan or bond would be at least 101% of its purchase price;
  - (C) if such Collateral Obligation is a loan, the price of such loan has changed during the period from the date on which it was acquired by the Issuer to the proposed sale date by a percentage either at least 0.25% more positive, or 0.25% less negative, as the case may be, than the percentage change in the average price of the applicable Eligible Loan Index over the same period;
- (D) if such Collateral Obligation is a floating rate note, the price of such note changed during the period from the date on which it was acquired by the Issuer to the date of determination by a percentage either at least 0.50% more positive, or at least 0.50% less negative, as the case may be, than the percentage change in the average price of the applicable Eligible Loan Index over the same period;

- (E) if such Collateral Obligation is a bond, the price of such bond has changed during the period from the date on which it was acquired by the Issuer to the proposed sale date by a percentage either at least 1.0% more positive or at least 1.0% less negative than the percentage change in the Eligible Bond Index over the same period;
  - (D) (F) if such Collateral Obligation is a loan, the spread over the applicable reference rate for such Collateral Obligation has been decreased in accordance with the underlying Collateral Obligation since the date of acquisition by (1) 0.25% or more (in the case of a loan with a spread (prior to such decrease) less than or equal to 2.00%), (2) 0.375% or more (in the case of a loan with a spread (prior to such decrease) greater than 2.00% but less than or equal to 4.00%) or (3) 0.50% or more (in the case of a loan with a spread (prior to such decrease) greater than 4.00%) due, in each case, to an improvement in the related borrower's financial ratios or financial results; or
  - (E) (G)—with respect to fixed-rate Collateral Obligations, there has been a decrease in the difference between its yield compared to the yield on the relevant United States Treasury security of more than 7.5% since the date of purchase; or (h)
  - it has a projected cash flow interest coverage ratio (earnings before interest and taxes divided by cash interest expense as estimated by the Investment Manager) of the underlying borrower or other obligor of such Collateral Obligation that is expected to be more than 1.15 times the current year's projected cash flow interest coverage ratio; or
- (b) if a Restricted Trading Period is in effect, any Collateral Obligation:
  - (i) that in the Investment Manager's commercially reasonable business judgment has significantly improved in credit quality from the condition of its credit at the time of purchase and with respect to which one or more of the criteria referred to in clause (a)(iv) above applies; or
  - (ii) with respect to which a Majority of the Controlling Class vote to treat such Collateral Obligation as a Credit Improved Obligation.
- "Credit Risk Obligation": (a)(a) So long as a Restricted Trading Period is not in effect, any Collateral Obligation that in the Investment Manager's commercially reasonable business judgment has a significant risk of declining in credit quality or market value, or (b) if a Restricted Trading Period is in effect:
  - (i) (i)—any Collateral Obligation as to which one or more of the following criteria applies:

- (A) such Collateral Obligation has been downgraded or put on a watch list for possible downgrade by either of the Rating-Agencies S&P, Fitch or Moody's since the date on which such Collateral Obligation was acquired by the Issuer;
- (B) if such Collateral Obligation is a loan, the price of such loan has changed during the period from the date on which it was acquired by the Issuer to the proposed sale date by a percentage either at least 0.25% more negative, or at least 0.25% less positive, as the case may be, than the percentage change in the average price of an Eligible Loan Index:
- (C) if such Collateral Obligation is a loan or bond, the Market Value of such Collateral Obligation has decreased by at least 1.00% of the price paid by the Issuer for such Collateral Obligation;
- (D)—if such Collateral Obligation is a bond, the price of such bond has changed during the period from the date on which it was acquired by the Issuer to the proposed sale date by a percentage either at least 1.0% more negative or at least 1.0% less positive than the percentage change in the Eligible Bond Index over the same period; or
  - (D) (E) if such Collateral Obligation is a loan or floating rate note, (A) the spread over the applicable reference rate for such Collateral Obligation has been increased in accordance with the underlying Collateral Obligation since the date of acquisition by (1) 0.25% or more (in the case of a loan with a spread (prior to such increase) less than or equal to 2.00%), (2) 0.375% or more (in the case of a loan with a spread (prior to such increase) greater than 2.00% but less than or equal to 4.00%) or (3) 0.50% or more (in the case of a loan with a spread (prior to such increase) greater than 4.00%) due, in each case, to a deterioration in the related borrower's financial ratios or financial results;
  - (E) (F)—such Collateral Obligation has a projected cash flow interest coverage ratio (earnings before interest and taxes divided by cash interest expense as estimated by the Investment Manager) of the underlying borrower or other obligor of such Collateral Obligation of less than 1.00 or that is expected to be less than 0.85 times the current year's projected cash flow interest coverage ratio; or
  - (G) with respect to fixed-rate Collateral Obligations, an increase since the date of purchase of more than 7.5% in the difference between the yield on such Collateral Obligation and the yield on the relevant United States Treasury security; or
- (ii) with respect to which a Majority of the Controlling Class consents to treat such Collateral Obligation as a Credit Risk Obligation.

"Credit Suisse": Credit Suisse Securities (USA) LLC.

"<u>Current Pay Obligation</u>": Any Collateral Obligation (other than a DIP Collateral Obligation) that

- (i) would otherwise be a Defaulted Obligation but for the exclusion of Current Pay Obligations from the definition of Defaulted Obligation pursuant to the proviso at the end of such definition;
- (ii) (ii) (A)(1) if the issuer of such Collateral Obligation is subject to a bankruptcy proceeding, the relevant court has authorized the issuer to make payments of principal, interest or commitment fees on such Collateral Obligation and no such payments that are due and payable are unpaid and (2) otherwise, no other payments authorized by such relevant court are due and payable and are unpaid and (B) is not past due with respect to any payments of principal, interest or commitment fees and for which the Investment Manager reasonably believes all such amounts will continue to be current as they become contractually due; and has a Market Value of at least 80% of its par value;
- (iii) satisfies the S&P Additional Current Pay Criteria; and
- (v) for so long as Moody's is a Rating Agency in respect of any Class of Secured-Notes, such Collateral Obligation has a facility rating from Moody's of either (A) at least "Caa1" (and if "Caa1," not on watch for downgrade) and its Market Value is at least 80% of its par value or (B) at least "Caa2" (and if "Caa2," not on watch for downgrade) and its Market Value is at least 85% of its par value (provided that for purposes of this definition, with respect to a Collateral Obligation already owned by the Issuer whose facility rating from Moody's is withdrawn after the Issuer's acquisition thereof, the facility rating shall be the last outstanding facility rating before the withdrawal);

provided, however, that to the extent the Principal Balance of all Collateral Obligations that would otherwise be Current Pay Obligations exceeds 7.5% in Aggregate 2.5% of the Collateral Principal Balance of the Current Portfolio Amount, such excess over 7.52.5% will constitute Defaulted Obligations; provided, further, that in determining which of the Collateral Obligations will be included in such excess, the Collateral Obligations with the lowest Market Value expressed as a percentage will be deemed to constitute such excess; provided, further, that each such Collateral Obligation included in such excess will be treated as a Defaulted Obligation for all purposes until such time as the Aggregate Principal Balance of Collateral Obligations that would otherwise be Current Pay Obligations would not exceed, on a pro forma basis including such Defaulted Obligation, 7.5% in Aggregate 2.5% of the Collateral Principal Balance of the Current Portfolio Amount.

"<u>Current Portfolio</u>": At any time, the portfolio of Collateral Obligations and Eligible Investments representing Principal Proceeds (determined in accordance with <u>Section 1.2</u> to the extent applicable), then held by the Issuer.

"Custodial Account": The account established pursuant to Section 10.3(b).

"<u>Default</u>": Any Event of Default or any occurrence that is, or with notice or the lapse of time or both would become, an Event of Default.

"Default Rate Dispersion": The meaning specified in Schedule 5.

"<u>Defaulted Obligation</u>": Any Collateral Obligation included in the Assets as to which:

- (a) a default as to the payment of principal and/or interest has occurred and is continuing with respect to such debt obligation (without regard to any grace period applicable thereto, or waiver thereof, after the passage (in the case of a default that in the Investment Manager's judgment, as certified to the Trustee in writing, is not due to credit-related causes) of a three-five Business Day grace period Days or seven calendar days, whichever is greater);
- (b) a default as to the payment of principal and/or interest has occurred and is continuing on another debt obligation of the same issuer which is senior or *pari passu* in right of payment to such debt obligation (<u>provided</u> that both debt obligations are full recourse obligations) after the passage of five Business Days or seven calendar days, whichever is greater;
- (c) the issuer or others have instituted proceedings to have the issuer adjudicated as bankrupt or insolvent or placed into receivership and such proceedings have not been stayed or dismissed within 90 days or such issuer has filed for protection under Chapter 11 of the United States Bankruptcy Code;
- (d) such Collateral Obligation has (x)a Fitch Rating of "D" or "RD" prior to any downward adjustment pursuant to the definition of Fitch Rating, the obligor of such Collateral Obligation has an S&P Rating of "CC" or below, (y) an S&P Rating of "D" or," "SD" or (z) an"D" or lower or the obligor withof such Collateral Obligation has a Moody's probability of default rating (as published by Moody's) of "D" or "LD" or, in each case, had such ratings before they were withdrawn by Fitch, S&P or Moody's, as applicable;
- (e) such Collateral Obligation is *pari passu* or junior in right of payment as to the payment of principal and/or interest to another debt obligation of the same issuer which has (i)(x) an S&P Rating of "CC" or below or subordinated to other indebtedness for borrowed money owing by the issuer thereof (i) which has a Fitch Rating of "D" or "RD" prior to any downward adjustment pursuant to the definition of Fitch Rating or (ii) the obligor of which has an S&P Rating of "CC," "SD" or "D" or (y) an S&P Rating of "SD", lower or had such rating before such rating it was withdrawn, by S&P or (iiii) anthe obligor withof which has a Moody's probability of default rating (as published by Moody's) of "D" or "LD", and in each case such other debt obligation remains outstanding (provided that both the Collateral Obligation and such other debt obligation are full recourse obligations of the applicable issuer);

- (f) the Investment Manager has received written notice or has knowledge that a default has occurred under the Underlying Instruments and any applicable grace period has expired such that the holders of such Collateral Obligation <a href="mayaeceleratehave">may aeceleratehave</a> accelerated the repayment of such Collateral Obligation (but only until such default is cured or waived) in the manner provided in the Underlying Instruments;
- (g) the Investment Manager has in its reasonable commercial judgment otherwise declared such debt obligation to be a Defaulted Obligation;
- (h) such Collateral Obligation is a Participation Interest with respect to which the Selling Institution has defaulted in the performance of any of its payment obligations under the Participation Interest (except to the extent such defaults were cured within the applicable grace period under the Underlying Instruments of the obligor thereof);
- (i) such Collateral Obligation is a Participation Interest in a loan that would, if such loan were a Collateral Obligation, constitute a "Defaulted Obligation" (other than under this clause (i)) or with respect to which the Selling Institution has (x) an S&P Rating of "CC" or below, "D" or "SD" or "D" or "D" or lower or "CC" or lower or had such ratings before such ratings were withdrawn, (y) a Fitch Rating of "D" or "RD" prior to any downward adjustment pursuant to the definition of Fitch Rating or had such rating before such rating was withdrawn or (z) a Moody's probability of default rating (as published by Moody's) of "D" or "LD" or had such rating before such rating was withdrawn:
- (j) a Distressed Exchange has occurred in connection with such Collateral Obligation;  $\overline{\mathbf{or}}$
- (k) such Collateral Obligation is a Deferring Security;

<u>provided</u> that a Collateral Obligation shall not constitute a Defaulted Obligation pursuant to clauses (a) through (f) and (j) above if: (x) in the case of clauses (a), (b), (c), (d), (e) and (j), such Collateral Obligation is a Current Pay Obligation or (y) in the case of clauses (b), (c) and (e), such Collateral Obligation is a DIP Collateral Obligation.

"<u>Deferrable Security</u>": A Collateral Obligation (other than a Partial Deferring Security) which by its terms permits the deferral or capitalization of payment of accrued, unpaid interest.

"<u>Deferred Interest</u>": With respect to any specified Class of Deferred Interest Notes, the meaning specified in <u>Section 2.8(a)</u>.

"<u>Deferred Interest Notes</u>": The Notes specified as such in <u>Section 2.3</u>.

"<u>Deferred Management Fees</u>": Collectively, the Deferred Senior Fee and the Deferred Subordinated Fee.

"<u>Deferred Senior Fee</u>": Any Senior Investment Management Fee (i) deferred by the Investment Manager pursuant to <u>Section 11.1(f)</u> and the Investment Management Agreement

or (ii) not paid because funds are not available in accordance with the Priority of Payments on a Payment Date.

"<u>Deferred Subordinated Fee</u>": Any Subordinated Investment Management Fee (i) deferred by the Investment Manager pursuant to <u>Section 11.1(f)</u> and the Investment Management Agreement or (ii) not paid because funds are not available in accordance with the Priority of Payments on a Payment Date.

"Deferring Security": A Deferrable Security that is deferring the payment of interest due thereon and has been so deferring the payment of interest due thereon (a) with respect to Collateral Obligations that have a Moody's Rating of at least "Baa3," for the shorter of two consecutive accrual periods or one year, and (b) with respect to Collateral Obligations that have a Moody's Rating of "Ba1" or below, for the shorter of one accrual period or six consecutive months, which deferred capitalized interest has not, as of the date of determination, been paid in cash; provided, however, that such Deferrable Security will cease to be a Deferring Security at such time as it (a) ceases to defer or capitalize the payment of interest, (b) pays in cash all accrued and unpaid interest, including all deferred amounts, and (c) commences payment of all current interest in cash.

"Delayed Drawdown Collateral Obligation": Any Collateral Obligation that (a) requires the Issuer to make one or more future advances to the borrower under the Underlying Instruments relating thereto, (b) specifies a maximum amount that can be borrowed on one or more fixed borrowing dates, and (c) does not permit the re-borrowing of any amount previously repaid by the borrower thereunder; <u>provided</u> that any such Collateral Obligation will be a Delayed Drawdown Collateral Obligation only until all commitments by the Issuer to make advances to the borrower expire or are terminated or reduced to zero.

"<u>Deliver</u>" or "<u>Delivered</u>" or "<u>Delivery</u>": The taking of the following steps:

- (a) (1)-in the case of each "certificated security" (as defined in Article 8 of the UCC) or Instrument (other than a Clearing Corporation Security or a certificated security or an Instrument evidencing debt underlying a Participation), (i) causing the delivery of such certificated security or Instrument to the Intermediary registered in the name of the Intermediary or its affiliated nominee or endorsed to the Intermediary or in blank, (ii) causing the Intermediary to continuously identify on its books and records that such certificated security or Instrument is credited to the relevant Account and (iii) causing the Intermediary to maintain continuous possession of such certificated security or Instrument;
- (b) (m) in the case of each Uncertificated Security (other than a Clearing Corporation Security), (i) causing such Uncertificated Security to be continuously registered on the books of the obligor thereof to the Intermediary and (ii) causing the Intermediary to continuously identify on its books and records that such Uncertificated Security is credited to the relevant Account;
- (c) (n)—in the case of each Clearing Corporation Security, causing (i) the relevant Clearing Corporation to continuously credit such Clearing Corporation Security

to the securities account of the Intermediary at such Clearing Corporation and (ii) the Intermediary to continuously identify on its books and records that such Clearing Corporation Security is credited to the relevant Account;

- (d) (o) in the case of any Financial Asset that is maintained in book-entry form on the records of an FRB, causing (i) the continuous crediting of such Financial Asset to a securities account of the Intermediary at any FRB and (ii) the Intermediary to continuously identify on its books and records that such Financial Asset is credited to the relevant Account;
- (e) (p)—in the case of Cash, (i) causing the delivery of such Cash to the Intermediary, (ii) causing the Intermediary to agree to treat such cash as a Financial Asset and (iii) causing the Intermediary to continuously credit such Financial Asset to the relevant Account;
- (f) (q)—in the case of each Financial Asset not covered by the foregoing clauses (a) through (e), causing the transfer of such Financial Asset to the Intermediary in accordance with applicable law and regulation and causing the Intermediary to continuously credit such Financial Asset to the relevant Account;
- (g) (r)—in the case of each general intangible (including any participation interest that is not, or the debt underlying which is not, evidenced by an Instrument or certificated security), notifying the obligor thereunder of the Grant to the Trustee (unless no applicable law requires such notice);
- (h) (s)—in the case of each participation interest in a loan as to which the underlying debt is represented by a certificated security an Instrument, obtaining the acknowledgment of the Person in possession of such certificated security or Instrument (which may not be the Issuer) that it holds the Issuer's interest in such certificated security or Instrument solely on behalf and for the benefit of the Trustee; and
- (i) (t) in all cases, the filing of an appropriate Financing Statement in the appropriate filing office in accordance with the Uniform Commercial Code as in effect in any relevant jurisdiction.

"Designated Maturity": Three months. With respect to (a) the Floating Rate Notes, three months (except that with respect to any class of Refinancing Obligations issued on a non-Scheduled Payment Date, for the period from the issuance date of such class to the last day of such Interest Accrual Period, the Reference Rate will be determined by interpolating linearly between the rate for the next shorter period of time for which rates are available and the rate for the next longer period of time for which rates are available) and (b) all references (other than with respect to the Floating Rate Notes), such period as the context requires. If at any time the three month rate is applicable but not available, the Reference Rate will be determined by interpolating linearly between the rate for the next shorter period of time for which rates are available and the rate for the next longer period of time for which rates are available. All interpolated rates will be rounded to five decimal places.

"Designated Reference Rate": The sum of (a) the Reference Rate Modifier and (b) either (i) the quarterly pay reference rate recognized or acknowledged as being the industry standard for leveraged loans (which recognition may be in the form of a press release, a member announcement, a member advice, letter, protocol, publication of standard terms or otherwise) by the Loan Syndications and Trading Association® (together with any successor organization, "LSTA") or (ii) the quarterly pay reference rate that is used in calculating the interest rate of (x) at least 50% of the Collateral Obligations (by par amount) or (y) in at least 50% of the collateralized loan obligation transactions which have priced or closed a new issuance of securities and/or amended their base rate within one month prior to such change of the base rate component, in each case, as determined by the Investment Manager as of the first day of the Interest Accrual Period during which the Reference Rate Amendment is proposed.

"Determination Date": The last day of each Collection Period.

"DIP Collateral Obligation": Any interest in a loan or financing facility that has a public or private facility rating from Moody's andan S&P\_Rating and is purchased directly or by way of assignment (a) which is an obligation of (i) a debtor-in-possession as described in §1107 of the Bankruptcy Code or (ii) a trustee if appointment of such trustee has been ordered pursuant to §1104 of the Bankruptcy Code (in either such case, a "Debtor") organized under the laws of the United States or any state therein, or (b) on which the related obligor is required to pay interest on a current basis and, with respect to either clause (a) or (b) above, the terms of which have been approved by an order of the United States Bankruptcy Court, the United States District Court, or any other court of competent jurisdiction, the enforceability of which order is not subject to any pending contested matter or proceeding (as such terms are defined in the Federal Rules of Bankruptcy Procedure) and which order provides that: (i)(A) such DIP Collateral Obligation is fully secured by liens on the Debtor's otherwise unencumbered assets pursuant to §364(c)(2) of the Bankruptcy Code or (B) such DIP Collateral Obligation is secured by liens of equal or senior priority on property of the Debtor's estate that is otherwise subject to a lien pursuant to §364(d) of the Bankruptcy Code and (ii) such DIP Collateral Obligation is fully secured based upon a current valuation or appraisal report. Notwithstanding the foregoing, such a loan will not be deemed to be a DIP Collateral Obligation following the emergence of the related debtor-in-possession from bankruptcy protection under Chapter 11 of the Bankruptcy Code.

"Discount Obligation": Any Collateral Obligation forming part of the Assets which was purchased (as determined without averaging prices of purchases on different dates) for less than (a) 80.0% of its principal balance, if such Collateral Obligation has (at the time of the purchase) a Moody's an S&P Rating of "B3=" or higher, or (b) 85.0% of its principal balance, if such Collateral Obligation has (at the time of the purchase) a Moody's S&P Rating of "Caal" or lower:

provided that: (x) such Collateral Obligation shall cease to be a Discount Obligation at CCC+" or lower, in each case until such time as the Market Value (expressed as a percentage of the par amount of such Collateral Obligation) determined for such Collateral Obligation on each day during any period of 22 consecutive Business Days since the acquisition by the Issuer of such Collateral Obligation, equals or exceeds 90.0% on each such day and;

## provided, that

- (I) (y) any Collateral Obligation that would otherwise be considered a Discount Obligation, but that is purchased with the proceeds of sale of a Collateral Obligation that was not a Discount Obligation at the time of its purchase, will not be considered to be a Discount Obligation so long as such purchased Collateral Obligation (A)
- (A) is purchased or committed to be purchased within five 20 Business Days of such sale, (B)
- (B) is purchased at a purchase price (expressed as a percentage of the par amount of such Collateral Obligation) equal to or greater than the sale price of the sold Collateral Obligation, (C)
- (C) is purchased at a purchase price (expressed as a percentage of the par amount of such Collateral Obligation) not less than 6560%, and (D) has a Moody's Default Probability
- (D) has an S&P Rating equal to or greater than the Moody's Default ProbabilityS&P Rating of the sold Collateral Obligation, will not be considered to be a Discount Obligation; provided;

<u>except</u> that the provisions of this <u>clause (y) shallproviso will</u> not apply to any such Collateral Obligation at any time on or after the acquisition by the Issuer of such Collateral Obligation if, as determined at the time of such acquisition, such application would result in <u>the current Aggregate Principal Balance of Collateral Obligations to which this <u>clause (y)proviso</u> has been applied since the <u>ClosingAmendment</u> Date exceeding <u>1015</u>% of the Aggregate Ramp-Up Par Amount; and</u>

(II) if such interest is a Revolving Collateral Obligation, and there exists an outstanding non-revolving loan to its Obligor ranking pari passu with such Revolving Collateral Obligation and secured by substantially the same collateral as such Revolving Collateral Obligation (a "Related Term Loan"), in determining whether such Revolving Collateral Obligation is and continues to be a Discount Obligation, the price of the Related Term Loan, and not of the Revolving Collateral Obligation, shall be referenced.

"Discount Obligation Principal Balance": With respect to each Discount Obligation, the product (expressed as a dollar amount) of (i) the purchase price of such Discount Obligation (excluding accrued interest and any syndication or upfront fees paid to the Issuer, but including, at the discretion of the Investment Manager, the amount of any related transaction costs (including assignment fees) paid by the Issuer to the seller of the Collateral Obligation of its agent) expressed as a percentage of par *multiplied* by (ii) the principal balance of such Discount Obligation.

"Discretionary Sale": The meaning specified in Section 12.1(f).

"<u>Disposition Proceeds</u>": Proceeds received with respect to sales of Collateral Obligations, Eligible Investments and Equity Securities and the termination of any Hedge

Agreement, in each case, net of reasonable out-of-pocket expenses and disposition costs in connection with such sales.

"<u>Dissolution Expenses</u>": The amount of expenses reasonably likely to be incurred in connection with the discharge of this Indenture, the liquidation of the Assets and the dissolution of the Co-Issuers, as reasonably certified by the Investment Manager or the Issuer, based in part on expenses incurred by the Trustee and reported to the Investment Manager.

"Distressed Exchange": In connection with any Collateral Obligation, a distressed exchange or other debt restructuring has occurred, as reasonably determined by the Investment Manager, pursuant to which the issuer or obligor of such Collateral Obligation has issued to the holders of such Collateral Obligation a new security or package of securities or obligations that, in the sole judgment of the Investment Manager, amounts to a diminished financial obligation or has the purpose of helping the issuer of such Collateral Obligation avoid default; provided that no Distressed Exchange shall be deemed to have occurred if the securities or obligations received by the Issuer in connection with such exchange or restructuring meet the definition of Collateral Obligation.

"<u>Distressed Exchange Offer</u>": An offer by the issuer of a Collateral Obligation to exchange one or more of its outstanding debt obligations for a different debt obligation or to repurchase one or more of its outstanding debt obligations for cash, or any combination thereof.

"<u>Distribution Report</u>": The meaning specified in <u>Section 10.6(b)</u>.

"<u>Diversity Score</u>": A single number that indicates collateral concentration in terms of both issuer and industry concentration, calculated as set forth in <u>Schedule 3</u>.

"Domicile" or "Domiciled": With respect to any issuer of or obligor with respect to a Collateral Obligation: (a) except as provided in clause (b) and (c) below, its country of organization; or (b) if it is organized in a Tax Jurisdiction, each of such jurisdiction and the country in which a substantial portion of its operations is located or from which a substantial portion of its revenue is derived, in each case directly or through subsidiaries; or (c) if its payment obligations in respect of such Collateral Obligation are guaranteed by a person or entity (in a guarantee agreement with such person or entity, which guarantee agreement complies with each Rating Agency's then-current criteria with respect to guarantees) that is organized in the United States, then the United States.

"<u>DTC</u>": The Depository Trust Company, its nominees, and their respective successors.

"<u>Due Date</u>": Each date on which any payment is due on a Pledged Obligation in accordance with its terms.

"Effective Date": The earlier of (a) September 4, 2013 and (b) any date selected by the Investment Manager in its sole discretion on or after which the Aggregate Ramp Up Par-Condition has been satisfied. September 4, 2013.

"Effective Date Certificate": The meaning specified in Section 7.17(c)(iviii).

<u>"Effective Date Interest Deposit Restriction"</u>: The requirement that the sum of the deposits from the Ramp-Up Account and the Principal Collection Account into the Interest Collection Account as Interest Proceeds after the Effective Date and on or before the first Determination Date not exceed \$5,000,000.

"Effective Date Ratings Confirmation": Written confirmation from each Rating AgencyS&P of its Initial Rating of each Class of the Secured Notes that it rated or, to the extent the Moody's or satisfaction of the S&P Effective Date Rating Condition has been satisfied, such written confirmation from S&P.

"Effective Date Report": The meaning specified in Section 7.17(c)(iii).

"Effective Spread": As of any Measurement Date, with respect to any floating rate Collateral Obligation—(including any LIBOR Floor Obligation), (x) if such floating rate Collateral Obligation bears interest based on a floating rate-based index that is the same as the Reference Rate, then the Effective Spread means the current per annum rate at which it pays interest in Cash minus—LIBOR for the Reference Rate for such Collateral Obligation or (y)(a) if such floating rate Collateral Obligation bears interest based on a floating rate index other than a floating rate-based index that is the same as the Reference Rate or (b) if such floating rate Collateral Obligation is a Reference Rate Floor Obligation whose interest rate is calculated using its floor rate as a base rate, then the Effective Spread means the then-current base rate applicable to such floating rate Collateral Obligation plus any margin above the base rate at which such floating rate Collateral Obligation pays interest in Cash minus the Reference Rate for the Floating Rate Notes;

## provided that

- (i) with respect to any unfunded commitment of a Revolving Collateral Obligation or Delayed Drawdown Collateral Obligation, the Effective Spread shall be the commitment fee payable with respect to such unfunded commitment,
- (ii) with respect to the funded portion of a commitment under a Revolving Collateral Obligation or Delayed Drawdown Collateral Obligation, (a) if such funded portion bears interest based on a floating rate-based index that is the same as the Reference Rate, the Effective Spread shall be the per annum rate at which it pays interest in Cash minus LIBORthe Reference Rate for such Collateral Obligation (in each case, as of such date) or, (b)(I) if such funded portion bears interest based on a floating rate index other than a London interbank offered rate-based index floating rate-based index that is the same as the Reference Rate or (II) if such funded portion is a Reference Rate Floor Obligation whose interest rate is calculated using its floor rate as a base rate, the Effective Spread will be the then-current base rate applicable to such funded portion plus the rate at which such funded portion pays interest in Cash in excess of such base rate minus three-month LIBORthe Reference Rate and

(iii) (iii) in respect of any Step \_Down Obligation, the Effective Spread of such Collateral Obligation will be the lowest permissible Effective Spread pursuant to the Underlying Instruments of the Obligation of such Step \_Down Obligation.\_;

provided further, if an S&P Effective Date Formula Election is in effect, the Effective Spread will be calculated without giving effect to clause (y)(b) above.

"Eligible Bond Index": With respect to each Collateral Obligation that is a bond, one of the following indices as selected by the Investment Manager upon the acquisition of such Collateral Obligation: Merrill Lynch US High Yield Master II Constrained Index, Bloomberg ticker HUCO, Bloomberg ticker HOAO, Bloomberg ticker HW40, Credit Suisse High Yield Index or any nationally recognized comparable replacement bond index (other than an index that is maintained by an Affiliate of the Investment Manager); provided, that the Investment Manager may change the index applicable to a Collateral Obligation at any time following the acquisitionthereof after giving notice to Moody's, the Trustee and the Collateral Administrator; provided further, however, that a single index will be in effect for all Collateral Obligations that are bonds on any Measurement Date. Account": An account with a financial institution (which may be the Trustee) that is a federal or state-chartered depository institution that has (a) a long-term debt rating of at least "A" or a short-term debt rating of at least "F1" by Fitch, and (b) a long-term debt rating of at least "A" and a short-term debt rating of at least "A-1" by S&P or, if no short-term debt rating is available from S&P, a long-term debt rating of at least "A+" by S&P and combined capital and surplus of at least \$200,000,000; provided that if such institution's ratings fall below the ratings set forth in clauses (a) or (b) the assets held in such account will be moved to another institution that satisfies such ratings within 30 calendar days.

"Eligible Cash": Cash eligible for investment.

"Eligible Institution": Any organization or entity organized and doing business under the laws of the United States of America or of any state thereof, authorized under such laws to exercise corporate trust powers, having a combined capital and surplus of at least \$200,000,000, subject to supervision or examination by federal or state authority, having a long-term debt rating of at least "BBB+" by S&P, and having an office within the United States. If such organization or entity publishes reports of condition at least annually, pursuant to law or to the requirements of the aforesaid supervising or examining authority, then for purposes of this definition, the combined capital and surplus of such organization or entity shall be deemed to be its combined capital and surplus as set forth in its most recent published report of condition.

- (i) direct obligations of, and obligations the timely payment of principal and interest on which is fully and expressly guaranteed by, the United States of America or any agency or instrumentality of the United States of America the obligations of which are expressly backed by the full faith and credit of the United States of America and which satisfy the Eligible Investment Required Ratings;
- (ii) demand and time deposits in, certificates of deposit of, bank deposit products of, trust accounts with, bankers' acceptances issued by, or federal funds sold by any depository institution or trust company incorporated under the laws of the United States of America (including the Bank) or any state thereof and subject to supervision and examination by federal and/or state banking authorities, in each case payable within 183 days of issuance, so long as the commercial paper and/or the debt obligations of such depository institution or trust company (or, in the case of the principal depository institution in a holding company system, the commercial paper or debt obligations of such holding company) at the time of such investment or contractual commitment providing for such investment have the Eligible Investment Required Ratings;
- (iii) unleveraged repurchase obligations with respect to (a) any security described in clause (i) above or (b) any other security issued or guaranteed by an agency or instrumentality of the United States of America, in either case entered into with a depository institution or trust company (acting as principal) described in clause (ii) above or entered into with an entity (acting as principal) with, or whose parent company has (in addition to a guarantee agreement with such entity, which guarantee agreement complies with S&P's then-current criteria with respect to guarantees), the Eligible Investment Required Ratings;
- (iv) securities bearing interest or sold at a discount with maturities up to 365 days (but in any event such securities shall mature by the next succeeding Payment Date) issued by any entity formed under the laws of the United States of America or any State thereof that have a credit rating of "Aaa" from Moody's and "AAA" from S&P at the time of such investment or contractual commitment providing for such investment;

(iii) (v) commercial paper or other short term obligations with the Eligible Investment Required Ratings and that either bear interest or are sold at a discount from the face amount thereof and have a maturity of not more than 183-days from their date of issuance; provided that this clause (v) shall not include(excluding extendible commercial paper or asset backed commercial paper; (vi) a Reinvestment Agreement issued by any bank (if treated as a deposit by such bank), or a Reinvestment Agreement issued by any insurance company or other corporation or entity, in each case) with the Eligible Investment Required Ratings and which satisfies the Global Rating Agency Condition; and

(iv) (vii) shares or other securities of non-United States registered money market funds domiciled outside of the United States which funds have, at all times, credit ratings of "Aaa mf" by Moody's and "AAAm" or "AAAm G" by S&P, respectively and "AAAmmf" by Fitch;

provided, however, that (A) Eligible Investments purchased with funds in the Collection Account shallwill be held until maturity except as otherwise specifically provided herein and shallwill include only such obligations or securities, other than those referred to in clause (viiiv) above, as mature (or are putable at par to the issuer or obligor thereof) no later than the earlier of 60 days and the Business Day prior to the next Payment Date (unless such Eligible Investments are issued by the Trustee in its capacity as a banking institution, in which case such Eligible Investments may mature on such Payment Date); and (B) none of the foregoing obligations or securities shallwill constitute Eligible Investments if (1) such obligation or security has an "f," "r," "p," "pi," "qsf" or "t" subscript assigned by S&Pto its rating by S&P or an "sf" subscript assigned to its rating by Moody's, (2) all, or substantially all, of the remaining amounts payable thereunder consist of interest and not principal payments, (3) such obligation or security is subject to withholding tax (other than any withholding tax imposed pursuant to FATCA) unless the issuer of the security is required to make "gross \_up" payments that ensure that the net amount actually received by the Issuer (after payment of all taxes, whether imposed on such obligor or the Issuer) shallwill equal the full amount that the Issuer would have received had no such taxes been imposed, (4) such obligation or security is secured by real property, (5) such obligation or security is purchased at a price greater than 100% of the principal or face amount thereof-or, (6) in the Investment Manager's sole judgment, such obligation or security is subject to material non-credit related risks; and or (7) such obligation or security invests in, or constitutes, a Structured Finance Obligation.

(C) none of the foregoing obligations or securities shall constitute Eligible Investments unless the obligation or security either (1) is treated as indebtedness for U.S. federal income tax purposes and is not a United States real property interest for U.S. federal income tax purposes, (2) is not treated as indebtedness for U.S. federal income tax purposes and is issued by an entity that is treated for U.S. federal income tax purposes as (x) a corporation the equity interests in which are not "United States real property interests" for U.S. federal income tax purposes, it being understood that stock will not be treated as a United States real property interest if the class of such stock is regularly traded on an established securities market and the Issuer holds no more than 5% of such class at any time, all within the meaning of Section 897(c)(3) of the Code, (y) a partnership or disregarded entity for U.S. federal income tax purposes that is not engaged in a trade or business within the United States for U.S. federal income tax purposes and does not own any "United States real property interests" within the meaning of Section 897(c)(1) of the Code,

or (z) a grantor trust all of the assets of which are treated as debt instruments that are in registered form for U.S. federal income tax purposes, or (3) based upon Tax Advice, the acquisition, ownership or disposition of such security will not cause the Issuer to be treated as engaged in a trade or business within the United States for U.S. federal income tax purposes or otherwise subject to U.S. federal income tax on a net income tax basis.

"Entitlement Order": The meaning specified in Section 8-102(a)(8) of the UCC.

"Equity Security": Any security or debt obligation which does not satisfy the requirements of clauses (i) through (xxiii) of the definition of Collateral Obligation (without regard to the requirement excluding Equity Securities) and is not an Eligible Investment; it being understood that Equity Securities may not be purchased by the Issuer but it is possible that the Issuer (or a Tax Subsidiary) may receive an Equity Security (which is received "in lieu of a debt previously contracted" for purposes of the Volcker Rule) in exchange for a Collateral Obligation or a portion thereof in connection with an insolvency, bankruptcy, reorganization, debt restructuring or workout of the issuer thereof.

"ERISA": The United States Employee Retirement Income Security Act of 1974, as amended from time to time.

"Euroclear": Euroclear Bank S.A./N.V., as operator of the Euroclear System.

"<u>European Countries</u>": Austria, Belgium, Denmark, Finland, France, Germany, Iceland, Ireland, Liechtenstein, Luxembourg, Norway, Spain, Sweden, Switzerland, The Netherlands and the United Kingdom.

"Event of Default": The meaning specified in Section 5.1.

"Excel Default Model Input File": The meaning specified in Schedule 5.

"Excepted Advances": Customary advances made to protect or preserve rights against the borrower of or obligor under a Collateral Obligation or to indemnify an agent or representative for lenders pursuant to the Underlying Instrument.

"Excepted Current Pay Obligation": The meaning specified in Schedule 5.

"Excepted Property": The meaning specified in Granting Clause I.

"Excess CCC/Caa Adjustment Amount": As of any date of determination, an amount equal to the excess, if any, of (i) the Aggregate Principal Balance of all Collateral Obligations included in the CCC/Caa Excess over (ii) the sum of the Market Values of all Collateral Obligations included in the CCC/Caa Excess.

<u>"Excess Par Amount"</u>: An amount, as of any Determination Date, equal to the greater of (a) zero and (b)(i) the Aggregate Principal Balance less (ii) the Reinvestment Target Par Balance.

"Excess Weighted Average Fixed Coupon": As of any Measurement Date, a percentage equal to the product obtained by multiplying (a) the greater of zero and the excess, if any, of the Weighted Average Fixed Coupon over the Minimum Fixed Coupon by (b) the number obtained by dividing the Aggregate Principal Balance of all fixed rate Collateral Obligations (excluding any Defaulted Obligation) by the Aggregate Principal Balance of all floating rate Collateral Obligations.

"Excess Weighted Average Floating Spread": As of any Measurement Date, an amount equal to the product obtained by multiplying (a) the greater of zero and the excess, if any, of the Weighted Average Floating Spread over the Minimum Floating Spread by (b) the number obtained by dividing the Aggregate Principal Balance of all floating rate Collateral Obligations (excluding any Defaulted Obligation) by the Aggregate Principal Balance of all fixed rate Collateral Obligations.

"Exchange Act": The United States Securities Exchange Act of 1934, as amended from time to time.

"Expected Portfolio Default Rate": The meaning specified in Schedule 5.

"Expense Reserve Account": The account established pursuant to Section 10.3(d).

"FATCA": Sections 1471 through 1474 of the Code and any applicable intergovernmental agreement entered into in respect thereof, and any related provisions of law, court decisions, or administrative guidance, including an agreement between the Issuer and the U.S. Internal Revenue Service that sets forth the requirements for the Issuer to be treated as complying with Section 1471(b) of the Code.

"<u>FATCA Compliance</u>": Compliance with FATCA as necessary so that no tax will be imposed or withheld thereunder in respect of payments to or for the benefit of Issuer or a Tax Subsidiary.

"<u>FATCA Compliance Costs</u>": The costs to the Issuer of achieving FATCA Compliance.

"<u>Federal Reserve Board</u>": The Board of Governors of the Federal Reserve System.

"Fee Basis Amount": As of any date of determination, the Collateral Principal Amount.

"Finance Lease": A lease agreement or other agreement entered into in connection with and evidencing any transaction pursuant to which the obligations of the lessee to pay rent or other amounts on a triple net basis under any lease of (or other arrangement conveying the right to use) real or personal property, or a combination thereof, are required to be classified and accounted for as a capital lease on a balance sheet of such lessee under generally accepted accounting principles in the United States; but only if (a) such lease or other transaction provides for the unconditional obligation of the lessee to pay a stated amount of principal no later than a stated maturity date, together with interest thereon, and the payment of such obligation is not subject to any material non-credit related risk as determined by the Investment Manager, (b) the obligations of the lessee in respect of such lease or other transaction are fully secured, directly or indirectly, by the property that is the subject of such lease, and (c) the interest held by the Issuer in respect of such lease or other transaction is treated as debt for U.S. federal income tax purposes and (d) it has a rating by Moody's and S&P.

"Financial Asset": The meaning specified in Section 8-102(a)(9) of the UCC. "Financial Regulator": The Irish Financial Services Regulatory Authority.

"<u>Financing Statements</u>": The meaning specified in Section 9-102(a)(39) of the UCC.

"First Interest Determination End Date": July 25, 2013.

"First-Lien Last-Out Loan": A Collateral Obligation that is a Senior Secured Loan that, prior to a default with respect such loan, is entitled to receive payments pari passu with other Any assignment of or Participation Interest in a loan that: (a) is not (and cannot by its terms become) subordinate in right of payment to any other obligation of the obligor of the loan (other than (i) with respect to trade claims, capitalized leases or similar obligations and (ii) subordination in right of payment solely to one or more Senior Secured Loans of the same obligor, but following a default becomes fully subordinated to other Senior Secured Loans of the same obligor and is not entitled to any payments until such other Senior Secured Loans are paid in fullobligor of the loan that becomes effective solely upon the occurrence of a default or event of default by the obligor of the loan) and (b) is secured by a valid perfected security interest or lien in, to or on specified collateral securing the obligor's obligations under the loan that, prior to

the occurrence of a default or event of default by the obligor of the loan, is a first priority security interest or lien.

"Floating Rate Notes": Notes that bear interest at floating rates.

"FRB": Any Federal Reserve Bank.

"GAAP": The meaning specified in Section 6.3(j).

"Global Rating Agency Condition": With respect to any action taken or to be taken by or on behalf of the Issuer, the satisfaction of both the Moody's S&P Rating Condition and the S&P Rating Condition. If either Moody's or S&P (a) makes a public announcement or informs the Issuer, the Investment Manager or the Trustee that (i) it believes satisfaction of the Global Rating Agency Condition is not required with respect to an action or (ii) its practice is to not give such confirmations, or (b) no longer constitutes a Rating Agency under this Indenture, the requirement for satisfaction of the Global Rating Agency Condition with respect to that Rating Agency will not applyproviding of notice to Fitch of such proposed action prior to such action taking effect (for so long as Fitch is a Rating Agency).

"Global Securities": Any Regulation S Global Securities and Rule 144A Global Securities.

"Global Security Procedures": In respect of any transfer or exchange as a result of which one or more Rule 144A Global Security or Regulation S Global Security representing Notes is increased or decreased, the following procedures: the Registrar will confirm the related instructions from DTC to (a) reduce and/or increase, as applicable, the principal amount of the applicable Global Security after giving effect to the exchange or transfer (determined in the case of an exchange for Preferred Shares based on the Share Exchange Rate) and, if applicable, (b) credit or request to be credited to the securities account specified by or on behalf of the holder of the beneficial interest in the applicable Global Security of the same Class.

"Grant" or "Granted": To grant, bargain, sell, convey, assign, transfer, mortgage, pledge, create and grant a security interest in and right of setoff against, deposit, set over and

confirm. A Grant of the Pledged Obligations, or of any other instrument, shall include all rights, powers and options (but none of the obligations) of the granting party thereunder, including, the immediate continuing right to claim for, collect, receive and receipt for principal and interest payments in respect of the Pledged Obligations, and all other Monies payable thereunder, to give and receive notices and other communications, to make waivers or other agreements, to exercise all rights and options, to bring Proceedings in the name of the granting party or otherwise, and generally to do and receive anything that the granting party is or may be entitled to do or receive thereunder or with respect thereto.

"Hedge Agreements": Any interest rate swap, floor and/or cap agreements, including, without limitation, one or more interest rate basis swap agreements, between the Issuer and any Hedge Counterparty, as amended from time to time, and any replacement agreement entered into pursuant to Section 16.1.

"Hedge Counterparty": Any one or more institutions entering into or guaranteeing a Hedge Agreement with the Issuer that satisfies the Required Hedge Counterparty Rating that has entered into a Hedge Agreement with the Issuer, including any permitted assignee or successor under the Hedge Agreements.

"<u>Hedge Counterparty Collateral Account</u>": Each account established pursuant to Section 10.4.

"Hedge Counterparty Credit Support": As of any date of determination, any cash or cash equivalents on deposit in, or otherwise to the credit of, the applicable Hedge Counterparty Collateral Account in an amount required to satisfy the then-current Rating Agency criteria.

"<u>High Yield Bond</u>": A publicly issued or privately placed debt obligation of a corporation or other entity (other than a loan, Senior Secured Bond or Senior Secured Note). Highest Ranking Class": The meaning specified in Schedule 5.

"<u>Holder</u>": With respect to any (a) Note, the Person whose name appears on the Register and (b) Preferred Shares, whose name appears on the Share Register.

"Holder Reporting Obligations": The meaning specified in Section 2.6(j)(ix).

"IAI": An institutional Accredited Investor as defined in Rule 501(a)(1), (2), (3) or (7) of Regulation D of the Securities Act.

"IAI/QP": Any Person that, at the time of its acquisition, purported acquisition or proposed acquisition of Securities is both an IAI and a Qualified Purchaser.

"<u>Identified Reinvestments</u>": The meaning specified in <u>Section 12.2(f)</u>.

"Incurrence Covenant": A covenant by the underlying obligor under a loan to comply with one or more financial covenants only upon the occurrence of certain actions of the underlying obligor or certain events relating to the underlying obligor, including, but not limited to, a debt issuance, dividend payment, share purchase, merger, acquisition or divestiture, unless, as of any date of determination, such action was taken or such event has occurred, in each case the effect of which causes such covenant to meet the criteria of a Maintenance Covenant.

"Indenture": This instrument as originally executed and, if from time to time supplemented or amended by one or more indentures supplemental hereto entered into pursuant to the applicable provisions hereof, as so supplemented or amended.

"Independent": As to any Person, any other Person (including, in the case of an accountant or lawyer, a firm of accountants or lawyers, and any member thereof, or an investment bank and any member thereof) who (i) does not have and is not committed to acquire any material direct or any material indirect financial interest in such Person or in any Affiliate of such Person, and (ii) is not connected with such Person as an Officer, employee, promoter, underwriter, voting trustee, partner, director or Person performing similar functions. "Independent" when used with respect to any accountant may include an accountant who audits the books of such Person if in addition to satisfying the criteria set forth above the accountant is independent with respect to such Person within the meaning of Rule 101 of the Code of Professional Conduct of the American Institute of Certified Public Accountants.

Whenever any Independent Person's opinion or certificate is to be furnished to the Trustee, such opinion or certificate shall state that the signer has read this definition and that the signer is Independent within the meaning hereof.

Any pricing service, certified public accountant or legal counsel that is required to be Independent of another Person under this Indenture must satisfy the criteria above with respect to the Issuer and the Investment Manager.

"Industry Diversity Measure": The meaning specified in Schedule 5.

"Information": The meaning specified in Schedule 5.

"Information Agent": The meaning specified in Section 14.16(a).

"<u>Initial Purchaser</u>": Credit Suisse, in its capacity as Initial Purchaser under the Purchase Agreement and the Refinancing Purchase Agreement.

"Initial Rating": With respect to any Class of Secured Notes, the rating or ratings, if any, indicated in Section 2.3.

"Instrument": The meaning specified in Section 9-102(a)(47) of the UCC.

"Interest Accrual Period": The period from and including the Closing Date to but excluding the first Payment Date, and each succeeding period from and including each Payment Date to but excluding the following Payment Date until the principal of the Secured Notes is paid or made available for payment (or, in the case of a Class that is being redeemed on a Partial Redemption Date, to but excluding such Partial Redemption Date); provided, that any interest bearing Additional Securities issued after the Closing Date in accordance with the terms of this Indenture will accrue interest during the Interest Accrual Period in which such Additional Securities are issued from and including the applicable date of issuance of such Additional Securities to but excluding the last day of such Interest Accrual Period at the applicable interest rate for such Additional Securities. For purposes of determining any Interest Accrual Period, (i) in the case of the Fixed Rate Notes, the Distribution Date shall be assumed to be the 25th day of the relevant month (irrespective of whether such day is a Business Day) and (ii) in the case of the Floating Rate Notes, if the 25th day of the relevant month is not a Business Day, then the Interest Accrual Period with respect to such Distribution Date shall end on but exclude the Business Day on which payment is made and the succeeding Interest Accrual Period shall begin on and include such date.

"Interest Collection Account": The meaning specified in Section 10.2(a).

"Interest Coverage Ratio": With respect to any designated Class or Classes of Secured Notes, as of any date of determination on or after the Determination Date immediately preceding the second Payment Date, the percentage derived from:

- (a) (u)—the sum of (i) the Collateral Interest Amount as of such date of determination *minus* (ii) amounts payable (or expected as of the date of determination to be payable) on the following Payment Date as set forth in clauses (A), (B) and (C) under the Priority of Interest Proceeds; *divided by*
- (b) (v)-interest due and payable on the Secured Notes of such Class or Classes, each Pari Passu Class and each Priority Class of Secured Notes on such Payment Date (excluding Deferred Interest, but including any interest on Deferred Interest, with respect to any such Class or Classes).

"Interest Coverage Test": A test that is satisfied with respect to any specified Class of Notes, if as of the Determination Date immediately preceding the second Payment Date, and at any date of determination occurring thereafter (i) the Interest Coverage Ratio for such Class is at least equal to the applicable Required Coverage Ratio for such Class, or (ii) such Class is no longer outstanding.

"Interest Determination Date": With respect to (a) the first Interest Accrual Period, (x) for the period from the Closing Date to but excluding the First Interest Determination End Date, the second London Banking Day preceding the Closing Date, and (y) for the remainder of the first Interest Accrual Period, the second London Banking Day preceding the First Interest Determination End Date, and (b) each Interest Accrual Period thereafter, the second London Banking Day preceding the first day of such Interest Accrual Period.

"Interest Diversion Test": The test that is satisfied as of any Measurement Date during the Reinvestment Period if the Overcollateralization Ratio for the Class E Notes is at least equal to 101.8102.9%.

"Interest Proceeds": With respect to any Collection Period or Determination Date, without duplication, the sum of:

- (i) all payments of interest and other income received by the Issuer during the related Collection Period on the Collateral Obligations and Eligible Investments, including the accrued interest received in connection with a sale thereof during the related Collection Period, *less* any such amount that represents Principal Financed Accrued Interest;
- (ii) all principal and interest payments received by the Issuer during the related Collection Period on Eligible Investments purchased with Interest Proceeds;
- (iii) all amendment and waiver fees, late payment fees and other fees received by the Issuer during the related Collection Period, except for those in connection with (a) the lengthening of the maturity of the related Collateral Obligation or (b) the reduction of the par of the related Collateral Obligation (in the case of such amounts described in subclauses (iii)(a) and (b)each case, as identified by the Investment Manager in writing to the Trustee and the Collateral Administrator);
- (iv) any payment received with respect to any Hedge Agreement other than (a) an upfront payment received upon entering into such Hedge Agreement or (b) a payment received as a result of the termination of any Hedge Agreement to the extent not used by the Issuer to enter into a new or replacement Hedge Agreement (for purposes of this subclause (iv), any such payment received or to be received on or before 10:00 a.m. New York time on the last day of the Collection Period in respect of such Payment Date will be deemed received in respect of the preceding Collection Period and included in the calculation of Interest Proceeds received in such Collection Period);
- (v) any payments received as repayment for Excepted Advances made using Interest Proceeds;

- (vi) all payments other than principal payments received by the Issuerduring the related Collection Period on Collateral Obligations that are Defaulted Obligations solely as the result of a Moody's Rating of "LD" in relation thereto;
- (vi) (vii) any amounts deposited in the Interest Collection Account from the Expense Reserve Account pursuant to Section 10.3(d) in respect of the related Determination Date;
- (vii) (viii) any proceeds from Tax Subsidiary Assets received by the Issuer from any Tax Subsidiary to the same extent as such proceeds would have constituted Interest Proceeds pursuant to this definition if received directly by the Issuer from the obligors of the Tax Subsidiary Assets;
- (viii) (ix)-commitment fees and other similar fees received by the Issuer during such Collection Period in respect of Revolving Collateral Obligations and Delayed Drawdown Collateral Obligations;
- (ix) (x)-in the case of the first Payment Date, all amounts on deposit in the Interest Reserve Account (other than amounts designated by the Investment Manager as Principal Proceeds);
- (x) Principal Proceeds designated by the Investment Manager (with the written consent of a Majority of the Subordinated Securities) as Interest Proceeds pursuant to Section 9.2(e) in an amount not to exceed the Excess Par Amount in connection with a Refinancing of all Classes of Secured Notes;
- (xi) any Contributions designated for application as Interest Proceeds; and
- (xii) any proceeds of an issuance of additional Subordinated Notes or Junior Mezzanine Notes designated as Interest Proceeds;

## provided that:

- (A)—(A)—except as set forth in clause (vi) above, any amounts received in respect of any Defaulted Obligation will constitute (1) Principal Proceeds (and not Interest Proceeds) until the aggregate of all recoveries in respect of such Defaulted Obligation since it became a Defaulted Obligation equals the outstanding Principal Balance of such Collateral Obligation when it became a Defaulted Obligation, and then (2) Interest Proceeds thereafter; and
- (B) amounts that would otherwise constitute Interest Proceeds may be designated as Principal Proceeds pursuant to Section 7.17(d) with notice to the Collateral Administrator. Notwithstanding the foregoing, in the Investment Manager's sole discretion (to be exercised on or before the related Determination Date), on any date after the first Payment Date, Interest Proceeds in any Collection Period may be deemed

to be Principal Proceeds so long as such designation would not result in an interest deferral on any Class of Secured Notes.

"Interest Rate": With respect to each Class of Secured Notes, the per annum stated interest rate payable on such Class with respect to each Interest Accrual Period (or, for the first Interest Accrual Period, the related portion thereof) specified in Section 2.3 with respect to such Notes which, if a Re-Pricing has occurred with respect to such Class of Secured Notes, will be the applicable Re-Pricing Rate.

"Interest Reserve Account": The account established pursuant to Section 10.3(e).

"Intermediary": The entity maintaining an Account pursuant to an Account Agreement.

"Internal Rate of Return": For purposes of the definition of Investment Manager Incentive Fee Amount, the rate of return on the Subordinated Securities (calculated using the XIRR function in Excel (or any successor)) that would result in a net present value of zero, assuming (i) an original purchase price of par for the Subordinated Notes and \$1,000 per share for the Preferred Shares as the initial negative cash flow—and, (ii) all payments to Holders of the Subordinated Securities on the current and each preceding Payment Date as subsequent positive cash flows (including the Redemption Date), if applicable, (iiii) proceeds relating to the issuance of Subordinated Notes on the Amendment Date as negative cash flows as of such date, (iv) the initial date for the calculation as the Closing Date, and (iiiv) the number of days to each subsequent Payment Date from the Closing Date, and (iv) such rate of return shall be calculated using the XIRR function in Excel (or any successor); provided that, for the avoidance of doubt, for purposes of this definition, the amount of Contributions described in Section 11.3(i) made by any Holder of Subordinated Securities shall be deemed to be a payment made to such Holder.

"Investment Advisers Act": The Investment Advisers Act of 1940, as amended from time to time.

"Investment Company Act": The Investment Company Act of 1940, as amended from time to time.

"Investment Criteria": The criteria specified in Section 12.2. The Reinvestment Period Investment Criteria and the Post Reinvestment Period Investment Criteria, collectively.

"Investment Criteria Adjusted Balance": With respect to any Asset, the Principal Balance of such Asset; provided that for all purposes the Investment Criteria Adjusted Balance of any: (i) Discount Obligation shall be the purchase price of such Discount Obligation; and (ii) CCC Collateral Obligation or Caa Collateral Obligation included in the CCC/Caa Excess shall be the Market Value of such CCC Collateral Obligation or Caa Collateral Obligation; provided, further, that the Investment Criteria Adjusted Balance for any Collateral Obligation that satisfies more than one of the definitions of Discount Obligation, CCC Collateral Obligation or Caa Collateral Obligation shall be the lowest amount determined pursuant to clauses (i) or (ii).

"Investment Management Agreement": The Investment Management Agreement, dated as of the Closing Date, between the Issuer and the Investment Manager, as amended from time to time.

"Investment Manager": ING Voya Alternative Asset Management LLC, a Delaware limited liability company, until a successor Person shall have become the Investment Manager pursuant to the provisions of the Investment Management Agreement, and thereafter "Investment Manager" shall mean such successor Person.

"Investment Manager Incentive Fee Amount": The fee payable to the Investment Manager on each Payment Date, including any Redemption Date (other than a Partial Redemption Date or a Re-Pricing Redemption Date that does not coincide with a Scheduled Payment Date) on and after which the Target Return has been achieved, pursuant to the Investment Management Agreement and the Priority of Payments, in an amount equal to 20% of any remaining Interest Proceeds and Principal Proceeds, as applicable, on such Payment Date.

"Irish Listing Agent": The meaning specified in Section 7.2.

"Issuer": ING IMVoya CLO 2013-2, Ltd., until a successor Person shall have become the Issuer pursuant to the applicable provisions of this Indenture, and thereafter "Issuer" shall mean such successor Person.

"<u>Issuer Only Notes</u>": The Class D Notes, the Class E Notes and the Subordinated Notes.

"Issuer Only Securities": The Issuer Only Notes and the Preferred Shares.

"Issuer Order": A written order dated and signed in the name of the Issuer or the Co-Issuer (which written order may be a standing order) by an Authorized Officer of the Issuer or the Co-Issuer, as applicable, or the Investment Manager on behalf of the Issuer. An order or request provided in an email by an Authorized Officer of the Issuer or the Investment Manager on behalf of the Issuer shall constitute an Issuer Order in each case except to the extent the Trustee requests otherwise.

"Junior Class": With respect to a particular Class of Notes, each Class of Notes that is subordinated to such Class, as indicated in <u>Section 2.3</u>.

"Junior Mezzanine Notes": Additional Notes of one or more new classes that are fully subordinated to the existing Secured Notes (or to the most junior class of securities of the Issuer (other than the Subordinated Notes) issued pursuant to this Indenture, if any Class of Notes issued pursuant to this Indenture other than the Secured Notes and the Subordinated Notes is then Outstanding).

"Knowledgeable Employee": The meaning set forth in Rule 3c-5(a)(4) under the Investment Company Act.

"LC Reserve Account": The meaning specified in Section 10.3(g).

"Letter of Credit": A facility whereby (i) a fronting bank that, at the time of the Issuer's commitment to acquire the same, has at least a long term rating of "A" and a short term rating of "A-1" (or if no short-term rating exists, a long-term rating of "A+") by S&P ("LOC Agent Bank") issues or will issue a letter of credit ("LC") for or on behalf of a borrower pursuant to an Underlying Instrument, (ii) in the event that the LC is drawn upon and the borrower does not reimburse the LOC Agent Bank, the lender/participant is obligated to fund its portion of the facility and (iii) the LOC Agent Bank passes on (in whole or in part) the fees it receives for providing the LC to the lender/participant.

"Libor": The London interbank offered rate for U.S. Dollars.

"<u>LIBOR</u>": (i) With respect to the Floating Rate Notes, Libor determined in accordance with <u>Exhibit C</u>, and (ii) with respect to Collateral Obligations or Eligible Investments, Libor determined under the related Underlying Instruments.

"LIBOR Floor Obligation": As of any date, a floating rate Collateral Obligation (a) for which the related Underlying Instruments allow a Libor rate option, (b) that provides that such Libor rate is (in effect) calculated as the greater of (i) a specified "floor" rate per annum and (ii) the London interbank offered rate for the applicable interest period for such Collateral Obligation and (c) that, as of such date, bears interest based on such Libor rate option, but only if as of such date Libor for the applicable interest period is less than such floor rate.

"<u>Listed Securities</u>": The Notes specified as such in <u>Section 2.3</u> and the Preferred Shares.

"London Banking Day": A day on which commercial banks are open for business (including dealings in foreign exchange and foreign currency deposits) in London, England.

"Maintenance Covenant": As of any date of determination, a covenant by the underlying obligor of a loan to comply with one or more financial covenants during each reporting period applicable to such loan, whether or not any action by, or event relating to, the underlying obligor occurs after such date of determination. Long-Dated Obligation": Any Collateral Obligation with an Underlying Asset Maturity after the Stated Maturity of the Secured Notes.

"Majority": With respect to any Class, the Holders of more than 50% of the Aggregate Outstanding Amount of the Securities of such Class.

"<u>Management Fees</u>": Collectively, the Senior Investment Management Fee, the Investment Manager Incentive Fee Amount and the Subordinated Investment Management Fee.

"Margin Stock": "Margin Stock" as defined under Regulation U issued by the Federal Reserve Board, including any debt security which is by its terms convertible into "Margin Stock."

"Market Value": With respect to any loans or other assets, the amount (determined by the Investment Manager) equal to the product of the principal amount thereof and the price determined in the following manner:

- (a) (a)—the quote determined by any of Loan Pricing Corporation, MarkIt Partners, IDC (with respect to bonds only) or any other nationally recognized loan pricing service selected by the Investment Manager, or
- (b) (b)—if such quote described in clause (a) is not available, the average of the bid-side quotes determined by three broker-dealers active in the trading of such asset that are Independent (with respect to each other and the Investment Manager); or
  - (i) (i) if only two such bids can be obtained, the lower of the bid-side quotes of such two bids; or
  - (ii) with respect to determining Market Value in connection with calculating the Adjusted Collateral Principal Amount only, if only one such bid can be obtained, such bid; provided that this subclause (B) shall not apply at any time at which the Investment Manager is not a registered investment adviser under the Investment Advisers Act; or

"Maximum Moody's Rating Factor Test": A test that will be satisfied on any date of determination if the Moody's Adjusted Weighted Average Rating Factor of the Collateral Obligations is less than or equal to the sum of (a) the Maximum Moody's Weighted Average Rating Factor in the Asset Quality Matrix Combination plus (b) the Moody's Weighted Average Recovery Adjustment.3300.

"Measurement Date": (a) Any day on which the Issuer purchases, or enters into a commitment to purchase, a Collateral Obligation or a default of a Collateral Obligation occurs, (b) any Determination Date, (c) the date as of which the information in any Monthly Report is calculated, (d) with five Business Days prior notice to the Collateral Administrator and the Investment Manager, any Business Day requested by S&P or Moody's if suchany Rating Agencyis then rating any Class of Outstanding Notes and , (e) the Effective Date and (f) the Refinancing Effective Date; provided that, in the case of (a) through (d), no Measurement Date can occur after the Amendment Date and prior to the Refinancing Effective Date.

"<u>Memorandum and Articles</u>": The Issuer's Memorandum and Articles of Association, as they may be amended, revised or restated from time to time.

"Merging Entity": The meaning specified in Section 7.10.

"Minimum Denomination": With respect to each Class of Notes, the following amounts; provided that interests in the Notes may be issued on the Amendment Date or issued or transferred after the Amendment Date to or from any Retention Holder in lower denominations to the extent such sale or transfer is being made in connection with the Investment Manager's compliance with the U.S. Risk Retention Regulations, if, with respect to any transfer from a Retention Holder to a non-Retention Holder, after giving effect thereto, the transferee owns at least the specified minimum of the Class being transferred:

"<u>Pledged Obligations</u>": As of any date of determination, the Collateral Obligations, the Eligible Investments and any Equity Security which forms part of the Assets that have been Granted to the Trustee.

"<u>Post-Acceleration Payment Date</u>": Any Business Day designated by the Trustee after the principal of the Secured Notes has been declared to be or has otherwise become immediately due and payable pursuant to <u>Section 5.2</u>; <u>provided</u> that such declaration has not been rescinded or annulled.

"<u>Post-Reinvestment Period Investment Criteria</u>": The meaning specified in Section 12.2(b).

<u>"Post Reinvestment Period Settlement Obligation"</u>: The meaning specified in Section 12.2(e).

"<u>Preferred Shares</u>": The Preferred Shares issued by the Issuer on the Closing Date and any additional Preferred Shares issued pursuant to the Memorandum and Articles and in compliance with the terms of this Indenture, all shown as issued and Outstanding in the Share Register.

"Preferred Shares Payment Account": An account established by the Fiscal Agent pursuant to the terms of the Fiscal Agency Agreement.

"Principal Balance": Subject to Section 1.2, with respect to any Pledged Obligation, as of any date of determination, the outstanding principal amount of such Pledged Obligation, including the funded and unfunded balance on any Revolving Collateral Obligation and Delayed Drawdown Collateral Obligation and excluding any capitalized or deferred interest; provided the Principal Balance of (i) any Equity Security, Margin Stock or Collateral Obligation that has been a Defaulted Obligation for three years or more shall be deemed to be zero, (ii) any Collateral Obligation that, at the time of its purchase by the Issuer, was subject to an offer for a price of less than its par amount, shall be, until the expiration of such offer in accordance with its terms, the offer price (expressed as a dollar amount) of such Collateral Obligation and (iii) any

revolving Collateral Obligation or Delayed Drawdown Collateral Obligation will not include the unfunded balance of such obligations for purposes of the calculation of any test or determination if amounts in the Unfunded Exposure Account are included in such calculation.

"Priority of Interest Proceeds": The meaning specified in Section 11.1(a)(i).

"Priority of Partial Redemption Proceeds": The meaning specified in Section 11.1(a)(iv).

"Priority of Payments": The meaning specified in Section 11.1(a).

"Priority of Principal Proceeds": The meaning specified in Section 11.1(a)(ii).

"Proceeding": Any suit in equity, action at law or other judicial or non-judicial enforcement or administrative proceeding.

"Proposed Portfolio": The portfolio of Collateral Obligations and Eligible Investments resulting from the proposed purchase, sale, maturity or other disposition of a Collateral Obligation or a proposed reinvestment in an additional Collateral Obligation, as the ease may be meaning specified in Schedule 5.

"Protected Purchaser": The meaning specified in Section 8-303 of the UCC.

"<u>Purchase Agreement</u>": The agreement dated as of the Closing Date between the Co-Issuers and Credit Suisse, as initial purchaser, as amended from time to time.

"QIB/QP": Any Person that, at the time of its acquisition, purported acquisition or proposed acquisition of Securities is both a Qualified Institutional Buyer and a Qualified Purchaser.

"Qualified Independent Fiduciary": A Person that is independent (within the meaning of 29 CFR 2510.3-21(c)(1)) of each of the Transaction Parties and their Affiliates and is one of the following: (a) a bank as defined in section 202 of the Investment Advisers Act or similar institution that is regulated and supervised and subject to periodic examination by a State or Federal agency, (b) an insurance carrier qualified under the laws of more than one State to perform the services of managing, acquiring or disposing of assets of a plan, (c) an investment adviser registered under the Investment Advisers Act or, if not registered an as investment adviser under the Investment Advisers Act by reason of paragraph (1) of section 203A of the Investment Advisers Act, is registered as an investment adviser under the laws of the State (referred to in such paragraph (1)) in which it maintains its principal office and place of business, (d) a broker-dealer registered under the Exchange Act, or (e) an independent fiduciary that holds, or has under management or control, total assets of at least \$50 million.

"S&P Additional Current Pay Criteria": Criteria satisfied with respect to any Collateral Obligation (a) if the issuer of such Collateral Obligation (other than a DIP Collateral Obligation) has made a Distressed Exchange Offer and the Collateral Obligation is already held by the Issuer and is subject to the Distressed Exchange Offer or ranks equal to or higher in priority than the obligation subject to the Distressed Exchange Offer and (b) such Collateral Obligation has a Market Value no less than 80% (determined under clause (i) or (ii) of the definition of Market Value. The meaning specified in Schedule 5.

"S&P Asset Specific Recovery Rating": With respect to any Collateral Obligation, the corporate recovery rating assigned by S&P (i.e., the S&P Recovery Rate) to such Collateral Obligation. The meaning specified in Schedule 5.

(with notice to the Collateral Administrator) in connection with the S&P CDO Monitor Test or (ii) in the event that no Weighted Average S&P Recovery Rate for such Class is selected by the Investment Manager (with notice to the Collateral Administrator) in connection with the S&P CDO Monitor Test, 43.73%.

"Share Exchange Rate": With respect to an exchange of interests in Preferred Shares being exchanged for interests in Subordinated Notes or interests in Subordinated Notes being exchanged for interests in Preferred Shares, \$1,000 of principal amount of Subordinated Notes is the equivalent of one Preferred Share.

"Share Register": The register of holders of Preferred Shares maintained on behalf of the Issuer.

"Share Registrar": The share registrar appointed by the Issuer pursuant to the Fiscal Agency Agreement.

"<u>Shareholder</u>": With respect to any Preferred Shares, the Person in whose name such Preferred Shares are registered in the Share Register.

"Similar Law": Any state, local or other law that is similar to Section 406 of ERISA or Section 4975 of the Code.

"Special Priority of Proceeds": The meaning specified in Section 11.1(a)(iii).

"Special Redemption": The meaning specified in Section 9.7.

"Special Redemption Amount": The meaning specified in Section 9.7.

"Special Redemption Date": The meaning specified in Section 9.7.

"Specified Amendment": With respect to any Collateral Obligation that is the subject of a rating estimate or a private or confidential rating by S&P, any waiver, modification, amendment or variance that would:

- (a) modify the amortization schedule with respect to such Collateral Obligation in a manner that:
  - (i) reduces the Dollar amount of any Scheduled Distribution by more than the greater of (x) 20% and (y) \$250,000;
  - (ii) postpones any Scheduled Distribution by more than two payment periods or eliminates a Scheduled Distribution; or
  - (iii) causes the Weighted Average Life of the applicable Collateral Obligation to increase by more than 10%;

- (b) reduce or increase the Cash interest rate payable by the obligor thereunder by more than 100 basis points (excluding any increase in an interest rate arising by operation of a default or penalty interest clause under a Collateral Obligation):
- (c) extend the stated maturity date of such Collateral Obligation by more than 24 months; provided, that (x) any such extension shall be deemed not to have been made until the Business Day following the original stated maturity date of such Collateral Obligation and (y) such extension shall not cause the Weighted Average Life of such Collateral Obligation to increase by more than 25%;
- (d) release any party from its obligations under such Collateral Obligation, if such release would have a material adverse effect on the Collateral Obligation;
  - (e) reduce the principal amount thereof; or
- (f) in the reasonable business judgment of the Investment Manager, have a material adverse impact on the value of such Collateral Obligation.

"Specified Event": With respect to any Collateral Obligation that is the subject of a rating estimate or a private or confidential rating by S&P and any DIP Collateral Obligation, the occurrence of any of the following events:

- (a) any failure of the obligor thereunder to pay interest on or principal of such Collateral Obligation when due and payable;
- (b) the rescheduling of the payment of principal of or interest on such Collateral Obligation or any other obligations for borrowed money of such obligor:
  - (c) the restructuring of any of the debt thereunder (including proposed debt):
  - (d) any significant sales or acquisitions of assets by the obligor;
- (e) the breach of any covenant of such Collateral Obligation or the reasonable determination by the Investment Manager that there is a greater than 50% chance that a covenant would be breached in the next six months;
- (f) the operating profit or cash flows of the obligor being more than 20% lower than the obligor's expected results:
- (g) the reduction or increase in the Cash interest rate payable by the obligor thereunder (excluding any increase in an interest rate arising by operation of a default or penalty interest clause under a Collateral Obligation):
  - (h) the extension of the stated maturity date of such Collateral Obligation; or
  - (i) the addition of payment-in-kind terms.

"Standby Directed Investment": The meaning specified in Section 10.5.

"Stated Maturity": With respect to (i) any security, the maturity date specified in such security or applicable Underlying Instrument and (ii) Notes of any Class, the date specified as such in Section 2.3.

"Step-Down Obligation": Any Collateral Obligation the Underlying Instruments of which contractually mandate decreases in coupon payments or spread over time (in each case other than decreases that are conditioned upon an improvement in the creditworthiness of the obligor or changes in a pricing grid or based on improvements in financial ratios or other similar coupon or spread-reset features).

"Step-Up Obligation": Any Collateral Obligation which provides for an increase, in the case of a Collateral Obligation which bears interest at a fixed rate, in the per annum interest rate on such Collateral Obligation or, in the case of a Collateral Obligation which bears interest at a floating rate, in the spread over that applicable index or benchmark rate, solely as a function of the passage of time.

"Structured Finance Obligation": Any obligation of a special purpose vehicle secured directly by, referenced to, or representing ownership of, a pool of receivables or other assets, including collateralized debt obligations and single-asset repackages.

"Subordinated Investment Management Fee": The fee payable to the Investment Manager in arrears on each Payment Date, including any Redemption Date (other than a Partial Redemption Date or a Re-Pricing Redemption Date that does not coincide with a Scheduled Payment Date), pursuant to the Investment Management Agreement and the Priority of Payments, in an amount equal to 0.35% per annum (calculated on the basis of a 360-day year and the actual number of days elapsed during the related Interest Accrual Period) of the Fee Basis Amount measured as of the first day of the Collection Period relating to each Payment Date.

"Subordinated Notes": The Subordinated Notes issued pursuant to this Indenture and having the characteristics specified in <u>Section 2.3</u>.

"Subordinated Securities": The Subordinated Notes and the Preferred Shares.

"Subordinated Securities Allocation": The allocation of Interest Proceeds or Principal Proceeds to Holders of Subordinated Notes and the Fiscal Agent (for payment to Shareholders in accordance with the Fiscal Agency Agreement) in the proportion that the Aggregate Outstanding Amount of the Subordinated Notes and Preferred Shares, respectively, bear to the Aggregate Outstanding Amount of the Subordinated Securities.

"Successor Entity": The meaning specified in Section 7.10(a).

"Supermajority": With respect to any Class, the Holders of at least 66• % of the Aggregate Outstanding Amount of the Securities of such Class.

"Synthetic Security": A security or swap transaction, other than a Participation Interest, that has payments associated with either payments of interest and/or principal on a reference obligation or the credit performance of a reference obligation.

"Target Return": With respect to any Payment Date, the amount that, together with all amounts paid to the Holders of the Subordinated Securities pursuant to the Priority of Payments prior to such Payment Date, would cause the Holders of the Subordinated Securities to first achieve an Internal Rate of Return of 12% on the Aggregate Outstanding Amount of Subordinated Securities issued on the Closing Date.

"<u>Tax</u>": Any present or future tax, levy, impost, duty, charge, assessment, deduction, withholding or fee of any nature (including interest, penalties and additions thereto) that is imposed by any government or other taxing authority other than a stamp, registration, documentation or similar tax.

"Tax Advice": Written advice from tax counsel of nationally recognized standing in the United States experienced in transactions of the type being addressed that (i) is based on knowledge by the person giving the advice of all relevant facts and circumstances of the Issuer and transaction (which are described in the advice or in a written description referred to in the advice which may be provided by the Issuer or Investment Manager), and (ii) is intended by the person rendering the advice to be relied upon by the Issuer in determining whether to enter into the transaction.

"Tax Event": An event that shall occur upon a change in or the adoption of any U.S. or non-U.S. tax statute or treaty, or any change in or the issuance of any regulation (whether final, temporary or proposed), ruling, procedure or any formal interpretation of any of the foregoing by a related governmental entity, which change, adoption or issuance results or will result in

- (a) any portion of any payment (other than a commitment fee or similar fee) due from any obligor under any Collateral Obligation becoming properly subject to the imposition of U.S. or foreign withholding tax, which withholding tax is not compensated for by a "gross-up" provision under the terms of such Collateral Obligation;
- (b) any jurisdiction's properly imposing net income, profits or similar tax on the Issuer;
- (c) any portion of any payment due under a Hedge Agreement by the Issuer becoming properly subject to the imposition of U.S. or foreign withholding tax, which withholding tax is compensated for by a "gross-up" provision under the terms of the Hedge Agreement; or
- (d) any portion of any payment due under a Hedge Agreement by a Hedge Counterparty becoming properly subject to the imposition of U.S. or foreign withholding tax, which withholding tax is not compensated for by a "gross-up" provision under the terms of the Hedge Agreement;

provided, that the total amount of (i) the tax or taxes imposed on the Issuer as described in clause (b) of this definition, (ii) the total amount withheld from payments to the Issuer which is not compensated for by a "gross-up" provision as described in clauses (a) and (d) of this definition and (iii) the total amount of any tax "gross-up" payments that are required to be made by the Issuer as described in clause (c) of this definition are determined to be in excess of 5.0% of the aggregate interest due and payable on the Collateral Obligations during the Collection Period.

Withholding taxes imposed under FATCA will be disregarded in applying the definition of Tax Event, except that a Tax Event will also occur if (i) aggregate FATCA Compliance Costs over the remaining period that any Securities would remain outstanding (disregarding any redemption of Securities arising from a Tax Event under this sentence), as reasonably estimated by the Issuer (or the Investment Manager acting on behalf of the Issuer) are expected to be incurred in excess of \$250,000 and (ii) any such withholding taxes are imposed (or are reasonably expected by the Issuer or the Investment Manager acting on its behalf to be imposed) in an aggregate amount in excess of \$500,000.

"Tax Jurisdiction": (a) One of the jurisdictions of A jurisdiction that is commonly used as the place of organization of special purpose vehicles (including, by way of example, the Bahamas, Bermuda, the British Virgin Islands, the Cayman Islands, the Channel Islands, Jersey, Singapore, the Netherlands Antilles Curacao, Ireland or the U.S. Virgin Islands, in each case so long as such jurisdiction is rated at least "AA" by S&P and "Aa2" by Moody's and (b) upon satisfaction of the Global Rating Agency Condition with respect to the treatment of another jurisdiction as a Tax Jurisdiction, such other jurisdictionand the U.S. Virgin Islands) (or such other countries as may be specified in publicly available published criteria from S&P).

"<u>Tax Redemption</u>": A redemption of the Securities in accordance with <u>Section</u> 9.4.

"Tax Subsidiary": The meaning specified in Section 7.16(k).

"<u>Tax Subsidiary Asset</u>": The meaning specified in <u>Section 7.16(m)</u>.

"Temporary Global Security": Any Security sold outside the United States to non-"U.S. persons" (as defined in Regulation S) in reliance on Regulation S and issued in the form of a temporary global security as specified in Section 2.2(b) in definitive, fully registered form without interest coupons substantially in the form set forth in the applicable Exhibit A hereto.

"Third Party Credit Exposure": As of any date of determination, the sum (without duplication) of the Principal Balance of each Collateral Obligation that is a Letter of Credit or a Participation Interest. Tested Items": The meaning specified in Section 7.17(c)(i).

"Third Party Credit Exposure Limits": Limits that shall be satisfied if the Third Party Credit Exposure with counterparties having the ratings below from S&P do not exceed the percentage of the Collateral Principal Amount specified below: ": The meaning specified in Schedule 5.

<u>"Total Obligor Indebtedness"</u>: With respect to any obligor and Collateral Obligation, the amount of total potential indebtedness (as determined by original or subsequent issuance size, at the time of purchase of such Collateral Obligation by the Issuer, whether drawn or undrawn) under all loan agreements, indentures, and other Underlying Instruments entered into directly or indirectly by such obligor; provided that any principal payments made in respect of such loan agreements, indentures and other Underlying Instruments will not be taken into account for purposes of determining such total potential indebtedness.

"<u>Transaction Documents</u>": Each of this Indenture, the Investment Management Agreement, the Fiscal Agency Agreement, the Collateral Administration Agreement, the Account Agreement, the Administration Agreement, the Registered Office Agreement and any Initial Hedge Agreements.

"<u>Transaction Parties</u>": The Issuer, the Co-Issuer, the Investment Manager, the Initial Purchaser, the Administrator, the Trustee, the Fiscal Agent and the Collateral Administrator.

"Transfer Agent": The Person or Persons, which may be the Issuer, authorized by the Issuer to exchange or register the transfer of Notes.

"Transfer Certificate": A duly executed certificate substantially in the form of the applicable Exhibit B.

"Trust Officer": When used with respect to the Trustee, any officer within the Corporate Trust Office (or any successor group of the Trustee) including any vice president, assistant vice president or officer of the Trustee customarily performing functions similar to those performed by the persons who at the time shall be such officers, respectively, or to whom any corporate trust matter is referred at the Corporate Trust Office because of such person's knowledge of and familiarity with the particular subject and in each case having direct responsibility for the administration of this Indenture.

"Trustee": As defined in the first sentence of this Indenture.

"<u>UCC</u>": The Uniform Commercial Code as in effect in the State of New York or, if different, the state of the United States that governs the perfection of the relevant security interest as amended from time to time.

"<u>Uncertificated Security</u>": The meaning specified in Section 8-102(a)(18) of the UCC.

"Underlying Asset Maturity": With respect to any Collateral Obligation, (x) the date on which such Collateral Obligation shall be deemed to mature (or its maturity date), which shall be the stated maturity of such Collateral Obligation or (y) if the Issuer has the right to require the issuer or obligor of such Collateral Obligation to purchase, redeem or retire such Collateral Obligation in full (at or above par) on any one or more dates prior to its stated maturity (a "put right") and the Investment Manager certifies to the Trustee that it has exercised such put right with respect to any such date, the maturity date shall be the date specified in such certification.

"<u>Underlying Instrument</u>": This Indenture or other agreement pursuant to which a Pledged Obligation has been issued or created and each other agreement that governs the terms of or secures the obligations represented by such Pledged Obligation or of which the holders of such Pledged Obligation are the beneficiaries.

"<u>Unfunded Exposure Account</u>": The account established pursuant to <u>Section</u> 10.3(f).

"<u>Unregistered Securities</u>": The meaning specified in <u>Section 5.17(c)</u>.

"Unsaleable Asset": (a) Any Defaulted Obligation (during the continuation of an Event of Default only), Equity Security, obligation received in connection with a tender offer, voluntary redemption, exchange offer, conversion, restructuring or plan of reorganization with respect to the obligor, or other exchange or any other security or debt obligation that is part of the Assets, in respect of which the Issuer has not received a payment in cash during the preceding 12 months or (b) any asset, claim or other property identified in a certificate of the Investment Manager as having a Market Value of less than \$1,000, in each case with respect to which the Investment Manager certifies to the Trustee that (x) it has made commercially reasonable efforts to dispose of such Collateral Obligation for at least 90 days and (y) in its commercially reasonable judgment such Collateral Obligation is not expected to be saleable for the foreseeable future.

"<u>Unscheduled Principal Payments</u>": Any principal payments received with respect to a Collateral Obligation as a result of optional redemptions, exchange offers, tender offers, consents or other payments or prepayments made at the option of the issuer thereof.

<u>"Unsecured Loan": Any assignment of, Participation Interest in or other interest in a senior unsecured loan which is not (and by its terms is not permitted to become) subordinate</u>

in right of payment to any other debt for borrowed money incurred by the obligor under such loan.

"<u>U.S. Dollar</u>" or "<u>\$</u>": A dollar or other equivalent unit in such coin or currency of the United States of America as at the time shall be legal tender for all debts, public and private.

"U.S. Person": The meaning specified in Section 7701(a)(30) of the Code.

"<u>U.S. person</u>": The meaning specified in Regulation S.

<u>"U.S. Risk Retention Regulations": Any requirement under Section 15G of the Exchange Act and the applicable rules and regulations.</u>

"Volcker Rule": Section 13 of the Bank Holding Company Act of 1956, as amended from time to time, and any applicable implementing regulations.

"Weighted Average Fixed Coupon": As of any Measurement Date, an amount equal to the number, expressed as a percentage, obtained by dividing:

- (a) (a)—the sum of (i) in the case of each fixed rate Collateral Obligation, the stated interest coupon on such Collateral Obligation times the Principal Balance of such Collateral Obligation (excluding any non-cash interest); *plus* (ii) to the extent that the amount obtained in clause (i) is insufficient to satisfy the Minimum Fixed Coupon Test, the Excess Weighted Average Floating Spread (if any); by
- (b) (b)—the Aggregate Principal Balance of the fixed rate Collateral Obligations as of such Measurement Date;

<u>provided</u> that in the case of each of the foregoing clauses (a) and (b), in calculating the Weighted Average Fixed Coupon in respect of any Step-Down Obligation, the coupon of such Collateral Obligation shall be the lowest permissible coupon pursuant to the Underlying Instruments of the Obligor of such Step-Down Obligation.

"Weighted Average Floating Spread": As of any Measurement Date, a fraction (expressed as a percentage) obtained by:

- (a) multiplying the Principal Balance of each floating rate Collateral Obligation held by the Issuer as of such Measurement Date by its Effective Spread;
- (b) (b) (1) summing the amounts determined pursuant to clause (a) and (2) adding thereto an amount (not less than zero) equal to the product of (x) LIBORthe Reference Rate for the Floating Rate Notes and (y) the amount, if any, by which the Aggregate Principal Balance of all floating rate Collateral Obligations exceeds the amount equal to the Reinvestment Target Par Balance minus the Aggregate Principal Balance of all fixed \_rate Collateral Obligations; and
- (c) (e)—dividing the sum determined pursuant to clause (b) by the lesser of (1) the sum of the Aggregate Principal Balance of all floating rate Collateral Obligations

held by the Issuer as of such Measurement Date and (2) the product of the Reinvestment Target Par Balance and a fraction, the numerator of which is the Aggregate Principal Balance of all floating rate Collateral Obligations and the denominator of which is the Aggregate Principal Balance of all Collateral Obligations; and

(d) if the result obtained in clause (c) is less than the minimum percentage necessary to pass the Minimum Floating Spread Test, adding to such sum the amount of the Excess Weighted Average Fixed Coupon, if any, as of such Measurement Date;

provided, that in calculating the Weighted Average Floating Spread (A), Defaulted Obligations will not be included, and (B); provided, further, that, for purposes of determining compliance with the S&P CDO Monitor, the amount Test, (x) the Weighted Average Floating Spread will be calculated by summing the amounts determined pursuant to clause (b)(2) will be deemed to be zero and the amount determined pursuant to clause (c)(1) will be deemed to be less than the amount determined pursuant to clause (c)(2)a) above and dividing by the sum of the Aggregate Principal Balance of all floating rate Collateral Obligations held by the Issuer as of such Measurement Date, and (y) if the Weighted Average Floating Spread as of any date of determination determined as provided above is less than the S&P CDO Monitor Weighted Average Floating Spread, an amount equal to the Excess Weighted Average Fixed Coupon, if any, as of such date will be added to the Weighted Average Floating Spread to the extent necessary to cause the Weighted Average Floating Spread to equal the S&P CDO Monitor Weighted Average Floating Spread.

"Weighted Average Life": As of any Measurement Date, with respect to each Collateral Obligation (other than any Defaulted Obligations), the number obtained by (i) summing the products obtained by multiplying (a) the Average Life at such time of each such Collateral Obligation by (b) the Aggregate Principal Balance of such Collateral Obligation and (ii) dividing such sum by the Aggregate Principal Balance at such time of all Collateral Obligations (excluding any Defaulted Obligations).

"Weighted Average Life Test": A test that will be satisfied on any date of determination if the Weighted Average Life of all Collateral Obligations as of such date is less than the number of years (rounded to the nearest one hundredth thereof) during the period from such date of determination to April 25, 2021. For the avoidance of doubt, the definition of Weighted Average Life Test" may not be modified without the prior written consent of the Majority of the Controlling Class. or equal to the greater of (i) zero and (ii) 9.0 years minus the full quarters elapsed since the Amendment Date. Quarter will mean 0.25 of a year.

"Weighted Average S&P Recovery Rate": The meaning specified in Schedule 5.

"Zero-Coupon Security": Any Collateral Obligation that at the time of purchase does not by its terms provide for the payment of cash interest; provided that if after such purchase such Collateral Obligation provides for the payment of cash interest, it will cease to be a Zero-Coupon Security.

Section 1.2 <u>Assumptions as to Pledged Obligations</u>. Unless otherwise specified, the assumptions described below (the "Collateral Assumptions") shall be applied in connection with all calculations required to be made pursuant to this Indenture with respect to

Scheduled Distributions on any Pledged Obligation, or any payments on any other assets included in the Assets, with respect to the sale of and reinvestment in Collateral Obligations, and with respect to the income that can be earned on Scheduled Distributions on such Pledged Obligations and on any other amounts that may be received for deposit in the Collection Account.

- (a) All calculations with respect to Scheduled Distributions on the Pledged Obligations shall be made on the basis of information as to the terms of each such Pledged Obligation and upon report of payments, if any, received on such Pledged Obligation that are furnished by or on behalf of the issuer of such Pledged Obligation and, to the extent they are not manifestly in error, such information or report may be conclusively relied upon in making such calculations.
- (b) For purposes of calculating the Coverage Tests, except as otherwise specified in the Coverage Tests, such calculations shall not include scheduled interest and principal payments on Defaulted Obligations unless or until such payments are actually made.
- (c) For each Collection Period and as of any date of determination, the Scheduled Distribution on any Pledged Obligation (other than a Defaulted Obligation, which, except as otherwise provided herein, shall be assumed to have a Scheduled Distribution of zero) shall be the sum of (i) the total amount of payments and collections to be received during such Collection Period in respect of such Pledged Obligation (including the proceeds of the sale of such Pledged Obligation received and, in the case of sales which have not yet settled, to be received during the Collection Period and not reinvested in additional Collateral Obligations or Eligible Investments or retained in the Collection Account for subsequent reinvestment pursuant to Section 12.2) that, if paid as scheduled, shall be available in the Collection Account at the end of the Collection Period and (ii) any such amounts received by the Issuer in prior Collection Periods that were not disbursed on a previous Payment Date.
- Obligation shall be assumed to be received on the applicable Due Date, and each such Scheduled Distribution shall be assumed to be immediately deposited in the Collection Account to earn interest at the Assumed Reinvestment Rate. All such funds shall be assumed to continue to earn interest until the date on which they are required to be available in the Collection Account for application, in accordance with the terms hereof, to payments of principal of or interest on the Notes or other amounts payable pursuant to this Indenture. For the avoidance of doubt, all amounts calculated pursuant to this Section 1.2(d) are estimates and may differ from the actual amounts available to make distributions hereunder, and no party shall have any obligation to make any payment hereunder due to the assumed amounts calculated under this Section 1.2(d) being greater than the actual amounts available. For purposes of the applicable determinations required by Section 10.6(b)(iv), Article XII and the definition of Interest Coverage Ratio, the expected interest on Secured Notes and floating rate Collateral Obligations shall be calculated using the then current interest rates applicable thereto.
- (e) References in <u>Section 11.1(a)</u> to calculations made on a "pro forma basis" shall mean such calculations after giving effect to all payments, in accordance with the Priority of

Payments described herein, that precede (in priority of payment) or include the clause in which such calculation is made.

- (f) For the purposes of calculating the Moody's Weighted Average Rating Factor, any Collateral Obligation that is a Defaulted Obligation shall be excluded.
- (g) For the purposes of calculating the Investment Manager Incentive Fee Amount Threshold, the purchase price of the Subordinated Securities issued on the Closing Date shall be deemed to be 100%.
- (h) Except as otherwise provided herein, Defaulted Obligations shall not be included in the calculation of the Collateral Quality Test.
- (i) For purposes of calculating all Concentration Limitations, in both the numerator and the denominator of any component of the Concentration Limitations, Defaulted Obligations shall be treated as having a principal balance equal to zero.
- (j) For purposes of calculating the Collateral Quality Test, DIP Collateral Obligations shallwill be treated as having an S&P Recovery Rate equal to the S&P Recovery Rate for Senior Secured Loans.
- (k) For purposes of calculating compliance with the Investment Criteria, upon the direction of the Investment Manager by notice to the Trustee and the Collateral Administrator, any Eligible Investment representing Principal Proceeds received upon the maturity, redemption, sale or other disposition of Collateral Obligations shall be deemed to have the characteristics of such Collateral Obligations until reinvested in additional Collateral Obligations. Such calculations shall be based upon the principal amount of such Collateral Obligations, except in the case of Defaulted Obligations and Credit Risk Obligations, in which case the calculations shall be based upon the Principal Proceeds received on the disposition or sale of such Defaulted Obligations or Credit Risk Obligations.
- (l) For purposes of calculating the Sale Proceeds of a Collateral Obligation in sale transactions, Sale Proceeds shall include any Principal Financed Accrued Interest received in respect of such sale.
- (m) For purposes of calculating elause (ivclauses (ii) and (iii) of the definition of Concentration Limitations, without duplication, the amounts on deposit in the Collection Account and the Ramp-Up Account (including Eligible Investments therein) representing Principal Proceeds shall each be deemed to be a floating rate Collateral Obligation that is a Senior Secured Loan.
  - (n)—For all purposes of this Indenture, (i) a Senior Secured Note shall be deemed to be a Moody's Senior Secured Loan if such Senior Secured Note, if it were a loan, would (A) meet the definition of Moody's Senior Secured Loan and (B) have a facility rating from Moody's not lower than such obligor's Moody's corporate family rating and (ii) a Senior Secured Note shall be deemed to be a Moody's Non-Senior Secured Loan if such Senior Secured Note, if it were a loan, would meet the definition of Moody's Non-Senior Secured Loan.

- (n) (o) Notwithstanding any other provision of this Indenture to the contrary, all monetary calculations under this Indenture shall be in U.S. Dollars.
- (o) (p)—Unless otherwise specified, any reference to the fee payable under Section 11.1 to an amount calculated with respect to a period at per annum rate shall be computed on the basis of a 360-day year of twelve 30-day months. Any fees applicable to periods shorter than or longer than a calendar quarter shall be prorated to the actual number of days within such period.
- (p) (q)—Unless otherwise specified, test calculations that evaluate to a percentage shall be rounded to the nearest ten-thousandth and test calculations that evaluate to a number shall be rounded to the nearest one-hundredth.
- (q) (r)-Unless otherwise specifically provided herein, all calculations required to be made and all reports which are to be prepared pursuant to this Indenture shall be made on the basis of the trade date.
- (r) (s) Determination of the purchase price of a Collateral Obligation shall be made independently each time such Collateral Obligation is purchased by the Issuer and pledged to the Trustee, without giving effect to whether the Issuer has previously purchased such Collateral Obligation (or an obligation of the related borrower or issuer).
- (s) (t) For purposes of the calculation of the Weighted Average Floating Spread, the Weighted Average Fixed Coupon and the Interest Coverage Test (and all interest-related component calculations of such calculations and tests, including when such a component calculation is calculated independently), a haircut of 30% the applicable tax rate shall be applied with respect to any Collateral Obligation (including, in the case of a floating rate Collateral Obligation, the applicable index) that has been held in a Tax Subsidiary longer than 15 Business Days. Any future anticipated tax liabilities with respect to an asset held by such Tax Subsidiary shall be excluded from the calculation of the Weighted Average Floating Spread, the Weighted Average Fixed Coupon and the Interest Coverage Test.
- (t) (u) If withholding tax is imposed on (x) the fees associated with any Letter of Credit or (y) commitment fees or other similar fees in respect of Revolving Collateral Obligations and Delayed Drawdown Collateral Obligations, the calculations of the Weighted Average Floating Spread will be made on a net basis after taking into account such withholding (with no credit being given for any amounts on deposit in the LC Reserve Account), unless the Obligor is required to make "gross-up" payments to the Issuer that cover the full amount of any such withholding tax on an after-tax basis pursuant to the Underlying Instrument with respect thereto.
- (u) (v) Any reference to <u>LIBORthe Reference Rate</u> applicable to any Note as of any Measurement Date during the first Interest Accrual Period shall mean <u>LIBORthe Reference Rate</u> for the relevant portion of the first Interest Accrual Period as determined on the preceding Interest Determination Date.

Section 1.3 Rules of Construction. The definitions of terms in Section 1.1 are equally applicable both to the singular and plural forms of such terms and to the masculine, feminine and neuter genders of such terms. The word "including" shall mean "including without limitation." All references in this Indenture to designated "Articles," "Sections," "Subsections" and other subdivisions are to the designated articles, sections, subsections and other subdivisions of this Indenture. The words "herein," "hereof," "hereunder" and other words of similar import refer to this Indenture as a whole and not to any particular article, section, subsection or other subdivision.

### **ARTICLE II**

#### THE NOTES

- Section 2.1 Forms Generally. The Notes and the Trustee's or Authenticating Agent's certificate of authentication thereon (the "Certificate of Authentication") shall be in substantially the forms required by this Article, with such appropriate insertions, omissions, substitutions and other variations as are required or permitted by this Indenture, and may have such letters, numbers or other marks of identification and such legends or endorsements placed thereon, as may be consistent herewith, determined by the Authorized Officers of the Applicable Issuers executing such Notes as evidenced by their execution of such Notes. Any portion of the text of any Note may be set forth on the reverse thereof, with an appropriate reference thereto on the face of the Note.
- Section 2.2 <u>Forms of Notes</u>. (a) The forms of the Notes will be as set forth in the applicable part of <u>Exhibit A</u> hereto.
- (b) Except for Certificated Securities, Notes offered to non-"U.S. persons" (as defined in Regulation S) in reliance on Regulation S will be issued as Temporary Global Securities (or, in the case of the Issuer Only Notes, Regulation S Global Securities) with the applicable legend set forth in the applicable Exhibit A added thereto, which will be deposited with the Trustee as custodian for DTC and registered in the name of a nominee of DTC for the respective accounts of Euroclear and Clearstream. On or after the 40th day after the later of the Closing Date or Amendment Date, as applicable, and the commencement of the offering of the Co-Issued Securities (the "Restricted Period"), interests in a Temporary Global Security of any Class of Co-Issued Securities will be exchangeable for interests in a Regulation S Global Security are owned by Persons who are not "U.S. persons" (as defined in Regulation S). Upon the exchange of a Temporary Global Security for a Regulation S Global Security, the Regulation S Global Security will be deposited with the Trustee as custodian for DTC and registered in the name of a nominee of DTC for the account of Euroclear and Clearstream.
- (c) Except for Certificated Securities, Notes sold to Qualified Institutional Buyers that are also Qualified Purchasers in reliance on Rule 144A will be issued initially in the form of one or more Rule 144A Global Securities with the applicable legend set forth in the applicable Exhibit A added thereto, which will be deposited with the Trustee as custodian for DTC and registered in the name of a nominee of DTC.
- (d) All Secured Notes sold in the United States to IAIs and all Subordinated Notes sold to Accredited Investors will be evidenced by Certificated Securities. In addition all Issuer Only Notes that are sold to Benefit Plan Investors or, except with respect to purchases by Controlling Persons on the Closing <u>Date or Amendment</u> Date, Controlling Persons will evidenced by Certificated Securities.

- (e) The aggregate principal amount of Global Securities may from time to time be increased or decreased by adjustments made on the records of the Trustee or DTC or its nominee, as the case may be, as hereinafter provided.
- (f) <u>Book Entry Provisions</u>. This <u>Section 2.2(f)</u> shall apply only to Global Securities deposited with or on behalf of DTC. Agent Members and owners of beneficial interests in Global Securities shall have no rights under this Indenture with respect to any Global Securities held by the Trustee, as custodian for DTC and DTC may be treated by the Co-Issuers, the Trustee, and any agent of the Co-Issuers or the Trustee as the absolute owner of such Note for purposes of this Indenture. Notwithstanding the foregoing, nothing herein shall prevent the Co-Issuers, the Trustee, or any agent of the Co-Issuers or the Trustee, from giving effect to any written certification, proxy or other authorization furnished by DTC or impair, as between DTC and its Agent Members, the operation of customary practices governing the exercise of the rights of a Holder of any Note.

## Section 2.3 <u>Authorized Amount; Stated Maturity; Denominations.</u>

(a) (a) The aggregate principal amount of Notes that may be authenticated and delivered under this Indenture is limited to U.S.\$470,250,000476,250,000 aggregate principal amount of Notes, (except for (i) Notes authenticated and delivered upon registration of transfer of, or in exchange for, or in lieu of, other Notes pursuant to Section 2.6, (ii) Deferred Interest, (iii) Additional Securities or (iv) Replacement Notes issued in connection with a Refinancing). A total principal amount of U.S.\$42,800,000,56,000,000 of Subordinated Notes authorized under this Indenture may be Outstanding to the extent all Preferred Shares have been exchanged for Subordinated Notes in accordance with Section 2.5. Such Notes shall be divided into the Classes, having the designations, original principal amounts and other characteristics as follows:

- (a) (a) At any time within the Reinvestment Period, as long as no Event of Default has occurred and is continuing (or, in the case of an issuance solely of additional Subordinated Notes and/or Junior Mezzanine Notes, at any time), subject to the written approval of (x) unless such issuance is a Risk Retention Issuance, a Majority of the Subordinated Securities and, (y) in the case of an additional issuance of Secured Notes, unless such issuance is a Risk Retention Issuance, a Majority of the Controlling Class and (z) the Investment Manager and, in the case of a Risk Retention Issuance of additional Subordinated Notes, so long as a Majority of the Subordinated Securities has not objected thereto, the Applicable Issuers may, pursuant to a supplemental indenture in accordance with Section 8.1 hereof, issue Additional Securities of each Class ((i) additional Notes of each Class of Notes, (ii) additional Subordinated Notes only, or (iii) additional Junior Mezzanine Notes (collectively, "Additional Securities").
- (b) The issuance of Additional Securities will be subject to the following conditions:
  - (i) in the case of an issuance of additional Notes of each Class of Notes, such issuance is on a pro rata basis with respect to each Class of Notes or on a pro rata basis for all Classes that are subordinate to the Class A-1 Notes, except, in each case, that (A) a larger proportion of Subordinated Notes may be issued and, (B) any Class may be issued as a component of a new class of combination security and the Issuer may issue additional preferred shares) up to an aggregate maximum(C) Pari Passu Classes will be

- (iv) (iix) in the proceedscase of anyan issuance of Additional Securities of a Class of one or more Secured Notes, the proceeds (net of fees and expenses incurred in connection with such issuance) shall be treated as Principal Proceeds or used to purchase additional Collateral Obligations, in accordance with the Indenture and (y) in the case of an issuance of additional Subordinated Notes and/or Junior Mezzanine Notes, the proceeds (net of fees and expenses incurred in connection with such issuance) may be treated as Principal Proceeds, Interest Proceeds or applied in accordance with any other Permitted Use;
- (v) (iii)—no Additional Security Securities will be senior to the Class A-1 Notes and unless such Additional Securities are being issued in connection with a Risk Retention Issuance, to the extent such issuance would be of additional Class A-1 Notes or any additional Class of Notes pari passu with the Class A-1 Notes, the prior written consent of a Supermajority Majority of the Class A-1 Notes shall have has been obtained:
- (vi) after giving effect to such issuance, (iv) the Overcollateralization Ratio with respect to each Class of Notes shall is not be reduced after giving effect to such issuance.
- an opinion of tax counsel of nationally recognized standing in the (vii) United States experienced in such matters shall be delivered to the Trustee, in form and substance satisfactory to the Trustee, to the effect that (A) such additional issuance shall not (1) result in the Issuer becoming subject to U.S. federal income taxation with respect to its net income, (2) result in the Issuer being treated as engaged in a trade or business within the United States to the effect that any additional Class A Notes, Class B Notes, Class C Notes and Class D Notes will be treated, and any additional Class E Notes should be treated, as indebtedness for U.S. federal income tax purposes or (3) have a material adverse effect on the tax treatment of the Issuer or the tax consequences to the holders of any Class of Notes, provided, however, that the opinion described in this clause will not be required with respect to any additional notes that bear a different CUSIP number (or equivalent identifier) from the Notes of the same Class that were issued on the Amendment Date and are Outstanding at the time of issuance, as described in the Offering Memorandum under "Certain U.S. Federal Income Tax Considerations," (B) such additional issuance shall not result in the holders or beneficial owners of Notes previously issued to be deemed to have sold or exchanged such Notes under Section 1001

of the Code, and (C) any additional Secured Notes would have the same U.S. federal income tax characterization as any Outstanding Secured Notes that are *pari passu* with such Additional Securities, the additional issuance;

- (viii) (vi)—such issuance is accomplished in a manner that allows the Independent accountants of the Issuer to accurately provide the tax information relating to original issue discount that this Indenture requires to be provided to the Holders of Secured Notes (including the Additional Securities); and
- (ix) (vii) an Officer's certificate of the Issuer shall be get delivered to the Trustee stating that the foregoing conditions of this Section 2.4(a(i) through (viii) have been satisfied.
- (c) (b) The terms and conditions of the Additional Securities of each Class issued pursuant to this Section 2.4 shall be identical to those of the initial Notes of that Class (except that the interest due on the Additional Securities that are Secured Notes shall accrue from the issue date of such Additional Securities and the interest rate of such Additional Securities may be lower (but not higher) than those of the initial Secured Notes of that Class). Interest on the Additional Securities that are Secured Notes shall be payable commencing on the first Payment Date following the issue date of such Additional Securities (if issued prior to the applicable Record Date). The Additional Securities shall rank pari passu in all respects with the initial Securities Notes of that Class.
- (d) (e) Any Except with respect to Notes issued in a Risk Retention Issuance to the Retention Holders, any Additional Securities of each Class issued pursuant to this Section 2.4 shall, to the extent reasonably practicable, be offered first to Holdersholders of that Class in such amounts as are necessary to preserve their *pro rata* holdings of Notes of such Class. Any additional Junior Mezzanine Notes of a class of Junior Mezzanine Notes that does not already exist shall, to the extent reasonably practicable, be offered first to the existing holders of Subordinated Securities in such amounts as are necessary to allow each such holder to purchase a share of such additional Junior Mezzanine Notes that is proportional to its then-current ownership of Subordinated Securities. Any holder of existing Notes that has not, within ten Business Days after delivery of such offer by or on behalf of the Issuer, accepted an offer required to be made by this paragraph shall be deemed to have declined to purchase the Additional Securities subject to such offer.

Section 2.5 <u>Execution, Authentication, Delivery and Dating</u>. The Notes shall be executed on behalf of each of the Applicable Issuers by one of their respective Authorized Officers. The signature of such Authorized Officer on the Notes may be manual or facsimile.

Notes bearing the manual or facsimile signatures of individuals who were at any time the Authorized Officers of the Issuer or the Co-Issuer, as applicable, shall bind the Issuer and the Co-Issuer, notwithstanding the fact that such individuals or any of them have ceased to hold such offices prior to the authentication and delivery of such Notes or did not hold such offices at the date of issuance of such Notes.

At any time and from time to time after the execution and delivery of this Indenture, the Issuer and the Co-Issuer may deliver Notes executed by the Applicable Issuers to the Trustee or the Authenticating Agent for authentication and the Trustee or the Authenticating Agent, upon Issuer Order, shall authenticate and deliver such Notes as provided in this Indenture and not otherwise.

Each Note authenticated and delivered by the Trustee or the Authenticating Agent upon Issuer Order on the Closing Date shall be dated as of the Closing Date. All other Notes that are authenticated after the Closing Date for any other purpose under this Indenture shall be dated the date of their authentication.

Notes issued upon transfer, exchange or replacement of other Notes shall be issued in Minimum Denominations reflecting the original Aggregate Outstanding Amount of the Notes so transferred, exchanged or replaced, but shall represent only the current Outstanding principal amount of the Notes so transferred, exchanged or replaced. In the event that any Note is divided into more than one Note in accordance with this <u>Article II</u>, the original principal amount of such Note shall be proportionately divided among the Notes delivered in exchange therefor and shall be deemed to be the original aggregate principal amount of such subsequently issued Notes.

No Note shall be entitled to any benefit under this Indenture or be valid or obligatory for any purpose, unless there appears on such Note a Certificate of Authentication, substantially in the form provided for herein, executed by the Trustee or by the Authenticating Agent by the manual signature of one of their Authorized Officers, and such certificate upon any Note shall be conclusive evidence, and the only evidence, that such Note has been duly authenticated and delivered hereunder.

For purposes of Cayman Islands law, an exchange of Subordinated Notes for Preferred Shares pursuant to Section 2.5(e)(x) will be effected by way of a redemption or repurchase of the applicable Subordinated Notes and the issuance of Preferred Shares in a number equivalent to the amount of Subordinated Notes being exchanged based on the Share Exchange Rate. The aggregate redemption and/or repurchase price for the Subordinated Notes will be deemed to be a price equal to the number of Preferred Shares issued in connection with such exchange. The Issuer's obligation to pay the redemption and/or repurchase price to the holder of the Subordinated Notes will be deemed to have been satisfied by way of set-off upon issuance of the Preferred Shares in a number equivalent to the amount of Subordinated Notes being exchanged based on the Share Exchange Rate. Any such redemption or repurchase will not be considered an Optional Redemption or a repurchase pursuant to Section 2.5(j) for purposes of this Indenture.

### Section 2.6 Registration, Registration of Transfer and Exchange.

(a) The Issuer shall cause to be kept a register (the "Register") at the Corporate Trust Office in which, subject to such reasonable regulations as it may prescribe, the Issuer shall provide for the registration of Notes and the registration of transfers of Notes. The Trustee is hereby initially appointed "Registrar" for the purpose of maintaining the Register and

registering Notes and transfers of such Notes. Upon any resignation or removal of the Registrar, the Issuer shall promptly appoint a successor.

If a Person other than the Trustee is appointed by the Issuer as Registrar, the Issuer shall give the Trustee prompt written notice of the appointment of a Registrar and of the location, and any change in the location, of the Register, and the Trustee shall have the right to inspect the Register at all reasonable times and to obtain copies thereof and the Trustee shall have the right to rely upon a certificate executed on behalf of the Registrar by an Officer thereof as to the names and addresses of the Holders of the Notes and the principal or face amounts and numbers of such Notes. Upon request at any time the Registrar shall provide to the Issuer, the Investment Manager, the Initial Purchaser or any Holder a current list of Holders as reflected in the Register.

Subject to this <u>Section 2.6</u>, upon surrender for registration of transfer of any Certificated Securities at the office or agency of the Co-Issuers to be maintained as provided in <u>Section 7.2</u>, the Applicable Issuers shall execute, and the Trustee shall authenticate and deliver, in the name of the designated transferee or transferees, one or more new Notes of any Minimum Denomination and of a like aggregate principal or face amount.

At the option of the Holder, Notes may be exchanged for Notes of like terms, in any Minimum Denominations and of like aggregate principal or face amount, upon surrender of the Certificated Securities to be exchanged at such office or agency. Whenever any Certificated NoteSecurity is surrendered for exchange, the Applicable Issuers shall execute, and the Trustee shall authenticate and deliver, the Certificated Securities that the Holder making the exchange is entitled to receive.

All Notes issued and authenticated upon any registration of transfer or exchange of Notes shall be the valid obligations of the Issuer and, solely in the case of the Co-Issued Securities, the Co-Issuer, evidencing the same debt and entitled to the same benefits under this Indenture as the Notes surrendered upon such registration of transfer or exchange.

Every Certificated Security presented or surrendered for registration of transfer or exchange shall be duly endorsed, or be accompanied by a written instrument of transfer in form satisfactory to the Registrar duly executed by the Holder thereof or such Holder's attorney duly authorized in writing, with such signature guaranteed by an "eligible guarantor institution" meeting the requirements of the Registrar, which requirements include membership or participation in Securities Transfer Agents Medallion Program ("STAMP") or such other "signature guarantee program" as may be determined by the Registrar in addition to, or in substitution for, STAMP, all in accordance with the Exchange Act.

No service charge shall be made to a Holder for any registration of transfer or exchange of Notes, but the Trustee may require payment of a sum sufficient to cover any tax or other governmental charge payable in connection therewith. The Trustee shall be permitted to request such evidence reasonably satisfactory to it documenting the identity and/or signature of the transferor and the transferee.

(b) (i)(i) No Note may be sold or transferred (including, without limitation, by pledge or hypothecation) unless such sale or transfer is exempt from the registration

requirements of the Securities Act, is exempt from the registration requirements under applicable state securities laws and will not cause either of the Co-Issuers or the pool of collateral to become subject to the requirement that it register as an investment company under the Investment Company Act.

- (iii) (ii) No Note may be offered, sold or delivered or transferred (including, without limitation, by pledge or hypothecation) except (i) to (A) a non-"U.S. person" (as defined under Regulation S) in accordance with the requirements of Regulation S, (B) a QIB/QP, (C) in the case of Secured Notes, an IAI/QP or (D) in the case of Subordinated Notes, an Accredited Investor that also either a Qualified Purchaser or a Knowledgeable Employee and (ii) in accordance with any applicable law.
- (iii) —No Note may be offered, sold or delivered (i) as part of the distribution by the Initial Purchaser at any time or (ii) otherwise until 40 days after the Closing Date or Amendment Date, as applicable, within the United States or to, or for the benefit of, "U.S. persons" (as defined in Regulation S) except in accordance with Rule 144A or an exemption from the registration requirements of the Securities Act, to Persons purchasing for their own account or for the accounts of one or more Qualified Institutional Buyers for which the purchaser is acting as a fiduciary or agent. The Notes may be sold or resold, as the case may be, in offshore transactions to non "U.S. persons" (as defined in Regulation S) in reliance on Regulation S. No Rule 144A Global Security may at any time be held by or on behalf of any Person that is not a QIB/QP, and no Temporary Global Security or Regulation S Global Security may be held at any time by or on behalf of any U.S. person. None of the Co-Issuers, the Trustee or any other Person may register the Notes under the Securities Act or any state securities laws or the applicable laws of any other jurisdiction.
- (iv) An interest in Subordinated Notes may be exchanged for an interest in Preferred Shares or an interest in Preferred Shares may be exchanged for an interest in Subordinated Notes at the Share Exchange Rate subject to the following conditions: (A) no Event of Default has occurred and is continuing; (B) the Issuer has consented to the exchange; (C) the exchange would not result in 25% or more of the Aggregate Outstanding Amount of the Preferred Shares or the Subordinated Shares being held by Benefit Plan Investors (determined in accordance with the Plan Asset Regulation and this Indenture or the Fiscal Agency Agreement, as applicable); and (D) the exchange would not result in the Preferred Shares or the Subordinated Notes being held in an amount less than the Minimum Denomination. The form of security (Certificated Security, Rule 144A Global Security or Regulation S Global Security) held by the holder of the interest after the exchange will be the same as the form held prior to the exchange.
- (c) (i)(i) No transfer of an interest in an Issuer Only Note to a proposed transferee that has represented that it is a Benefit Plan Investor or a Controlling Person will be effective, and the Trustee, the Registrar and the Applicable Issuer will not recognize any such transfer, if such transfer would result in Benefit Plan Investors holding 25% or more of the Aggregate Outstanding Amount of the Class of Issuer Only Notes determined in accordance with the Plan Asset Regulation and this Indenture, and assuming, for this purpose, that all of the representations made (or, in the case of Global Securities, deemed to be made) by Holders of

such Securities are true. For purposes of such calculation, (x) the investment by a Plan Asset Entity shall be treated as plan assets for purposes of calculating the 25% threshold in accordance with the Plan Asset Regulation only to the extent of the percentage of its equity interests held by Benefit Plan Investors and (y) any Issuer Only Notes held by a Controlling Person shall be excluded and treated as not being Outstanding. With respect to any interest in an Issuer Only Note that is purchased by a Controlling Person on the Closing Date or the Amendment Date and represented by a Global Security, if such Controlling Person notifies the Trustee that all or a portion of its interest in such Global Security has been transferred under Section 2.6 to a transferee that is not a Controlling Person, such transferred interest will no longer be excluded for the calculation of this clause (c)(i).

- (ii) (ii)—No transfer of a beneficial interest in a Note will be effective, and the Trustee and the Applicable Issuer will not recognize any such transfer, if the transferee's acquisition, holding and disposition of such interest would constitute or result in a prohibited transaction under Section 406 of ERISA or Section 4975 of the Code (or in a violation of any Similar Laws or other applicable law), unless an exemption is available and all conditions have been satisfied.
- (iii) In respect of the purchase of Issuer Only Notes, if the purchaser is a bank organized outside the United States, (x) it is acquiring such Notes as a capital markets investment and will not for any purpose treat such Notes or assets of the Issuer as loans acquired in its banking business, and (y) it is not acquiring such Notes as part of a plan having as one of its principal purposes the avoidance of U.S. withholding taxes.
- (d) The Trustee shall not be responsible for ascertaining whether any transfer complies with, or for otherwise monitoring or determining compliance with, the requirements or terms of the Securities Act, applicable state securities laws, ERISA, the Code or the Investment Company Act; except that if a certificate is specifically required by the terms of this Section 2.6 to be provided to the Trustee by a prospective transferor or transferee, the Trustee shall be under a duty to receive and examine the same to determine whether it conforms substantially on its face to the applicable requirements of this Section 2.6. Notwithstanding the foregoing, the Trustee, relying solely on representations made or deemed to have been made by Holders of Issuer Only Notes shall not permit any transfer of any Class of Issuer Only Notes if such transfer would result in a Benefit Plan Investor holding 25% or more of the Aggregate Outstanding Amount of the Class of Issuer Only Notes being transferred as calculated pursuant to the Plan Asset Regulation.
- (e) For so long as any of the Notes are Outstanding, the Issuer shall not issue or permit the transfer of any shares of the Issuer to U.S. Persons.
- (f) So long as a Global Security remains Outstanding and is held by or on behalf of DTC, transfers of such Global Security, in whole or in part, shall only be made in accordance with Section 2.2(f), this Section 2.6(f) and Section 2.6(g) and (h).
  - (i) Subject to clauses (ii) and (iii) of this <u>Section 2.6(f)</u>, transfers of a Global Security shall be limited to transfers of such Global Security in whole, but not in part, to nominees of DTC or to a successor of DTC or such successor's nominee.

- Rule 144A Global Security to Regulation S Global Security. If a holder of (ii) a beneficial interest in a Rule 144A Global Security wishes at any time to exchange its interest in such Rule 144A Global Security for an interest in the corresponding Regulation S Global Security, or to transfer its interest in such Rule 144A Global Security to a Person who wishes to take delivery thereof in the form of an interest in the corresponding Regulation S Global Security, such holder (provided that such holder or, in the case of a transfer, the transferee is not a U.S. person and is acquiring such interest in an offshore transaction) may, subject to the immediately succeeding sentence and the rules and procedures of DTC, exchange or transfer, or cause the exchange or transfer of, such interest for an equivalent beneficial interest in the corresponding Regulation S Global Security. Upon receipt by the Registrar of (A) instructions given in accordance with DTC's procedures from an Agent Member directing the Registrar to credit or cause to be credited a beneficial interest in the corresponding Regulation S Global Security, but not less than the Minimum Denomination applicable to such holder's Notes, in an amount equal to the beneficial interest in the Rule 144A Global Security to be exchanged or transferred, (B) a written order given in accordance with DTC's procedures containing information regarding the participant account of DTC and the Euroclear or Clearstream account to be credited with such increase and (C) a Transfer Certificate, then the Registrar shall implement the Global Security Procedures.
- Regulation S Global Security to Rule 144A Global Security. If a holder of (iii) a beneficial interest in a Regulation S Global Security deposited with DTC wishes at any time to exchange its interest in such Regulation S Global Security for an interest in the corresponding Rule 144A Global Security or to transfer its interest in such Regulation S Global Security to a Person who wishes to take delivery thereof in the form of an interest in the corresponding Rule 144A Global Security, such holder may, subject to the immediately succeeding sentence and the rules and procedures of Euroclear, Clearstream and/or DTC, as the case may be, exchange or transfer, or cause the exchange or transfer of, such interest for an equivalent beneficial interest in the corresponding Rule 144A Global Security. Upon receipt by the Registrar of (A) instructions from Euroclear, Clearstream and/or DTC, as the case may be, directing the Registrar to cause to be credited a beneficial interest in the corresponding Rule 144A Global Security in an amount equal to the beneficial interest in such Regulation S Global Security, but not less than the Minimum Denomination applicable to such holder's Notes to be exchanged or transferred, such instructions to contain information regarding the participant account with DTC to be credited with such increase and (B) a Transfer Certificate, then the Registrar shall implement the Global Security Procedures.
- (g) Transfers of Certificated Securities shall only be made in accordance with Section 2.2(b) and this Section 2.6(g).
  - (i) Transfer and Exchange of Certificated Securities to Certificated Securities. If a holder of a Certificated Security wishes at any time to exchange its interest in such Certificated Security for a Certificated Security or to transfer such Certificated Security to a Person who wishes to take delivery in the form of a Certificated Security, such holder may exchange or transfer its interest upon delivery of the documents set forth in the

following sentence. Upon receipt by the Registrar of (A) a Holder's Certificated Security properly endorsed for assignment to the transferee, and (B) a Transfer Certificate, the Registrar shall cancel such Certificated Security in accordance with Section 2.10, record the transfer in the Register in accordance with Section 2.6(a) and upon execution by the Applicable Issuers and authentication and delivery by the Trustee, deliver one or more Certificated Securities bearing the same designation as the Certificated Security endorsed for transfer, registered in the names specified in the assignment described in clause (A) above, in principal amounts designated by the transferee (the aggregate of such principal amounts being equal to the aggregate principal amount of the Certificated Security surrendered by the transferor), and in Minimum Denominations.

- (ii) Transfer of Global Securities to Certificated Securities. If a holder of a beneficial interest in a Global Security wishes at any time to exchange its interest in such Global Security for a Certificated Security or to transfer its interest in such Global Security to a Person who wishes to take delivery thereof in the form of a Certificated Security, such holder may, subject to the immediately succeeding sentence and the rules and procedures of Euroclear, Clearstream and/or DTC, as the case may be, exchange or transfer, or cause the exchange or transfer of, such interest for a Certificated Security. Upon receipt of (A) a Transfer Certificate executed by the transferee and (B) instructions from Euroclear, Clearstream and/or DTC, as the case may be, if required, the Registrar shall implement the Global Security Procedures and upon execution by the Applicable Issuers authenticate and deliver one or more Certificated Securities, registered in the names specified in the Transfer Certificate above, in principal amounts designated by the transferee (the aggregate of such principal amounts being equal to the aggregate principal amount of the interest in the Global Security transferred by the transferor), and in Minimum Denominations.
- Transfer of Certificated Securities to Regulation S Global Securities. If a holder of a Certificated Security wishes at any time to exchange its interest in such Certificated Security for a beneficial interest in a Regulation S Global Security or to transfer such Certificated Security to a Person who wishes to take delivery thereof in the form of a beneficial interest in a Regulation S Global Security, such holder may, subject to the immediately succeeding sentence and the rules and procedures of Euroclear, Clearstream and/or DTC, as the case may be, exchange or transfer, or cause the exchange or transfer of, such Certificated Security for beneficial interest in a Regulation S Global Security of the same Class. Upon receipt of (A) a Holder's Certificated Security properly endorsed for assignment to the transferee; (B) a Transfer Certificate executed by the transferor; (C) instructions given in accordance with Euroclear, Clearstream or DTC's procedures, as the case may be, from an Agent Member to instruct DTC to cause to be credited a beneficial interest in the Regulation S Global Securities in an amount equal to the Certificated Securities to be transferred or exchanged; and (D) a written order given in accordance with DTC's procedures containing information regarding the participant's account of DTC and/or Euroclear or Clearstream accounts to be credited with such increase, the Registrar shall implement the Global Security Procedures.
- (iv) <u>Transfer of Certificated Securities to Rule 144A Global Securities</u>. If a holder of a Certificated Security wishes at any time to exchange its interest in such

Security for a beneficial interest in a Rule 144A Global Security or to transfer such Security to a Person who wishes to take delivery thereof in the form of a beneficial interest in a Rule 144A Global Security, such holder may, subject to the immediately succeeding sentence and the rules and procedures of DTC, exchange or transfer, or cause the exchange or transfer of, such Note for a beneficial interest in a Rule 144A Global Note of the same Class. Upon receipt by the Registrar of (A) in the case of the Holder of a Certificated Security, such Holder's Certificated Security properly endorsed for assignment to the transferee, (B) a Transfer Certificate from the transferor, (C) instructions given in accordance with DTC's procedures from an Agent Member to instruct DTC to cause to be credited a beneficial interest in the Rule 144A Global Securities of the same Class in an amount equal to the Certificated Securities to be transferred or exchanged and (D) a written order given in accordance with DTC's procedures containing information regarding the participant's account at DTC to be credited with such increase, the Registrar shall implement the Global Security Procedures.

- (h) Exchange of a Beneficial Interest in Subordinated Notes for a beneficial interest in Preferred Shares. If a holder of a beneficial interest in Subordinated Notes held in the form of a Certificated Security, Rule 144A Global Security or Regulation S Global Security wishes at any time to exchange such Subordinated Notes for a beneficial interest in Preferred Shares held in the same form, such holder may exchange or cause the exchange of such interest for an equivalent interest based on the Share Exchange Rate (in at least a Minimum Denominations) in a Certificated Security, Rule 144A Global Security or Regulation S Global Security, respectively, but only upon delivery of the documents set forth in the following sentence. Upon receipt by the Registrar of:
  - (i) the Certificated Security endorsed for exchange, if applicable; and
  - (ii) a Subordinated Note Exchange Certificate;

the Registrar shall (x) implement the Global Security Procedures or cancel such Certificated Security or in the case of a partial exchange, issue a new Certificated Security for the principal amount of Subordinated Notes remaining, as applicable; (y) forward a copy of the Subordinated Note Exchange Certificate to the Issuer, the Fiscal Agent and the Share Registrar and request that the Fiscal Agent implement the applicable requirements of the Fiscal Agency Agreement and (z) upon notice from the Fiscal Agent that the interest in Preferred Shares has been issued, record the exchange in the Register.

(i) Exchange of a Beneficial Interest in Preferred Shares for a beneficial interest in Subordinated Notes. Upon receipt by the Registrar, the Trustee and the Issuer of (x) notice from the Fiscal Agent attaching a copy of the Share Exchange Certificate delivered under the Fiscal Agency Agreement for the exchange of a beneficial interest in Preferred Shares held in the form of a Certificated Security, Rule 144A Global Security or Regulation S Global Security for a beneficial interest in Subordinated Notes held in the same form, and (y) in the case of Global Securities, receipt by the Registrar of instructions given in accordance with the procedures of Euroclear, Clearstream or DTC, as the case may be, that contain information regarding the participant account to be credited with the interest in Subordinated Notes or, if

applicable receipt of the Certificated Security representing the Preferred Shares endorsed for exchange, the Registrar shall:

- (i) in the case of exchanges of interests in Global Securities, implement the Global Security Procedures with respect to the applicable Global Security; and
- (ii) in the case of exchanges of interests held in the form of Certificated Securities, record the exchange in the Register and the Trustee shall authenticate and deliver one or more Certificated Securities registered in the names and in the principal amounts (in Minimum Denominations and based on the Share Exchange Rate) designated by the holder in the Share Exchange Certificate.
- (j) If Notes are issued upon the transfer, exchange or replacement of Notes bearing the applicable legends set forth in the applicable part of Exhibit A hereto, and if a request is made to remove such applicable legend on such Notes, the Notes so issued shall bear such applicable legend, or such applicable legend shall not be removed, as the case may be, unless there is delivered to the Trustee and the Applicable Issuers such satisfactory evidence, which may include an Opinion of Counsel acceptable to them, as may be reasonably required by the Applicable Issuers (and which shall by its terms permit reliance by the Trustee), to the effect that neither such applicable legend nor the restrictions on transfer set forth therein are required to ensure that transfers thereof comply with the provisions of the Securities Act, the Investment Company Act, ERISA or the Code. Upon provision of such satisfactory evidence, the Trustee or its Authenticating Agent, at the written direction of the Applicable Issuers shall, after due execution by the Applicable Issuers authenticate and deliver Notes that do not bear such applicable legend.
- (k) Each Person who becomes a beneficial owner of Global Security shall be deemed to have represented and agreed as follows:
  - (i) If the Purchaser is purchasing an interest in Regulation S Global Securities, (i) the Purchaser understands that the Securities are offered to and purchased by it in an offshore transaction not involving any public offering in the United States, in reliance on the exemption from registration provided by Regulation S under the Securities Act, and that the Securities will not be registered under the U.S. federal securities laws and (ii) the Purchaser is not a U.S. person or U.S. resident for purposes of the Investment Company Act and understands that interests in a Regulation S Global Security may not be owned at any time by a U.S. person.
  - (ii) If the Purchaser is purchasing an interest in a Rule 144A Global Security, (i) the Purchaser understands that the Securities are offered to and purchased by it in a transaction not involving any public offering in the United States, in reliance on the exemption from registration provided by Rule 144A, and that the Securities will not be registered under the U.S. federal securities laws and (ii) the Purchaser is both a Qualified Institutional Buyer and a Qualified Purchaser.
  - (iii) Such beneficial owner's acquisition, holding and disposition of the Notes will not constitute or result in a prohibited transaction under Section 406 of ERISA or

Section 4975 of the Code (or in a violation of any Similar Laws or other applicable law) unless an exemption is available and all conditions have been satisfied. Such beneficial owner understands that the representations made in this clause will be deemed made on each day from the date of its acquisition through and including the date it disposes of such Notes.

If it is a Benefit Plan Investor, it (1) acknowledges and agrees that (i) none of the Transaction Parties nor any of their Affiliates has rendered or will render any investment advice (impartial or otherwise) or is otherwise undertaking to give any advice in a fiduciary capacity in connection with its acquisition of such Notes; and (ii) the Transaction Parties have financial interests in the offering and sale of the Notes which are disclosed in the Offering Memorandum or at the time of sale and (2) represents and warrants that (i) the Person making the investment decision on its behalf with respect to the acquisition and holding of the Notes is a Qualified Independent Fiduciary; (ii) the Qualified Independent Fiduciary is capable of evaluating investment risks independently, both in general and with regard to particular transactions and strategies, including the acquisition, holding and subsequent disposition of the Notes; (iii) the Qualified Independent Fiduciary is a fiduciary to it under ERISA or the Code, or both, with respect to the acquisition, holding and subsequent disposition of the Notes and is responsible for exercising independent judgment in evaluating such transactions; and (iv) no fee or other compensation is being paid directly to any of the Transaction Parties or their Affiliates by it or its Qualified Independent Fiduciary for investment advice (as opposed to other services) in connection with the acquisition and holding of the Notes; provided that if 29 CFR 2510.3-21(c)(1), as amended in 2016, is revoked, repealed or no longer effective, the foregoing representations shall be deemed to be no longer in effect.

- (iv) With respect to the purchase of interests in Issuer Only Notes, for so long as it holds a beneficial interest in such Notes, such beneficial owner is not a Benefit Plan Investor or, except with respect to purchases by Controlling Persons on the Closing Date or the Amendment Date, a Controlling Person. Such beneficial owner understands that interests in any Global Securities may not at any time be held by or on behalf of a Benefit Plan Investor or, except with respect to purchases by Controlling Persons on the Closing Date or the Amendment Date, a Controlling Person. The beneficial owner understands that the representations made in this clause will be deemed to be made on each day from the date of its acquisition through and including the date on which it disposes of such Notes.
- (v) Such beneficial owner understands that such Notes are being offered only in a transaction not involving any public offering in the United States within the meaning of the Securities Act, such Notes have not been and will not be registered under the Securities Act, and, if in the future such beneficial owner decides to offer, resell, pledge or otherwise transfer such Notes, such Notes may be offered, resold, pledged or otherwise transferred only in accordance with the provisions of this Indenture and the legend on such Notes. Such beneficial owner acknowledges that no representation has been made as to the availability of any exemption under the Securities Act or any state securities laws for resale of such Notes. Such beneficial owner understands that neither of the Co-Issuers has been registered under the Investment Company Act, and that the

Co-Issuers are exempt from registration as such by virtue of Section 3(c)(7) of the Investment Company Act.

- (vi) Such beneficial owner is aware that, except as otherwise provided in this Indenture, any Notes being sold to it in reliance on Regulation S will be represented by one or more Regulation S Global Securities, and that beneficial interests therein may be held only through DTC for the respective accounts of Euroclear or Clearstream.
- (vii) Such beneficial owner will provide notice to each person to whom it proposes to transfer any interest in the Notes of the transfer restrictions and representations set forth in this <u>Section 2.6</u>, including the Exhibits referenced herein.
- (viii) Such beneficial owner agrees that it will not cause the filing of a petition in bankruptcy against the Issuer, the Co-Issuer or any Tax Subsidiary prior to the date which is one year (or, if longer, the applicable preference period then in effect) plus one day after the payment in full of the Notes and payment of any amounts payable to the Fiscal Agent pursuant to the Indenture for distribution to Shareholders in accordance with the Fiscal Agency Agreement.
- (ix) Such beneficial owner understands that the Issuer may receive a list of participants holding positions in Notes from one or more book-entry depositories.
- (x) In the case of beneficial interests in an Issuer Only Note, if the beneficial owner is a bank organized outside the United States, such beneficial owner will be deemed to represent that (x) it is acquiring such Notes as a capital markets investment and will not for any purpose treat the assets of the Issuer as loans acquired in its banking business, and (y) it is not acquiring such Notes as part of a plan having as one of its principal purposes the avoidance of U.S. withholding taxes.
- (xi) Such beneficial owner, by acceptance of such Notes or such an interest in such Notes, agrees or is deemed to agree (i) the Issuer has the right to compel any beneficial owner of Secured Notes that does not consent to a Re-Pricing with respect to its Notes pursuant to the applicable terms of this Indenture to sell its interest in the Notes or may sell such interest in the Notes on behalf of such beneficial owner and (ii)(A) except as prohibited by applicable law, to obtain and provide the Issuer and the Trustee with information or documentation, and to update or correct such information or documentation, as may be necessary or helpful (in the sole determination of the Issuer or the Trustee or their agents, as applicable) to achieve FATCA Compliance (the obligations undertaken pursuant to this clause (A), the "Holder Reporting Obligations"), (B) that the Issuer and/or the Trustee may (1) provide such information and documentation and any other information concerning its investment in the Notes to the U.S. Internal Revenue Service and any other relevant tax authority, and (2) take such other steps as they deem necessary or helpful to achieve FATCA Compliance, including withholding on "passthru payments" (as defined in the Code) made to such beneficial owner or any agent or intermediary through which Notes are held, and (C) that if it fails for any reason to provide any such information or documentation described in clause (A), or such information or documentation is not accurate or complete, or the Issuer otherwise

reasonably determines that such beneficial owner's or subsequent transferee's direct or indirect acquisition, holding or transfer of an interest in such Note would cause the Issuer to be unable to achieve FATCA Compliance, the Issuer shall have the right, in addition to withholding on passthru payments to such beneficial owner or subsequent transferee or any agent or intermediary through which Notes are held, to (x) compel it to sell its interest in such Note, (y) sell such interest on its behalf, and/or (z) assign to such Note a separate CUSIP or CUSIPs.

- (xii) Such beneficial owner agrees to provide upon request certification acceptable to the Issuer or, in the case of the Co-Issued Securities, the Co-Issuers to permit the Issuer or the Co-Issuers, as applicable, to (A) make payments to it without, or at a reduced rate of, withholding and (B) qualify for a reduced rate of withholding in any jurisdiction from or through which the Issuer receives payments on its assets. Each purchaser has read the summary of the U.S. federal income tax considerations contained in the Offering Memorandum as it relates to the Notes, and it represents that it will treat the Notes for U.S. federal income tax purposes in a manner consistent with the treatment of such Notes by the Issuer described therein and will take no action inconsistent with such treatment.
- (xiii) Such beneficial owner acknowledges and agrees that the Issuer has the right to compel any Non-Permitted Holder to sell its interest in the Notes or may sell such interest in the Notes on behalf of such Non-Permitted Holder.
- (xiv) Such beneficial owner is not a member of the public in the Cayman Islands.
- (l) Each Person who becomes an owner of a Certificated Security will be required to provide a Transfer Certificate.
- (m) Any purported transfer of a Note not in accordance with this <u>Section 2.6</u> shall be null and void and shall not be given effect for any purpose whatsoever.
- (n) The Trustee, the Registrar and the Issuer shall be entitled to conclusively rely on any Transfer Certificate delivered pursuant to this <u>Section 2.6</u> and shall be able to presume conclusively the continuing accuracy thereof, in each case without further inquiry or investigation.
- Section 2.7 <u>Mutilated, Defaced, Destroyed, Lost or Stolen Note</u>. If (a) any mutilated or defaced Certificated Security is surrendered to a Transfer Agent, or if there shall be delivered to the Applicable Issuers, the Trustee and the relevant Transfer Agent evidence to their reasonable satisfaction of the destruction, loss or theft of any Note, and (b) there is delivered to the Applicable Issuers, the Trustee and such Transfer Agent, and any agent of the Applicable Issuers, the Trustee and such Transfer Agent, such security or indemnity as may be reasonably required by them to save each of them harmless, then, in the absence of notice to the Applicable Issuers, the Trustee or such Transfer Agent that such Note has been acquired by a Protected Purchaser, the Applicable Issuers shall execute and, upon Issuer Order, the Trustee shall authenticate and deliver, in lieu of any such mutilated, defaced, destroyed, lost or stolen Note, a

new Certificated Security, of like tenor (including the same date of issuance) and equal principal or face amount, registered in the same manner, dated the date of its authentication, bearing interest from the date to which interest has been paid on the mutilated, defaced, destroyed, lost or stolen Note and bearing a number not contemporaneously outstanding.

If, after delivery of such new Certificated Security, a Protected Purchaser of the predecessor Note presents for payment, transfer or exchange such predecessor Note, the Applicable Issuers, the Transfer Agent and the Trustee shall be entitled to recover such new Note from the Person to whom it was delivered or any Person taking therefrom, and shall be entitled to recover upon the security or indemnity provided therefor to the extent of any loss, damage, cost or expense incurred by the Applicable Issuers, the Trustee and the Transfer Agent in connection therewith.

In case any such mutilated, defaced, destroyed, lost or stolen Note has become due and payable, the Applicable Issuers in their discretion may, instead of issuing a new Note pay such Note without requiring surrender thereof except that any mutilated or defaced Note shall be surrendered.

Upon the issuance of any new Note under this <u>Section 2.7</u>, the Applicable Issuers, the Trustee or the applicable Transfer Agent may require the payment by the Holder thereof of a sum sufficient to cover any tax or other governmental charge that may be imposed in relation thereto and any other expenses (including the fees and expenses of the Trustee) connected therewith.

Every new Note issued pursuant to this <u>Section 2.7</u> in lieu of any mutilated, defaced, destroyed, lost or stolen Note shall constitute an original additional contractual obligation of the Applicable Issuers and such new Note shall be entitled, subject to the second paragraph of this Section 2.7, to all the benefits of this Indenture equally and proportionately with any and all other Notes of the same Class duly issued hereunder.

The provisions of this <u>Section 2.7</u> are exclusive and shall preclude (to the extent lawful) all other rights and remedies with respect to the replacement or payment of mutilated, defaced, destroyed, lost or stolen Notes.

Section 2.8 <u>Payment of Principal and Interest and Other Amounts; Principal and Interest Rights Preserved.</u>

(a) — The Secured Notes of each Class shall accrue interest during each Interest Accrual Period at the applicable Interest Rate and such interest shall be payable in arrears on each Payment Date in the case of the Secured Notes, on the Aggregate Outstanding Amount thereof on the first day of the related Interest Accrual Period (after giving effect to payments of principal thereof on such date). Payment of interest on each Class of Secured Notes (and payments of Interest Proceeds to the Holders of the Subordinated Securities) shall be subordinated to the payments of interest on the related Priority Classes. So long as any Priority Classes are Outstanding with respect to any Class of Deferred Interest Notes, any payment of interest due on such Class of Deferred Interest Notes which is not available to be paid in accordance with the Priority of Payments on any Payment Date, if such interest is not paid in

order to satisfy the Coverage Tests ("<u>Deferred Interest</u>" with respect thereto), shall not be considered due and payable for the purposes of <u>Section 5.1(a)</u> (and the failure to pay such interest shall not be an Event of Default) until the earliest of the Payment Date (i) on which such interest is available to be paid in accordance with the Priority of Payments, (ii) which is a Redemption Date with respect to such Class of Deferred Interest Notes, and (iii) which is the Stated Maturity of such Class of Deferred Interest Notes. Deferred Interest on any Class of Deferred Interest Notes will be added to the principal balance of such Class.

Interest shall cease to accrue on each Secured Note, or in the case of a partial repayment, on such part, from the date of repayment or the respective Stated Maturity unless payment of principal is improperly withheld or unless default is otherwise made with respect to such payments of principal. To the extent lawful and enforceable, (x) interest on Deferred Interest with respect to any Class of Deferred Interest Notes and (y) the interest on any Class A Note or, if no Class A Notes are Outstanding, the Controlling Class that is not paid when due and payable shall accrue at the Interest Rate for such Class until paid as provided herein.

Subordinated Notes will receive distributions of Interest Proceeds on each Payment Date in accordance with the Priority of Interest Proceeds; <u>provided</u> that any interest on the Subordinated Notes which is not available to be paid on a Payment Date in accordance with the Priority of Payments will not be payable on such Payment Date or any date and shall not be considered "due and payable" for purposes of this Indenture (and the failure to pay such interest will not be an Event of Default).

- Each Secured Note matures at par and is due and payable at the Stated (b) Maturity, unless such Note has been previously repaid or becomes due and payable at an earlier date by declaration of acceleration, redemption or otherwise. Prior to the Stated Maturity, principal shall be paid as provided in the Priority of Payments; provided that, except as otherwise provided in Article IX and the Priority of Payments, the payment of principal on each Secured Note (x) may only occur after each Priority Class is no longer Outstanding and (y) is subordinated to the payment on each Payment Date of the principal due and payable on each Priority Class and other amounts in accordance with the Priority of Payments. Subordinated Note will mature at the Stated Maturity, unless such Note has been previously repaid or becomes due and payable at an earlier date by declaration of acceleration, redemption or otherwise. Holders of Subordinated Notes will receive distributions of Principal Proceeds, if any, in accordance with the Priority of Principal Proceeds only after each Priority Class is paid in full. Any payment of principal of any Note which is not paid, in accordance with the Priority of Payments, on any Payment Date (other than the Stated Maturity or any Redemption Date), will not be considered "due and payable" for purposes of Section 5.1(a) until the Payment Date on which such principal may be paid in accordance with the Priority of Payments.
- (c) Principal payments on each Class of Notes shall be made in accordance with the Priority of Payments.
- (d) Payments made on the Subordinated Securities from Principal Proceeds will be characterized by the Issuer as principal payments and payments made on the Subordinated Securities from Interest Proceeds will be characterized by the Issuer as interest payments.

- (e) (d)—As a condition to payments on any Note without the imposition of withholding or back-up withholding tax, the Trustee and any Paying Agent shall require certification acceptable to it to enable the Issuer, the Co-Issuer, the Trustee and any Paying Agent to determine their duties and liabilities with respect to any taxes or other charges that they may be required to deduct or withhold from payments in respect of such Note under any present or future law or regulation of the United States and any other applicable jurisdiction, or any present or future law or regulation of any political subdivision thereof or taxing authority therein or to comply with any reporting or other requirements under any such law or regulation and the delivery of any information required under FATCA to determine if the Issuer is subject to withholding or payments by the Issuer are subject to withholding.
- (e) Payments in respect of any Note shall be made by the Trustee or by a Paying Agent in United States dollars to the Holder, by wire transfer, as directed by the Holder, in immediately available funds to a United States dollar account maintained by DTC or its nominee with respect to a Global Security, and to the Holder or its designee with respect to a Certificated Security, provided that in the case of a Certificated Security, the Holder thereof shall have provided written wiring instructions to the Trustee or the applicable Paying Agent, on or before the related Record Date; provided, further, that if appropriate instructions for any such wire transfer are not received by the related Record Date, then such payment shall be made by check drawn on a U.S. bank mailed to the address of the Holder specified in the Register. Upon final payment due on the Maturity of a Certificated Security, the Holder thereof shall present and surrender such Note to the office designated by the Trustee on or prior to such Maturity; provided, however, that if the Trustee and the Applicable Issuers shall have been furnished such security or indemnity as may be required by them to save each of them harmless and an undertaking thereafter to surrender such certificate, then, in the absence of notice to the Applicable Issuers or the Trustee that the applicable Note has been acquired by a bona fide purchaser, such final payment shall be made without presentation or surrender. Neither the Co-Issuers, the Trustee, the Investment Manager, nor any Paying Agent shall have any responsibility or liability for any aspects of the records maintained by DTC, Euroclear, Clearstream or any of the Agent Members relating to or for payments made thereby on account of beneficial interests in a Global Security. In the case where any final payment of principal and interest is to be made on any Secured Note (other than on the Stated Maturity thereof) or any final payment is to be made on any Subordinated Note (other than on the Stated Maturity thereof), the Trustee, in the name and at the expense of the Applicable Issuers shall, not more than 30 nor less than 10 days prior to the date on which such payment is to be made provide notice which shall specify the date on which such payment shall be made, the amount of such payment per U.S.\$100,000 original principal amount and the place where such Notes in the form of Certificated Securities may be presented and surrendered for such payment.
- (g) (f) Payments of principal to Holders of the Notes of each Class shall be made in the proportion that the Aggregate Outstanding Amount of the Notes of such Class registered in the name of each such Holder on the applicable Record Date bears to the Aggregate Outstanding Amount of all Notes of such Class on such Record Date.
- (h) (g)—Interest accrued with respect to the Floating Rate Notes will be calculated on the basis of the actual number of days elapsed in the applicable Interest Accrual

Period (or for the first Interest Accrual Period, the related portion thereof) <u>divided</u> by 360. Interest on the Fixed Rate Notes will be calculated on the basis of a 360-day year consisting of twelve 30-day months.

- (i) (h)—All reductions in the principal amount of a Note (or one or more predecessor Notes) effected by payments made on any Payment Date shall be binding upon all future Holders of such Note and of any Note issued upon the registration of transfer thereof or in exchange therefor or in lieu thereof, whether or not such payment is noted on such Note.
- (i) Notwithstanding any other provision of this Indenture, the obligations of the Co-Issuers under the Co-Issued Securities and this Indenture are limited recourse obligations of the Co-Issuers and the obligations of the Issuer under the Issuer Only Notes are limited recourse obligations of the Issuer, payable solely from the Assets and following realization of the Assets, and application of the proceeds thereof in accordance with this Indenture, all obligations of and any claims against the Co-Issuers (or, in the case of the Issuer Only Notes, the Issuer) hereunder or in connection herewith after such realization shall be extinguished and shall not thereafter revive. No recourse shall be had against any Officer, director, employee, shareholder or incorporator of either the Co-Issuers, the Investment Manager or their respective successors or assigns for any amounts payable under the Notes or (except as otherwise provided herein or in the Investment Management Agreement) this Indenture. It is understood that the foregoing provisions of this paragraph (j) shall not (x) prevent recourse to the Assets for the sums due or to become due under any security, instrument or agreement which is part of the Assets or (y) constitute a waiver, release or discharge of any indebtedness or obligation evidenced by the Notes or secured by this Indenture until such Assets have been realized. It is further understood that the foregoing provisions of this paragraph (j) shall not limit the right of any Person to name the Issuer or the Co-Issuer as a party defendant in any Proceeding or in the exercise of any other remedy under the Notes or this Indenture, so long as no judgment in the nature of a deficiency judgment or seeking personal liability shall be asked for or (if obtained) enforced against any such Person or entity.
- (k) (j)—Subject to the foregoing provisions of this <u>Section 2.8</u>, each Note delivered under this Indenture and upon registration of transfer of or in exchange for or in lieu of any other Note shall carry the rights of unpaid interest and principal (or other applicable amount) that were carried by such other Note.
- Section 2.9 <u>Persons Deemed Owners</u>. The Issuer, the Co-Issuer, the Trustee, and any agent of the Co-Issuers or the Trustee may treat as the owner of such Note the Person in whose name any Note is registered on the Register on the applicable Record Date for the purpose of receiving payments of principal of and interest on such Note and on any other date for all other purposes whatsoever (whether or not such Note is overdue), and neither the Issuer, the Co-Issuers nor the Trustee nor any agent of the Issuer, the Co-Issuers or the Trustee shall be affected by notice to the contrary.

### Section 2.10 Surrender of Notes; Cancellation.

(a) Notwithstanding anything herein to the contrary, no Note may be surrendered (including any surrender in connection with any abandonment) for any purpose other

than for payment in full, registration of transfer, exchange or redemption in accordance with Article IX, or for replacement in connection with any Note that is deemed lost or stolen.

(b) All Certificated Securities that are surrendered for payment, registration of transfer, exchange or redemption, or deemed lost or stolen, shall be promptly cancelled by the Trustee and may not be reissued or resold; provided that, in the event an anticipated Optional Redemption, Partial Redemption or Tax Redemption or Re-Pricing does not occur, Notes that are delivered in connection with such anticipated Optional Redemption shall be returned by the Trustee to the Person surrendering the same. Any such Notes shall, if surrendered to any Person other than the Trustee, be delivered to the Trustee. No Notes shall be authenticated in lieu of or in exchange for any Notes canceled as provided in this Section 2.10, except as expressly permitted by this Indenture. All canceled Notes held by the Trustee shall be destroyed by the Trustee in accordance with its standard policy, unless the Co-Issuers shall direct by an Issuer Order received prior to destruction that they be returned to it.

# Section 2.11 <u>DTC Ceases to be Depository</u>.

- shall be transferred in the form of a Certificated Security to the beneficial owners thereof only if such transfer complies with Section 2.6 and either (i) DTC notifies the Co-Issuers that it is unwilling or unable to continue as depository for such Global Security or (ii) at any time DTC ceases to be a Clearing Agency registered under the Exchange Act and, in each case, a successor depository is not appointed by the Co-Issuers within 90 days after such notice. In addition, the owner of a beneficial interest in a Global Security shall be entitled to receive a Certificated Security in exchange for such interest if an Event of Default has occurred and is continuing.
- (b) Any Global Security that is transferable in the form of a Certificated Security to the beneficial owners thereof pursuant to this Section 2.11 shall be surrendered by DTC to the Trustee's designated office located in the United States to be so transferred, in whole or from time to time in part, without charge, and the Applicable Issuers shall execute and the Trustee shall authenticate and deliver, upon such transfer of each portion of such Global Security, an equal aggregate principal amount of Certificated Securities in Minimum Denominations. Any Certificated Security delivered in exchange for an interest in a Global Security shall, except as otherwise provided by Section 2.6(i), bear the legends set forth in the applicable Exhibit A and shall be subject to the transfer restrictions referred to in such legends.
- (c) Subject to the provisions of paragraph (b) of this <u>Section 2.11</u>, the Holder of a Global Security may grant proxies and otherwise authorize any Person, including Agent Members and Persons that may hold interests through Agent Members, to take any action which a Holder is entitled to take under this Indenture or the Notes.
- (d) In the event of the occurrence of either of the events specified in subclauses (i) and (ii) of subsection (a) of this <u>Section 2.11</u>, the Co-Issuers shall promptly make available to the Trustee a reasonable supply of Certificated Securities.

In the event that Certificated Securities are not so issued by the Issuer to such beneficial owners of interests in Global Securities as required by <u>Section 2.11(a)</u>, the Issuer

expressly acknowledges that the beneficial owners shall be entitled to pursue any remedy that the Holder of a Global Security would be entitled to pursue in accordance with <u>Article V</u> of this Indenture (but only to the extent of such beneficial owner's interest in the Global Security) as if Certificated Securities had been issued. Neither the Trustee nor the Registrar shall be liable for any delay in the delivery of directions from DTC and may conclusively rely on, and shall be fully protected in relying on, such direction as to the names of beneficial owners in whose names such Certificated Securities shall be registered or as to delivery instructions for such Certificated Securities.

# Section 2.12 <u>Notes Beneficially Owned by Non-Permitted Holders.</u>

(a) (a) Notwithstanding anything to the contrary elsewhere in this Indenture, (x) any transfer of a beneficial interest in any Security to a U.S. person that is not (i) in the case of a Rule 144A Global Security, a QIB/QP, (ii) in the case of a Secured Note, an IAI/QP or a QIB/QP, or (iii) in the case of an Subordinated Note, a QIB/QP or an Accredited Investor that is also either a Qualified Purchaser or Knowledgeable Employee, and, in each case that is not made pursuant to an applicable exemption under the Securities Act and the Investment Company Act shall be null and void and any such purported transfer of which the Issuer, the Co-Issuer or the Trustee shall have notice may be disregarded by the Issuer, the Co-Issuer and the Trustee for all purposes.

If (a)(i) any U.S. person that is not a Qualified Institutional Buyer and a (b) Qualified Purchaser or that does not have an exemption available under the Securities Act and the Investment Company Act becomes the holder or beneficial owner of an interest in any Rule 144A Global Security, (ii) any U.S. person becomes the holder or beneficial owner of an interest in a Regulation S Global Security, or (iii) any U.S. person that is not (A) a Qualified Institutional Buyer and a Qualified Purchaser, (B) in the case of Secured Notes, an IAI that is also a Qualified Purchaser or (C) in the case of Subordinated Securities, an Accredited Investor that is also either a Qualified Purchaser or a Knowledgeable Employee becomes the holder or beneficial owner of a Certificated Security, or (b) any Non-Permitted ERISA Holder becomes a Holder or beneficial owner of a Security or (c) any holder of Securities fails to comply with the Holder Reporting Obligations or (d) any other Holder or beneficial owner if the Issuer reasonably determines that such Holder or beneficial owner's direct or indirect acquisition, holding or transfer of an interest in such Security would cause the Issuer to be unable to achieve FATCA Compliance (any such person a "Non-Permitted Holder"), the Issuer shall, promptly after discovery that such person is a Non-Permitted Holder by the Issuer, the Co-Issuer or the Trustee (and notice to the Issuer by the Trustee if a Trust Officer of the Trustee obtains actual knowledge or by the Co-Issuer if it makes the discovery), send notice to such Non-Permitted Holder demanding that such Non-Permitted Holder transfer its interest in the Securities held by such person to a Person that is not a Non-Permitted Holder within 30 days of the date of such notice. If such Non-Permitted Holder fails to so transfer Securities, the Issuer shall have the right, without further notice to the Non-Permitted Holder, to sell such Securities or interest in such Securities to a purchaser selected by the Issuer that is not a Non-Permitted Holder on such terms as the Issuer may choose. The Issuer, or the Investment Manager (on its own or acting through an investment bank selected by the Investment Manager at the Issuer's expense) acting on behalf of the Issuer, may select the purchaser by soliciting one or more bids from one or more brokers or other market professionals that regularly deal in securities similar to the Securities, and selling such Securities to the highest such bidder. However, the Issuer may select a purchaser by any other means determined by it in its sole discretion. The Holder of each Security, the Non-Permitted Holder and each other Person in the chain of title from the Holder to the Non-Permitted Holder, by its acceptance of an interest in the Securities, agrees to cooperate with the Issuer, the Investment Manager and the Trustee to effect such transfers. The proceeds of such sale, net of any commissions, expenses and taxes due in connection with such sale shall be remitted to the Non-Permitted Holder. The terms and conditions of any sale under this subsection shall be determined in the sole discretion of the Issuer, and the Issuer shall not be liable to any Person having an interest in the Securities sold as a result of any such sale or the exercise of such discretion.

Section 2.13 Deduction or Withholding from Payments on Notes; No Gross Up. If the Issuer is required to deduct or withhold Tax from, or with respect to, payments to any Holder of the Notes, then the Trustee or other Paying Agent, as applicable, shall deduct, or withhold, the amount required to be deducted or withheld and remit to the relevant authority such amount. Without limiting the generality of the foregoing, the Issuer may withhold any amount that it determines is required to be withheld from any amounts otherwise distributable to any holder of a Security. The Issuer shall not be obligated to pay any additional amounts to the Holders or beneficial owners of the Notes as a result of any withholding or deduction for, or on account of, any Tax imposed on payments in respect of the Notes. The amount of any withholding tax or deduction with respect to any Holder shall be treated as cash distributed to such Holder at the time it is withheld or deducted by the Trustee or Paying Agent and remitted to the appropriate taxing authority.

Section 2.14 Repurchase of Notes. The Co-Issuers are not permitted to repurchase any Notes from any Holder.

#### **ARTICLE III**

#### CONDITIONS PRECEDENT

- Section 3.1 <u>Conditions to Issuance of Notes on Closing Date.</u>
- (a) (a) The Notes to be issued on the Closing Date shall be executed by the Applicable Issuers and delivered to the Trustee for authentication and thereupon the same shall be authenticated and delivered by the Trustee upon Issuer Order and upon receipt by the Trustee of the followingOn the Closing Date, the Trustee received the following in satisfaction of the conditions precedent to the issuance of the Notes:
  - (i) Officers' Certificates of the Co-Issuers Regarding Corporate Matters. An Officer's certificate of each of the Co-Issuers (A) evidencing the authorization by Resolution of the execution and delivery of this Indenture, the Purchase Agreement and, in the case of the Issuer, the Investment Management Agreement, the Fiscal Agency Agreement, the Collateral Administration Agreement, any Hedge Agreements and related transaction documents and in each case the execution, authentication and delivery of the Notes applied for by it and specifying the principal amount of each Class of Notes to be authenticated and delivered and, in the case of the Issuer, the Preferred Shares, (B) in the case of the Issuer, certifying that the Preferred Shares have been issued and (C) certifying that (1) the attached copy of the Resolution is a true and complete copy thereof, (2) such Resolutions have not been rescinded and are in full force and effect on and as of the Closing Date and (3) the Officers authorized to execute and deliver such documents hold the offices and have the signatures indicated thereon.
  - (ii) Governmental Approvals. From each of the Co-Issuers either (A) a certificate of the Applicable Issuer or other official document evidencing the due authorization, approval or consent of any governmental body or bodies, at the time having jurisdiction in the premises, together with an Opinion of Counsel of such Applicable Issuer that no other authorization, approval or consent of any governmental body is required for the performance by the Applicable Issuer of its obligations under the Transaction Documents or (B) an Opinion of Counsel of the Applicable Issuer that no such authorization, approval or consent of any governmental body is required for the performance by the Applicable Issuer of its obligations under the Transaction Documents except as has been given.
  - (iii) <u>U.S. Counsel Opinions</u>. Opinions of Cleary Gottlieb Steen & Hamilton LLP, special U.S. counsel to the Co-Issuers, and of internal counsel to the Investment Manager, in each case dated the Closing Date, in form and substance satisfactory to the Issuer.
  - (iv) <u>Cayman Counsel Opinion</u>. An opinion of Maples and Calder, Cayman Islands counsel to the Issuer, dated the Closing Date, in form and substance satisfactory to the Issuer.

- (v) Officers' Certificates of Co-Issuers. An Officer's certificate of each of the Co-Issuers stating that the Applicable Issuer is not in default under this Indenture and that the issuance of the Notes applied for by it and, in the case of the Issuer, the issuance of the Preferred Shares, shall not result in a default or a breach of any of the terms, conditions or provisions of, or constitute a default under, its organizational documents, any indenture or other agreement or instrument to which it is a party or by which it is bound, or any order of any court or administrative agency entered in any Proceeding to which it is a party or by which it may be bound or to which it may be subject; that all conditions precedent provided in this Indenture relating to the authentication and delivery of the Notes applied for by it have been complied with; and that all expenses due or accrued with respect to the Offering or relating to actions taken on or in connection with the Closing Date have been paid or reserves therefor have been made. The Officer's certificate of the Issuer shall also state that all of its representations and warranties contained herein are true and correct as of the Closing Date.
- (vi) <u>Hedge Agreements</u>. Executed copies of any Hedge Agreement entered into by the Issuer, if any.
- (vii) <u>Investment Management, Collateral Administration, Account and Administration Agreements</u>. An executed counterpart of the Investment Management Agreement, the Collateral Administration Agreement, the Account Agreement and the Administration Agreement.
- (viii) <u>Certificate of the Investment Manager</u>. An Officer's certificate of the Investment Manager, dated as of the Closing Date, to the effect that, to the best knowledge of the Investment Manager:
  - (A) the Issuer owns or has entered into commitments to purchase Collateral Obligations with an aggregate par amount of at least U.S.\$ 292,500,000 as of the Closing Date; and
  - (B) each such Collateral Obligation satisfies the requirements of the definition of Collateral Obligation.
- (ix) <u>Grant of Collateral Obligations</u>. The Grant pursuant to the Granting Clause of this Indenture of all of the Issuer's right, title and interest in and to the Collateral Obligations on the Closing Date and Delivery of such Collateral Obligations (including any promissory note and all other Underlying Instruments related thereto to the extent received by the Issuer) as contemplated by <u>Section 3.3</u>.
- (x) <u>Certificate of the Issuer Regarding Assets</u>. A certificate of an Authorized Officer of the Issuer, dated as of the Closing Date, to the effect that, in the case of each Collateral Obligation pledged to the Trustee for inclusion in the Assets on the Closing Date and immediately prior to the Delivery thereof on the Closing Date:
  - (A) the Issuer is the owner of such Collateral Obligation free and clear of any liens, claims or encumbrances of any nature whatsoever except for (i) those

which are being released on the Closing Date and (ii) those Granted or permitted pursuant to this Indenture;

- (B) the Issuer has acquired its ownership in such Collateral Obligation in good faith without notice of any adverse claim (as such term is defined in Section 8-102(a)(1) of the UCC), except as described in paragraph (A) above;
- (C) the Issuer has not assigned, pledged or otherwise encumbered any interest in such Collateral Obligation (or, if any such interest has been assigned, pledged or otherwise encumbered, it has been released or is being released on the Closing Date) other than interests Granted pursuant to this Indenture;
- (D) the Issuer has full right to Grant a security interest in and assign and pledge such Collateral Obligation to the Trustee;
- (E) based on the certificate of the Investment Manager delivered pursuant to <u>Section 3.1(a)(viii)</u>, the information with respect to such Collateral Obligation is correct;
- (F) based on the certificate of the Investment Manager delivered pursuant to Section 3.1(a)(viii), each Collateral Obligation included in the Assets satisfies the requirements of the definition of Collateral Obligation and of Section 3.1(a)(ix); and
- (G) upon Grant by the Issuer, the Trustee has a first priority perfected security interest in the Collateral Obligations and other Assets, except as permitted by this Indenture.
- (xi) <u>Rating Letters</u>. A letter signed by each Rating Agency assigning to each Class of Secured Notes its Initial Rating.
  - (xii) <u>Accounts</u>. Evidence of the establishment of each of the Accounts.
- (xiii) <u>Preferred Shares</u>. Copies of the certificates representing the Preferred Shares.
- (xiv) Other Documents. Such other documents as the Trustee may reasonably require; *provided* that nothing in this clause (xiii) shall imply or impose a duty on the part of the Trustee to require any other documents reasonably required.
- (b) In connection with the execution by the Applicable Issuers of the Notes to be issued on the Closing Date, the Trustee shall deliverdelivered to the Applicable Issuers an opinion of Nixon Peabody LLP, counsel to the Trustee, dated the Closing Date, in form and substance satisfactory to the Applicable Issuers.

#### Section 3.2 Conditions to Issuance of Additional Securities.

- (a) Additional Securities to be issued on an Additional Securities Closing Date pursuant to Section 2.4 may be executed by the Applicable Issuers and delivered to the Trustee for authentication and thereupon the same shall be authenticated and delivered to the Issuer by the Trustee upon Issuer Order, upon compliance with clauses (ix) and (x) of Section 3.1(a) (with all references therein to the Closing Date being deemed to be the applicable Additional Securities Closing Date) and upon receipt by the Trustee of the following:
  - (i) Officers' Certificates of the Co-Issuers Regarding Corporate Matters. An Officer's certificate of each of the Co-Issuers (1) evidencing the authorization by Resolution of the execution and delivery of a supplemental indenture relating to an additional issuance and the execution, authentication and delivery of the Additional Securities applied for by it and the principal amount of each Class of such Additional Securities that are Secured Notes and the principal amount of the Subordinated Notes to be authenticated and delivered, (2) certifying that the issuance of additional Preferred Shares (if any) is in accordance with the terms of the Memorandum and Articles and (3) certifying that (a) the attached copy of such Resolution is a true and complete copy thereof, (b) such Resolutions have not been rescinded and are in full force and effect on and as of the Additional Securities Closing Date and (c) the Officers authorized to execute and deliver such documents hold the offices and have the signatures indicated thereon.
  - (ii) <u>Governmental Approvals</u>. From each of the Co-Issuers either (A) a certificate of the Applicable Issuer or other official document evidencing the due authorization, approval or consent of any governmental body or bodies, at the time having jurisdiction in the premises, together with an Opinion of Counsel of such Applicable Issuer to the effect that no other authorization, approval or consent of any governmental body is required for the valid issuance of such Additional Securities, or (B) an Opinion of Counsel of the Applicable Issuer to the effect that no such authorization, approval or consent of any governmental body is required for the valid issuance of such Additional Securities except as have been given (provided that the opinions delivered pursuant to Section 3.2(iii) may satisfy the requirement).
  - (iii) <u>U.S. Counsel Opinions</u>. Opinions of special U.S. counsel to the Co-Issuers or other counsel acceptable to the Trustee, dated the Additional Securities Closing Date, in form and substance satisfactory to the Issuer and the Trustee.
  - (iv) <u>Cayman Counsel Opinion</u>. An opinion of counsel to the Issuer, or other counsel acceptable to the Trustee, dated the Additional Securities Closing Date, in form and substance satisfactory to the Issuer.
  - (v) <u>Officers' Certificates of Co-Issuers Regarding Indenture</u>. An Officer's certificate of each Co-Issuer stating that the Applicable Issuer is not in default under this Indenture and that the issuance of the Additional Securities applied for by it shall not result in a default or a breach of any of the terms, conditions or provisions of, or

constitute a default under, its organizational documents, any indenture or other agreement or instrument to which it is a party or by which it is bound, or any order of any court or administrative agency entered in any Proceeding to which it is a party or by which it may be bound or to which it may be subject; that all conditions precedent provided in this Indenture and the supplemental indenture relating to the authentication and delivery of the Additional Securities applied for have been complied with and that the authentication and delivery of the Additional Securities is authorized or permitted under this Indenture and the supplemental indenture entered into in connection with such Additional Securities; and that all expenses due or accrued with respect to the Offering of the Additional Securities or relating to actions taken on or in connection with the Additional Securities Closing Date have been paid or reserved. The Officer's certificate of the Issuer shall also state that all of its representations and warranties contained herein are true and correct as of the Additional Securities Closing Date.

- (vi) <u>Irish Listing</u>. If the Additional Securities are of a Class of Listed Securities, an Officer's certificate of the Issuer to the effect that application will be made to list such Additional Securities on the Irish Stock Exchange.
- (vii) Rating Agencies. To the extent required by Section 2.4, evidence that the Moody's Rating Condition or S&P Rating Condition has been satisfied, or rating have been assigned, with respect to such issuance of Additional Securities Evidence that the condition set forth in Section 2.4(b) with respect to each Rating Agency has been satisfied.
- (viii) <u>Preferred Shares</u>. Copies of\_certificates representing the additional Preferred Shares (if any).
- (ix) <u>Other Documents</u>. Such other documents as the Trustee may reasonably require; <u>provided</u> that nothing in this clause (ix) shall imply or impose a duty on the Trustee to so require any other documents.

Prior to any Additional Securities Closing Date, the Trustee shall provide to the Holders notice of such issuance of Additional Securities as soon as reasonably practicable but in no case less than 15 days prior to the Additional Securities Closing Date; provided, that the Trustee shall receive such notice at least two Business Days prior to the 15<sup>th</sup> day prior to such Additional Securities Closing Date. On or prior to any Additional Securities Closing Date, the Trustee shall provide to the Holders copies of any supplemental indentures executed as part of such issuance.

# Section 3.3 <u>Custodianship</u>; <u>Delivery of Collateral Obligations and Eligible</u> <u>Investments.</u>

(a) Except as otherwise provided in this Indenture, the Trustee shall hold all Collateral Obligations purchased in accordance with this Indenture in the relevant Account established and maintained pursuant to Article X, as to which in each case the Trustee shall have entered into an Account Agreement, providing, inter alia, that the establishment and maintenance of such Account will be governed by the law of a jurisdiction satisfactory to the Issuer and the Trustee.

causes the acquisition of any Collateral Obligation, Eligible Investment or other investment, the Investment Manager (on behalf of the Issuer) shall, if the Collateral Obligation, Eligible Investment or other investment is required to be, but has not already been, transferred to the relevant Account, cause the Collateral Obligation, Eligible Investment or other investment to be Delivered to the Intermediary to be held in the Custodial Account (or in the case of any such investment that is not a Collateral Obligation, in the Account in which the funds used to purchase the investment are held in accordance with Article X) for the benefit of the Trustee in accordance with this Indenture. The security interest of the Trustee in the funds or other property used in connection with the acquisition shall, immediately and without further action on the part of the Trustee, be released. The security interest of the Trustee shall nevertheless come into existence and continue in the Collateral Obligation, Eligible Investment or other investment so acquired, including all interests of the Issuer in any contracts related to and proceeds of such Collateral Obligation, Eligible Investment or other investment.

#### **ARTICLE IV**

#### SATISFACTION AND DISCHARGE

Section 4.1 Satisfaction and Discharge of Indenture. This Indenture will be discharged and shall cease to be of further effect except as to (i) rights of registration of transfer and exchange, (ii) substitution of mutilated, defaced, destroyed, lost or stolen Notes, (iii) rights of Holders of Secured Notes to receive payments of principal thereof and interest that accrued prior to Maturity (and to the extent lawful and enforceable, interest on due and unpaid accrued interest) thereon and the Subordinated Securities to receive distributions as provided for under the Priority of Payments, subject to Section 2.8(i), (iv) the rights, obligations and immunities of the Investment Manager hereunder and under the Investment Management Agreement and of the Collateral Administrator under the Collateral Administration Agreement, (v) the rights of Holders as beneficiaries hereof with respect to the property deposited with the Trustee and payable to all or any of them (subject to Section 2.8(i)) and (vi) the rights and immunities of the Trustee hereunder, and the obligations of the Trustee hereunder in connection with the foregoing clauses (i) through (v) and otherwise under this Article IV (and the Trustee, on demand of and at the expense of the Issuer, shall execute proper instruments acknowledging satisfaction and discharge of this Indenture) when:

#### (a) (x) either:

- (i) all Notes theretofore authenticated and delivered to Holders (other than (A) Notes which have been mutilated, defaced, destroyed, lost or stolen and which have been replaced or paid as provided in <u>Section 2.7</u> or, (B) Notes for whose payment Money has theretofore irrevocably been deposited in trust and thereafter repaid to the Issuer or discharged from such trust, as provided in <u>Section 7.3</u>) have been delivered to the Trustee for cancellation; or
- all Notes not theretofore delivered to the Trustee for cancellation (A) have become due and payable, or (B) will become due and payable at their Stated Maturity within one year, or (C) are to be called for redemption pursuant to Article IX under an arrangement satisfactory to the Trustee for the giving of notice of redemption by the Applicable Issuers pursuant to Section 9.5 and the Issuer has irrevocably deposited or caused to be deposited with the Trustee, in trust for such purpose, Cash or non-callable direct obligations of the United States of America; provided that the obligations are entitled to the full faith and credit of the United States of America or are debt obligations which are rated "Aaa" by Moody's and "AAA" by S&P, in an amount sufficient, as recalculated in writing by a firm of Independent certified public accountants which are nationally recognized have the Eligible Investment Required Ratings, in an amount sufficient to pay and discharge the entire indebtedness on such Notes, for principal and interest payable thereon under this Indenture to the date of such deposit (in the case of Notes which have become due and payable), or to their Stated Maturity or Redemption Date, as the case may be, and shall have Granted to the Trustee a valid perfected security interest in such cash or obligations that is of first priority or free of any adverse claim, as

applicable, and shall have furnished an Opinion of Counsel with respect to the creation and perfection of such security interest; provided that this subsection (ii) shall not apply if an election to act in accordance with the provisions of Section 5.5(a) shall have been made and not rescinded; and

- (y) the Co-Issuers have paid or caused to be paid all other sums payable by the Co-Issuers hereunder and under the Collateral Administration Agreement and the Investment Management Agreement; or
- (b) (1) all Pledged Obligations of the Issuer that are subject to the lien of this Indenture have been realized, (2) all Hedge Agreements have been terminated and (3) all funds on deposit in the Accounts have been distributed in accordance with the terms of this Indenture;

provided that, in each case, the Co-Issuers have delivered to the Trustee Officer's certificates (which may rely on information provided by the Trustee or the Collateral Administrator as to the Cash, Collateral Obligations, Equity Securities and Eligible Investments included in the Assets and any paid and unpaid obligations of the Co-Issuers), each stating that all conditions precedent herein provided for relating to the satisfaction and discharge of this Indenture have been complied with.

Notwithstanding the satisfaction and discharge of this Indenture, the rights and obligations of the Co-Issuers, the Trustee, the Investment Manager and, if applicable, the Holders, as the case may be, under <u>Sections 2.8, 4.2, 5.4(d), 5.9, 5.18, 6.1, 6.3, 6.6, 6.7, 7.1, 7.3, 13.1 and 14.15 shall survive.</u>

Section 4.2 <u>Application of Trust Money</u>. All Monies deposited with the Trustee pursuant to <u>Section 4.1</u> shall be held in trust and applied by it in accordance with the provisions of the Securities and this Indenture, including, without limitation, the Priority of Payments, to the payment of principal and interest (or other amounts with respect to the Subordinated Securities), either directly or through any Paying Agent (including, in case of distributions on the Preferred Shares, the Fiscal Agent), as the Trustee may determine; and such Money shall be held in a segregated account identified as being held in trust for the benefit of the Secured Parties and satisfying the requirements in <u>Section 10.5(b)</u>.

Section 4.3 <u>Repayment of Monies Held by Paying Agent</u>. In connection with the satisfaction and discharge of this Indenture with respect to the Securities, all Monies then held by any Paying Agent other than the Trustee under the provisions of this Indenture shall, upon demand of the Co-Issuers, be paid to the Trustee to be held and applied pursuant to <u>Section 7.3</u> hereof and in accordance with the Priority of Payments and thereupon such Paying Agent shall be released from all further liability with respect to such Monies.

Section 4.4 <u>Limitation on Obligation to Incur Administrative Expenses</u>. If at any time the sum of (i) Eligible Investments, (ii) Cash and (iii) amounts reasonably expected to be received by the Issuer in Cash during the current Due Period (as certified by the Investment Manager in its reasonable judgment) is less than the sum of Dissolution Expenses and any accrued and unpaid Administrative Expenses, then notwithstanding any other provision of this Indenture, the Issuer shall no longer be required to incur Administrative Expenses as otherwise

required by this Indenture to any Person other than the Trustee, the Administrator and their Affiliates, and failure to pay such amounts or provide or obtain such opinions, reports or services shall not constitute a Default hereunder, and the Trustee shall have no liability for any failure to obtain or receive any of the foregoing opinions, reports or services.

#### **ARTICLE V**

#### REMEDIES

- Section 5.1 <u>Events of Default</u>. "<u>Event of Default</u>," wherever used herein, means any one of the following events (whatever the reason for such Event of Default and whether it shall be voluntary or involuntary or be effected by operation of law or pursuant to any judgment, decree or order of any court or any order, rule or regulation of any administrative or governmental body):
- (a) a default in the payment, when due and payable, of (i) any interest on any Class A Note or, if there are no Class A Notes Outstanding, the Controlling Class and the continuation of any such default for five Business Days, or (ii) any principal, interest, or Deferred Interest on, or any Redemption Price in respect of, any Secured Note, in any case, at its Stated Maturity or any Redemption Date; provided that, in the case of a default in payment resulting solely from an administrative error or omission by the Trustee, any Paying Agent or the Registrar, such default continues for a period of seventen or more Business Days after the Trustee receives written notice or a Trust Officer of the Trustee has actual knowledge of such administrative error or omission; provided, further, that, in the case of any default on any Redemption Date, only to the extent that such default continues for a period of 10 or more Business Days; provided, further, that, for the avoidance of doubt, the failure to effect an Optional Redemption, Tax Redemption—or, Partial Redemption, Clean-Up Call Redemption or Re-Pricing Redemption will not constitute an Event of Default;
- (b) either of the Co-Issuers or the pool of collateral becomes an investment company required to be registered under the Investment Company Act<u>and such requirement has not been eliminated after a period of 45 days</u>;
- (c) except as otherwise provided in this <u>Section 5.1</u>, a default, in the performance, or breach, of any other covenant or other agreement of the Issuer or the Co-Issuer in this Indenture in any material respect (it being understood, without limiting the generality of the foregoing, that any failure to meet any Concentration Limitation, Collateral Quality Test, Coverage Test or Interest Diversion Test is not an Event of Default), or the failure of any representation or warranty of the Issuer or the Co-Issuer made in this Indenture or in any certificate or other writing delivered pursuant hereto or in connection herewith to be correct in all material respects when the same shall have been made, and the continuation of such default, breach or failure for a period of 30 days after notice to the Applicable Issuers and the Investment Manager by registered or certified mail or overnight courier, by the Trustee, the Applicable Issuers or the Investment Manager, or to the Applicable Issuers, the Investment Manager and the Trustee by a Majority of the Controlling Class, specifying such default, breach or failure and requiring it to be remedied and stating that such notice is a "Notice of Default" hereunder;
- (d) on any Measurement Date, the failure of the quotient of (i) the sum of (A) the Aggregate Principal Balance of all Pledged Obligations (excluding Defaulted Obligations), plus (B) with respect to each Defaulted Obligation included in the Pledged Obligations, the

Market Value thereof, divided by (ii) the Aggregate Outstanding Amount of the Class A-1 Notes, to equal or exceed 102.5%; or

(e) the occurrence of a Bankruptcy Event.

Upon obtaining knowledge of the occurrence of an Event of Default, each of (i) the Co-Issuers, (ii) the Trustee and (iii) the Investment Manager shall notify each other in writing and the Trustee shall provide the notices of Default required under <u>Section 6.2</u>.

# Section 5.2 Acceleration of Maturity; Rescission and Annulment.

- (a) (a)— If an Event of Default occurs and is continuing (other than a Bankruptcy Event), the Trustee may, and shall, upon the written direction of a Supermajority Majority of the Controlling Class, by notice to the Applicable Issuers and each of the Rating Agencies, declare the principal of all the Secured Notes to be immediately due and payable, and upon any such declaration such principal, together with all accrued and unpaid interest thereon, and other amounts payable hereunder, shall become immediately due and payable and the Reinvestment Period shall terminate. If a Bankruptcy Event occurs, all unpaid principal, together with all accrued and unpaid interest thereon, of all the Secured Notes, and other amounts payable hereunder, shall automatically become due and payable without any declaration or other act on the part of the Trustee or any Holder.
- (b) At any time after such a declaration of acceleration of maturity has been made and before a judgment or decree for payment of the Money due has been obtained by the Trustee as hereinafter provided in this <u>Article V</u>, a Majority of the Controlling Class by written notice to the Issuer and the Trustee, may rescind and annul such declaration and its consequences if:
  - (i) The Issuer or the Co-Issuer has paid or deposited with the Trustee a sum sufficient to pay:
    - (A) all unpaid installments of interest and principal then due on the Secured Notes (other than as a result of such acceleration);
    - (B) to the extent that the payment of such interest is lawful, interest upon any Deferred Interest at the applicable Interest Rates; and
    - (C) all unpaid taxes and Administrative Expenses of the Co-Issuers and other sums paid, incurred or advanced by the Trustee hereunder and any other amounts then payable by the Co-Issuers hereunder prior to such Administrative Expenses; and
  - (ii) if it has been determined that all Events of Default, other than the nonpayment of the interest on or principal of the Secured Notes, have (A) been cured, and a Majority of the Controlling Class by written notice to the Trustee has agreed with such determination (which agreement shall not be unreasonably withheld), or (B) been waived as provided in Section 5.14.

No such rescission shall affect any subsequent Default or impair any right consequent thereon. Any Hedge Agreement in effect upon such declaration of an acceleration must remain in effect until liquidation of the Assets has begun and such declaration is no longer capable of being rescinded or annulled; <u>provided</u> that the Issuer shall nevertheless be entitled to designate an early termination date under and in accordance with the terms of such Hedge Agreement. The Trustee shall notify each Rating Agency of any rescission of a declaration of acceleration of maturity pursuant to this Section 5.2(b).

(c) Notwithstanding anything in this <u>Section 5.2</u> to the contrary, the Secured Notes shall not be subject to acceleration by the Trustee or a Majority of the Controlling Class solely as a result of the failure to pay any amount due on Notes that are not of the Controlling Class.

Section 5.3 <u>Collection of Indebtedness and Suits for Enforcement by Trustee</u>. The Applicable Issuers covenant that if a default shall occur in respect of the payment of any principal of or interest when due and payable on any Secured Note, the Applicable Issuers shall, upon demand of the Trustee, pay to the Trustee, for the benefit of the Holder of such Secured Note, the whole amount, if any, then due and payable on such Secured Note for principal and interest with interest upon the overdue principal, at the applicable Interest Rate, and, in addition thereto, such further amount as shall be sufficient to cover the costs and expenses of collection, including the reasonable compensation, expenses, disbursements and advances of the Trustee and its agents and counsel.

If the Issuer or the Co-Issuer fails to pay such amounts forthwith upon such demand, the Trustee, in its own name and as trustee of an express trust, may, and shall upon written direction of a Majority of the Controlling Class (subject to the Trustee's rights hereunder, including Section 6.1(c)(iv)), institute a Proceeding for the collection of the sums so due and unpaid, may prosecute such Proceeding to judgment or final decree, and may enforce the same against the Applicable Issuers or any other obligor upon the Secured Notes and collect the Monies adjudged or decreed to be payable in the manner provided by law out of the Assets.

If an Event of Default occurs and is continuing, the Trustee may, and shall upon written direction of the Majority of the Controlling Class (subject to the Trustee's rights hereunder, including Section 6.1(c)(iv)), proceed to protect and enforce its rights and the rights of the Secured Parties by such appropriate Proceedings as the Trustee shall deem most effectual (if no such direction is received by the Trustee) or as the Trustee may be directed by the Majority of the Controlling Class, to protect and enforce any such rights, whether for the specific enforcement of any covenant or agreement in this Indenture or in aid of the exercise of any power granted herein, or to enforce any other proper remedy or legal or equitable right vested in the Trustee by this Indenture or by law.

In case there shall be pending Proceedings relative to the Issuer or the Co-Issuer or any other obligor upon the Secured Notes under the Bankruptcy Law or any other applicable bankruptcy, insolvency or other similar law, or in case a receiver, assignee or trustee in bankruptcy or reorganization, liquidator, sequestrator or similar official shall have been appointed for or taken possession of the Issuer, the Co-Issuer or their respective property or such

other obligor or its property, or in case of any other comparable Proceedings relative to the Issuer, the Co-Issuer or other obligor upon the Secured Notes, or the creditors or property of the Issuer, the Co-Issuer or such other obligor, the Trustee, regardless of whether the principal of any Secured Notes shall then be due and payable as therein expressed or by declaration or otherwise and regardless of whether the Trustee shall have made any demand pursuant to the provisions of this Section 5.3, shall be entitled and empowered, by intervention in such Proceedings or otherwise:

- (a) to file and prove a claim or claims for the whole amount of principal and interest owing and unpaid in respect of the Secured Notes, as applicable, and to file such other papers or documents as may be necessary or advisable in order to have the claims of the Trustee (including any claim for reasonable compensation to the Trustee and each predecessor Trustee, and their respective agents, attorneys and counsel, and for reimbursement of all reasonable expenses and liabilities incurred, and all advances made, by the Trustee and each predecessor Trustee, except as a result of negligence or bad faith) and of the Holders of Secured Notes or Holders allowed in any Proceedings relative to the Issuer, the Co-Issuer or other obligor upon the Secured Notes or to the creditors or property of the Issuer, the Co-Issuer or such other obligor;
- (b) unless prohibited by applicable law and regulations, to vote on behalf of the Holders of the Secured Notes upon the direction of such Holders, in any election of a trustee or a standby trustee in arrangement, reorganization, liquidation or other bankruptcy or insolvency Proceedings or person performing similar functions in comparable Proceedings; and
- (c) to collect and receive any Monies or other property payable to or deliverable on any such claims, and to distribute all amounts received with respect to the claims of the Holders and of the Trustee on their behalf; and any trustee, receiver or liquidator, custodian or other similar official is hereby authorized by each of the Holders of Secured Notes to make payments to the Trustee, and, in the event that the Trustee shall consent to the making of payments directly to the Holders of Secured Notes to pay to the Trustee such amounts as shall be sufficient to cover reasonable compensation to the Trustee, each predecessor Trustee and their respective agents, attorneys and counsel, and all other reasonable expenses and liabilities incurred, and all advances made, by the Trustee and each predecessor Trustee except as a result of negligence or bad faith.

Nothing herein contained shall be deemed to authorize the Trustee to authorize or consent to or vote for or accept or adopt on behalf of any Holder of Secured Notes, any plan of reorganization, arrangement, adjustment or composition affecting the Secured Notes or any Holder thereof, or to authorize the Trustee to vote in respect of the claim of any Holder of Secured Notes in any such Proceeding except, as aforesaid, to vote for the election of a trustee in bankruptcy or similar person.

In any Proceedings brought by the Trustee on behalf of the Holders of the Secured Notes (and any such Proceedings involving the interpretation of any provision of this Indenture to which the Trustee shall be a party), the Trustee shall be held to represent all the Holders of the Secured Notes.

Notwithstanding anything in this <u>Section 5.3</u> to the contrary, the Trustee may not sell or liquidate the Assets or institute Proceedings in furtherance thereof pursuant to this <u>Section 5.3</u> except according to the provisions specified in <u>Section 5.5(a)</u>.

#### Section 5.4 Remedies.

- (a) (a) If an Event of Default shall have occurred and be continuing, and the Secured Notes have been declared due and payable and such declaration and its consequences have not been rescinded and annulled, the Co-Issuers agree that the Trustee may, and shall, upon written direction of a Majority of the Controlling Class (subject to the Trustee's rights hereunder, including Section 6.1(c)(iv)), to the extent permitted by applicable law, exercise one or more of the following rights, privileges and remedies:
  - (i) institute Proceedings for the collection of all amounts then payable on the Secured Notes or otherwise payable under this Indenture, whether by declaration or otherwise, enforce any judgment obtained, and collect from the Assets any Monies adjudged due;
  - (ii) sell or cause the sale of all or a portion of the Assets or rights or interests therein, at one or more public or private sales called and conducted in any manner permitted by law and in accordance with Section 5.17;
  - (iii) institute Proceedings from time to time for the complete or partial foreclosure of this Indenture with respect to the Assets;
  - (iv) exercise any remedies of a secured party under the UCC and take any other appropriate action to protect and enforce the rights and remedies of the Trustee and the Holders of the Secured Notes hereunder (including, without limitation, exercising all rights of the Trustee under the Account Agreement); and
  - (v) exercise any other rights and remedies that may be available at law or in equity;

<u>provided</u>, <u>however</u>, that the Trustee may not sell or liquidate the Assets or institute Proceedings in furtherance thereof pursuant to this <u>Section 5.4</u> except according to the provisions specified in <u>Section 5.5(a)</u>. The <u>Trustee shall notify Fitch of any action taken at the direction of the Controlling Class pursuant to this Section 5.4(a)</u>.

The Trustee may, but need not, obtain (at the expense of the Co-Issuers) and rely upon an opinion of an Independent investment banking firm of national reputation, or other appropriate advisor concerning the matter, which may (but need not) be the Initial Purchaser, as to the feasibility of any action proposed to be taken in accordance with this <u>Section 5.4</u> and as to the sufficiency of the proceeds and other amounts receivable with respect to the Assets to make the required payments of principal of and interest on the Secured Notes, which opinion shall be conclusive evidence as to such feasibility or sufficiency and the cost of which shall be commercially reasonable.

- (b) If an Event of Default as described in <u>Section 5.1(c)</u> hereof shall have occurred and be continuing the Trustee may, and at the written direction of the Holders of not less than 25% of the Aggregate Outstanding Amount of the Controlling Class (subject to the Trustee's rights hereunder, including <u>Section 6.1(c)(iv)</u>), shall, institute a Proceeding solely to compel performance of the covenant or agreement or to cure the representation or warranty, the breach of which gave rise to the Event of Default under such Section, and enforce any equitable decree or order arising from such Proceeding. <u>The Trustee shall notify Fitch of any action taken at the direction of the Controlling Class pursuant to this Section 5.4(b).</u>
- (c) Upon any sale, whether made under the power of sale hereby given or by virtue of judicial Proceedings, any Secured Party may bid for and purchase the Assets or any part thereof and, upon compliance with the terms of sale, may hold, retain, possess or dispose of such property in its or their own absolute right without accountability; and any purchaser at any such sale of Assets may, in paying the purchase Money, deliver to the Trustee for cancellation any of the Class A-1 Notes in lieu of Cash equal to the amount which shall, upon distribution of the net proceeds of such sale, be payable on the Class A-1 Notes so delivered by such Holder (taking into account the Priority of Payments and Article XIII). Said Notes, in case the amounts payable thereon shall be less than the amount due thereon, shall be returned to the Holders thereof after proper notation has been made thereon to show partial payment.

Upon any sale, whether made under the power of sale hereby given or by virtue of judicial Proceedings, the receipt of the Trustee, or of the Officer making a sale under judicial Proceedings, shall be a sufficient discharge to the purchaser or purchasers at any sale for its or their purchase Money, and such purchaser or purchasers shall not be obliged to see to the application thereof.

Any such sale, whether under any power of sale hereby given or by virtue of judicial Proceedings, shall bind the Co-Issuers, the Trustee and the Holders of the Secured Notes, shall operate to divest all right, title and interest whatsoever, either at law or in equity, of each of them in and to the property sold, and shall be a perpetual bar, both at law and in equity, against each of them and their successors and assigns, and against any and all Persons claiming through or under them.

(d) Notwithstanding any other provision of this Indenture, none of the Trustee, the Secured Parties, the Holders of the Securities, or the beneficial owners of the Securities may, prior to the date which is one year (or, if longer, any applicable preference period) plus one day after the payment in full of the Notes and payment of any amounts payable to the Fiscal Agent pursuant to this Indenture for distribution to Shareholders in accordance with the Fiscal Agency Agreement, institute against, or join any other Person in instituting against, the Issuer, Co-Issuer or any Tax Subsidiary any bankruptcy, reorganization, arrangement, insolvency, moratorium or liquidation Proceedings, or other Proceedings under Cayman Islands, U.S. federal or State bankruptcy or similar laws. The parties hereto agree that the restrictions set forth in this clause (d) are a material inducement for each Holder and beneficial owner of the Securities to acquire such Securities and for the Issuer, the Co-Issuer and the Investment Manager to enter into this Indenture (in the case of the Issuer and the Co-Issuer) and the other applicable transaction documents and are an essential term of this Indenture. Any Holder or beneficial owner of the

Securities, the Investment Manager, the Trustee, any Tax Subsidiary or either of the Co-Issuers may seek and obtain specific performance of such restrictions (including injunctive relief), including, without limitation, in any bankruptcy, reorganization, arrangement, insolvency, moratorium or liquidation proceedings, or other proceedings under Cayman Islands law, U.S. federal or state bankruptcy law or similar laws. Nothing in this Section 5.4 shall preclude, or be deemed to stop, the Trustee (i) from taking any action prior to the expiration of the aforementioned period in (A) any case or Proceeding voluntarily filed or commenced by the Issuer or the Co-Issuer or (B) any involuntary insolvency Proceeding filed or commenced by a Person other than the Trustee, or (ii) from commencing against the Issuer or the Co-Issuer or any of its properties any legal action which is not a bankruptcy, reorganization, arrangement, insolvency, moratorium or liquidation Proceeding.

## Section 5.5 Optional Preservation of Assets.

- (a) (a) Notwithstanding anything to the contrary herein, if an Event of Default shall have occurred and be continuing, the Trustee shall retain the Assets intact (except as otherwise expressly permitted or required by Sections 7.16(n), 10.7 and, as directed by the Investment Manager, 12.1), collect and cause the collection of the proceeds thereof and make and apply all payments and deposits and maintain all Accounts and the Notes in accordance with the Priority of Payments and the provisions of Article X, Article XII and Article XIII unless:
  - (i) the Trustee, pursuant to <u>Section 5.5(c)</u>, determines that the anticipated proceeds of a sale or liquidation of all or any portion of the Assets (after deducting the reasonable expenses of such sale or liquidation) would be sufficient to discharge in full the amounts then due (or, in the case of interest, accrued) and unpaid on the Secured Notes for principal and interest (including Deferred Interest) and all amounts payable prior to payment of principal on such Secured Notes (including amounts due and owing as Administrative Expenses (without regard to the Administrative Expense Cap) and amounts payable to any Hedge Counterparty upon liquidation of all or any portion of the Assets) and a Majority of the Controlling Class agrees with such determination; or
  - (ii) the sale and liquidation of all or any portion of the Assets is directed by either (A) solely in the case of an Event of Default described in Section 5.1(a) with respect to payments on the Class A-1 Notes or an Event of Default described in Section 5.1(d), a Supermajority Majority of the Class A-1 Notes or (B) in all other cases, a Supermajority of each Class of Secured Notes voting separately.

The Trustee shall give written notice of the retention of the Assets to the Issuer with a copy to the Co-Issuer-and, the Investment Manager and each Rating Agency. So long as such Event of Default is continuing, any such retention pursuant to this Section 5.5(a) may be rescinded at any time when the conditions specified in clause (i) or (ii) exist.

(b) Nothing contained in <u>Section 5.5(a)</u> shall be construed to require the Trustee to sell the Assets securing the Secured Notes if the conditions set forth in clause (i) or (ii) of <u>Section 5.5(a)</u> are not satisfied. Nothing contained in <u>Section 5.5(a)</u> shall be construed to require the Trustee to preserve the Assets if prohibited by applicable law.

In determining whether the condition specified in <u>Section 5.5(a)(i)</u> exists, (c) the Trustee shall, with the written consent of the Majority of the Controlling Class, request bid prices with respect to each security contained in the Assets from two nationally recognized dealers at the time making a market in such securities (as identified by the Investment Manager to the Trustee in writing) and shall compute the anticipated proceeds of sale or liquidation on the basis of the lower of such bid prices for each such security. If the Trustee is unable to obtain any bids, the condition specified in Section 5.5(a)(i) shall be deemed to not exist. For the purposes of making the determinations required pursuant to Section 5.5(a)(i), the Trustee shall apply the standards set forth in Section 6.3(c)(i) or (ii). In addition, for the purposes of determining issues relating to the execution of a sale or liquidation of all or any portion of the Assets and the execution of a sale or other liquidation thereof in connection with a determination whether the condition specified in Section 5.5(a)(i) exists, the Trustee may retain (at the Co-Issuers' expense and for a commercially reasonable fee) and conclusively rely without limitation on an opinion of an Independent investment banking firm of national reputation or other appropriate advisor concerning the matter.

The Trustee shall deliver to the Holders and the Investment Manager a report stating the results of any determination required pursuant to  $\underline{Section\ 5.5(a)(i)}$  no later than 10 days after such determination is made. Unless a Majority of the Controlling Class has not consented to the Trustee making a determination pursuant to  $\underline{Section\ 5.5(c)}$ , the Trustee shall make the determinations required by  $\underline{Section\ 5.5(a)(i)}$  within 30 days after an Event of Default (or such longer period as is necessary if the information required to make such determination has not yet been received) or at the request of a Majority of the Controlling Class at any time, but not more frequently than once in any calendar month, during which the Trustee retains the Assets pursuant to  $\underline{Section\ 5.5(a)}$ .

Section 5.6 <u>Trustee May Enforce Claims without Possession of Notes.</u> All rights of action and claims under this Indenture or under any of the Secured Notes may be prosecuted and enforced by the Trustee without the possession of any of the Secured Notes or the production thereof in any trial or other Proceeding relating thereto, and any such action or Proceeding instituted by the Trustee shall be brought in its own name as trustee of an express trust, and any recovery of judgment shall be applied as set forth in <u>Section 5.7</u>.

Section 5.7 <u>Application of Money Collected.</u> Any Money collected by the Trustee (after payment of costs of collection, liquidation and enforcement) with respect to the Securities pursuant to this <u>Article V</u> and any Money that may then be held or thereafter received by the Trustee with respect to the Securities hereunder shall be applied, subject to <u>Section 13.1</u> and in accordance with the provisions of the Priority of Payments, at the date or dates fixed by the Trustee (each such date to occur on a Payment Date). Upon the final distribution of all proceeds of any liquidation effected hereunder, the provisions of <u>Sections 4.1(a)</u> and <u>(b)</u> shall be deemed satisfied for the purposes of discharging this Indenture pursuant to <u>Article IV</u>.

Section 5.8 <u>Limitation on Suits</u>. No Holder of any Note shall have any right to institute any Proceedings, judicial or otherwise, with respect to this Indenture, or for the appointment of a receiver or trustee, or for any other remedy hereunder, unless:

- (a) such Holder has previously given to the Trustee written notice of an Event of Default;
- (b) the Holders of not less than 25% of the then Aggregate Outstanding Amount of the Notes of the Controlling Class shall have made written request to the Trustee to institute Proceedings in respect of such Event of Default in its own name as Trustee hereunder and such Holder or Holders have provided the Trustee security or indemnity reasonably satisfactory to the Trustee against the costs, expenses (including reasonable attorneys' fees and expenses) and liabilities to be incurred in compliance with such request;
- (c) the Trustee, for 30 days after its receipt of such notice, request and provision of such indemnity, has failed to institute any such Proceeding; and
- (d) no direction inconsistent with such written request has been given to the Trustee during such 30 day period by a Majority of the Controlling Class;

it being understood and intended that no one or more Holders shall have any right in any manner whatever by virtue of, or by availing of, any provision of this Indenture to affect, disturb or prejudice the rights of any other Holders of the same Class or to obtain or to seek to obtain priority or preference over any other Holders of the same Class or to enforce any right under this Indenture, except in the manner herein provided and for the equal and ratable benefit of all the Holders of the same Class subject to and in accordance with <u>Section 13.1</u> and the Priority of Payments.

In the event the Trustee shall receive conflicting or inconsistent requests and indemnity from two or more groups of Holders of the Controlling Class, each representing less than a Majority of the Controlling Class, pursuant to this <u>Section 5.8</u>, the Trustee shall act in accordance with the request specified by the group of Holders with the greatest percentage of the Aggregate Outstanding Amount of the Controlling Class, notwithstanding any other provisions of this Indenture. If the groups represent the same percentage, the Trustee in its sole discretion may determine what action, if any, shall be taken.

The Issuer or the Co-Issuer, as applicable, shall, so long as any Notes remain outstanding and for a year and a day thereafter, and subject to the availability of funds therefor under the Priority of Payments, timely file an answer and any other appropriate pleading objecting to (i) the institution of any proceeding to have the Issuer or the Co-Issuer, as the case may be, adjudicated as bankrupt or insolvent, or (ii) the filing of any petition seeking relief, reorganization, arrangement, adjustment, liquidation, winding up or composition of or in respect of the Issuer or the Co-Issuer, as the case may be, under any bankruptcy law or any other applicable law. The reasonable fees, costs, charges and expenses incurred by the Issuer or Co-Issuer (including reasonable attorneys' fees and expenses) in connection with taking any such action shall be paid as Administrative Expenses.

Section 5.9 <u>Unconditional Rights of Holders of Secured Notes to Receive Principal and Interest.</u> Subject to <u>Sections 2.8(i)</u>, 2.13, 5.13, 6.15 and 13.1, but notwithstanding any other provision in this Indenture, the Holder of any Secured Note shall have the right, which is absolute and unconditional, to receive payment of the principal of and interest on such Secured Note as such principal and interest becomes due and payable in accordance with the Priority of Payments and <u>Section 13.1</u>, and, subject to the provisions of <u>Sections 5.4(d)</u> and <u>5.8</u>, to institute Proceedings for the enforcement of any such payment, and such right shall not be impaired without the consent of such Holder. Holders of Secured Notes of a Junior Class shall have no right to institute proceedings for the enforcement of any such payment until such time as no Secured Note ranking senior to such Secured Note remains Outstanding, which right shall be subject to the provisions of <u>Sections 5.4(d)</u> and <u>5.8</u>, and shall not be impaired without the consent of any such Holder.

Section 5.10 <u>Restoration of Rights and Remedies</u>. If the Trustee or any Holder has instituted any Proceeding to enforce any right or remedy under this Indenture and such Proceeding has been discontinued or abandoned for any reason, or has been determined adversely to the Trustee or to such Holder, then and in every such case the Co-Issuers, the Trustee and the Holder shall, subject to any determination in such Proceeding, be restored severally and respectively to their former positions hereunder, and thereafter all rights and remedies of the Trustee and the Holder shall continue as though no such Proceeding had been instituted.

Section 5.11 <u>Rights and Remedies Cumulative</u>. No right or remedy herein conferred upon or reserved to the Trustee or to the Holders is intended to be exclusive of any other right or remedy, and every right and remedy shall, to the extent permitted by law, be cumulative and in addition to every other right and remedy given hereunder or now or hereafter existing at law or in equity or otherwise. The assertion or employment of any right or remedy hereunder, or otherwise, shall not prevent the concurrent assertion or employment of any other appropriate right or remedy.

Section 5.12 <u>Delay or Omission Not Waiver</u>. No delay or omission of the Trustee or any Holder of Secured Notes to exercise any right or remedy accruing upon any Event of Default shall impair any such right or remedy or constitute a waiver of any such Event of Default or an acquiescence therein or of a subsequent Event of Default. Every right and remedy given by this <u>Article V</u> or by law to the Trustee or to the Holders of the Secured Notes may be exercised from time to time, and as often as may be deemed expedient, by the Trustee or by the Holders of the Secured Notes.

Section 5.13 <u>Control by Majority of Controlling Class</u>. Notwithstanding any other provision of this Indenture, a Majority of the Controlling Class shall have the right following the occurrence, and during the continuance of, an Event of Default to cause the institution of and direct the time, method and place of conducting any Proceeding for any remedy available to the Trustee, and to direct the exercise of any trust, right, remedy or power conferred upon the Trustee; <u>provided</u> that:

(a) such direction shall not conflict with any rule of law or with any express provision of this Indenture;

- (b) the Trustee may take any other action deemed proper by the Trustee that is not inconsistent with such direction; <u>provided</u>, <u>however</u>, that subject to <u>Section 6.1</u>, the Trustee need not take any action that it determines might involve it in liability or expense (unless the Trustee has received the indemnity as set forth in (c) below);
- (c) the Trustee shall have been provided with security or indemnity reasonably satisfactory to it; and
- (d) notwithstanding the foregoing, any direction to the Trustee to undertake a Sale of the Assets shall be by the Holders representing the requisite percentage of the Aggregate Outstanding Amount specified in <u>Section 5.5</u>.
- Section 5.14 <u>Waiver of Past Defaults</u>. Prior to the time a judgment or decree for payment of the Money due has been obtained by the Trustee, as provided in this <u>Article V</u>, a Majority of the Controlling Class may on behalf of the Holders of all the Notes waive any past Default and its consequences, except a Default:
- (a) in the payment of the principal of any Secured Note (which may be waived with the consent of each Holder of such Secured Note);
- (b) in respect of a covenant or provision hereof that under <u>Section 8.2</u> cannot be modified or amended without the waiver or consent of the Holder of each Outstanding Note (which may be waived with the consent of each such Holder); or
- (c) in respect of a representation contained in <u>Section 7.18</u> (which may be waived by a Majority of the Controlling Class if the Global Rating Agency Condition is satisfied).

In the case of any such waiver, the Co-Issuers, the Trustee and the Holders of the Notes shall be restored to their former positions and rights hereunder, respectively, but no such waiver shall extend to any subsequent or other Default or impair any right consequent thereto. The Trustee shall promptly give written notice of any such waiver to Moody's, S&Peach Rating Agency, the Investment Manager and each Holder.

Upon any such waiver, such Default shall cease to exist, and any Event of Default arising therefrom shall be deemed to have been cured, for every purpose of this Indenture, but no such waiver shall extend to any subsequent or other Default or impair any right consequent thereto.

Section 5.15 <u>Undertaking for Costs</u>. All parties to this Indenture agree, and each Holder of any Note by his acceptance thereof shall be deemed to have agreed, that any court may in its discretion require, in any suit for the enforcement of any right or remedy under this Indenture, or in any suit against the Trustee, Collateral Administrator or Investment Manager for any action taken, or omitted by it as Trustee, Collateral Administrator or Investment Manager, as applicable, the filing by any party litigant in such suit of an undertaking to pay the costs of such suit, and that such court may in its discretion assess reasonable costs, including reasonable attorneys' fees, against any party litigant in such suit, having due regard to the merits and good

faith of the claims or defenses made by such party litigant; but the provisions of this <u>Section 5.15</u> shall not apply to any suit instituted by the Trustee, to any suit instituted by any Holder, or group of Holders, holding in the aggregate more than 10% in Aggregate Outstanding Amount of the Controlling Class, or to any suit instituted by any Holder for the enforcement of the payment of the principal of or interest on any Note on or after the applicable Stated Maturity (or, in the case of redemption, on or after the applicable Redemption Date).

Section 5.16 <u>Waiver of Stay or Extension Laws</u>. The Co-Issuers covenant (to the extent that they may lawfully do so) that they shall not at any time insist upon, or plead, or in any manner whatsoever claim or take the benefit or advantage of, any stay or extension law or any valuation, appraisement, redemption or marshalling law or rights, in each case wherever enacted, now or at any time hereafter in force, which may affect the covenants, the performance of or any remedies under this Indenture; and the Co-Issuers (to the extent that they may lawfully do so) hereby expressly waive all benefit or advantage of any such law or rights, and covenant that they shall not hinder, delay or impede the execution of any power herein granted to the Trustee, but shall suffer and permit the execution of every such power as though no such law had been enacted or rights created.

#### Section 5.17 Sale of Assets.

- (a) (a)— The power to effect any sale (a "Sale") of all or any portion of the Assets pursuant to Sections 5.4 and 5.5 shall not be exhausted by any one or more Sales as to any portion of such Assets remaining unsold, but shall continue unimpaired until the entire Assets shall have been sold or all amounts secured by the Assets shall have been paid. The Trustee may upon notice provided as soon as reasonably practicable to the Holders, and shall, upon direction of the Holders of Securities representing the requisite percentage of the Aggregate Outstanding Amount the Class having the power to direct such Sale, from time to time postpone any Sale by public announcement made at the time and place of such Sale pursuant to Section 5.5. The Trustee hereby expressly waives its rights to any amount fixed by law as compensation for any Sale; provided that the Trustee and the Investment Manager shall be authorized to deduct the reasonable costs, charges and expenses incurred by it in connection with such Sale from the proceeds thereof notwithstanding the provisions of Section 6.7.
- (b) The Trustee may bid for and acquire any portion of the Assets in connection with a public Sale thereof, and may pay all or part of the purchase price by crediting against amounts owing on the Secured Notes or other amounts secured by the Assets, all or part of the net proceeds of such Sale after deducting the reasonable costs, charges and expenses incurred by the Trustee in connection with such Sale notwithstanding the provisions of Section 6.7. The Secured Notes need not be produced in order to complete any such Sale, or in order for the net proceeds of such Sale to be credited against amounts owing on the Notes. The Trustee may hold, lease, operate, manage or otherwise deal with any property so acquired in any manner permitted by law in accordance with this Indenture.
- (c) If any portion of the Assets consists of securities issued without registration under the Securities Act ("<u>Unregistered Securities</u>"), the Investment Manager may seek an Opinion of Counsel, or, if no such Opinion of Counsel can be obtained and with the written consent of a Majority of the Controlling Class, seek a no action position from the

Securities and Exchange Commission or any other relevant federal or State regulatory authorities, regarding the legality of a public or private Sale of such Unregistered Securities.

- (d) The Trustee shall execute and deliver an appropriate instrument of conveyance transferring its interest in any portion of the Assets in connection with a Sale thereof. In addition, the Trustee is hereby irrevocably appointed the agent and attorney in fact of the Issuer to transfer and convey its interest in any portion of the Assets in connection with a Sale thereof, and to take all action necessary to effect such Sale. No purchaser or transferee at such a sale shall be bound to ascertain the Trustee's authority, to inquire into the satisfaction of any conditions precedent or see to the application of any Monies.
- (e) The Trustee shall provide notice as soon as reasonably practicable of any public Sale to the Holders of the Subordinated Securities, and the Holders of the Subordinated Securities shall be permitted to participate in any such public Sale to the extent such Holders meet any applicable eligibility requirements with respect to such Sale.

Section 5.18 Action on the Notes. The Trustee's right to seek and recover judgment on the Notes or under this Indenture shall not be affected by the seeking or obtaining of or application for any other relief under or with respect to this Indenture. Neither the lien of this Indenture nor any rights or remedies of the Trustee or the Holders shall be impaired by the recovery of any judgment by the Trustee against the Issuer or by the levy of any execution under such judgment upon any portion of the Assets or upon any of the assets of the Issuer or the Co-Issuer.

#### **ARTICLE VI**

#### THE TRUSTEE

## Section 6.1 <u>Certain Duties and Responsibilities</u>.

- (a) Except during the continuance of an Event of Default known to the Trustee:
  - (i) the Trustee undertakes to perform such duties and only such duties as are specifically set forth in this Indenture, and no implied covenants or obligations shall be read into this Indenture against the Trustee; and
  - (ii) in the absence of bad faith on its part, the Trustee may conclusively rely, as to the truth of the statements and the correctness of the opinions expressed therein, upon certificates or opinions furnished to the Trustee and conforming to the requirements of this Indenture; provided, however, that in the case of any such certificates or opinions which by any provision hereof are specifically required to be furnished to the Trustee, the Trustee shall be under a duty to examine the same to determine whether or not they substantially conform on their face to the requirements of this Indenture and shall promptly, but in any event within three Business Days in the case of an Officer's certificate furnished by the Investment Manager, notify the party delivering the same if such certificate or opinion does not conform. If a corrected form shall not have been delivered to the Trustee within 15 days after such notice from the Trustee, the Trustee shall so notify the Holders.
- (b) In case an Event of Default actually known to the Trustee has occurred and is continuing, the Trustee shall, prior to the receipt of written directions, if any, from a Majority of the Controlling Class, exercise such of the rights and powers vested in it by this Indenture, and use the same degree of care and skill in its exercise, as a prudent person would exercise or use under the circumstances in the conduct of such person's own affairs.
- (c) No provision of this Indenture shall be construed to relieve the Trustee from liability for its own negligent action, its own negligent failure to act, or its own willful misconduct, except that:
  - (i) this subsection shall not be construed to limit the effect of subsection (a) of this Section 6.1;
  - (ii) the Trustee shall not be liable for any error of judgment made in good faith by a Trust Officer, unless it shall be proven that the Trustee was negligent in ascertaining the pertinent facts;
  - (iii) the Trustee shall not be liable with respect to any action taken or omitted to be taken by it in good faith in accordance with the direction of the Issuer or the

Co-Issuer or the Investment Manager in accordance with this Indenture and/or a Majority (or such other percentage as may be required by the terms hereof) of the Controlling Class (or other Class if required or permitted by the terms hereof), relating to the time, method and place of conducting any Proceeding for any remedy available to the Trustee, or exercising any trust or power conferred upon the Trustee, under this Indenture;

- (iv) no provision of this Indenture shall require the Trustee to expend or risk its own funds or otherwise incur any financial liability in the performance of any of its duties hereunder, or in the exercise of any of its rights or powers contemplated hereunder, if it shall have reasonable grounds for believing that repayment of such funds or indemnity satisfactory to it against such risk or liability is not reasonably assured to it unless such risk or liability relates to the performance of its ordinary services, including providing notices under Article V, under this Indenture (and it is hereby expressly acknowledged and agreed, without implied limitation, that the enforcement or exercise of rights and remedies under Article V, and/or the commencement of or participation in any legal proceeding does not constitute "ordinary services"); and
- (v) in no event shall the Trustee be liable for special, indirect, punitive or consequential loss or damage of any kind whatsoever (including but not limited to lost profits) even if the Trustee has been advised of the likelihood of such damages and regardless of the form of such action.
- (d) For all purposes under this Indenture, the Trustee shall not be deemed to have notice or knowledge of any Default or Event of Default described in Section 5.1(c) a Bankruptcy Event or any other matter unless a Trust Officer assigned to and working in the Corporate Trust Office has actual knowledge thereof or unless written notice of any event which is in fact such an Event of Default or Default or other matter, as the case may be, is received by the Trustee at the Corporate Trust Office, and such notice references the Notes generally, the Issuer, the Co-Issuer, the Assets or this Indenture. For purposes of determining the Trustee's responsibility and liability hereunder, whenever reference is made in this Indenture to such an Event of Default or a Default, such reference shall be construed to refer only to such an Event of Default or Default of which the Trustee is deemed to have notice as described in this Section 6.1.
- (e) Whether or not therein expressly so provided, every provision of this Indenture relating to the conduct or affecting the liability of or affording protection to the Trustee shall be subject to the provisions of this <u>Section 6.1</u>.
- (f) The Trustee shall, upon reasonable (but no less than three Business Days') prior written notice to the Trustee, permit any representative of a Holder, during the Trustee's normal business hours, to examine all books of account, records, reports and other papers of the Trustee (other than items protected by attorney-client privilege) relating to the Notes, to make copies and extracts therefrom (the reasonable out-of-pocket expenses incurred in making any such copies or extracts to be reimbursed to the Trustee by such Holder) and to discuss the Trustee's actions, as such actions relate to the Trustee's duties with respect to the Notes, with the Trustee's Officers and employees responsible for carrying out the Trustee's duties with respect to the Notes.

Section 6.2 <u>Notice of Default</u>. As soon as reasonably practicable (and in no event later than two Business Days) after the occurrence of any Default actually known to a Trust Officer of the Trustee or after any declaration of acceleration has been made or delivered to the Trustee pursuant to <u>Section 5.2</u>, the Trustee shall give notice to the Co-Issuers, the Investment Manager, DTC, each Rating Agency, each Hedge Counterparty, each Paying Agent and all Holders, and the Irish Stock Exchange, for so long as any Class of Securities is listed on the Irish Stock Exchange and so long as the guidelines of such exchange so require, of all Defaults hereunder actually known to the Trust Officer of the Trustee, unless such Default shall have been cured or waived.

Section 6.3 <u>Certain Rights of Trustee</u>. Except as otherwise provided in <u>Section</u> 6.1:

- (a) the Trustee may conclusively rely and shall be fully protected in acting or refraining from acting upon any resolution, certificate, statement, instrument, opinion, report, notice, request, direction, consent, order, note or other paper or document believed by it to be genuine and to have been signed or presented by the proper party or parties;
- (b) any direction of the Issuer or the Co-Issuer mentioned herein shall be sufficiently evidenced by an Issuer Order;
- (c) whenever in the administration of this Indenture the Trustee shall (i) deem it desirable that a matter be proved or established prior to taking, suffering or omitting any action hereunder, the Trustee (unless other evidence be herein specifically prescribed) may, in the absence of bad faith on its part, rely upon an Officer's certificate or Issuer Order, or (ii) be required to determine the value of any Assets or funds hereunder or the cash flows projected to be received therefrom, the Trustee may, in the absence of bad faith on its part, rely on reports of nationally recognized accountants, investment bankers or other Persons qualified to provide the information required to make such determination, including nationally recognized dealers in securities of the type being valued and securities quotation services;
- (d) as a condition to the taking or omitting of any action by it hereunder, the Trustee may consult with counsel and the advice of such counsel or any Opinion of Counsel shall be full and complete authorization and protection in respect of any action taken or omitted by it hereunder in good faith and in reliance thereon;
- (e) the Trustee shall be under no obligation to exercise, enforce or to honor any of the rights or powers vested in it by this Indenture at the request or direction of any of the Holders pursuant to this Indenture, unless such Holders shall have provided to the Trustee security or indemnity reasonably satisfactory to it against the costs, expenses (including reasonable attorneys' fees and expenses) and liabilities which might reasonably be incurred by it in compliance with such request or direction;
- (f) the Trustee shall not be bound to make any investigation into the facts or matters stated in any resolution, certificate, statement, instrument, opinion, report, notice, request, direction, consent, order, note or other paper or document, but the Trustee, in its

discretion, may, and upon the written direction of a Majority of the Controlling Class or of a Rating Agency shall, make such further inquiry or investigation into such facts or matters as it may see fit or as it shall be directed, and the Trustee shall be entitled, on reasonable prior notice to the Co-Issuers and the Investment Manager, to examine the books and records relating to the Notes and the Assets, personally or by agent or attorney, during the Co-Issuers' or the Investment Manager's normal business hours; provided that the Trustee shall, and shall cause its agents to, hold in confidence all such information, except (i) to the extent disclosure may be required by law or by any regulatory, administrative or governmental authority and (ii) to the extent that the Trustee, in its sole judgment, may determine that such disclosure is consistent with its obligations hereunder; provided, further, that the Trustee may disclose on a confidential basis any such information to its agents, attorneys and auditors in connection with the performance of its responsibilities hereunder;

- (g) the Trustee may execute any of the trusts or powers hereunder or perform any duties hereunder either directly or by or through agents or attorneys; <u>provided</u> that the Trustee shall not be responsible for any misconduct or negligence on the part of any non-Affiliated agent or non-Affiliated attorney appointed with due care by it hereunder;
- (h) the Trustee shall not be liable for any action it takes or omits to take in good faith that it reasonably believes to be authorized or within its rights or powers hereunder;
- (i) nothing herein shall be construed to impose an obligation on the part of the Trustee to recalculate, evaluate, verify or independently determine the accuracy of any report, certificate or information received from the Issuer or Investment Manager and the Trustee shall not be liable for actions or omissions of, or any inaccuracies in the records of the Co-Issuers, the Trustee, the Investment Manager, Euroclear or Clearstream;
- (j) to the extent any defined term hereunder, or any calculation required to be made or determined by the Trustee hereunder, is dependent upon or defined by reference to generally accepted accounting principles (as in effect in the United States) ("GAAP"), the Trustee shall be entitled to request and receive (and conclusively rely upon) instruction from the Issuer or the accountants identified in the Accountants' Certificate (and in the absence of its receipt of timely instruction therefrom, shall be entitled to obtain from an Independent accountant at the expense of the Issuer) as to the application of GAAP in such connection, in any instance;
- (k) to the extent permitted by applicable law, the Trustee shall not be required to give any bond or surety in respect of the execution of this Indenture or otherwise;
- (l) the Trustee shall not be deemed to have notice or knowledge of any matter unless a Trust Officer has actual knowledge thereof or unless written notice thereof is received by the Trustee at the Corporate Trust Office and such notice references the Securities generally, the Issuer, the Co-Issuer or this Indenture;
- (m) the permissive rights of the Trustee to take or refrain from taking any actions enumerated in this Indenture shall not be construed as a duty;

- (n) the Trustee shall not be responsible for delays or failures in performance resulting from acts beyond its control;
- (o) in making or disposing of any investment permitted by this Indenture, the Trustee is authorized to deal with itself (in its individual capacity) or with any one or more of its Affiliates, whether it or such Affiliate is acting as a subagent of the Trustee or for any third person or dealing as principal for its own account. If otherwise qualified, obligations of the Bank or any of its Affiliates shall qualify as Eligible Investments hereunder;
- (p) the Trustee or its Affiliates are permitted to receive additional compensation that could be deemed to be in the Trustee's economic self-interest for (i) serving as investment adviser, administrator, shareholder, servicing agent, custodian or sub-custodian with respect to certain of the Eligible Investments, (ii) using Affiliates to effect transactions in certain Eligible Investments and (iii) effecting transactions in certain Eligible Investments. Such compensation is not payable or reimbursable under Section 6.7;
- (q) to help fight the funding of terrorism and money laundering activities, the Trustee shall obtain, verify, and record information that identifies individuals or entities that establish a relationship or open an account with the Trustee. The Trustee shall ask for the name, address, tax identification number and other information that will allow the Trustee to identify the individual or entity who is establishing the relationship or opening the account. The Trustee may also ask for formation documents such as articles of incorporation, an offering memorandum, or other identifying documents to be provided;
- (r) the Trustee shall not be liable for the actions or omissions of the Investment Manager, the Issuer, the Co-Issuer, any Paying Agent (other than the Trustee) or any Authenticating Agent (other than the Trustee) and without limiting the foregoing, the Trustee shall not be under any obligation to monitor, evaluate or verify compliance by the Investment Manager with the terms hereof or the Investment Management Agreement, or to verify or independently determine the accuracy of information received by it from the Investment Manager (or from any selling institution, agent bank, trustee or similar source) with respect to the Collateral;
- (s) neither the Trustee nor the Collateral Administrator shall have any obligation to determine: (a) if a Collateral Obligation meets the criteria specified in the definition thereof, or (b) if the conditions specified in the definition of Deliver have been complied with;
- (t) the Collateral Administrator shall have the same rights, privileges and indemnities afforded to the Trustee in this <u>Article VI</u>; <u>provided</u>, that such rights, immunities and indemnities shall be in addition to, and not in limitation of, any rights, immunities and indemnities provided in the Collateral Administration Agreement; and
- (u) the Trustee and the Collateral Administrator shall be entitled to conclusively rely on the Investment Manager with respect to whether or not a Collateral Obligation meets the criteria specified in the definition thereof and for the characterization,

classification, designation or categorization of each Collateral Obligation to the extent such characterization, classification, designation or categorization is subjective or judgmental in nature or based on information not readily available to the Trustee and Collateral Administrator.

Section 6.4 Not Responsible for Recitals or Issuance of Notes. The recitals contained herein and in the Notes, other than the Certificate of Authentication thereon, shall be taken as the statements of the Applicable Issuers; and the Trustee assumes no responsibility for their correctness. The Trustee makes no representation as to the validity or sufficiency of this Indenture (except as may be made with respect to the validity of the Trustee's obligations hereunder), the Assets or the Notes. The Trustee shall not be accountable for the use or application by the Co-Issuers of the Notes or the proceeds thereof or any Money paid to the Co-Issuers pursuant to the provisions hereof.

Section 6.5 <u>May Hold Securities</u>. The Trustee, the Fiscal Agent, any Paying Agent, Registrar or any other agent of the Co-Issuers, in its individual or any other capacity, may become the owner or pledgee of Securities and may otherwise deal with the Co-Issuers or any of their Affiliates with the same rights it would have if it were not Trustee, the Fiscal Agent, the Paying Agent, Registrar or such other agent.

Section 6.6 <u>Money Held in Trust</u>. Money held by the Trustee hereunder shall be held in trust to the extent required herein. The Trustee shall be under no liability for interest on any Money received by it hereunder, except in its capacity as the Bank to the extent of income or other gain on investments which are deposits in or certificates of deposit of the Bank in its commercial capacity and income or other gain actually received by the Trustee on Eligible Investments.

# Section 6.7 <u>Compensation and Reimbursement.</u>

# (a) (a) The Issuer agrees:

- (i) to pay the Trustee on each Payment Date reasonable compensation as set forth in a separate fee schedule dated on or near the Closing Date between the Trustee and the Issuer for all services rendered by it hereunder (which compensation shall not be limited by any provision of law in regard to the compensation of a trustee of an express trust);
- (ii) except as otherwise expressly provided herein, to reimburse the Trustee in a timely manner upon its request for all reasonable expenses, disbursements and advances incurred or made by the Trustee in accordance with any provision of this Indenture (including, without limitation, securities transaction charges and the reasonable compensation and expenses and disbursements of its agents and legal counsel and of any accounting firm or investment banking firm employed by the Trustee pursuant to <u>Sections 5.4, 5.5, 10.8</u> or any other term of this Indenture, except any such expense, disbursement or advance as may be attributable to its negligence, willful misconduct or bad faith) but with respect to securities transaction charges, only to the extent any such charges have not been waived during a Collection Period due to the Trustee's receipt of a payment from a

financial institution with respect to certain Eligible Investments, as specified by the Investment Manager in writing;

- (iii) to indemnify the Trustee and its Officers, directors, employees and agents for, and to hold them harmless against, any loss, liability or expense incurred without negligence, willful misconduct or bad faith on their part, and arising out of or in connection with the acceptance or administration of this Indenture and the transactions contemplated thereby, including the costs and expenses of defending themselves (including reasonable attorney's fees and costs) against any claim or liability in connection with the exercise or performance of any of their powers or duties hereunder and under any other Transaction Document; and
- (iv) to pay the Trustee reasonable additional compensation together with its expenses (including reasonable counsel fees) for any collection action taken pursuant to <u>Section 6.13</u> or the exercise or enforcement of remedies pursuant to <u>Article V</u>.
- (b) The Trustee shall receive amounts pursuant to this <u>Section 6.7</u> in accordance with the Priority of Payments but only to the extent that funds are available for the payment thereof. Subject to <u>Section 6.9</u>, the Trustee shall continue to serve as Trustee under this Indenture notwithstanding the fact that the Trustee shall not have received amounts due it hereunder; <u>provided</u> that nothing herein shall impair or affect the Trustee's rights under <u>Section 6.9</u>. No direction by the Holders shall affect the right of the Trustee to collect amounts owed to it under this Indenture. If on any date when a fee or expense shall be payable to the Trustee pursuant to this Indenture insufficient funds are available for the payment thereof, any portion of a fee not so paid shall be deferred and payable on such later date on which a fee shall be payable and sufficient funds are available therefor. The Issuer's obligations under this <u>Section 6.7</u> shall survive the termination of this Indenture and the resignation or removal of the Trustee pursuant to <u>Section 6.9</u>.
- (c) The Trustee hereby agrees not to cause the filing of a petition in bankruptcy against the Issuer, the Co-Issuer and any Tax Subsidiary for the non-payment to the Trustee of any amounts provided by this Section 6.7 until at least one year (or, if longer, the applicable preference period then in effect) plus one day after the payment in full of all Notes and payment of any amount payable to the Fiscal Agent pursuant to this Indenture for distribution to Shareholders in accordance with the Fiscal Agency Agreement.
- (d) To the extent that the entity acting as Trustee is acting as Registrar, Calculation Agent, Paying Agent, Authenticating Agent or Intermediary, the rights, privileges, immunities and indemnities set forth in this <u>Article VI</u> shall also apply to it acting in each such capacity.
- Section 6.8 <u>Corporate Trustee Required; Eligibility</u>. There shall at all times be a Trustee hereunder which shall be an organization or entity organized and doing business underthe laws of the United States of America or of any state thereof, authorized under such laws to exercise corporate trust powers, having a combined capital and surplus of at least U.S.\$200,000,000, subject to supervision or examination by federal or state authority, having a long term debt rating of at least "Baa1" by Moody's and a long term debt rating of at least "A+"

by S&P or a long term debt rating of at least "A" by S&P and a short term debt rating of at least "A 1" by S&P, and having an office within the United States. If such organization or entity publishes reports of condition at least annually, pursuant to law or to the requirements of the aforesaid supervising or examining authority, then for the purposes of this Section 6.8, the combined capital and surplus of such organization or entity shall be deemed to be its combined capital and surplus as set forth in its most recent published report of condition Eligible Institution. If at any time the Trustee shall cease to be eligible in accordance with the provisions of this Section 6.8, ceases to be an Eligible Institution, it shall resign immediately in the manner and with the effect hereinafter specified in this Article VI.

# Section 6.9 Resignation and Removal; Appointment of Successor.

- (a) (a) No resignation or removal of the Trustee and no appointment of a successor Trustee pursuant to this <u>Article VI</u> shall become effective until the acceptance of appointment by the successor Trustee under <u>Section 6.10</u>.
- The Trustee may resign at any time by giving written notice thereof to the Co-Issuers, the Investment Manager, the Holders and each Rating Agency not less than 60 days prior to such resignation. Upon receiving such notice of resignation, the Co-Issuers shall promptly appoint a successor trustee or trustees satisfying the requirements of Section 6.8that is an Eligible Institution by written instrument, in duplicate, executed by an Authorized Officer of the Issuer and an Authorized Officer of the Co-Issuer, one copy of which shall be delivered to the Trustee so resigning and one copy to the successor Trustee or Trustees, together with a copy to each Holder and the Investment Manager; provided that the Issuer shall provide prior written notice to the Rating Agencies of any such appointment; provided, further, that the Issuer shall not appoint such successor trustee or trustees without the consent of a Majority of the Secured Notes of each Class voting as a single class (or, at any time when an Event of Default shall have occurred and be continuing or when a successor Trustee has been appointed pursuant to <u>Section</u> 6.9(e), by an Act of a Majority of the Controlling Class) unless (i) the Issuer gives ten days' prior written notice to the Holders of such amendment and (ii) a Majority of the Secured Notes (or, at any time when an Event of Default shall have occurred and be continuing or when a successor Trustee has been appointed pursuant to Section 6.9(e), a Majority of the Controlling Class) do not provide written notice to the Issuer objecting to such appointment (the failure of any such Majority to provide such notice to the Issuer within ten days of receipt of notice of such appointment from the Issuer being conclusively deemed to constitute hereunder consent to such appointment and approval of such successor trustee or trustees). If no successor Trustee shall have been appointed and an instrument of acceptance by a successor Trustee shall not have been delivered to the Trustee within 30 days after the giving of such notice of resignation, the resigning Trustee or any Holder, on behalf of himself and all others similarly situated, may petition any court of competent jurisdiction for the appointment of a successor Trustee satisfying the requirements of Section 6.8. that is an Eligible Institution.
- (c) The Trustee may be removed at any time by Act of a Majority of each Class of Secured Notes voting separately or, at any time when an Event of Default shall have occurred and be continuing by an Act of a Majority of the Controlling Class, delivered to the Trustee and to the Co-Issuers.

- (d) If at any time:
- (i) the Trustee shall cease to be eligible under Section 6.8an Eligible Institution and shall fail to resign after written request therefor by the Co-Issuers or a Majority of the Controlling Class; or
- (ii) the Trustee shall become incapable of acting or shall be adjudged as bankrupt or insolvent or a receiver or liquidator of the Trustee or of its property shall be appointed or any public officer shall take charge or control of the Trustee or of its property or affairs for the purpose of rehabilitation, conservation or liquidation;

then, in any such case (subject to <u>Section 6.9(a)</u>), (A) the Co-Issuers, by Issuer Order, may remove the Trustee, or (B) subject to <u>Section 5.15</u>, any Holder may, on behalf of himself and all others similarly situated, petition any court of competent jurisdiction for the removal of the Trustee and the appointment of a successor Trustee.

- (e) If the Trustee shall be removed or become incapable of acting, or if a vacancy shall occur in the office of the Trustee for any reason (other than resignation), the Co-Issuers, by Issuer Order, shall promptly appoint a successor Trustee. If the Co-Issuers shall fail to appoint a successor Trustee within 30 days after such removal or incapability or the occurrence of such vacancy, a successor Trustee may be appointed by a Majority of the Controlling Class by written instrument delivered to the Issuer and the retiring Trustee. The successor Trustee so appointed shall, forthwith upon its acceptance of such appointment, become the successor Trustee and supersede any successor Trustee proposed by the Co-Issuers. If no successor Trustee shall have been so appointed by the Co-Issuers or a Majority of the Controlling Class and shall have accepted appointment in the manner hereinafter provided, subject to Section 5.15, the retiring Trustee may, or any Holder may, on behalf of himself and all others similarly situated, petition any court of competent jurisdiction for the appointment of a successor Trustee.
- (f) The Co-Issuers shall give prompt notice of each resignation and each removal of the Trustee and each appointment of a successor Trustee to the Investment Manager, to the Holders and to each Rating Agency. Each notice shall include the name of the successor Trustee and the address of its Corporate Trust Office. If the Co-Issuers fail to provide such notice within 10 days after acceptance of appointment by the successor Trustee, the successor Trustee shall cause such notice to be given at the expense of the Co-Issuers.
- (g) Any resignation or removal of the Trustee under this <u>Section 6.9</u> shall be an effective resignation or removal of the Bank in all capacities under this Indenture and as Collateral Administrator under the Collateral Administration Agreement.

Section 6.10 Acceptance of Appointment by Successor. Every successor Trustee appointed hereunder shall meet the requirements of Section 6.8 by an Eligible Institution and shall execute, acknowledge and deliver to the Co-Issuers and the retiring Trustee an instrument accepting such appointment. Upon delivery of the required instruments, the resignation or removal of the retiring Trustee shall become effective and such successor Trustee, without any further act, deed or conveyance, shall become vested with all the rights, powers,

trusts, duties and obligations of the retiring Trustee; but, on request of the Co-Issuers or a Majority of any Class of Secured Notes or the successor Trustee, such retiring Trustee shall, upon payment of its charges then unpaid, execute and deliver an instrument transferring to such successor Trustee all the rights, powers and trusts of the retiring Trustee, and shall duly assign, transfer and deliver to such successor Trustee all property and Money held by such retiring Trustee hereunder. Upon request of any such successor Trustee, the Co-Issuers shall execute any and all instruments for more fully and certainly vesting in and confirming to such successor Trustee all such rights, powers and trusts.

Section 6.11 Merger, Conversion, Consolidation or Succession to Business of Trustee. Any organization or entity into which the Trustee may be merged or converted or with which it may be consolidated, or any organization or entity resulting from any merger, conversion or consolidation to which the Trustee shall be a party, or any organization or entity succeeding to all or substantially all of the corporate trust business of the Trustee, shall be the successor of the Trustee hereunder, provided such organization or entity shall be otherwise qualified and eligible under this Article VI, without the execution or filing of any paper or any further act on the part of any of the parties hereto. In case any of the Notes has been authenticated, but not delivered, by the Trustee then in office, any successor by merger, conversion or consolidation to such authenticating Trustee may adopt such authentication and deliver the Notes so authenticated with the same effect as if such successor Trustee had itself authenticated such Notes.

Section 6.12 <u>Co-Trustees</u>. At any time or times, for the purpose of meeting the legal requirements of any jurisdiction in which any part of the Assets may at the time be located, the Co-Issuers and the Trustee shall have power to appoint one or more Persons that satisfy the eligibility requirements of Section 6.8 are Eligible Institutions to act as co-trustee (with notice to the Rating Agencies), jointly with the Trustee, of all or any part of the Assets, with the power to file such proofs of claim and take such other actions pursuant to <u>Section 5.6</u> and to make such claims and enforce such rights of action on behalf of the Holders, as such Holders themselves may have the right to do, subject to the other provisions of this <u>Section 6.12</u>.

The Co-Issuers shall join with the Trustee in the execution, delivery and performance of all instruments and agreements necessary or proper to appoint a co-trustee. If the Co-Issuers do not join in such appointment within 15 days after the receipt by them of a request to do so, the Trustee shall have the power to make such appointment.

Should any written instrument from the Co-Issuers be required by any co-trustee so appointed, more fully confirming to such co-trustee such property, title, right or power, any and all such instruments shall, on request, be executed, acknowledged and delivered by the Co-Issuers. The Co-Issuers agree to pay (but only from and to the extent of the Assets), to the extent funds are available therefor under the Priority of Payments, any reasonable fees and expenses in connection with such appointment.

Every co-trustee shall, to the extent permitted by law, but to such extent only, be appointed subject to the following terms:

- (a) the Notes shall be authenticated and delivered and all rights, powers, duties and obligations hereunder in respect of the custody of securities, Cash and other personal property held by, or required to be deposited or pledged with, the Trustee hereunder, shall be exercised solely by the Trustee;
- (b) the rights, powers, duties and obligations hereby conferred or imposed upon the Trustee in respect of any property covered by the appointment of a co-trustee shall be conferred or imposed upon and exercised or performed by the Trustee or by the Trustee and such co-trustee jointly as shall be provided in the instrument appointing such co-trustee;
- (c) the Trustee at any time, by an instrument in writing executed by it, with the concurrence of the Co-Issuers evidenced by an Issuer Order, may accept the resignation of or remove any co-trustee appointed under this Section 6.12, and in case an Event of Default has occurred and is continuing, the Trustee shall have the power to accept the resignation of, or remove, any such co-trustee without the concurrence of the Co-Issuers. A successor to any co-trustee so resigned or removed may be appointed in the manner provided in this Section 6.12;
- (d) no co-trustee hereunder shall be personally liable by reason of any act or omission of the Trustee hereunder;
- (e) the Trustee shall not be liable by reason of any act or omission of a co-trustee; and
- (f) any Act of Holders delivered to the Trustee shall be deemed to have been delivered to each co-trustee.

Section 6.13 <u>Certain Duties of Trustee Related to Delayed Payment of Proceeds.</u> In the event that in any month the Trustee shall not have received a payment with respect to any Pledged Obligation on its Due Date, (a) the Trustee shall promptly notify the Issuer and the Investment Manager in writing and (b) unless within three Business Days (or the end of the applicable grace period for such payment, if longer) after such notice such payment shall have been received by the Trustee, or the Issuer, in its absolute discretion (but only to the extent permitted by Section 10.2(a)), shall have made provision for such payment satisfactory to the Trustee in accordance with Section 10.2(a), the Trustee shall request the issuer of such Pledged Obligation, the trustee under the related Underlying Instrument or paying agent designated by either of them, as the case may be, to make such payment as soon as practicable after such request but in no event later than three Business Days after the date of such request. In the event that such payment is not made within such time period, the Trustee, subject to the provisions of clause (iv) of Section 6.1(c), shall take such action as the Investment Manager shall direct in writing. Any such action shall be without prejudice to any right to claim a Default or Event of Default under this Indenture. In the event that the Issuer or the Investment Manager requests a release of a Pledged Obligation and/or delivers an additional Collateral Obligation in connection with any such action under the Investment Management Agreement, such release and/or

substitution shall be subject to <u>Section 10.7</u> and <u>Article XII</u> of this Indenture, as the case may be. Notwithstanding any other provision hereof, the Trustee shall deliver to the Issuer or its designee any payment with respect to any Pledged Obligation, or any additional Collateral Obligation received after the Due Date thereof to the extent the Issuer previously made provisions for such payment satisfactory to the Trustee in accordance with this <u>Section 6.13</u> and such payment shall not be deemed part of the Assets.

Section 6.14 <u>Authenticating Agents</u>. Upon the request of the Co-Issuers, the Trustee shall, and if the Trustee so chooses the Trustee may, appoint one or more Authenticating Agents with power to act on its behalf and subject to its direction in the authentication of Notes in connection with issuance, transfers and exchanges under <u>Sections 2.4, 2.5, 2.6, 2.7</u> and <u>8.5</u>, as fully to all intents and purposes as though each such Authenticating Agent had been expressly authorized by such Sections to authenticate such Notes. For all purposes of this Indenture, the authentication of Notes by an Authenticating Agent pursuant to this <u>Section 6.14</u> shall be deemed to be the authentication of Notes by the Trustee.

Any corporation into which any Authenticating Agent may be merged or converted or with which it may be consolidated, or any corporation resulting from any merger, consolidation or conversion to which any Authenticating Agent shall be a party, or any corporation succeeding to the corporate trust business of any Authenticating Agent, shall be the successor of such Authenticating Agent hereunder, without the execution or filing of any further act on the part of the parties hereto or such Authenticating Agent or such successor corporation.

Any Authenticating Agent may at any time resign by giving written notice of resignation to the Trustee and the Issuer. The Trustee may at any time terminate the agency of any Authenticating Agent by giving written notice of termination to such Authenticating Agent and the Co-Issuers. Upon receiving such notice of resignation or upon such a termination, the Trustee shall, upon the written request of the Issuer, promptly appoint a successor Authenticating Agent and shall give written notice of such appointment to the Co-Issuers.

Unless the Authenticating Agent is also the same entity as the Trustee, the Issuer agrees to pay to each Authenticating Agent from time to time reasonable compensation for its services, and reimbursement for its reasonable expenses relating thereto as an Administrative Expense under Section 11.1. The provisions of Sections 2.9, 6.4 and 6.5 shall be applicable to any Authenticating Agent.

Section 6.15 <u>Withholding</u>. If any withholding tax is imposed on the Issuer's payment (or allocations of income) under the Notes to any Holder, such tax shall reduce the amount otherwise distributable to such Holder. The Trustee or any Paying Agent is hereby authorized and directed to retain from amounts otherwise distributable to any Holder sufficient funds for the payment of any tax that is legally owed or required to be withheld by the Issuer (but such authorization shall not prevent the Trustee or such Paying Agent from contesting any such tax in appropriate proceedings and withholding payment of such tax, if permitted by law, pending the outcome of such proceedings). The amount of any withholding tax imposed with respect to any Holder shall be treated as Cash distributed to such Holder at the time it is withheld by the Trustee or any Paying Agent and remitted to the appropriate taxing authority. If there is a possibility that withholding tax is payable with respect to a distribution and the Trustee or any

Paying Agent has not received documentation from such Holder showing an exemption from withholding, the Trustee or such Paying Agent shall withhold such amounts in accordance with this Section 6.15. If any Holder wishes to apply for a refund of any such withholding tax, the Trustee or such Paying Agent shall reasonably cooperate with such Holder in making such claim so long as such Holder agrees to reimburse the Trustee or such Paying Agent for any out-of-pocket expenses incurred. Nothing herein shall impose an obligation on the part of the Trustee or any Paying Agent to determine the amount of any tax or withholding obligation on the part of the Issuer or in respect of the Securities.

Section 6.16 Representative for Holders of Secured Notes Only; Agent for each Hedge Counterparty and the Holders of the Subordinated Notes. With respect to the security interest created hereunder, the delivery of any Asset to the Trustee is to the Trustee as representative of the Holders of Secured Notes and agent for each other Secured Party and the Holders of the Subordinated Notes. In furtherance of the foregoing, the possession by the Trustee of any Asset, the endorsement to or registration in the name of the Trustee of any Asset are all undertaken by the Trustee in its capacity as representative of the Holders of Secured Notes and agent for each other Secured Party and the Holders of the Subordinated Notes.

Section 6.17 <u>Representations and Warranties of the Bank</u>. The Bank hereby represents and warrants as follows:

- (a) <u>Organization</u>. The Bank has been duly organized and is validly existing as a trust company with trust powers under the laws of the Commonwealth of Massachusetts and has the power to conduct its business and affairs as a trustee, paying, agent, registrar, transfer agent, custodian, calculation agent, bank and Securities Intermediary.
- (b) Authorization; Binding Obligations. The Bank has the corporate power and authority to perform the duties and obligations of trustee under this Indenture. The Bank has taken all necessary corporate action to authorize the execution, delivery and performance of this Indenture, and all of the documents required to be executed by the Bank pursuant hereto. Upon execution and delivery by the Bank, this Indenture shall constitute the legal, valid and binding obligation of the Bank enforceable against the Bank in accordance with its terms, subject to applicable bankruptcy, insolvency, reorganization, fraudulent conveyance, moratorium, liquidation and similar laws affecting the rights of creditors, and subject to equitable principles including without limitation concepts of materiality, reasonableness, good faith and fair dealing (whether enforcement is sought in a legal or equitable Proceeding), and except that certain of such obligations may be enforceable solely against the Assets.
- (c) <u>Eligibility</u>. The Bank is <u>eligible under Section 6.8 to serve as Trustee</u> <u>hereunder an Eligible Institution</u>.
- (d) <u>No Conflict</u>. Neither the execution, delivery and performance of this Indenture, nor the consummation of the transactions contemplated by this Indenture, (i) is prohibited by, or requires the Bank to obtain any consent, authorization, approval or registration with any United States federal or state or other governmental body under any United States federal or state regulation or law having jurisdiction over the banking or trust powers of the Bank.

Section 6.18 Communication with Rating Agencies. Any written communication, including any confirmation, from a Rating Agency provided for or required to be obtained by the Trustee hereunder shall be sufficient in each case when such communication or confirmation is received by the Trustee, including by electronic message, facsimile, press release, or by posting to the applicable Rating Agency's website. For the avoidance of doubt, no written communication given by S&P or Moody's under this Section 6.18 shall be deemed to satisfy the S&P Rating Condition or the Moody's Rating Condition unless such communication is provided by S&P or Moody's specifically in satisfaction of the S&P Rating Condition or the Moody's Rating Condition, as applicable.

#### **ARTICLE VII**

#### **COVENANTS**

Section 7.1 <u>Payment of Principal and Interest</u>. The Applicable Issuers shall duly and punctually pay the principal of and interest on the Secured Notes, in accordance with the terms of such Notes and this Indenture pursuant to the Priority of Payments. The Issuer shall, to the extent legally permitted and to the extent funds are available pursuant to the Priority of Payments, duly and punctually pay all required distributions on the Subordinated Notes, in accordance with such Notes and this Indenture.

The Issuer shall, subject to the Priority of Payments, reimburse the Co-Issuer for any amounts paid by the Co-Issuer pursuant to the terms of the Notes or this Indenture. The Co-Issuer shall not reimburse the Issuer for any amounts paid by the Issuer pursuant to the terms of the Notes or this Indenture.

Amounts properly withheld under the Code or other applicable law by any Person from a payment to any Holder shall be considered as having been paid by the Applicable Issuers to such Holder for all purposes of this Indenture.

Section 7.2 <u>Maintenance of Office or Agency</u>. The Co-Issuers hereby appoint the Trustee as a Paying Agent for payments on the Notes. Certificated Securities may be surrendered for registration of transfer or exchange at the Corporate Trust Office of the Trustee or its agent designated for purposes of surrender, transfer or exchange. The Co-Issuers hereby appoint National Corporate Research, Ltd., 10 East 40th Street, 10th Floor, New York, New York 10016, as agent upon whom process or demands may be served in any action arising out of or based on this Indenture or the transactions contemplated hereby.

The Co-Issuers may at any time and from time to time vary or terminate the appointment of any such agent or appoint any additional agents for any or all of such purposes; provided, however, that the Co-Issuers shall maintain in the Borough of Manhattan, The City of New York, an office or agency where notices and demands to or upon the Co-Issuers in respect of such Notes and this Indenture may be served and, subject to any laws or regulations applicable thereto, an office or agency outside of the United States where Certificated Securities may be presented and surrendered for payment; provided, further, that no paying agent shall be appointed in a jurisdiction which subjects payments on the Notes to withholding tax in excess of any withholding tax that was imposed on such payments immediately before the appointment. If at any time the Co-Issuers shall fail to maintain any such required office or agency in the Borough of Manhattan, The City of New York, or outside the United States, or shall fail to furnish the Trustee with the address thereof, presentations and surrenders may be made (subject to the limitations described in the preceding paragraph) at and notices and demands may be served on the Co-Issuers, and Notes may be presented and surrendered for payment to the appropriate Paying Agent at its main office, and the Co-Issuers hereby appoint the same as their agent to receive such respective presentations, surrenders, notices and demands.

The Co-Issuers hereby appoint, for so long as any Class of Securities is listed on the Irish Stock Exchange, Maples and Calder (the "Irish Listing Agent") as listing agent in Ireland with respect to the Listed Securities. In the event that the Irish Listing Agent is replaced at any time during such period, notice of the appointment of any replacement shall be sent to the Irish Stock Exchange as promptly as practicable after such appointment. The Co-Issuers shall give written notice as soon as reasonably practicable to the Trustee, the Holders, and each Rating Agency of the appointment or termination of any such agent and of the location and any change in the location of any such office or agency.

Section 7.3 <u>Money for Note Payments to Be Held in Trust</u>. All payments of amounts due and payable with respect to any Securities that are to be made from amounts withdrawn from the Payment Account shall be made on behalf of the Applicable Issuers by the Trustee or a Paying Agent with respect to payments on the Securities.

When the Applicable Issuers shall have a Paying Agent that is not also the Registrar, they shall furnish, or cause the Registrar to furnish, no later than the fifth calendar day after each Record Date a list, if necessary, in such form as such Paying Agent may reasonably request, of the names and addresses of the Holders and of the certificate numbers of individual Notes held by each such Holder.

Whenever the Applicable Issuers shall have a Paying Agent other than the Trustee, they shall, on or before the Business Day next preceding each Payment Date or Redemption Date, as the case may be, direct the Trustee to deposit on such Payment Date with such Paying Agent, if necessary, an aggregate sum sufficient to pay the amounts then becoming due (to the extent funds are then available for such purpose in the Payment Account), such sum to be held in trust for the benefit of the Persons entitled thereto and (unless such Paying Agent is the Trustee) the Co-Issuers shall promptly notify the Trustee of its action or failure so to act. Any Monies deposited with a Paying Agent (other than the Trustee) in excess of an amount sufficient to pay the amounts then becoming due on the Notes with respect to which such deposit was made shall be paid over by such Paying Agent to the Trustee for application in accordance with Article X.

The initial Paying Agent shall be as set forth in Section 7.2. Any additional or successor Paying Agents shall be appointed by Issuer Order with written notice thereof to the Trustee, with a copy to the Investment Manager; provided, however, that so long as the Notes of any Class are rated by a Rating Agency, with respect to any additional or successor Paying Agent, either (i) such Paying Agent has a long-term debt rating of at least "A+" or higher by S&P and "A2" or higher by Moody's andor a short-term debt rating of "P-1" by Moody's and "A-1+at least "A-1" by S&P or (ii) the Global Rating Agency Condition is satisfied. In the event that, If such successor Paying Agent ceases to have a long term debt rating of "A+" or higher by S&P and "A2" or higher by Moody's or a short term debt rating of "P-1" by Moody's and "A-1+" by S&Psuch ratings, the Co-Issuers shall promptly remove such Paying Agent and appoint a successor Paying Agent that satisfies such required ratings within 30 days of receipt of notice of such failure. The Co-Issuers shall not appoint any Paying Agent that is not, at the time of such appointment, a depository institution or trust company subject to supervision and examination by federal and/or state and/or national banking authorities. The Co-Issuers shall

cause each Paying Agent other than the Trustee to execute and deliver to the Trustee an instrument in which such Paying Agent shall agree with the Trustee and if the Trustee acts as Paying Agent, it hereby so agrees, subject to the provisions of this <u>Section 7.3</u>, that such Paying Agent shall:

- (a) allocate all sums received for payment to the Holders of Classes for which it acts as Paying Agent on each Payment Date and any Redemption Date among such Holders in the proportion specified in the applicable Distribution Report or report pertaining to such Redemption Date to the extent permitted by applicable law;
- (b) hold all sums held by it for the payment of amounts due with respect to the Securities in trust for the benefit of the Persons entitled thereto until such sums shall be paid to such Persons or otherwise disposed of as herein provided and pay such sums to such Persons as herein provided;
- (c) if such Paying Agent is not the Trustee, immediately resign as a Paying Agent and forthwith pay to the Trustee all sums held by it in trust for the payment of Securities if at any time it ceases to meet the standards set forth above required to be met by a Paying Agent at the time of its appointment;
- (d) if such Paying Agent is not the Trustee, immediately give the Trustee notice of any default by the Issuer or the Co-Issuer (or any other obligor upon the Securities) in the making of any payment required to be made; and
- (e) if such Paying Agent is not the Trustee, during the continuance of any such default, upon the written request of the Trustee, forthwith pay to the Trustee all sums so held in trust by such Paying Agent.

The Co-Issuers may at any time, for the purpose of obtaining the satisfaction and discharge of this Indenture or for any other purpose, pay, or by Issuer Order direct any Paying Agent to pay, to the Trustee all sums held in trust by the Co-Issuers or such Paying Agent, such sums to be held by the Trustee upon the same trusts as those upon which such sums were held by the Co-Issuers or such Paying Agent; and, upon such payment by any Paying Agent to the Trustee, such Paying Agent shall be released from all further liability with respect to such Money.

Except as otherwise required by applicable law, any Money deposited with the Trustee or any Paying Agent in trust for any payment on any Note and remaining unclaimed for two years after such amount has become due and payable shall be paid to the Applicable Issuers on Issuer Order; and the Holder of such Note shall thereafter, as an unsecured general creditor, look only to the Applicable Issuers for payment of such amounts (but only to the extent of the amounts so paid to the Applicable Issuers) and all liability of the Trustee or such Paying Agent with respect to such trust Money shall thereupon cease. The Trustee or such Paying Agent, before being required to make any such release of payment, may, but shall not be required to, adopt and employ, at the expense of the Applicable Issuers any reasonable means of notification of such release of payment, including, but not limited to, mailing notice of such release to Holders whose Certificated Securities have been called but have not been surrendered for

redemption or whose right to or interest in Monies due and payable but not claimed is determinable from the records of any Paying Agent, at the last address of record of each such Holder.

# Section 7.4 Existence of Co-Issuers.

The Issuer and the Co-Issuer shall, to the maximum extent permitted by applicable law, maintain in full force and effect their existence and rights as companies incorporated or organized under the laws of the Cayman Islands and the State of Delaware, respectively, and shall obtain and preserve their qualification to do business as foreign corporations in each jurisdiction in which such qualifications are or shall be necessary to protect the validity and enforceability of this Indenture, the Notes or any of the Assets; provided, however, that the Issuer shall be entitled to change its jurisdiction of incorporation from the Cayman Islands to any other jurisdiction reasonably selected by the Issuer so long as (i) the Issuer has received a legal opinion (upon which the Trustee may conclusively rely) to the effect that such change is not disadvantageous in any material respect to the Holders, (ii) written notice of such change shall have been given by the Issuer to the Trustee (which shall provide notice to the Holders), the Investment Manager, and each Rating Agency and (iii) on or prior to the 15th Business Day following receipt of such notice the Trustee shall not have received written notice from a Majority of the Controlling Class objecting to such change; provided, further, that the Issuer shall be entitled to take any action required by this Indenture within the United States notwithstanding any provision of this Indenture requiring the Issuer to take such action outside of the United States so long as prior to taking any such action the Issuer receives a legal opinion from nationally recognized legal counsel to the effect that it is not necessary to take such action outside of the United States or any political subdivision thereof in order to prevent the Issuer from becoming subject to U.S. federal, state or local income taxes on a net income basis or any material other taxes to which the Issuer would not otherwise be subject.

Each of the Issuer and the Co-Issuer shall (i) ensure that all corporate or other formalities regarding its existence (including, to the extent required by applicable law, holding regular board of directors,' members', partners' and shareholders' or other similar meetings) are followed, (ii) conduct business in its own name, (iii) correct any known misunderstanding as to its separate existence, (iv) keep separate books and records and (v) not commingle its funds with those of any other entity. Neither the Issuer nor the Co-Issuer shall take any action, or conduct its affairs in a manner, that is likely to result in its separate existence being ignored or in its assets and liabilities being substantively consolidated with any other Person in a bankruptcy, reorganization or other insolvency proceeding. Without limiting the foregoing, (i) the Issuer shall not have any subsidiaries (other than the Co-Issuer and any Tax Subsidiary), (ii) the Co-Issuer shall not have any subsidiaries and (iii) except to the extent contemplated in the Administration Agreement, the Registered Office Agreement or the Issuer's amended and restated declaration of trust, the Issuer and the Co-Issuer shall not (A) have any employees (other than their respective directors, members or managers, as applicable), (B) except as contemplated by the Investment Management Agreement, the Memorandum and Articles, the Registered Office Agreement or the Administration Agreement, engage in any transaction with any shareholder or member, as applicable, that would constitute a conflict of interest or (C) pay dividends other than in accordance with the terms of this Indenture and the Memorandum and Articles.

#### Section 7.5 Protection of Assets.

- (a) (a) The Issuer, or the Investment Manager on behalf and at the expense of the Issuer, shall cause the taking of such action by the Issuer (or by the Investment Manager if within the Investment Manager's control under the Investment Management Agreement) as is reasonably necessary in order to perfect and maintain the perfection and priority of the security interest of the Trustee in the Assets. The Issuer shall from time to time prepare or cause to be prepared, execute, deliver and file all such supplements and amendments hereto and all such Financing Statements, continuation statements, instruments of further assurance and other instruments, and shall take such other action as may be necessary or advisable or desirable to secure the rights and remedies of the Trustee for the benefit of the Holders of the Secured Notes hereunder and to:
  - (i) Grant more effectively all or any portion of the Issuer's right, title and interest in, to and under the Assets;
  - (ii) maintain, preserve and perfect any Grant made or to be made by this Indenture including, without limitation, the first priority nature of the lien or carry out more effectively the purposes hereof;
  - (iii) perfect, publish notice of or protect the validity of any Grant made or to be made by this Indenture (including, without limitation, any and all actions necessary or desirable as a result of changes in law or regulations);
  - (iv) enforce any of the Pledged Obligations or other instruments or property included in the Assets;
  - (v) preserve and defend title to the Assets and the rights therein of the Secured Parties in the Assets against the claims of all Persons and parties; or
  - (vi) if required to avoid or reduce the withholding, deduction, or imposition of United States income or withholding tax, and if reasonably able to do so, deliver or cause to be delivered a United States Internal Revenue Service Form W-8BEN or successor applicable form and other properly completed and executed documentation, agreements, and certifications to each issuer, counterparty, paying agent, and/or to any applicable taxing authority or other governmental authority as necessary to permit the Issuer to receive payments without withholding or deduction or at a reduced rate of withholding or deduction and to otherwise pay or cause to be paid any and all taxes levied or assessed upon all or any part of the Assets.

The Issuer hereby designates the Trustee as its agent and attorney in fact to prepare and file or record any Financing Statement (other than the Financing Statement delivered on the Closing Date), continuation statement and all other instruments, and take all other actions, required pursuant to this <u>Section 7.5</u>; <u>provided</u> that such appointment shall not impose upon the Trustee any of the Issuer's or the Investment Manager's obligations under this <u>Section 7.5</u>. In connection therewith, the Trustee shall be entitled to receive, at the cost of the Issuer, and conclusively rely upon an Opinion of Counsel delivered in accordance with <u>Section 7.6</u> as to the

need to file, the dates by which such filings are required to be made and the jurisdiction in which such filings are to be made and the form and content of such filings. The Issuer further authorizes and shall cause the Issuer's United States counsel to file a Financing Statement that names the Issuer as debtor and the Trustee, on behalf of the Secured Parties, as secured party and that describes "all assets in which the debtor now or hereafter has rights" as the Assets in which the Trustee has a Grant.

- (b) The Trustee shall not, except in accordance with <u>Article V</u> and <u>Sections 10.6, 12.1</u> and <u>12.3</u>, as applicable, permit the removal of any portion of the Assets or transfer any such Assets from the Account to which it is credited, or cause or permit any change in the Delivery made pursuant to <u>Section 3.3</u> with respect to any Assets if, after giving effect thereto, the jurisdiction governing the perfection of the Trustee's security interest in such Assets is different from the jurisdiction governing the perfection at the time of delivery of the most recent Opinion of Counsel pursuant to <u>Section 7.6</u> (or, if no Opinion of Counsel has yet been delivered pursuant to <u>Section 7.6</u>, the Opinion of Counsel delivered at the Closing Date pursuant to <u>Section 3.1(a)(iii)</u>) unless the Trustee shall have received an Opinion of Counsel to the effect that the lien and security interest created by this Indenture with respect to such property and the priority thereof shall continue to be maintained after giving effect to such action or actions.
- (c) The Issuer shall make an entry of the security interest created by this Indenture in the Register of Mortgages and Charges maintained at the Issuer's registered office in the Cayman Islands.

Section 7.6 Opinions as to Assets. For so long as any Secured Notes are Outstanding, no later than the March 31<sup>st</sup> that precedes the fifth anniversary of the Closing Date (and every five years thereafter), the Issuer shall furnish to the Trustee an Opinion of Counsel stating that, in the opinion of such counsel, as of the date of such opinion, the lien and security interest created by this Indenture with respect to the Assets remains a valid and perfected lien or the equivalent under applicable law and stating that no further action (other than as specified in such opinion) needs to be taken under current law to ensure the continued effectiveness and perfection of such lien over the next year.

### Section 7.7 <u>Performance of Obligations.</u>

- (a) (a) The Co-Issuers, each as to itself, shall not take any action, and shall use their commercially reasonable efforts not to permit any action to be taken by others, that would release any Person from any of such Person's covenants or obligations under any instrument included in the Assets, except in the case of pricing amendments, ordinary course waivers/amendments, and enforcement action taken with respect to any Defaulted Obligation in accordance with the provisions hereof and actions by the Investment Manager under the Investment Management Agreement and in conformity with this Indenture or as otherwise required hereby.
- (b) The Applicable Issuers may, with the prior written consent of a Majority of each Class of Secured Notes (except in the case of the Investment Management Agreement and the Collateral Administration Agreement, in which case no consent shall be required), contract with other Persons, including the Investment Manager, the Trustee and the Collateral

Administrator for the performance of actions and obligations to be performed by the Applicable Issuers hereunder and under the Investment Management Agreement by such Persons. Notwithstanding any such arrangement, the Applicable Issuers shall remain primarily liable with respect thereto. In the event of such contract, the performance of such actions and obligations by such Persons shall be deemed to be performance of such actions and obligations by the Applicable Issuers; and the Applicable Issuers shall punctually perform, and use their commercially reasonable efforts to cause the Investment Manager, the Trustee, the Collateral Administrator and such other Person to perform, all of their obligations and agreements contained in the Investment Management Agreement, this Indenture, the Collateral Administration Agreement or any such other agreement.

(c) If the Co-Issuers receive a notice from a Rating Agency stating that they are not in compliance with Rule 17g-5, the Co-Issuers shall take such action as mutually agreed between the Co-Issuers and such Rating Agency in order to comply with Rule 17g-5.

## Section 7.8 <u>Negative Covenants</u>.

- (a) (a) The Issuer shall not and, with respect to clauses (i), (ii), (iii), (iv), (vi), (vii), (viii), (ix) and (x) the Co-Issuer shall not, except as otherwise permitted by this Indenture, in each case from and after the Closing Date:
  - (i) sell, transfer, exchange or otherwise dispose of, or pledge, mortgage, hypothecate or otherwise encumber (or permit such to occur or suffer such to exist), any part of the Assets;
  - (ii) claim any credit on, make any deduction from, or dispute the enforceability of payment of the principal or interest payable (or any other amount) in respect of the Notes (other than amounts withheld in accordance with the Code or any applicable laws of the Cayman Islands or other applicable jurisdiction) or assert any claim against any present or future Holder of Notes, by reason of the payment of any taxes levied or assessed upon any part of the Assets;
  - (iii) (A) incur or assume or guarantee any indebtedness, other than the Securities and this Indenture and the transactions contemplated hereby, or (B)(1) issue any additional class of securities or (2) issue any additional shares;
  - (iv) (A) permit the validity or effectiveness of this Indenture or any Grant hereunder to be impaired, or permit the lien of this Indenture to be amended, hypothecated, subordinated, terminated or discharged, or permit any Person to be released from any covenants or obligations with respect to this Indenture or the Notes, (B) permit any lien, charge, adverse claim, security interest, mortgage or other encumbrance to be created on or extend to or otherwise arise upon or burden any part of the Assets, any interest therein or the proceeds thereof, or (C) take any action that would permit the lien of this Indenture not to constitute a valid first priority security interest in the Assets;
  - (v) amend the Investment Management Agreement except pursuant to the terms thereof;

- (vi) dissolve or liquidate in whole or in part, except as permitted hereunder or required by applicable law;
- (vii) pay any distributions other than in accordance with the Priority of Payments;
  - (viii) permit the formation of any subsidiaries (other than any Tax Subsidiary);
  - (ix) conduct business under any name other than its own;
- (x) have any employees (other than directors to the extent they are employees);
- (xi) sell, transfer, exchange or otherwise dispose of Assets, or enter into an agreement or commitment to do so or enter into or engage in any business with respect to any part of the Assets;
- (xii) elect to be taxable for U.S. federal income tax purposes as other than a foreign corporation;
- (xiii) establish a branch, agency, office or place of business in the United States, or take any action or engage in any activity (directly or through any other agent) which would subject it to U.S. federal, state, or local tax;
- (xiv) solicit, advertise or publish the Issuer's ability to enter into credit derivatives;
- (xv) register as or become subject to regulatory supervision or other legal requirements under the laws of any country or political subdivision thereof as a bank, insurance company or finance company;
- (xvi) knowingly take any action that would reasonably be expected to cause it to be treated as a bank, insurance company or finance company for purposes of (i) any tax, securities law or other filing or submission made to any governmental authority, (ii) any application made to a rating agency or (iii) qualification for any exemption from tax, securities law or any other legal requirements; and
- (xvii) hold itself out to the public as a bank, insurance company or finance company.
- (b) The Co-Issuer shall not invest any of its assets in "<u>securities</u>" as such term is defined in the Investment Company Act, and shall keep all of its assets in Cash.
- (c) Notwithstanding anything to the contrary contained herein, the Issuer shall not, and shall use its commercially reasonable efforts to ensure that the Investment Manager acting on the Issuer's behalf does not, acquire or own any asset, conduct any activity or take any action unless the acquisition or ownership of such asset, the conduct of such activity or the taking

of such action, as the case may be, would not cause the Issuer to be engaged, or deemed to be engaged, in a trade or business within the United States for U.S. federal income tax purposes or otherwise to be subject to U.S. federal income tax on a net basis or income tax on a net income basis in any other jurisdiction.

- (d) The Issuer and the Co-Issuer shall not be party to any agreements (including Hedge Agreements) without including customary "non-petition" and "limited recourse" provisions therein (and shall not amend or eliminate such provisions in any agreement to which it is party), except for any agreements related to the purchase and sale of any Collateral Obligations or Eligible Investments which contain customary (as determined by the Investment Manager in its sole discretion) purchase or sale terms or which are documented using customary (as determined by the Investment Manager in its sole discretion) loan trading documentation.
- (e) The Issuer shall not acquire or hold any Certificated Securities in bearer form (other than securities not required to be in registered form under Section 163(f)(2)(A) of the Code) in a manner that does not satisfy the requirements of United States Treasury Regulations Section 1.165-12(c).
- (f) The Co-Issuer shall not fail to maintain an independent manager under its limited liability company agreement.
- Section 7.9 <u>Statement as to Compliance</u>. On or before March 31 in each calendar year, commencing in 2014, or immediately if there has been a Default under this Indenture and prior to the issuance of any Additional Securities pursuant to <u>Section 2.4</u>, the Issuer shall deliver to the Trustee, the Investment Manager and the Administrator (to be forwarded, at the cost of the Issuer, by the Trustee to each Holder making a written request therefor and each Rating Agency) an Officer's certificate of the Issuer that, having made reasonable inquiries of the Investment Manager, and to the best of the knowledge, information and belief of the Issuer, there did not exist, as at a date not more than five days prior to the date of the certificate, nor had there existed at any time prior thereto since the date of the last certificate (if any), any Default hereunder or, if such Default did then exist or had existed, specifying the same and the nature and status thereof, including actions undertaken to remedy the same, and that the Issuer has complied with all of its obligations under this Indenture or, if such is not the case, specifying those obligations with which it has not complied.
- Section 7.10 <u>Co-Issuers May Consolidate, etc., Only on Certain Terms</u>. Neither the Issuer nor the Co-Issuer (the "<u>Merging Entity</u>") shall consolidate or merge with or into any other Person or transfer or convey all or substantially all of its assets to any Person, unless permitted by Cayman Islands law (in the case of the Issuer) or United States and Delaware law (in the case of the Co-Issuer) and unless:
- (a) the Merging Entity shall be the surviving corporation, or the Person (if other than the Merging Entity) formed by such consolidation or into which the Merging Entity is merged or to which all or substantially all of the assets of the Merging Entity are transferred (the "Successor Entity") (A) if the Merging Entity is the Issuer, shall be a company incorporated and existing under the laws of the Cayman Islands or such other jurisdiction approved by a Majority of the Controlling Class; provided, that no such approval shall be required in connection with any

such transaction undertaken solely to effect a change in the jurisdiction of incorporation pursuant to <u>Section 7.4</u>, and (B) in any case shall expressly assume, by an indenture supplemental hereto, executed and delivered to the Trustee and each Holder, the due and punctual payment of the principal of and interest on all Secured Notes issued by the Merging Entity and the performance and observance of every covenant of this Indenture on its part to be performed or observed, all as provided herein;

- (b) the Trustee shall have received notice of such consolidation or merger and shall have distributed copies of such notice to each Rating Agency as soon as reasonably practicable and in any case no less than five days prior to such merger or consolidation, and the Trustee shall have received written confirmation from each Rating Agency S&P that its ratings issued with respect to the Secured Notes then rated by such Rating Agency shall not be reduced or withdrawn as a result of the consummation of such transaction;
- (c) if the Merging Entity is not the surviving corporation, the Successor Entity shall have agreed with the Trustee (i) to observe the same legal requirements for the recognition of such formed or surviving corporation as a legal entity separate and apart from any of its Affiliates as are applicable to the Merging Entity with respect to its Affiliates and (ii) not to consolidate or merge with or into any other Person or transfer or convey the Assets or all or substantially all of its assets to any other Person except in accordance with the provisions of this Section 7.10;
- if the Merging Entity is not the surviving corporation, the Successor Entity shall have delivered to the Trustee, and each Rating Agency, an Officer's certificate and an Opinion of Counsel each stating that such Person shall be duly organized, validly existing and in good standing in the jurisdiction in which such Person is organized; that such Person has sufficient power and authority to assume the obligations set forth in subsection (a) above and to execute and deliver an indenture supplemental hereto for the purpose of assuming such obligations; that such Person has duly authorized the execution, delivery and performance of an indenture supplemental hereto for the purpose of assuming such obligations and that such supplemental indenture is a valid, legal and binding obligation of such Person, enforceable in accordance with its terms, subject only to bankruptcy, reorganization, insolvency, moratorium and other laws affecting the enforcement of creditors' rights generally and to general principles of equity (regardless of whether such enforceability is considered in a Proceeding in equity or at law); if the Merging Entity is the Issuer, that, immediately following the event which causes such Successor Entity to become the successor to the Issuer, (i) such Successor Entity has title, free and clear of any lien, security interest or charge, other than the lien and security interest of this Indenture, to the Assets, and (ii) the Trustee continues to have a valid perfected first priority security interest in the Assets; and in each case as to such other matters as the Trustee or any Holder may reasonably require; provided, that nothing in this clause shall imply or impose a duty on the Trustee to require such other documents;
- (e) immediately after giving effect to such transaction, no Default or Event of Default shall have occurred and be continuing;
- (f) the Merging Entity shall have delivered notice to each Rating Agency, and the Merging Entity shall have delivered to the Trustee and each Holder an Officer's certificate

and an Opinion of Counsel each stating that such consolidation, merger, transfer or conveyance and such supplemental indenture comply with this <u>Article VII</u> and that all conditions in this <u>Article VII</u> relating to such transaction have been complied;

- (g) the Merging Entity shall have delivered to the Trustee an Opinion of Counsel stating that after giving effect to such transaction, neither of the Co-Issuers (or, if applicable, the Successor Entity) will be required to register as an investment company under the Investment Company Act; and
- (h) after giving effect to such transaction, the outstanding stock (other than the Subordinated Securities) of the Merging Entity (or, if applicable, the Successor Entity) will not be beneficially owned within the meaning of the Investment Company Act by any U.S. Person.

Section 7.11 <u>Successor Substituted</u>. Upon any consolidation or merger, or transfer or conveyance of all or substantially all of the assets of the Issuer or the Co-Issuer, in accordance with <u>Section 7.10</u> in which the Merging Entity is not the surviving corporation, the Successor Entity shall succeed to, and be substituted for, and may exercise every right and power of, and shall be bound by each obligation and covenant of, the Merging Entity under this Indenture with the same effect as if such Person had been named as the Issuer or the Co-Issuer, as the case may be, herein. In the event of any such consolidation, merger, transfer or conveyance, the Person named as the "Issuer" or the "Co-Issuer" in the first paragraph of this Indenture or any successor which shall theretofore have become such in the manner prescribed in this <u>Article VII</u> may be dissolved, wound up and liquidated at any time thereafter, and such Person thereafter shall be released from its liabilities as obligor and maker on all the Notes and from its obligations under this Indenture.

Section 7.12 No Other Business. From and after the Closing Date, the Issuer shall not engage in any business or activity other than issuing and selling the Securities pursuant to this Indenture and acquiring, owning, holding, selling, lending, exchanging, redeeming, pledging, contracting for the management of and otherwise dealing with Collateral Obligations and the other Assets in connection therewith and entering into Hedge Agreements, the Collateral Administration Agreement, the Account Agreement, the Investment Management Agreement and other agreements specifically contemplated by this Indenture, and the Co-Issuer shall not engage in any business or activity other than issuing and selling the Securities to be issued by it pursuant to this Indenture and, with respect to the Issuer and the Co-Issuer, such other activities which are necessary, suitable or convenient to accomplish the foregoing or are incidental thereto or connected therewith or ancillary thereto. The Issuer and the Co-Issuer may amend, or permit the amendment of, the Memorandum and Articles of the Issuer and the Certificate of Formation and Limited Liability Company Agreement of the Co-Issuer, respectively only in accordance with their terms. Notice will be provided to each Rating Agency of any such amendment.

# Section 7.13 <u>Annual Rating Review</u>.

(a) (a) So long as any of the Secured Notes of any Class remain Outstanding, on or before March 31st in each year, commencing in 2014, the Applicable Issuers shall obtain and pay for an annual the ongoing review of the rating of each such Class—of Secured Notes from each Rating Agency, as applicable; provided that the timeframe for the annual ratings

<u>review by Fitch may be determined by Fitch (as notified to the Investment Manager and the Trustee)</u>. The Applicable Issuers shall promptly notify the Trustee and the Investment Manager in writing (and the Trustee shall promptly provide the Holders with a copy of such notice) if at any time the rating of any such Class of Secured Notes has been, or is known shall be, changed or withdrawn.

(b) With respect to The Issuer shall obtain and pay for a review of any Collateral Obligation that has an S&P Rating derived as set forth in clause (iii)(B) of the definition of S&P Rating, the Issuer shall with a Moody's Credit Estimate (A) annually obtain (and pay for) from S&P written confirmation of, or an update to, the credit estimate with respect to and (B) upon the occurrence of a material amendment of the Underlying Instruments of such Collateral Obligation. With respect to or a restructuring of the obligor. The Issuer shall obtain and pay for an annual review of any Collateral Obligation that which has an S&P Rating derived as set forth in clause (iii)(D)b) of the part of the definition of S&P Rating, the Issuer shall annually submit all available Required S&P Credit Estimate Information to S&P.

Section 7.14 Reporting. At any time when the Co-Issuers are not subject to Section 13 or 15(d) of the Exchange Act and are not exempt from reporting pursuant to Rule 12g3-2(b) under the Exchange Act, upon the request of a Holder or beneficial owner of a Security, the Co-Issuers shall promptly furnish or cause to be furnished "Rule 144A Information" to such Holder or beneficial owner, to a prospective purchaser of such Note designated by such Holder or beneficial owner, or to the Trustee for delivery to such Holder or beneficial owner or a prospective purchaser designated by such Holder or beneficial owner, as the case may be, in order to permit compliance by such Holder or beneficial owner of such Note with Rule 144A under the Securities Act in connection with the resale of such Note by such Holder or beneficial owner of such Security, respectively. "Rule 144A Information" shall be such information as is specified pursuant to Rule 144A(d)(4) under the Securities Act (or any successor provision thereto).

# Section 7.15 <u>Calculation Agent.</u>

(a) The Issuer hereby agrees that for so long as any Floating Rate Notes remain Outstanding there shall at all times be an agent appointed (which does not control or is not controlled or under common control with the Issuer or its Affiliates or the Investment Manager or its Affiliates) to calculate LIBORthe Reference Rate in respect of each Interest Accrual Period (or, for the first Interest Accrual Period, the related portion thereof) in accordance with the terms of Exhibit C hereto (the "Calculation Agent"). The Issuer hereby appoints the Trustee as Calculation Agent. The Calculation Agent may be removed by the Issuer or the Investment Manager, on behalf of the Issuer, at any time. If the Calculation Agent is unable or unwilling to act as such or is removed by the Issuer or the Investment Manager, on behalf of the Issuer, shall promptly appoint a replacement Calculation Agent which does not control or is not controlled by or under common control with the Issuer or its Affiliates or the Investment Manager or its Affiliates. The Calculation Agent may not resign its duties without a successor having been duly appointed. In addition, for so long as any Securities are listed on the Irish Stock Exchange and the guidelines of such exchange so require, notice of the appointment of any replacement Calculation Agent shall be sent to the Irish Stock Exchange for release through the Companies Announcements Office.

(b) The Calculation Agent shall be required to agree (and the Trustee as Calculation Agent does hereby agree) that, as soon as practicable after 11:00 a.m. London time on each Interest Determination Date, but in no event later than 11:00 a.m. New York time on the London Banking Day immediately following each Interest Determination Date, the Calculation Agent shall calculate the Interest Rate for each Class of Floating Rate Notes for the next Interest Accrual Period (or, for the first Interest Accrual Period, the related portion thereof) and the Note Interest Amount for each Class of Floating Rate Notes (in each case, rounded to the nearest cent, with half a cent being rounded upward) for the next such period, on the related Payment Date. At such time the Calculation Agent shall communicate such rates and amounts to the Co-Issuers, the Trustee, each Paying Agent, the Investment Manager, Euroclear and Clearstream. Calculation Agent shall also specify to the Co-Issuers the quotations upon which the foregoing rates and amounts are based, and in any event the Calculation Agent shall notify the Co-Issuers and the Investment Manager before 5:00 p.m. (New York time) on every Interest Determination Date if it has not determined and is not in the process of determining any such Interest Rate or Note Interest Amount together with its reasons therefor. The Calculation Agent's determination of the foregoing rates and amounts for any period shall (in the absence of manifest error) be final and binding upon all parties.

#### Section 7.16 Certain Tax Matters.

- (a) The Issuer will treat the Secured Notes as debt and intends to treat the Subordinated Securities as equity for U.S. federal income tax purposes, except as otherwise required by applicable law.
- (b) No later than July 31 of each calendar year, the Issuer shall (or shall cause its Independent accountants to) provide to each Holder of Subordinated Securities, Class D Notes or Class E Notes requesting such information (i) all information that a U.S. shareholder making a "qualified electing fund" election (as defined in the Code) is required to obtain for U.S. federal income tax purposes and (ii) a "PFIC Annual Information Statement" as described in United States Treasury Regulations Section 1.1295-1 (or any successor Treasury Regulation), including all representations and statements required by such statement, and will take any other reasonable steps necessary to facilitate such election by, and any reporting requirements of, the owner of a beneficial interest in such Securities. Upon request by the Independent accountants, the Registrar shall provide to the Independent accountants information contained in the Register and requested by the Independent accountants to comply with this Section 7.16(b).
- (c) The Issuer has not and will not elect to be treated other than as a corporation for U.S. federal, state or local income or franchise tax purposes and shall make any election necessary to avoid classification as a partnership or disregarded entity for U.S. federal, state or local tax purposes.
- (d) The Issuer shall not file, or cause to be filed, any income or franchise tax return in any state of the United States unless it shall have obtained a legal opinion from nationally recognized legal counsel prior to such filing that, under the laws of such jurisdiction, the Issuer is required to file such income or franchise tax return.

- (e) The Issuer will provide, upon request of a Holder of Subordinated Securities, any information that such Holder reasonably requests to assist such Holder with regard to any filing requirements the Holder may have as a result of the controlled foreign corporation rules under the Code.
- (f) The Issuer shall not (i) become the owner of any asset (A) that is treated as an equity interest in an entity that is treated as a partnership or other fiscally transparent entity for U.S. federal income tax purposes if such entity is at any time engaged in a trade or business within the United States for U.S. federal income tax purposes or owns, or will own, any "United States real property interests" within the meaning of Section 897(c)(1) of the Code, (B) the gain from the disposition of which would be subject to U.S. federal income or withholding tax under Section 897 or Section 1445, respectively, of the Code or (C) if the ownership or disposition of such asset would cause the Issuer to be engaged in a trade or business within the United States for U.S. federal income tax purposes or (ii) engage in any activity that would cause the Issuer to be subject to U.S. federal income tax on a net income basis; provided, however, that a Tax Subsidiary may become the owner of a Tax Subsidiary Asset if the acquisition, ownership and disposition of such Tax Subsidiary Asset would not cause any income or gain of the Issuer to be treated as income or gain that is effectively connected with the conduct of a trade or business of the Issuer within the United States for U.S. federal income tax purposes (other than as a result of a change in law after the acquisition of such Tax Subsidiary Asset).
- (g) The Issuer (or the Investment Manager acting on behalf of the Issuer) will take such reasonable actions, consistent with law and its obligations under this Indenture, as are necessary to achieve FATCA Compliance.
- (h) The Co-Issuer has not and will not elect to be treated as other than a disregarded entity for U.S. federal, state or local tax purposes.
- (i) It is the intention of the parties hereto and, by its acceptance of a Note, each Holder and each beneficial owner of a Note shall be deemed to have agreed, not to treat any income generated by such Note as derived in connection with the Issuer's active conduct of a banking, financing, insurance, or other similar business for purposes of Section 954(h)(2) of the Code.
- (j) Upon the Trustee's receipt of a request of a Holder, delivered in accordance with the notice procedures of Section 14.3, for the information described in United States Treasury Regulations Section 1.1275-3(b)(i) that is applicable to such Holder, the Issuer shall cause its Independent accountants to provide promptly to the Trustee and such requesting Holder or owner of a beneficial interest in such a Note all of such information. Any additional issuance of the Additional Securities shall be accomplished in a manner that shall allow the Independent accountants of the Issuer to accurately calculate original issue discount income to Holders of the Additional Securities.
- (k) Prior to the time that the Issuer would acquire or receive any asset in connection with a workout or restructuring of a Collateral Obligation that could cause the Issuer to be treated as engaged in a trade or business in the United States or subject to U.S. federal tax

on a net income basis, the Issuer shall either (x) organize one or more wholly-owned special purpose vehicles of the Issuer that are treated as corporations for U.S. federal income tax purposes (each, a "<u>Tax Subsidiary</u>"), and contribute the Collateral Obligation that is the subject of the workout or restructuring to a Tax Subsidiary, (y) contribute such Collateral Obligation to an existing Tax Subsidiary, or (z) sell such Collateral Obligation.

- (l) Notwithstanding <u>Section 7.16(k)</u>, the Issuer shall not acquire any Collateral Obligation if a restructuring or workout of such Collateral Obligation is in process and if such restructuring or workout could reasonably result in the Issuer being treated as engaged in a trade or business in the United States or subject to U.S. federal tax on a net income basis.
- Each Tax Subsidiary must at all times have at least one independent director meeting the requirements of an "Independent Director" as set forth in the Tax Subsidiary's organizational documents complying with any applicable then-current Rating Agency rating criteria. The Issuer shall cause the purposes and permitted activities of any Tax Subsidiary to be restricted solely to the acquisition, receipt, holding, management and disposition of Collateral Obligations referred to in clauses (x) and (y) of Section 7.16(k), and any assets, income and proceeds received in respect thereof (collectively, "Tax Subsidiary Assets"), and shall require the Tax Subsidiary to distribute 100% of the proceeds from such assets, including, without limitation, the proceeds of any sale of such assets, net of any tax or other liabilities, to the Issuer on or before the Stated Maturity of the Secured Notes or at such earlier time designated at the sole discretion of the Investment Manager. At the request of the Investment Manager, the Issuer will cause any Tax Subsidiary to enter into a separate management agreement with the Investment Manager which agreement shall be substantially in the form of the Investment Management Agreement. Notice of any such separate management agreement and a copy of such agreement shall be provided to each of the Rating Agencies. No supplemental indenture pursuant to Sections 8.1 or 8.2 hereof shall be necessary to permit the Issuer, or the Investment Manager on its behalf, to take any actions necessary to set up a Tax Subsidiary.
  - (n) With respect to any Tax Subsidiary:
  - (i) the Issuer shall not allow such Tax Subsidiary to (A) purchase any assets, or (B) acquire title to real property or a controlling interest in any entity that owns real property;
  - (ii) the Issuer shall ensure that such Tax Subsidiary shall not sell, transfer, exchange or otherwise dispose of, or pledge, mortgage, hypothecate or otherwise encumber (or permit such to occur or suffer such to exist), any part of such Tax Subsidiary Assets, except as expressly permitted by this Indenture and the Investment Management Agreement;
  - (iii) the Tax Subsidiary shall not elect to be treated as a "real estate investment trust" for U.S. federal income tax purposes;
  - (iv) the Issuer shall ensure that such Tax Subsidiary shall not (A) have any employees (other than their respective directors), (B) have any subsidiaries (other than any subsidiary of such Tax Subsidiary which is subject, to the extent applicable, to

covenants set forth in this <u>Section 7.16(n)</u> applicable to a Tax Subsidiary), or (C) incur or assume or guarantee any indebtedness or hold itself out as liable for the debt of any other Persons:

- (v) the Issuer shall ensure that such Tax Subsidiary shall not conduct business under any name other than its own;
- (vi) the constitutive documents of such Tax Subsidiary shall provide that recourse with respect to costs, expenses or other liabilities of such Tax Subsidiary shall be solely to the assets of such Tax Subsidiary and no creditor of such Tax Subsidiary shall have any recourse whatsoever to the Issuer or its assets except to the extent otherwise required under applicable law;
- (vii) the Issuer shall ensure that such Tax Subsidiary shall file all tax returns and reports required to be filed by it and to pay all taxes required to be paid by it;
- (viii) the Issuer shall notify the Trustee of the filing or commencement of any action, suit or proceeding by or before any arbiter or governmental authority against or affecting such Tax Subsidiary;
- (ix) the Issuer shall ensure that such Tax Subsidiary shall not enter into any agreement or other arrangement that prohibits or restricts or imposes any condition upon the ability of such Tax Subsidiary to pay dividends or other distributions with respect to any of its ownership interests;
- (x) the Issuer shall be permitted take any actions and enter into any agreements to effect the transactions contemplated by Section 7.16(k) so long as they do not violate Section 7.16(l);
- (xi) the Issuer shall keep in full effect the existence, rights and franchises of each Tax Subsidiary as a company or corporation organized under the laws of its jurisdiction and shall obtain and preserve its qualification to do business in each jurisdiction in which such qualification is or shall be necessary to preserve the Tax Subsidiary Assets held from time to time by the related Tax Subsidiary. In addition, the Issuer and each Tax Subsidiary shall not take any action, or conduct its affairs in a manner, that is likely to result in its separate existence being ignored or in its assets and liabilities being substantively consolidated with any other Person in a bankruptcy, reorganization or other insolvency proceeding. Notwithstanding the foregoing, the Issuer shall be permitted to dissolve any Tax Subsidiary at any time;
- (xii) with respect to any Tax Subsidiary, the parties hereto agree that any reports prepared by the Trustee, the Investment Manager or Collateral Administrator with respect to the Collateral Obligations shall indicate that the related Tax Subsidiary Assets and related assets are held by the Tax Subsidiary, shall refer directly and solely to the related Tax Subsidiary Assets, and the Trustee shall not be obligated to refer to the equity interest in such Tax Subsidiary;

- (xiii) the Issuer, the Co-Issuer, the Investment Manager and the Trustee shall not cause the filing of a petition in bankruptcy against the Tax Subsidiary for the nonpayment of any amounts due hereunder until at least one year (or, if longer, any preference period then in effect) plus one day after the payment in full of all the Notes and payment of any amounts payable to the Fiscal Agent pursuant to this Indenture for distribution to Shareholders in accordance with the Fiscal Agency Agreement;
- (xiv) in connection with the organization of any Tax Subsidiary and the contribution of any Tax Subsidiary Assets to such Tax Subsidiary pursuant to Section 7.16(n)(x), such Tax Subsidiary shall establish one or more custodial and/or collateral accounts, as necessary, with the Bank or a financial institution meeting the requirements of Section 10.5(b) to hold the Tax Subsidiary Assets and any proceeds thereof pursuant to an account control agreement which will contain non-petition covenants of the Tax Subsidiary with respect to the Issuer and the Co-Issuer; provided, however, that (A) a Tax Subsidiary Asset shall not be required to be held in such a custodial or collateral account if doing so would be in violation of another agreement related to such Tax Subsidiary Asset or any other asset and (B) the Issuer may pledge a Tax Subsidiary Asset to a Person other than the Trustee if required pursuant to a related reorganization or bankruptcy Proceeding;
- (xv) the Issuer shall cause the Tax Subsidiary to distribute, or cause to be distributed, the proceeds of Tax Subsidiary Assets to the Issuer, in such amounts and at such times as shall be determined by the Investment Manager (any Cash proceeds distributed to the Issuer shall be deposited into the Interest Collection Amount or the Principal Collection Account, as applicable, as determined in accordance with subclause (xvi)); provided that the Issuer shall not cause any amounts to be so distributed unless all amounts in respect of any related tax liabilities and expenses have been paid in full or have been properly reserved for in accordance with GAAP;
- Asset to a Tax Subsidiary, for purposes of measuring compliance with the Concentration Limitations, Collateral Quality Test, and Coverage Tests or for the purpose of characterizing any Cash proceeds distributed to the Issuer as Interest Proceeds or Principal Proceeds, the ownership interests of the Issuer in a Tax Subsidiary or any property distributed to the Issuer by a Tax Subsidiary (other than Cash) shall be treated as ownership of the Tax Subsidiary Asset(s) owned by such Tax Subsidiary (and shall be treated as having the same characteristics as such Tax Subsidiary Asset(s) or of any asset received in consideration of such Tax Subsidiary Asset(s)). If, prior to its transfer to a Tax Subsidiary, a Tax Subsidiary Asset was a Defaulted Obligation, the ownership interests of the Issuer in such Tax Subsidiary shall be treated as a Defaulted Obligation until such Tax Subsidiary Asset would have ceased to be a Defaulted Obligation if owned directly by the Issuer;
- (xvii) any distribution of Cash by a Tax Subsidiary to the Issuer shall be characterized as Interest Proceeds or Principal Proceeds to the same extent that such Cash

would have been characterized as Interest Proceeds or Principal Proceeds if received directly by the Issuer;

- (xviii) if (A) any Event of Default occurs, the Notes have been declared due and payable (and such declaration shall not have been rescinded and annulled in accordance with this Indenture), and the Trustee or any other authorized party takes any action under this Indenture to sell, liquidate or dispose of the Collateral, (B) notice is given of any Optional Redemption, Tax Redemption, or other prepayment in full or repayment in full of all Notes Outstanding occurs and such notice is not capable of being rescinded, (C) the Stated Maturity has occurred or will occur within five Business Days, or (D) irrevocable notice is given of any other final liquidation and final distribution of the Assets, however described, the Issuer or the Investment Manager on the Issuer's behalf shall (x) with respect to each Tax Subsidiary, instruct such Tax Subsidiary to sell each Tax Subsidiary Asset and all other assets held by such Tax Subsidiary for the Issuer and distribute the proceeds of such sale, net of any amounts necessary to satisfy any related expenses and tax liabilities, to the Issuer in exchange for the equity security of or other interest in such Tax Subsidiary; and
- (xix) the Issuer shall not dispose of an interest in any Tax Subsidiary if such interest is a "United States real property interest," as defined in Section 897(c) of the Code, and a Tax Subsidiary shall not make any distribution to the Issuer if such distribution would cause the Issuer to be treated as engaged in a trade or business in the United States for U.S. federal income tax purposes or cause the Issuer to be subject to U.S. federal tax on a net income basis.

Each contribution of an asset by the Issuer to a Tax Subsidiary as provided in this <u>Section 7.16</u> may be effected by means of granting a participation interest in such asset to the Tax Subsidiary if such grant transfers ownership of such asset to the Tax Subsidiary for U.S. federal income tax purposes, based on Tax Advice.

# Section 7.17 Ramp-Up Period; Purchase of Additional Collateral Obligations.

- (a) (a) The Issuer shall use its commercially reasonable efforts to satisfy the Aggregate Ramp—Up Par Condition by the <u>Refinancing</u> Effective Date.
- (b) During the Ramp—Up Period, the Issuer shall use the following funds to purchase additional Collateral Obligations in the following order: (i) to pay for the principal portion of any Collateral Obligation from, first, any amounts on deposit in the Ramp—Up Account, and second, any Principal Proceeds on deposit in the Collection Account and (ii) to pay for accrued interest on any such Collateral Obligation from, any amounts on deposit in the Ramp—Up Account. In addition, the Issuer shall use its commercially reasonable efforts to acquire such Collateral Obligations that shall satisfy, as of the Refinancing Effective Date, the Collateral Quality Test and the Overcollateralization Ratio Tests.
- (c) Within 30 Business Days after the <u>Refinancing Effective Date</u> (but in any event, prior to the Determination Date relating to the first Payment <u>Date following the</u>

<u>Amendment</u> Date), the Issuer shall provide, or (at the Issuer's expense) cause the Investment Manager to provide, the following documents (the "Refinancing Effective Date Requirements"):

- (i) to each Rating Agency, a report identifying the Collateral Obligations and to S&P, the S&P Excel Default Model Input File, requesting that S&P reaffirm its Initial Ratings of the Secured Notes;
- (ii) (ii) to the Trustee and each Rating Agency a report, prepared by the Collateral Administrator (the "Effective Date Report"),— (A) setting forth the issuer, principal balance, coupon/spread, Stated Maturity, S&P Ratingstated maturity, Moody's Default Probability Rating, Moody's Rating, S&P Rating and country of Domicile with respect to each Collateral Obligation as of the Refinancing Effective Date, and (B) calculating as of the Refinancing Effective Date the level of compliance with, or satisfaction or non-satisfaction of (1) each Overcollateralization Ratio Test, (2) the Collateral Quality Tests—(excluding the S&P CDO Monitor Test), (3) the Concentration Limitations, and (4) the Aggregate Ramp-Up Par Condition, in each case, as of the Refinancing Effective Date (such items in clause (B) collectively, the "Tested Items");
- (ii) (iii) to the Trustee, an Accountants' Certificate recalculating and comparing the following items Tested Items in the Effective Date Report: (A) each Overcollateralization Ratio Test, the Collateral Quality Tests (excluding the S&P CDO Monitor Test) and the Concentration Limitations, and (B) whether the Aggregate Ramp Up Par Condition is satisfied, together with a statement specifying the procedures undertaken by them to review data and computations relating to the Accountants' Certificate; and
- (iii) (iv) to the Trustee and each Rating Agency an Officer's certificate of the Issuer (the "Effective Date Certificate") certifying as to the level of compliance with, or satisfaction or non-satisfaction of, (1) each Overcollateralization Ratio Test, (2) the Collateral Quality Tests (excluding the S&P CDO Monitor Test), (3) the Concentration Limitations, and (4) the Aggregate Ramp Up Par Condition, in each case, as of the Effective Date.
- If (x) the Issuer provides the foregoing—Accountants' Certificate to the Trusteespecified in clause (ii) above with the results of (1) the items set forth in subclause (ii)(B) above and (2) the Aggregate Ramp Up Par Condition, the Tested Items and such results do not indicate any failure of any such tested item, Tested Item and (y) the Moody's S&P Effective Date Rating Condition is satisfied, a written confirmation from Moody's S&P of its Initial Rating of the Secured Notes will not be required. For the avoidance of doubt, the The Effective Date Certificate and the Effective Date Report shall not include or refer to the Accountants' Certificate.
- (d) If, by the Determination Date relating to the first Payment Date following the Amendment Date, Effective Date Ratings Confirmation has not been obtained, then (i) the Trustee will notify Fitch thereof and (ii) the Investment Manager, on behalf of the Issuer, shall will notify the Trustee thereof and instruct the Trustee in writing to transfer amounts from the Interest Collection Account to the Principal Collection Account (and with such funds the Issuer shall purchase additional Collateral Obligations) in an amount sufficient to obtain from

Moody's or S&P, respectively, a confirmation of its Initial Ratings of each Class of the Secured Notes Effective Date Ratings Confirmation (provided that the amount of such transfer would not result in default in the payment of interest with respect to the Class A-1 Notes or the Class A-2 Notes); provided that, in the alternative, the Investment Manager on behalf of the Issuer may take such other action, including but not limited to, a Rating Confirmation Redemption—and/or transferring amounts from the Interest Collection Account to the Principal Collection Account as Principal Proceeds (for use in a Rating Confirmation Redemption), sufficient to obtain from Moody's a confirmation of its Initial Ratings of each Class of the Secured Notes), sufficient to obtain Effective Date Ratings Confirmation.

- (e) The failure of the Issuer to satisfy the requirements of this Section 7.17 shall not constitute an Event of Default unless such failure would otherwise constitute an Event of Default under Section 5.1(c) hereof and the Issuer, or the Investment Manager acting on behalf of the Issuer, has acted in bad faith. At the written direction of the Issuer (or the Investment Manager on behalf of the Issuer), the Trustee shall apply amounts held in the Ramp-\_Up Account to purchase additional Collateral Obligations during the Ramp-\_Up Period as described forth in clause Section 7.17(b) above. If at the Refinancing Effective Date, any amounts on deposit in the Ramp-\_Up Account have not been applied to purchase Collateral Obligations, such amounts shall be applied as described set forth in Section 10.3(c).
- Asset Quality Matrix; S&P CDO Monitor. On or prior to the Effective Date, the Investment Manager shall (i) determine which Asset Quality Matrix Combination shall apply on and after the Effective Date for purposes of determining compliance with the Moody's Diversity Test, the Maximum Moody's Rating Factor Test and the Minimum Floating Spread Test, and if such Asset Qualify Matrix Combination differs from the Asset Qualify Matrix Combination chosen to apply as of the Closing Date, the Investment Manager shall so notify the Trustee and the Collateral Administrator and (ii) determine the applicable S&P CDO Monitor that shall apply on and after the Effective Date to the Collateral Obligations for purposes of determining compliance with the S&P CDO Monitor Test. On and after the Effective Date, the Investment Manager may request from time to time for S&P to provide S&P CDO Monitors for up to 50 different combinations of S&P Matrix Spreads and Recovery Rate Sets with respect to all Classes of Secured Notes for each such request, which may, for example, be two S&P Matrix Spreads and 25 Recovery Rate Sets or 10 S&P Matrix Spreads and five Recovery Rate Sets. Thereafter, at any time on written notice of two Business Day to the Trustee, the Collateral Administrator and the Rating Agencies, the Investment Manager may elect a different Asset-Qualify Matrix Combination or a different S&P CDO Monitor to apply to the Collateral Obligations; provided, that if (i) the Collateral Obligations are currently in compliance with the Moody's Diversity Test, the Maximum Moody's Rating Factor Test and the Minimum Floating Spread Test (in the case of a proposed change in the Asset Qualify Matrix Combination) or the S&P CDO Monitor Test (in the case of a proposed change to the S&P CDO Monitor), the Collateral Obligations comply with such applicable tests after giving effect to such proposed election, or (ii) the Collateral Obligations are not currently in compliance with the Moody's Diversity Test, the Maximum Moody's Rating Factor Test and the Minimum Floating Spread Test (in the case of a proposed change in the Asset Qualify Matrix Combination) or the S&P CDO Monitor Test (in the case of a proposed change to the S&P CDO Monitor) or would not be in compliance with such applicable tests after the application of any other Asset Qualify Matrix Combination or S&P CDO Monitor (as the case may be), the Collateral Obligations need not

comply with such applicable tests after the proposed change so long as (x) the Class Default Differential of the Priority Class increases and (y) in the case of the Asset Qualify Matrix Combination, the degree of compliance of the Collateral Obligations with each of the Moody's Diversity Test, the Maximum Moody's Rating Factor Test and the Minimum Floating Spread Test not in compliance would be maintained or improved if the Asset Qualify Matrix Combination to which the Investment Manager desires to change is used; provided that if subsequent to such election of an Asset Qualify Matrix Combination the Collateral Obligations would comply with the Moody's Diversity Test, the Maximum Moody's Rating Factor Test and the Minimum Floating Spread Test if a different Asset Qualify Matrix Combination were selected, the Investment Manager shall elect an Asset Qualify Matrix Combination in which the Collateral Obligations are in compliance with such tests. If the Investment Manager does not notify the Trustee and the Collateral Administrator that it will alter the Asset Qualify Matrix Combination or the S&P CDO Monitor, in each case chosen on the Effective Date in the manner set forth above, the Asset Qualify Matrix Combination or the S&P CDO Monitor (as the casemay be) chosen on the Effective Date shall continue to apply. (i) Within 30 calendar days after the Refinancing Effective Date, the Issuer shall provide, or cause the Investment Manager to provide, to S&P the Excel Default Model Input File, which must include, at a minimum, the following data with respect to each Collateral Obligation: CUSIP number (if any), the LoanX identifier (if any), name of obligor, coupon, spread (if applicable), legal final maturity date, average life, principal balance, the Reference Rate floor with respect to any Reference Rate Floor Obligation, identifying such Collateral Obligation with a trade date and settlement date, the purchase price thereof, identification as a Cov-Lite Loan or otherwise, S&P Industry Classification, S&P Rating and S&P Recovery Rate and an indication as to whether each such Collateral Obligation is (1) a Senior Secured Loan, (2) a Second Lien Loan, (3) an Unsecured Loan or (4) a DIP Collateral Obligation.

- In connection with determining the "Default Differential" for purposes of (ii) the S&P CDO Monitor Test, the Investment Manager may provide written notice (such notice, a "S&P CDO Monitor Test Notice") to the Issuer, S&P, the Trustee and the Collateral Administrator, that the Investment Manager is electing (such election, an "S&P CDO Formula Election") to determine the Class Break-even Default Rate, Class Default Differential and Class Scenario Default Rate in accordance with the provisions of the definitions thereof applicable if the S&P CDO Formula Election is in effect. Following the Effective Date, the Investment Manager may deliver one S&P CDO Monitor Test Notice and may subsequently withdraw one S&P CDO Formula Election upon written notice (such notice of withdrawal, an "S&P CDO Monitor Withdrawal Notice") to the Issuer, S&P, the Trustee and the Collateral Administrator. Unless otherwise withdrawn, any S&P CDO Formula Election will remain in effect until the end of the Reinvestment Period. Any S&P CDO Formula Election or withdrawal thereof will take effect on the first Measurement Date that occurs at least five (5) Business Days after delivery of the related S&P CDO Monitor Test Notice or S&P CDO Monitor Withdrawal Notice.
- (iii) Solely in connection with the Refinancing Effective Date, the Investment Manager may, in its sole discretion, at any time prior to the Refinancing Effective Date and upon at least five Business Days' prior written notice to the Issuer, S&P, the Trustee and the Collateral Administrator, elect to apply the modified S&P non-model methodology in connection with the Refinancing Effective Date (such election, an "S&P

Effective Date Formula Election") for purposes of determining compliance with the S&P CDO Monitor Test. Following the Refinancing Effective Date, once the Effective Date Ratings Confirmation has been obtained, the S&P Effective Date Formula Election shall no longer be in effect and the S&P methodology used to determine compliance with the S&P CDO Monitor Test in effect immediately prior to the S&P Effective Date Formula Election shall be applied to determine compliance with the S&P CDO Monitor Test.

(iv) Compliance with the S&P CDO Monitor Test shall be measured by the Investment Manager on each Measurement Date during the Reinvestment Period. Compliance with the S&P CDO Monitor Test is not required after the Reinvestment Period.

# Section 7.18 Representations Relating to Security Interests in the Assets.

- (a) (a)—The Issuer hereby represents and warrants that, as of the Closing Date (which representations and warranties shall survive the execution of this Indenture and be deemed to be repeated on each date on which an Asset is Granted to the Trustee hereunder):
  - (i) The Issuer owns such Asset free and clear of any lien, claim or encumbrance of any person, other than such as are created under, or permitted by, this Indenture.
  - (ii) Other than the security interest Granted to the Trustee pursuant to this Indenture, except as permitted by this Indenture, the Issuer has not pledged, assigned, sold, granted a security interest in, or otherwise conveyed any of the Assets. The Issuer has not authorized the filing of and is not aware of any Financing Statements against the Issuer that include a description of collateral covering the Assets other than any Financing Statement relating to the security interest granted to the Trustee hereunder or that has been terminated; the Issuer is not aware of any judgment, PBGC liens or tax lien filings against the Issuer.
  - (iii) All Assets constitute Cash, accounts (as defined in Article 9 of the UCC), Instruments, general intangibles (as defined in Article 9 of the UCC), Uncertificated Securities (as defined in Article 8 of the UCC), Certificated Securities or security entitlements to Financial Assets resulting from the crediting of Financial Assets to a "securities account" (as defined in Article 8 of the UCC).
  - (iv) All Accounts constitute "securities accounts" (as defined in Article 8 of the UCC).
  - (v) This Indenture creates a valid and continuing security interest (as defined in Article 1 of the UCC) in such Assets in favor of the Trustee, for the benefit and security of the Secured Parties, which security interest is prior to all other liens, claims and encumbrances (except as permitted otherwise in this Indenture), and is enforceable as such against creditors of and purchasers from the Issuer.
  - (vi) The Issuer has caused or will have caused, within ten days after the Closing Date, the filing of all appropriate Financing Statements in the proper office in the

appropriate jurisdictions under applicable law in order to perfect the security interest in the Instruments granted to the Trustee, for the benefit and security of the Secured Parties.

- (vii) None of the Instruments that constitute or evidence the Assets has any marks or notations indicating that they have been pledged, assigned or otherwise conveyed to any Person other than the Trustee, for the benefit of the Secured Parties.
- (viii) The Issuer has received all consents and approvals required by the terms of the Assets to the pledge hereunder to the Trustee of its interest and rights in the Assets.
- (ix) All Assets other than the Accounts have been credited to one or more Accounts (other than any "general intangibles" within the meaning of the applicable Uniform Commercial Code and any instruments evidencing debt underlying a participation held by a collateral agent).
- (x) (A) The Issuer has delivered to the Trustee a fully executed Account Agreement pursuant to which the Intermediary has agreed to comply with all instructions and Entitlement Orders originated by the Trustee relating to the Accounts without further consent by the Issuer or (B) the Issuer has taken all steps necessary to cause the Intermediary to identify in its records the Trustee as the person having a security entitlement against the Intermediary in each of the Accounts.
- (xi) The Accounts are not in the name of any Person other than the Trustee. The Issuer has not consented to the Intermediary to comply with the Entitlement Order or instruction of any Person other than the Trustee.
- (b) The Issuer agrees to notify the Rating Agencies, with a copy to the Investment Manager, promptly if it becomes aware of the breach of any of the representations and warranties contained in this Section 7.18 and shall not waive any of the representations and warranties in this Section 7.18 or any breach thereof.

Section 7.19 Acknowledgement of Investment Manager Standard of Care. The Co-Issuers acknowledge that they shall be responsible for their own compliance with the covenants set forth in this Article VII and that, to the extent the Co-Issuers have engaged the Investment Manager to take certain actions on their behalf in order to comply with such covenants, the Investment Manager shall only be required to perform such actions in accordance with the standard of care set forth in Section 2 of the Investment Management Agreement (or the corresponding provision of any portfolio management agreement entered into as a result of INGVoya Alternative Asset Management LLC no longer being the Investment Manager). The Co-Issuers further acknowledge and agree that the Investment Manager shall have no obligation to take any action to cure any breach of a covenant set forth in this Article VII until such time as an Authorized Officer of the Investment Manager has actual knowledge of such breach.

Section 7.20 <u>Maintenance of Listing</u>. So long as any Listed Securities remain Outstanding, the Co-Issuers shall use all reasonable efforts to maintain the listing of such Securities on the Irish Stock Exchange.

- Section 7.21 Section 3(c)(7) Procedures. In addition to the notices required to be given under Section 10.5, the Issuer, or the Investment Manager on the Issuer's behalf, shall take the following actions to ensure compliance with the requirements of Section 3(c)(7) of the Investment Company Act (provided, that such procedures and disclosures may be revised by the Issuer to be consistent with generally accepted practice for compliance with the requirements of Section 3(c)(7) of the Investment Company Act):
- (a) The Issuer shall, or shall cause its agent to request of DTC, and cooperate with DTC to ensure, that (i) DTC's security description and delivery order include a "3(c)(7) marker" and that DTC's reference directory contains an accurate description of the restrictions on the holding and transfer of the Securities due to the Issuer's reliance on the exemption to registration provided by Section 3(c)(7) of the Investment Company Act, (ii) DTC send to its participants in connection with the initial offering of the Securities, a notice that the Issuer is relying on Section 3(c)(7) and (iii) DTC's reference directory include each class of Securities (and the applicable CUSIP numbers for the Securities) in the listing of 3(c)(7) issues together with an attached description of the limitations as to the distribution, purchase, sale and holding of the Securities.
- (b) The Issuer shall, or shall cause its agent to, (i) ensure that all CUSIP numbers identifying the Securities shall have a "fixed field" attached thereto that contains "3c7" and "144A" indicators and (ii) take steps to cause the Initial Purchaser to require that all "confirms" of trades of the Securities contain CUSIP numbers with such "fixed field" identifiers.
- The Issuer shall, or shall cause its agent to, cause the Bloomberg screen or screens containing information about the Securities to include the following language: (i) the "Note Box" on the bottom of "Security Display" page describing the Securities shall state: "Iss'd Under 144A/3(c)(7)," (ii) the "Security Display" page shall have the flashing red indicator "See Other Available Information," and (iii) the indicator shall link to the "Additional Security Information" page, which shall state that the securities "are being offered in reliance on the exemption from registration under Rule 144A of the Securities Act of 1933, as amended (the "Securities Act") to Persons who are both (x) qualified institutional buyers (as defined in Rule 144A under the Securities Act) and (y) qualified purchasers (as defined under Section 3(c)(7) under the Investment Company Act of 1940)." The Issuer shall use commercially reasonable efforts to cause any other third-party vendor screens containing information about the Securities to include substantially similar language to clauses (i) through (iii) above.

### **ARTICLE VIII**

#### SUPPLEMENTAL INDENTURES

Section 8.1 <u>Supplemental Indentures without Consent of Holders</u>. Without the consent of the Holders or any Hedge Counterparty, the Co-Issuers, when authorized by Resolutions, at any time and from time to time subject to the requirement provided below in this <u>Section 8.1</u> with respect to the ratings of any Class of Secured Notes, may enter into one or more indentures supplemental hereto in form satisfactory to the Trustee for any of the following purposes:

- (i) to evidence the succession of another Person to the Issuer or the Co-Issuer and the assumption by any such successor Person of the covenants of the Issuer or the Co-Issuer herein and in the Notes:
- (ii) to add to the covenants of the Co-Issuers or the Trustee for the benefit of the Secured Parties or to surrender any right or power herein conferred upon the Co-Issuers;
- (iii) to convey, transfer, assign, mortgage or pledge any property to or with the Trustee for the benefit of the Secured Parties;
- (iv) to evidence and provide for the acceptance of appointment hereunder by a successor trustee and to add to or change any of the provisions of this Indenture as shall be necessary to facilitate the administration of the trusts hereunder by more than one Trustee, pursuant to the requirements of <u>Sections 6.9</u>, <u>6.10</u> and <u>6.12</u>;
- (v) to correct or amplify the description of any property at any time subject to the lien of this Indenture, or to better assure, convey and confirm unto the Trustee any property subject or required to be subjected to the lien of this Indenture (including, without limitation, any and all actions necessary or desirable as a result of changes in law or regulations, whether pursuant to <u>Section 7.5</u> or otherwise) or to subject to the lien of this Indenture any additional property;
- (vi) to modify the restrictions on and procedures for resales and other transfers of Notes to reflect any changes in applicable law or regulation (or the interpretation thereof) or to enable the Co-Issuers to rely upon any exemption from registration under the Securities Act or the Investment Company Act or to remove restrictions on resale and transfer to the extent not required thereunder;
- (vii) to make such changes as shall be necessary or advisable in order for the Listed Securities to be listed or de-listed on an exchange, including the Irish Stock Exchange;

- (viii) with the consent of a Majority of the Subordinated Securities, at any time within the Reinvestment Period, to make such changes as are necessary to facilitate the Applicable Issuers (A) to issue Additional Securities of any one or more existing Classes; provided that any such additional issuance of Securities shall be issued in accordance with Section 2.4, or (B) to issue Replacement Notes in connection with a Refinancing in accordance with Section 9.2(d) or Section 9.3;
- (ix) otherwise to correct any inconsistency or cure any ambiguity, omission or errors in this Indenture or to conform the provisions of this Indenture to the Offering Memorandum;
- (x) to amend, modify, enter into or accommodate the execution of any Hedge Agreement;
- (xi) to take any action advisable, necessary or helpful to prevent the Issuer, any Tax Subsidiary and the holders of any Class of Securities from becoming subject to (or otherwise minimize) withholding or other taxes, fees or assessments, including by achieving FATCA Compliance, or to reduce the risk that the Issuer may be treated as engaged in a trade or business within the United States or otherwise subject to U.S. federal, state or local income tax on a net income basis;
- (xii) to modify the procedures herein relating to compliance with Rule 17g-5 of the Exchange Act;
- (xiii) with the consent of a Majority of the Subordinated Securities, to effect a Refinancing in accordance with Section 9.2(d);
- (xiv) with the consent of a Majority of the Class A-1 Notes, to evidence any waiver or elimination by any Rating Agency of any requirement or condition of such Rating Agency set forth herein;
- (xv) with the consent of a Majority of the Class A-1 Notes, to conform to ratings criteria and other guidelines (including any alternative methodology published by any of the Rating Agencies) relating to collateral debt obligations in general published by either of the Rating Agencies;
- (xvi) to amend, modify or otherwise accommodate changes to <u>Section 7.13</u> relating to the administrative procedures for reaffirmation of ratings on the Notes;
- (xvii) to change the name of the Issuer or the Co-Issuer in connection with the change in name or identity of the Investment Manager or as otherwise required pursuant to a contractual obligation or to avoid the use of a trade name or trademark in respect of which the Issuer or the Co-Issuer does not have a license;
- (xviii) to accommodate the settlement of the Securities in book-entry form through the facilities of DTC or otherwise;

- (xix) to authorize the appointment of any listing agent, transfer agent, paying agent or additional registrar for any Class of Securities required or advisable in connection with the listing of any Class of Securities on the Irish Stock Exchange or any other stock exchange, and otherwise to amend this Indenture to incorporate any changes required or requested by any governmental authority, stock exchange authority, listing agent, transfer agent, paying agent or additional registrar for any Class of Securities in connection herewith; or
- (xx) to amend or modify this Indenture as required for compliance with any rule or regulation promulgated by any regulatory agency of the U.S. federal government after the Closing Date that is applicable to the Co-Issuers or the Securities as based on advice from nationally recognized counsel; or
- (xxi) to (A) provide administrative procedures and any related modifications of this Indenture (but not a modification of the Reference Rate itself) necessary in respect of the determination of a Designated Reference Rate elected by the Investment Manager pursuant to Section 8.7 or (B) to designate a non-LIBOR rate (other than a Designated Reference Rate) as the Reference Rate and provide for a Reference Rate Modifier and any administrative procedures and any related modifications of this Indenture necessary in respect of the determination thereof; provided in the case of this clause (B) that (x) the Investment Manager has provided written notice to the Trustee (who will forward such notice to the Holders and each Rating Agency) and the Issuer certifying that the conditions specified in Section 8.7(a)(i) or Section 8.7(a)(ii) have been satisfied and (y) a Majority of the Controlling Class and a Majority of the Subordinated Notes have consented and the Global Rating Condition has been satisfied;

provided that with respect to any proposed supplemental indenture pursuant to clause (ix) orand (xvi) above only, if a Majority of the Controlling Class has provided written notice to the Trustee within 15 Business Days after delivery of notice of such proposed supplemental indenture that the Controlling Class objects to such proposed supplemental indenture, the Trustee and the Co-Issuers shall not enter into such supplemental indenture. For the avoidance of doubt, in the event less than a Majority of the Controlling Class provides written notice objecting to such proposed supplemental indenture, the Trustee and the Co-Issuers may enter into such supplemental indenture.

The Trustee shall join in the execution of any such supplemental indenture and to make any further appropriate agreements and stipulations which may be therein contained, but the Trustee shall not be obligated to enter into any such supplemental indenture which affects the Trustee's own rights, duties, liabilities or immunities under this Indenture or otherwise, except to the extent required by law.

At the cost of the Co-Issuers, not later than 20 Business Days prior to the execution of any proposed supplemental indenture, the Trustee shall provide to the Investment Manager, the Holders, and the Rating Agencies a copy of such supplemental indenture. At the cost of the Co-Issuers, the Trustee shall provide to the Holders, and each Rating Agency a copy of the executed supplemental indenture after its execution. Any failure of the Trustee to publish

or deliver such notice, or any defect therein, shall not, however, in any way impair or affect the validity of any such supplemental indenture.

At the cost of the Co-Issuers not later than one Business Day prior to the execution of any proposed supplemental indenture pursuant to Section 8.1(viii), the Trustee shall distribute to the Investment Manager, the Collateral Administrator and the Holders a copy of such supplemental indenture. At the cost of the Co-Issuers, the Trustee shall distribute to the Holders and the Rating Agencies a copy of the executed supplemental indenture after its execution. Any failure of the Trustee to supply such copy, shall not, however, in any way impair or affect the validity of any such supplemental indenture.

A supplemental indenture entered into for any purpose other than the purposes provided for in this <u>Section 8.1</u> shall require the consent of the Holders as required in <u>Section 8.2</u>.

# Section 8.2 <u>Supplemental Indentures with Consent of Holders.</u>

- (a) With the consent of a Majority of each Class materially and adversely affected thereby, except as described in Section 8.2(b), the Trustee and the Co-Issuers may enter into a supplemental indenture to add any provisions to, or change in any manner or eliminate any of the provisions of, this Indenture or modify in any manner the rights of the Holders of such Class under this Indenture; provided, however, that no such supplemental indenture pursuant to this Section 8.2(a) shall, except as described in the proviso to clause (i) below, without the consent of each Holder of Securities of each Outstanding Class materially and adversely affected thereby:
  - (i) change the Stated Maturity of the principal of or the due date of any installment of interest on any Secured Note; reduce the principal amount thereof or, other than in connection with a Re-Pricing, the rate of interest thereon or the Redemption Price with respect to any Security, or change the earliest date on which Securities of any Class may be redeemed, change the provisions of this Indenture relating to the application of proceeds of any Assets to the payment of principal of or interest on Secured Notes, application of proceeds of any Assets to the payment of distributions on the Subordinated Securities or change any place where, or the coin or currency in which, Subordinated Securities or Secured Notes or the principal thereof or interest thereon is payable, or impair the right to institute suit for the enforcement of any such payment on or after the Stated Maturity thereof (or, in the case of redemption, on or after the applicable Redemption Date); provided, that with respect to lowering the rate of interest payable on a Class, the consent of Holders of the other Classes shall not be required;
  - (ii) change the percentage of the Aggregate Outstanding Amount of Holders of Securities of each Class whose consent is required under this Indenture, including for the authorization of any such supplemental indenture, exercise of remedies under this Indenture or for any waiver of compliance with certain provisions of this Indenture or certain defaults hereunder or their consequences;

- (iii) impair or adversely affect the Assets except as otherwise permitted in this Indenture:
- (iv) except as otherwise expressly permitted by this Indenture, permit the creation of any lien ranking prior to or on a parity with the lien of this Indenture with respect to any part of the Assets or terminate such lien on any property at any time subject hereto or deprive the Holder of any Secured Note of the security afforded by the lien of this Indenture;
  - (v) modify any of the provisions of this <u>Section 8.2</u>;
- (vi) modify the definitions of the terms Outstanding, Class, Controlling Class, Majority or Supermajority;
  - (vii) modify the Priority of Payments;
- (viii) modify any of the provisions of this Indenture in such a manner as to directly affect the calculation of the amount of any payment of interest or principal on any Secured Note, or any amount available for distribution to the Subordinated Securities or to affect the rights of the Holders of Secured Notes to the benefit of any provisions for the redemption of such Secured Notes contained herein;
- (ix) amend any of the provisions of this Indenture relating to the institution of proceedings for a Bankruptcy Event in respect of either of the Co-Issuers;
- (x) modify the restrictions on and procedures for resales and other transfers of Notes (except as set forth in <u>Section 8.1(vi)</u>); or
- (xi) modify any of the provisions of this Indenture in such a manner as to impose any liability on a Holder to any third party (other than any liabilities set forth in this Indenture on the Closing Date).
- (b) A supplemental indenture may not modify (i)(x) any of the Collateral Quality Tests or any defined term utilized in the determination of any Collateral Quality Test or (y) the definition of the term Concentration Limitations without, in each case, the prior written consent of a Majority of the Controlling Class or (ii) criteria regarding reinvestment after the Reinvestment Period, without the prior written consent of a Majority of each Class of Notes.
- (c) Not later than 20 Business Days prior to the execution of any proposed supplemental indenture, the Trustee, at the expense of the Co-Issuers, shall provide to the Holders, the Investment Manager, any Hedge Counterparty and each Rating Agency a copy of such proposed supplemental indenture. Any such notice of a proposed supplemental indenture shall (i) request any required consent from the Holders of each Class from which consent is required and (ii) inform Holders of any Class from which consent is not being requested that they may notify the Trustee if they believe that such Class will be materially and adversely affected by such proposed supplemental indenture in accordance with Section 8.2(g). Any consent given to a proposed supplemental indenture by the Holder of any Securities shall be irrevocable and binding

on all future holders or beneficial owners of that Security, irrespective of the execution date of the supplemental indenture.

- (d) It shall not be necessary for any Act of Holders under this <u>Section 8.2</u> to approve the particular form of any proposed supplemental indenture, but it shall be sufficient if such Act or consent shall approve the substance thereof, so long as the Holders have received a copy of the language to be included in any proposed supplemental indenture.
- (e) The Issuer shall not enter into any supplemental indenture pursuant to this <u>Section 8.2</u> if any Hedge Counterparty (in its reasonable judgment) would be materially and adversely affected by such supplemental indenture and notifies the Issuer and the Trustee thereof without the prior written consent of such Hedge Counterparty.
- (f) Promptly after the execution by the Co-Issuers and the Trustee of any supplemental indenture pursuant to this <u>Section 8.2</u>, the Trustee, at the expense of the Co-Issuers, shall deliver to the Holders, the Investment Manager, and each Rating Agency a copy thereof. Any failure of the Trustee to deliver a copy of any supplemental indenture as provided herein, or any defect therein, shall not, however, in any way impair or affect the validity of any such supplemental indenture.
- If the Trustee and the Issuer are notified within 20 days after notice by the Issuer to the Holders of a proposed supplemental indenture by a Majority of any Class that such Holders believe the interests of the Holders in such Class will be materially and adversely affected by the proposed supplemental indenture, the consent of a Majority (or, if higher, the percentage required for such amendment) of such Class will be required for execution of such supplemental indenture. Unless so notified prior to the execution of a supplemental indenture by a Majority of any Class of Notes that such Class of Notes would be materially and adversely affected, the Trustee may rely upon a certificate of any of the Issuer, the Investment Manager, any investment banking firm or other Independent expert familiar with the market for the Notes as to whether the proposed supplemental indenture would have a material adverse effect on any Class. Such determination will be conclusive and binding on all present and future Holders. For the avoidance of doubt, satisfaction of the S&P Rating Condition or the Moody's Global Rating Agency Condition, as applicable, shall not be required prior to the execution or effectiveness of any supplemental indenture.
- Section 8.3 Execution of Supplemental Indentures. In executing or accepting the additional trusts created by any supplemental indenture permitted by this Article VIII or the modifications thereby of the trusts created by this Indenture, the Trustee and the Issuer shall be entitled to receive, and (subject to Sections 6.1 and 6.3) shall be fully protected in relying upon, an Opinion of Counsel stating that the execution of such supplemental indenture is authorized or permitted by this Indenture and that all conditions precedent thereto have been satisfied. The Trustee may, but shall not be obligated to, enter into any such supplemental indenture which affects the Trustee's own rights, duties or immunities under this Indenture or otherwise. The Investment Manager shall not be bound to follow any amendment or supplement to this Indenture unless it has received written notice of such amendment or supplement and a copy of the amendment or supplement from the Issuer or the Trustee prior to the execution thereof in accordance with the notice requirements of Section 8.1 and Section 8.2. Notwithstanding

anything in this Indenture to the contrary, the Issuer agrees that it shall not permit to become effective any amendment or supplement to this Indenture which would (i) increase the duties or liabilities of, reduce or eliminate any right or privilege of (including as a result of an effect on the amount or priority of any fees or other amounts payable to the Investment Manager), or adversely change the economic consequences to, the Investment Manager, (ii) directly or indirectly modify the restrictions on the purchases or sales of Collateral Obligations under Article XII or the Investment Criteria, (iii) expand or restrict the Investment Manager's discretion or (iv) adversely affect the Investment Manager, unless the Investment Manager shall have consented in advance thereto in writing, such consent to not be unreasonably withheld or delayed; provided, that the Investment Manager may withhold its consent in its sole discretion if such amendment or supplement affects the amount, timing or priority of payment of the Investment Manager's fees or increases or adds to the obligations of the Investment Manager, and the Issuer shall not enter into any such amendment or supplement unless the Investment Manager shall have given its prior written consent. For so long as any Securities are listed on the Irish Stock Exchange, the Trustee at the expense of the Issuer shall notify the Irish Stock Exchange of any material modification to this Indenture.

Section 8.4 <u>Effect of Supplemental Indentures</u>. Upon the execution of any supplemental indenture under this <u>Article VIII</u>, this Indenture shall be modified in accordance therewith, and such supplemental indenture shall form a part of this Indenture for all purposes; and every Holder of Securities theretofore and thereafter authenticated and delivered hereunder shall be bound thereby.

Section 8.5 <u>Reference in Notes to Supplemental Indentures</u>. Notes authenticated and delivered after the execution of any supplemental indenture pursuant to this <u>Article VIII</u> may, and if required by the Issuer shall, bear a notice in form approved by the Trustee as to any matter provided for in such supplemental indenture. If the Applicable Issuers shall so determine, new Notes, so modified as to conform in the opinion of the Trustee and the Co-Issuers to any such supplemental indenture, may be prepared and executed by the Applicable Issuers and authenticated and delivered by the Trustee in exchange for Outstanding Notes.

Section 8.6 <u>Re-Pricing Amendment</u>. For the avoidance of doubt, the Co-Issuers and the Trustee may, without regard for the provisions of this <u>Article VIII</u>, enter into a supplemental indenture pursuant to <u>Section 9.9(d)</u> solely to modify the spread over <u>LIBOR the Reference Rate</u> or fixed interest rate applicable to the Re-Priced Class.

### Section 8.7 Reference Rate Amendment.

- (a) Notwithstanding Section 8.2(a), in the event that either (i) Libor is no longer reported (or actively updated) on the Reuters Screen or the administrator for Libor has publicly announced that the foregoing will occur within the next six months, or (ii) at least 50% (by par amount) of (1) quarterly pay floating rate Collateral Obligations or (2) floating rate collateralized loan obligation notes issued in the preceding three months rely on reference rates other than Libor, in each case, determined as of the first day of the Interest Accrual Period during which the Reference Rate Amendment is proposed, the Investment Manager shall either (x) elect a Designated Reference Rate as the replacement Reference Rate or (y) propose a Reference Rate Amendment.
- (b) If the Investment Manager proposes a Reference Rate Amendment to which clause (y) of the proviso to Section 8.1(xxi)(B) applies, and either requirement thereof is not satisfied, the Investment Manager shall then propose a Reference Rate that is a Designated Reference Rate, and such Designated Reference Rate shall become the Reference Rate (subject to the conditions specified in the definition thereof) without the execution of a supplemental indenture.

### **ARTICLE IX**

### REDEMPTION OF NOTES

Section 9.1 <u>Mandatory Redemption</u>. If a Coverage Test is not met on any Determination Date on which such Coverage Test is applicable, the Issuer shall apply available amounts in the Payment Account on the related Payment Date to make payments as required pursuant to the Priority of Payments to achieve compliance with such Coverage Test.

# Section 9.2 Optional Redemption.

the Co-Applicable Issuers or the Issuer, as the case may be, at the applicable Redemption Prices in whole but not in part, on any Business Day after the end of the Non-Call Period at the written direction of a Majority of the Subordinated Securities or at the direction of the Investment Manager (with the consent of a Majority of the Subordinated Securities) delivered as required under Section 9.5. A Majority of the Subordinated Securities may direct that cause an Optional Redemption of all Outstanding Secured Notes to occur by directing, or giving consent to, the Investment Manager either to (i) liquidate a sufficient amount of the Assets (a "Redemption by Liquidation") to fully redeem all Outstanding Classes of Secured Notes, or (ii) negotiate and obtain on behalf of the Issuer (x) one or more loans or other financing arrangements to be made to the Issuer, and/or (y) the issuance of replacement notes ("Replacement Notes" and, together with the arrangements set forth in clause (x), "Refinancing Obligations") by the Issuer (each, a "Refinancing"), the proceeds of which shall be used to fully redeem all Outstanding Classes of Secured Notes (an "Optional Redemption by Refinancing"). The Issuer shall deposit, or cause to be deposited, the funds required for an Optional Redemption on or prior to the Redemption Date.

- (b) Upon receipt of a notice of a Redemption by Liquidation, the Investment Manager shall, in its sole discretion, direct the sale of all or part of the Collateral Obligations and other Assets in accordance with the procedures set forth in Section 9.2(c). The Sale Proceeds and all other funds available for such redemption in the Collection Account and the Payment Account shall be at least sufficient to pay the Redemption Price of all of the Secured Notes and to pay all accrued and unpaid Administrative Expenses and other fees and expenses (including Dissolution Expenses) payable under the Priority of Payments prior to any distributions with respect to the Subordinated Securities (the "Redemption Amount"), unless such Administrative Expenses, other fees and expenses will be adequately provided for by an entity other than the Issuer. If the Sale Proceeds and all other funds available for such redemption would not be at least equal to the Redemption Amount, the Secured Notes maywill not be redeemed. The Investment Manager, in its sole discretion, may effect the sale of all or any part of the Collateral Obligations or other Assets through the direct sale of such Collateral Obligations or other Assets or by participation or other arrangement.
- Notwithstanding anything to the contrary set forth herein, the Secured Notes shall not be redeemed pursuant to a Redemption by Liquidation unless (i) at least seventwo Business Days before the scheduled Redemption Date the Investment Manager shall have furnished to the Trustee evidence, in form satisfactory to the Trustee, that the Investment Manager on behalf of the Issuer has entered into a binding agreement or agreements with a financial or other institution or institutions whose short-term unsecured debt obligations (other than such obligations whose rating is based on the credit of a person other than such institution) are rated or guaranteed by a Person whose short term unsecured debt obligations at least "A-1" by S&P and at least "P-1" by Moody's under a guarantee which satisfies the then-current Rating Agency criteria with respect to guarantees to purchase (which purchase may be through a participation), not later than the Business Day immediately preceding the scheduled Redemption Date in immediately available funds, all or part of the Collateral Obligations and/or any Hedge Agreements at an aggregate purchase price at least equal together with all other funds expected to be available on the scheduled Redemption Date, including any payments to be received in respect of any Hedge Agreements, to the Redemption Amount, or (ii) prior to selling any Collateral Obligations and/or Eligible Investmentsnot sold pursuant to an agreement meeting the requirements of clause (i) above, the Investment Manager has certified to the Trustee in an Officer's certificate upon which the Trustee can conclusively rely that, in its judgment (which may be based on the Issuer having entered into an agreement to sell such Assets to another special purpose entity that has priced but has not yet closed its securities offering), the aggregate sum of (A) all other funds expected to be available on the scheduled Redemption Date, including (A) any expected proceeds from Hedge Agreements, (B) any Refinancing Proceeds and (C, (C) the sale price of any Collateral Obligation sold or to be sold pursuant to an agreement meeting the requirements of clause (i) above, and (D) for each Collateral Obligation, the product of its Principal Balance and not sold or to be sold pursuant to an agreement meeting the requirements of clause (i) above, its Market Value and its Applicable Advance Rate, will at least equal the Redemption Amount. Any certification delivered by the Investment Manager pursuant to this Section 9.2(c) shall include (1) the prices of, and expected proceeds from, the sale (directly or by participation or other arrangement) of any Collateral Obligations and Eligible Investments and payments under any Hedge Agreements and (2) all calculations required by this Section 9.2(c).

- (d) Upon receipt of a\_notice of an Optional Redemption by Refinancing, the Investment Manager may obtain a Refinancing after the Non-Call Period on behalf of the Issuer only if (i) the Refinancing Proceeds and all other available funds in the Accounts shall be at least equal to the Redemption Amount, (ii) the Refinancing Proceeds and other available funds are used to the extent necessary to make such redemption, and (iii) the agreements relating to such Refinancing contain limited recourse and non-petition provisions equivalent (mutatis mutandis) to those contained in Section 5.4(d), (iv) the terms of such Refinancing are acceptable to a Majority of the Subordinated Securities and (v) neither the Investment Manager nor any "sponsor" (as defined in the U.S. Risk Retention Regulations) with respect to the Securities or the Refinancing Obligations will fail to be in compliance with the U.S. Risk Retention Regulations as a result of such Refinancing. Unless it consents to do so, none of the Investment Manager, the Retention Holders or any Affiliate of the Investment Manager will be required to purchase or invest in any Refinancing Obligations.
- In connection with a Refinancing of all Outstanding Secured Notes, the Investment Manager, with the written consent of a Majority of the Subordinated Securities, may designate Principal Proceeds in an amount not to exceed the Excess Par Amount as of the related Determination Date as Interest Proceeds for distribution on the related Redemption Date so long as, immediately prior to such Refinancing and designation, each Overcollateralization Ratio Test is satisfied. Notice of any such designation will be provided to the Rating Agencies on or before the related Determination Date.
- (f) (e) The Subordinated Securities maywill be redeemed by the Issuer, in whole but not in part, at their Redemption Price, on any Business Day on or after the redemption or repayment of date on which all of the Secured Notes has been redeemed or repaid in full, at the written direction of a Majority of the Subordinated Securities or at the direction of the Investment Manager (with the consent of a Majority of the Subordinated Securities), which direction may be given in connection with a direction to conduct an Optional Redemption.

The Holders of the Subordinated Securities shall not have any cause of action against any of the Co-Issuers, the Investment Manager or the Trustee for any failure to obtain a Refinancing. In the event that a Refinancing is obtained meeting the requirements specified above as certified by the Investment Manager, the Co-Issuers and the Trustee (as directed by the Issuer) shall amend this Indenture pursuant to <u>Article VIII</u> to the extent necessary to reflect the terms of the Refinancing and no further consent for such amendments shall be required from the Holders, other than the Majority of the Subordinated Securities directing the redemption of the Secured Notes.

# Section 9.3 Partial Redemption by Refinancing.

(a) Upon written direction of a Majority of the Subordinated Securities or at the direction of the Investment Manager (with the consent of a Majority of the Subordinated Securities) delivered as required under Section 9.5, the Issuer shall redeem fewer than all and refinance one or more (but not all) Outstanding Classes of Secured Notes on any Business Day after the end of the Non-Call Period (in whole but not in part) from Refinancing Proceeds (any such redemption, a "Partial Redemption"); provided that the terms of such Refinancing and any

financial institutions acting as lenders thereunder or purchasers thereof must be acceptable to a Majority of the Subordinated Securities and to the Investment Manager and such Refinancing otherwise satisfies the conditions described set forth below.

- (b) The Issuer shall obtain a Refinancing in connection with a Partial Redemption only if:
  - (i) (v) the Global Rating Agency Condition has been satisfied with respect to any Secured Notes that are not subject to notice of such Partial Redemption has been given to each Rating Agency,
  - (ii) (vi) the Refinancing Proceeds (together with Partial Redemption Interest Proceeds available in accordance with the Priority of Partial Redemption Proceeds to pay the accrued interest portion of the Redemption Price, if any) are in an amount at least equal to the amount required to pay the Redemption Price of the Class or Classes of Secured Notes subject to such Partial Redemption,
  - (iii) (vii) the principal amount of each Class of the Replacement Notes issued by the Issuer under such Refinancing or the financing obtained by the Issuer Obligations is equal to the Aggregate Outstanding Amount of the corresponding Class subject to such Partial Redemption (or, (viii) the Stated Maturity of the obligations providing such in the case of Pari Passu Classes, the sum of the Aggregate Outstanding Amount of each such Class subject to such Partial Redemption).
  - (iv) the stated maturity of the Refinancing Obligations is the same as the Stated Maturity of the Class or Classes of Secured Notes subject to such Partial Redemption,
  - (v) (ix) the Refinancing Proceeds (to the extent necessary) are used to redeem the Class or Classes of Secured Notes subject to such Partial Redemption,
  - (vi) (x)— the agreements relating to the Refinancing contain limited recourse and non-petition provisions equivalent (*mutatis mutandis*) to those contained in <u>Section 5.4(d)</u>,
  - (vii) (xi) the obligations of the Issuer under such any Refinancing Obligations are not senior in priority pursuant to the Priority of Payments to the corresponding Class or Classes of Secured Notes subject to such Partial Redemption,
  - (viii) (xii) the holders of the obligations of the Issuer under such Refinancing Obligations do not have greater rights under this Indenture than the Holders of the Class or Classes of Secured Notes subject to such Partial Redemption;
  - (ix) (xiii) the Replacement Notes have the same or lower spread over LIBOR (or fixed interest rate) as the Class or Classes of Secured Notes subject to such Partial Redemption; and Refinancing Rate Condition is satisfied:
  - (xiv) with respect to any Replacement Notes issued pursuant to such Refinancing, such issuance is accomplished any Refinancing Obligations will be issued or

<u>incurred</u> in a manner that allows the Independent accountants of the Issuer to accurately provide the tax information relating to original issue discount required to be provided to the <u>holders of Notes (including the Replacement Notes)</u>. <u>Holders</u>; and

- (xi) neither the Investment Manager nor any "sponsor" (as defined in the U.S. Risk Retention Regulations) with respect to the Securities or the Refinancing Obligations will fail to be in compliance with the U.S. Risk Retention Regulations as a result of such Refinancing.
- (c) Unless it consents to do so, none of the Investment Manager, the Retention Holders or any Affiliate of the Investment Manager shall be required to purchase or invest in any Refinancing Obligations.
  - (d) Expenses related to a Refinancing will be Administrative Expenses.

# Section 9.4 <u>Redemption Following a Tax Event.</u>

The Notes shall be redeemed by the Co-Applicable Issuers or the Issuer, as the case may be, in whole but not in part, on any Business Day on or afterfollowing the occurrence and during the continuation of a Tax Event at the written direction of a Majority of the Subordinated Securities delivered as required under Section 9.5. Such Any such redemption will be a Redemption by Liquidation to fully redeem all Classes of Notes in accordance with the procedures set forth in Section 9.5. The funds available for such a redemption of the Notes Tax Redemption shall include all Principal Proceeds, Interest Proceeds, Disposition Sale Proceeds and all other available funds. Each Class of Notes shall be redeemed at the applicable Redemption Price for such Class in accordance with the Priority of Payments.

## Section 9.5 <u>Redemption Procedures</u>.

- Redemption or TaxClean-Up Call Redemption must be delivered by a Majority of the Subordinated Securities or the Investment Manager, as applicable, to the Issuer, the Trustee and unless the Investment Manager is giving such direction, the Investment Manager not later than 3020 days prior to the Business Day on which such redemption will occur (or such shorter period to which the Trustee, the Issuer and the Investment Manager may agree). A notice of such redemption shall be given by the Trustee not later than 10ten Business Days prior to the applicable Redemption Date to each Holder of Securities to be redeemed and each Rating Agency. In addition, for so long as any Securities are listed on the Irish Stock Exchange and so long as the guidelines of such exchange so require, notice to the Holders of such Securities of an Optional Redemption, Partial Redemption or Tax Redemption shall also be sent to the Irish Stock Exchange.
  - (b) All notices of redemption delivered pursuant to <u>Section 9.5(a)</u> shall state:
  - (i) the applicable Redemption Date;
  - (ii) the Redemption Price of the Securities Classes to be redeemed;

- (iii) in the case of an Optional Redemption or Tax Redemption, that all of the Secured Notes (or, in the case of a Tax Redemption, all of the Notes) are to be redeemed in full and that interest on such Secured Notes shall cease to accrue on the Payment Date specified in the notice;
- (iv) in the case of a Partial Redemption, the Classes of Secured Notes to be redeemed in full and that interest on such Secured Notes shall cease to accrue on the Partial Redemption Date specified in the notice;
- (v) the place or places where Certificated Securities are to be surrendered forupon payment of the Redemption Price; and
- (vi) in the case of an Optional Redemption, whether the Subordinated Securities are to be redeemed on such Redemption Date.

In the case of Redemption by Liquidation (including a Tax Redemption), the Applicable Issuers shall have the option to withdraw any such notice of redemption up to and including the sixth Business Day prior to the proposed Redemption Date. Any withdrawal of such notice of redemption shall be made by written notice to the Trustee and the Investment Manager and shall be made by the Applicable Issuers only if the Investment Manager has notified the Co Issuers that either (i) it is unable to deliver the sale agreement or agreements or certifications described in Sections 9.2(c) and 12.1(e), in form satisfactory to the Trustee, or (ii) the Issuer receives written direction from a Majority of the Subordinated Securities to withdraw such notice of redemption.

- (c) Such notice of redemption shall be given by the Co-Issuers (so long as the Co-Issuers have received notice thereof) or, upon an Issuer Order, by the Trustee in the name and at the expense of the Co-Issuers. Failure to give notice of redemption, or any defect therein, to any Holder of any Class selected for redemption shall not impair or affect the validity of the redemption of any other Class.
- In the case of any Refinancing, the Co-Issuers shall withdraw any notice of redemption up to (and including) the third Business Day prior to the scheduled Redemption Dateby written notice to the Trustee and the Investment Manager only if (i) the Investment Manager has notified the Co-Issuers that it is unable to obtain the applicable Refinancing on behalf of the Issuer or (ii) the Issuer receives written direction from a Majority of the Subordinated Securities to withdraw such notice of redemption. For the avoidance of doubt, the failure to effect any Refinancing as the result of a failure to settle the related Refinancing shall not constitute an Event of Default. At the direction of the Majority of the Subordinated Securities, the Issuer shall withdraw any notice of Optional Redemption, Partial Redemption, Tax Redemption or Clean-Up Call Redemption by written notice to the Trustee on any day up to and including the Business Day prior to the proposed Redemption Date. The Issuer may, following good faith efforts by the Issuer and the Investment Manager to facilitate any Optional Redemption, Partial Redemption, Tax Redemption or Clean-Up Call Redemption, and, if the conditions to such redemption have not been satisfied (including the receipt of sufficient funds to effect such redemption) shall, withdraw any notice of such redemption by written notice to the Trustee on any day up to and including the Business Day prior to the proposed Redemption Date. The Trustee shall at the

expense of the Issuer promptly forward any notice of withdrawal of a redemption to the Holders and any Rating Agency that received notice of such redemption.

- (e) If the Co-Issuers Issuer so withdraw any notice of redemption or are is otherwise unable to complete anythe redemption of the applicable Securities, the Sale Proceeds received from the sale of any Collateral Obligations and other Assets sold pursuant to Section 9.2 or Section 9.10 may, during the Reinvestment Period at the Investment Manager's sole discretion, be reinvested in accordance with the Investment Criteria.
- Any Holder of Secured Notes, the Investment Manager or any of the Investment Manager's Affiliates or accounts managed by it shall have the right, subject to the same terms and conditions afforded to other bidders, to bid on Assets to be sold as part of a Redemption by Liquidation (including a Tax Redemption) or a Clean-Up Call Redemption.

Notice of redemption shall be given by the Co Issuers (so long as the Co Issuers have received notice thereof) or, upon an Issuer Order, by the Trustee in the name and at the expense of the Co-Issuers. Failure to give notice of redemption, or any defect therein, to any Holder of any Class selected for redemption shall not impair or affect the validity of the redemption of any other Classes.

Manager (or other Retention Holder) to the extent that the Investment Manager determines (based upon the written advice of nationally recognized counsel experienced in such matters, a summary of which shall be provided to the holders of the Subordinated Securities) that the purchase of such Refinancing Obligations is necessary for compliance with the U.S. Risk Retention Regulations.

### Section 9.6 Securities Payable on Redemption Date.

(a) Notice of redemption pursuant to Section 9.5 having been given as aforesaid, the Securities Notes to be redeemed shall, on the Redemption Date, subject to Section 9.2(c) in the case of Redemption by Liquidation (including a Tax Redemption) and the right to withdraw any such notice of redemption pursuant to Section 9.5(b), become due and payable at the Redemption Price therein specified, and from and after the Redemption Date (unless the Issuer shall default in the payment of the Redemption Price-and accrued interest) all such Secured Notes shall cease to bear interest on the Redemption Date. Upon final payment on a Certificated Security to be so redeemed, the Holder shall present and surrender such Certificated Security (or note) at the place specified in the notice of redemption on or prior to such Redemption Date; provided, however, that if there is delivered to the Co-Issuers and the Trustee such security or indemnity as may be required by any of them to save such party harmless and an undertaking thereafter to surrender such Certificated Security, then, in the absence of notice to the Co-Issuers or the Trustee that the applicable NoteCertificated Security has been acquired by a Protected Purchaser, such final payment shall be made without presentation or surrender. Payments of interest on Secured Notes so to be redeemed whose Stated Maturity is on or prior to the Redemption Date shall be payable to the Holders of such Secured Notes, or one or more predecessor Notes, registered as such at the close of business on the relevant Record Date.

- (b) If any Secured NoteNotes called for redemption shall not be paid upon surrender thereof-for redemption, the principal thereof shall, until paid, bear interest from the Redemption Date at the applicable Interest Rate for each successive Interest Accrual Period (or, for the first Interest Accrual Period, the related portion thereof) the Secured NoteNotes remains Outstanding; provided that the reason for such non-payment is not the fault of such Holder.
- (c) Notwithstanding anything to the contrary set forth herein, the proceeds Refinancing Proceeds from a Refinancing related to a Partial Redemption shall not constitute Interest Proceeds or Principal Proceeds but shall be applied directly on the related Partial Redemption Date to redeem the Class or Classes of Secured Notes subject to such redemption by Refinancing Partial Redemption pursuant to the Priority of Partial Redemption Proceeds; provided that to the extent such Refinancing Proceeds are not applied to redeem such Class or Classes of Secured Notes, such Refinancing Proceeds shall be treated as Principal Proceeds.

# Section 9.7 <u>Special Redemption</u>.

Principal payments on the Secured Notes shall be made—in part in accordance with the Priority of Payments on any Payment Date during the Reinvestment Period, if the Investment Manager at its sole discretion notifies the Trustee that it has been unable, for a period of at least 2030 consecutive Business Days, to identify additional Collateral Obligations that are deemed appropriate by the Investment Manager in its sole discretion and would meet the Investment Criteria (a "Special Redemption"). On the first Payment Date following—the notice (a "Special Redemption Date"), the amount designated by the Investment Manager (such amount, athe "Special Redemption Amount"), shall be applied in accordance with the Priority of Payments. Notice of payments pursuant to this Section 9.7 shall be given by the Trustee not less than three Business Days prior to the applicable Special Redemption Date to each Holder of Secured Notes affected thereby, each Holder of Subordinated Securities and to the Rating Agencies. In addition, for so long as any Securities are listed on the Irish Stock Exchange and so long as the guidelines of such exchange so require, notice of Special Redemption will be provided to the Irish Stock Exchange. Principal Proceeds.

#### Section 9.8 <u>Rating Confirmation Redemption.</u>

Principal payments on the Secured Notes shall be made in part in accordance with the Priority of Payments on any Payment Date after the Refinancing Effective Date if the Investment Manager notifies the Trustee that a redemption is principal payments are required (a "Rating Confirmation Redemption") in order to obtain Effective Date Ratings Confirmation. On the first Payment Date following such notice is given, Interest Proceeds and Principalafter the Amendment Date and any Payment Date thereafter until Effective Date Ratings Confirmation is obtained, Interest Proceeds in an amount determined designated by the Investment Manager (such amount, athe "Rating Confirmation Redemption Amount") will shall be applied to redeempay principal of the Secured Notes in order to the extent required to obtain Effective Date Rating Ratings Confirmation under the Priority of Payments.

### Section 9.9 Re—Pricing of Notes.

- (a) On any Business Day after the Non-\_Call Period, at the written direction of a Majority of the Subordinated Securities, the Issuer shall reduce the spread over LIBOR or fixed interest rateInterest Rate applicable with respect to any Class of Secured Notes other than the Class A 1Re-Pricing Eligible Notes (such reduction a "Re-with respect to any such Class of Secured Notes, a "Re-Pricing" and any such Class that is subject to a Re-Pricing, a "Re-Priced Class"); provided that the Issuer shall not effect any Re-Pricing unless each applicable condition specified in this Section 9.9 is satisfied with respect thereto. For the avoidance of doubt, no. No terms of anythe Re-Priced Class other than theits Interest Rate applicable thereto—may be modified or supplemented in connection with a Re-Pricing, Pricing; provided that the foregoing shall not limit the ability of the Co-Issuers to execute a supplemental indenture necessary to issue Re-Pricing Replacement Notes pursuant to Section 8.6. In connection with any Re-Pricing, the Issuer may engage a broker-dealer (the "Re-Pricing Intermediary") to assist the Issuer in effecting the Re-Pricing.
- At least 4520 Business Days prior to the Business Day fixed by a Majority of the Subordinated Securities for any proposed Re-Pricing (the "Re-Pricing Date"), the Issuer, or the Re-Pricing Intermediary on behalf of the Issuer, shall deliver a notice in writing (with a copy to the Investment Manager, the Trustee and each Rating Agency) to each Holder of the proposed Re--Priced Class, which notice shall (i) specify the proposed Re--Pricing Date and the revised spread over LIBOR (or fixed rate in the case of Fixed Rate Notes Interest Rate (or range of interest rates from which a single Interest Rate will be chosen by the Issuer prior to the Re-Pricing Date) to be applied with respect to such Class (LIBOR plus suchthe revised spread or such fixed rate as applicable Interest Rate, the "Re-Pricing Rate"), (ii) request that each Holder consent to the terms of the Re-Priced Class approve the proposed Re-Pricing, proposed Re-Pricing on or before the date that is ten Business Days prior to the proposed Re-Pricing Date and (iii) specify the price applicable Redemption Price at which the Notes of any Holder of the Re-Priced Class that does not approve the Re-Pricing may consent to the Re-Pricing on or before the date that is five Business Days prior to the proposed Re-Pricing Date (each, a "Non-Consenting Holder") may (x) be required by the Issuer to be sold and transferred pursuant to clause (c) below, which, for purposes of such Re-Pricing, shall be an amount equal to the Aggregate Outstanding Amount of the Re Priced Class, plus accrued and unpaid interest thereon at the applicable Interest Rate to but excluding the applicable Re Pricing Dateto one or more transferees specified by or on behalf of the Issuer or (v) be redeemed in a Re-Pricing Redemption with the proceeds of an issuance of Re-Pricing Replacement Notes and Re-Pricing Interest Proceeds.
- (c) In the event any holder Holder of the Re-Priced Class does has not deliverdelivered written consent to the proposed Re-Pricing on or before the date which that is 20 five Business Days prior to the proposed Re-Pricing Date, the Issuer, or the Re-Pricing Intermediary on behalf of the Issuer, shall deliver written notice thereof to the consenting holders Consenting Holders of the Re-Priced Class, specifying the Aggregate Outstanding Amount of the Notes of the Re-Priced Class held by all such non-consenting holders Non-Consenting Holders, and shall request that, within four Business Days of receipt of such notice, each such consenting holder to Consenting Holder provide written notice to the

Issuer, the Trustee, the Investment Manager and the Re-Pricing Intermediary if such holderspecifying the Aggregate Outstanding Amount (if any) of such Notes that it would like be willing to purchase all or any portion of the Notes of the Re-Priced Class held by the non-consenting holders or, if the Issuer elects to issue Re-Pricing Replacement Notes in lieu of the forced sale of Non-Consenting Holders' Notes, the Aggregate Outstanding Amount (if any) of Re-Pricing Replacement Notes that it would be willing to purchase (each such notice, an "Exercise Notice") within 5Business Days of receipt of such notice.

In the event that the Issuer receives Exercise Notices with respect to more than the Aggregate Outstanding Amount of the Notes of the Re-Priced Class held by non-consenting holders Non-Consenting Holders, the Issuer, or the Re-Pricing Intermediary on behalf of the Issuer, shall cause the sale and transfer of such Notes, or will sell Re-Pricing Replacement Notes, without further notice to the non-consenting holders Non-Consenting Holders thereof, on the Re-Pricing Date to the holders Holders delivering Exercise Notices with respect thereto, (pro rata based on the Aggregate Outstanding Amount of the Notes such holders Holders indicated an interest in purchasing pursuant to their Exercise Notices) and, if applicable, conduct a Re-Pricing Redemption of Non-Consenting Holders' Notes.

In the event that the Issuer receives Exercise Notices with respect to less than the Aggregate Outstanding Amount of the Notes of the Re-Priced Class held by non-consenting holders Non-Consenting Holders, the Issuer, or the Re-Pricing Intermediary on behalf of the Issuer, shall cause the sale and transfer of such Notes, or will sell Re-Pricing Replacement Notes, without further notice to the non-consenting holders Non-Consenting Holders thereof, on the Re-Pricing Date to the holders Holders delivering Exercise Notices with respect thereto, and any excess Notes of the Re-Priced Class held by non-consenting holders shall be sold to a transferee designated by the Re-(if any) and, if applicable, conduct a Re-Pricing Redemption of Non-Consenting Holders' Notes. Any Non-Consenting Holders' Notes not purchased or redeemed pursuant to the preceding sentence will be sold to, or redeemed with proceeds from the sale of Re-Pricing Replacement Notes to, one or more purchasers designated by the Re-Pricing Intermediary on behalf of the Issuer.

All sales of Notes to be effected pursuant to this clause (c) shall Non-Consenting Holders' Notes or Re-Pricing Replacement Notes will be made at the Redemption Price with respect to such Notes, and shall be effected only if the related Re-Pricing is effected in accordance with the provisions hereof. The holder Holder of each Note, by its acceptance of an interest in the Notes, agrees to sell and transfer its Notes or be redeemed in accordance with this Section 9.9 and agrees to cooperate with the Issuer, the Re-Pricing Intermediary and the Trustee to effect such sales and transfers or redemption. The Issuer, or the Re-Pricing Intermediary on behalf of the Issuer, shall deliver written notice to the Trustee and the Investment Manager not later than 12the Business Days Day prior to the proposed Re-Pricing Date confirming that the Issuer has received written commitments to purchase all Notes of the Re-Priced Class held by non-consenting holders sufficient Non-Consenting Holders' Notes and Re-Pricing Replacement Notes to pay the Redemption Price to all Non-Consenting Holders.

- (d) The Issuer shall not effect any proposed Re-Pricing unless:
- (i) the Co-Issuers and the Trustee (with the consent of a Majority of the Subordinated Securities) shall have entered into atthe related supplemental indenture dated as of the Re-Pricing Date, which can be executed and delivered without regard to the provisions of Article VIII hereof, solely to (a) modify the spread over LIBOR or fixed interest rate the Reference Rate applicable to the Re-Pricing Class and (b) in the case of an issuance of Re-Pricing Replacement Notes; issue such Re-Pricing Replacement Notes;
- (ii) all Notes of the Re-\_Priced Class held by non-consenting holders Non-Consenting Holders have been sold and transferred or redeemed pursuant to clause (c) above;
  - (iii) each Rating Agency shall have has been notified of such Re-Pricing; and
- (iv) all expenses of the Issuer and the Trustee that are currently due and payable (including the fees of the Re-Pricing Intermediary and fees of counsel) incurred in connection with the Re-Pricing shall not exceed the amount of Interest Proceeds available after taking into account all amounts required to be paid pursuant to the Priority of Interest Payments-Pricing will be paid on the Re-Pricing Date or the next subsequent Payment Date-prior to distributions to the holders of the Subordinated Securities, unless such expenses shall have been paid or will be adequately provided for by an entity other than the Issuer; and
- (v) neither the Investment Manager nor any "sponsor" (as defined in the U.S. Risk Retention Regulations) with respect to the Notes or the Re-Pricing Replacement Notes will fail to be in compliance with the U.S. Risk Retention Regulations as a result of such Re-Pricing.
- (e) <u>Unless it consents to do so, none of the Investment Manager, the Retention Holders or any Affiliate of the Investment Manager will be required to purchase or invest in any Re-Pricing Replacement Notes.</u>
- (f) (e) The Trustee shall be entitled to receive, and (subject to Sections Section 6.1 and Section 6.3(a) hereof) shall be fully protected in relying upon an Opinion of CounselOfficer's certificate of the Issuer stating that the Re-Pricing is permitted by this Indenture and that all conditions precedent thereto have been complied with. The Trustee may request and rely on an Issuer Order providing direction and any additional information requested by the Trustee in order to effect a Re-Pricing in accordance with this Section 9.9. The Issuer shall direct the Trustee to segregate payments and take other reasonable steps to effect the Re-Pricing, and the Trustee shall have the authority to take such actions as may be directed by the Issuer or the Investment Manager to effect a Re-Pricing. In order to give effect to the Re-Pricing, the Issuer may, to the extent necessary, obtain and assign a separate CUSIP or CUSIPs to the Notes of each Class held by Consenting Holders or Non-Consenting Holders.
- (g) (f) Notice of Re-Pricing shall be given by the Trustee (at the expense of the Issuer) not less than 10three Business Days prior to the proposed Re-Pricing Date to each

holder Holder of Notes of the Re-Priced Class (with a copy to the Investment Manager) specifying the applicable Re-Pricing Date-and, Re-Pricing Rate and Redemption Price. Failure to give a notice of Re-Pricing, or any defect therein, to any holder Holder of any Re-Priced Class shall not impair or affect the validity of the Re-Pricing or give rise to any claim based upon such failure or defect.

Any notice of a Re—Pricing may be withdrawn by a Majority of the Subordinated Securities or, if any condition to the Re-Pricing is not satisfied, the Issuer, on or prior to the fourth—Business Day prior to the scheduled Re—Pricing Date by written notice to the Issuer, the Trustee, and the Investment Manager for any reason. Upon receipt of such notice of withdrawal, the Trustee shall send such notice to the Holders of Notes and each Rating Agency. The failure to effect a Re-Pricing will not constitute an Event of Default.

# Section 9.10 Clean-Up Call Redemption.

- (a) The Outstanding Secured Notes will be redeemed by the Co-Issuers, in whole but not in part (a "Clean-Up Call Redemption"), at the applicable Redemption Prices on any Business Day after the Non-Call Period on which the Collateral Principal Amount is less than 15% of the Aggregate Ramp-Up Par Amount, subject to the conditions set forth below at the written direction at least 15 Business Days prior to the proposed Redemption Date of (i) a Majority of the Subordinated Securities or (ii) the Investment Manager so long as a Majority of the Subordinated Securities does not object to such direction within ten Business Days of notice of such direction.
- Any Clean-Up Call Redemption is subject to (i) the purchase of the Assets (other than Eligible Investments) by the Investment Manager or any other Person from the Issuer, on or prior to the Business Day immediately preceding the related Redemption Date, for a purchase price in cash (the "Clean-Up Call Redemption Price") at least equal to the Redemption Amount *less* all other funds available for such redemption and (ii) the receipt by the Trustee from the Investment Manager, prior to such purchase, of certification from the Investment Manager that the funds expected to be received will satisfy clause (i). Upon receipt of the certification referred to in the preceding sentence, the Trustee (pursuant to written direction from the Issuer) and the Issuer will take all actions necessary to sell, assign and transfer the Assets to the Investment Manager or such other Person upon payment in immediately available funds of the Clean-Up Call Redemption Price. The Trustee will deposit such payment into the Collection Account in accordance with the instructions of the Investment Manager. Any sale of an Asset in connection with a Clean-Up Call Redemption will be on arms' length terms and, in the case of a sale of any Asset to the Investment Manager, its Affiliates or any account managed by the Investment Manager or its Affiliate, at a price not less than the Market Value of such Asset as of the date that the Issuer commits to such sale.
- the Issuer will provide written notice of the proposed Redemption Date to the Trustee, the Collateral Administrator, the Investment Manager and the Rating Agencies (and the Trustee in turn shall, in the name and at the expense of the Issuer, notify the Holders at least ten Business Days prior to the Redemption Date). Any notice of Clean-Up Call Redemption may be withdrawn by the Issuer on any day up to and including the Business Day prior to the proposed Redemption Date by written notice to the Trustee and the Investment Manager for any reason. The Trustee will give notice of any such withdrawal of a Clean-Up Call Redemption, at the expense of the Issuer, to each Holder and each Rating Agency.
- (d) On the Redemption Date related to any Clean-Up Call Redemption, the Clean-Up Call Redemption Price will be distributed pursuant to the Priority of Payments.

#### **ARTICLE X**

### ACCOUNTS, ACCOUNTINGS AND RELEASES

Section 10.1 <u>Collection of Money</u>. Except as otherwise expressly provided herein, the Trustee may demand payment or delivery of, and shall receive and collect, directly and without intervention or assistance of any fiscal agent or other intermediary, all Money and other property payable to or receivable by the Trustee pursuant to this Indenture, including all payments due on the Pledged Obligations, in accordance with the terms and conditions of such Pledged Obligations. The Trustee shall segregate and hold all such Money and property received by it in trust for the Holders of the Securities and shall apply it as provided in this Indenture.

#### Section 10.2 Collection Accounts.

- (a) The Trustee shall, on or prior to the Closing Date, establish has (a) established at the Intermediary two segregated non-interest bearing trust accounts, each in the name of the Trustee in trust for the benefit of the Secured Parties, one of which shall be designated the "Interest Collection Account" and the other of which shall be designated the "Principal Collection Account," each of which shall be maintained by the Issuer with the Intermediary in accordance with the Account Agreement. The Trustee shall from time to time deposit into the Interest Collection Account, in addition to the deposits required pursuant to Section 10.5(a), immediately upon receipt thereof (i) any funds in the Interest Reserve Account (other than amounts designated as Principal Proceeds by the Investment Manager in its sole discretion pursuant to Section 10.3(e)) and (ii) all Interest Proceeds (unless simultaneously reinvested in additional Collateral Obligations in accordance with Article XII) received by the Trustee. The Trustee shall deposit immediately upon receipt thereof all other amounts remitted to the Collection Account into the Principal Collection Account, including in addition to the deposits required pursuant to Section 10.5(a), (i) any funds in the Interest Reserve Account deemed by the Investment Manager in its sole discretion to be Principal Proceeds pursuant to Section 10.3(e), (ii) all Principal Proceeds (unless simultaneously reinvested in additional Collateral Obligations in accordance with Article XII or in Eligible Investments) received by the Trustee, (iii) upon written direction of a Contributing Noteholder Holder to the Issuer and the Trustee at any time during or after the Reinvestment Period, the amount of any Contribution made to the Issuer by such Contributing Noteholder Holder for application to a Permitted Use, and (iv) all other funds received by the Trustee; provided that on any Business Day after the Effective Date and on or before the first Determination Date, so long as the Aggregate Ramp-Up-Par Condition has been satisfied and a Rating Confirmation Redemption is not required, the Trustee will deposit from the Principal Collection Account into the Interest Collection Account as Interest Proceeds an amount designated by the Investment Manager subject to the Effective Date Interest Deposit Restriction. All Monies deposited from time to time in the Collection Account pursuant to this Indenture shall be held by the Trustee as part of the Assets and shall be applied to the purposes herein provided. Subject to Section 10.2(d), amounts in the Collection Account shall be reinvested pursuant to Section 10.5(a).
- (b) The Trustee, within one Business Day after receipt of any distribution or other proceeds in respect of the Assets which are not Cash, shall so notify or cause the Issuer to

be notified and the Issuer shall use its commercially reasonable efforts to, within five Business Days of receipt of such notice from the Trustee (or as soon as practicable thereafter), sell such distribution or other proceeds for Cash in an arm's length transaction to a Person which is not the Investment Manager or an Affiliate of the Issuer or the Investment Manager and deposit the proceeds thereof in the Collection Account; provided, however, that the Issuer (i) need not sell such distributions or other proceeds if it delivers an Officer's certificate to the Trustee certifying (after consultation with nationally recognized counsel) that such distributions or other proceeds constitute Collateral Obligations or Eligible Investments or (ii) may otherwise retain such distribution or other proceeds for up to two years from the date of receipt thereof if it delivers an Officer's certificate to the Trustee certifying that (x) it shall sell such distribution within such two-year period and (y, (y) such distribution or other proceeds were received "in lieu of debt previously contracted" for purposes of the Volcker Rule as determined by the Investment Manager in consultation with counsel and (z) retaining such distribution is not otherwise prohibited by this Indenture.

- (c) At any time when reinvestment is permitted pursuant to <u>Article XII</u>, the Investment Manager on behalf of the Issuer may by Issuer Order direct the Trustee to, and upon receipt of such Issuer Order the Trustee shall, withdraw funds on deposit in the Principal Collection Account representing Principal Proceeds (including Principal Financed Accrued Interest used to pay for accrued interest on an additional Collateral Obligation) and reinvest (or invest, in the case of funds referred to in <u>Section 7.17</u>) such funds in additional Collateral Obligations, in each case in accordance with the requirements of <u>Article XII</u> and such Issuer Order.
- (d) The Investment Manager on behalf of the Issuer may by Issuer Order direct the Trustee to, and upon receipt of such Issuer Order the Trustee shall, pay from amounts on deposit in the Collection Account representing Interest Proceeds on any Business Day during any Interest Accrual Period (i) any amount required to exercise a warrant held in the Assets or right to acquire securities in accordance with the requirements of Article XII and such Issuer Order and (ii) any Administrative Expenses (paid in the order of priority set forth in the definition thereof); provided that the payment of Administrative Expenses payable to the Trustee or to the Bank in any capacity shall not require such direction by Issuer Order; provided, further, that the aggregate Administrative Expenses paid pursuant to this Section 10.2(d) during any Collection Period shall not exceed the Administrative Expense Cap for the related Payment Date.
- (e) The Trustee shall transfer to the Payment Account as applicable, from the Collection Account, for application pursuant to <u>Section 11.1(a)</u> of this Indenture, on or not later than the Business Day preceding each Payment Date, the amount set forth to be so transferred in the Distribution Report for such Payment Date.
- (f) The Investment Manager on behalf of the Issuer may by Issuer Order direct the Trustee to, and upon receipt of such Issuer Order the Trustee shall, transfer from amounts on deposit in the Interest Collection Account on any Business Day during any Interest Accrual Period to the Principal Collection Account, amounts necessary for application pursuant to Section 7.17(d).

# Section 10.3 Other Accounts.

- (a) Payment Account. The Trustee shall, on or prior to the Closing Date, established at the Intermediary a segregated non-interest bearing trust account which shall be designated as the "Payment Account." Except as provided in Section 11.1(a), the only permitted withdrawal from or application of funds on deposit in, or otherwise to the credit of, the Payment Account shall be to pay amounts due and payable on the Securities in accordance with their terms and the provisions of this Indenture and to pay Administrative Expenses and other amounts specified herein, each in accordance with the Priority of Payments. The Co-Issuers shall not have any legal, equitable or beneficial interest in the Payment Account other than in accordance with the Priority of Payments. Funds in the Payment Account shall not be invested.
- (b) <u>Custodial Account</u>. The Trustee <u>shall</u>, on or prior to the <u>Closing Date</u>, <u>establishhas established</u> at the Intermediary a segregated non-interest bearing trust account which shall be designated as the "<u>Custodial Account</u>." The only permitted withdrawals from the Custodial Account shall be in accordance with the provisions of this Indenture. The Co-Issuers shall not have any legal, equitable or beneficial interest in the Custodial Account other than in accordance with the Priority of Payments.
- (c) Ramp-Up Account. The Trustee shall, on or prior to the Closing Date, establishhas established at the Intermediary a segregated non-interest bearing trust account which shall be designated as the "Ramp-Up Account." On the Closing Amendment Date, the Issuer hereby directs the Trustee to deposit the amount specified in the Closing Amendment Date Certificate. In connection with any purchase of an additional Collateral Obligation, the Trustee shall apply amounts held in the Ramp-Up Account as provided by Section 7.17(b). Upon the occurrence of an Event of Default or a failure to obtain Effective Date Ratings Confirmation, the Trustee shall deposit any remaining amounts in the Ramp-Up Account into the Principal Collection Account as Principal Proceeds (excluding any proceeds that shall be used to settle binding commitments entered into prior to such occurrence). On any Business Day after the Effective Date and before the first Determination Date, so long as the Aggregate Ramp Up Par-Condition has been satisfied and a Rating Confirmation Redemption is not required, the Trusteewill transfer from amounts remaining in the Ramp-Up Account (excluding any proceeds that willbe used to settle binding commitments entered into prior to the Effective Date) into the Interest Collection Account as Interest Proceeds an amount designated by the Investment Manager subject to the Effective Date Interest Deposit Restriction. On the First the first Determination Date, the Trustee will transfer any amounts remaining in the Ramp-Up Account into the Principal Collection Account as Principal Proceeds. Any income earned on amounts deposited in the Ramp-Up Account shall be deposited in the Collection Account as Interest Proceeds.
- (d) Expense Reserve Account. The Trustee shall, on or prior to the Closing Date, established at the Intermediary a segregated non-interest bearing trust account which shall be designated as the "Expense Reserve Account." On the Closing Amendment Date, the Issuer hereby directs the Trustee to deposit the amount specified in the Closing Amendment Date Certificate. The Trustee shall apply funds from the Expense Reserve Account, in the amounts and as directed in writing by the Investment Manager, to pay (x) amounts due in respect

of actions taken in connection with the refinancing effected on or before the Closing Amendment Date and (y) subject to the Administrative Expense Cap, Administrative Expenses in the order of priority contained in the definition thereof. Any income earned on amounts on deposit in the Expense Reserve Account shall be deposited in the Interest Collection Account as Interest Proceeds as it is paid. On or before the first Determination Date after the Amendment Date, all funds in the Expense Reserve Account (after deducting any expenses paid on such Determination Date) shall be deposited in the Collection Account as Interest Proceeds and/or Principal Proceeds (in the respective amounts directed by the Investment Manager in its sole discretion).

- (e) Interest Reserve Account. The Trustee shall, on or prior to the Closing Date, establish has established at the Intermediary a segregated non-interest bearing trust account which shall be designated as the "Interest Reserve Account." On the Closing Amendment Date, the Issuer hereby directs the Trustee to deposit the amount specified in the Closing Amendment Date Certificate. On any date prior to the Determination Date relating to the first Payment Date after the Amendment Date, the Investment Manager, by Issuer Order, may direct that all or any portion of funds in the Interest Reserve Account be transferred to the Principal Collection Account, as long as, after giving effect to such deposits, the Investment Manager determines (as certified in such Issuer Order) that the Issuer shall have sufficient funds in the Collection Account to pay interest payments on the Secured Notes and all amounts senior in right of payment under the Priority of Interest Proceeds on the first Payment Date after the Amendment Date. All funds remaining in the Interest Reserve Account on the first Determination Date after the Amendment Date shall be transferred to the Interest Collection Account. Any income earned on amounts deposited in the Interest Reserve Account shall be deposited in the Interest Collection Account as Interest Proceeds as it is paid.
- (f) <u>Unfunded Exposure Account</u>. Upon the purchase of any Revolving Collateral Obligation or Delayed Drawdown Collateral Obligation, funds in an amount equal to the undrawn portion of such obligation shall be withdrawn first from the Ramp-Up Account and, if necessary, from the Principal Collection Account and deposited in a segregated non-interest bearing trust account established by the Trustee at the Intermediary which shall be designated as the "<u>Unfunded Exposure Account</u>." Upon initial purchase of any such obligations, funds deposited in the Unfunded Exposure Account in respect of any Revolving Collateral Obligation or Delayed Drawdown Collateral Obligation will be treated as part of the purchase price therefor. Amounts in the Unfunded Exposure Account will be invested in overnight funds that are Eligible Investments and earnings from all such investments will be deposited in the Interest Collection Account as Interest Proceeds as it is paid.

The Issuer shall, at all times maintain sufficient funds on deposit in the Unfunded Exposure Account such that the sum of the amount of funds on deposit in the Unfunded Exposure Account shall be equal to or greater than the sum of the unfunded funding obligations under all such Revolving Collateral Obligations and Delayed Drawdown Collateral Obligations then included in the Assets. Funds shall be deposited in the Unfunded Exposure Account upon the purchase of any Revolving Collateral Obligation or Delayed Drawdown Collateral Obligation and upon the receipt by the Issuer of any Principal Proceeds with respect to a Revolving Collateral Obligation as directed by the Investment Manager on behalf of the Issuer. In the event of any shortfall in the Unfunded Exposure Account, the Investment Manager (on behalf of the Issuer) may direct the Trustee to, and the Trustee thereafter shall, transfer funds in an amount

equal to such shortfall from the Principal Collection Account to the Unfunded Exposure Account.

Any funds in the Unfunded Exposure Account (other than earnings from Eligible Investments therein) will be available solely to cover any drawdowns on the Revolving Collateral Obligations and Delayed Drawdown Collateral Obligations; provided that any excess of (A) the amounts on deposit in the Unfunded Exposure Account over (B) the sum of the unfunded funding obligations under all Revolving Collateral Obligations and Delayed Drawdown Collateral Obligations that are included in the Assets may be transferred by the Trustee (at the written direction of the Investment Manager on behalf of the Issuer) from time to time as Principal Proceeds to the Principal Collection Account.

(g) LC Reserve Account. If an LOC Agent Bank does not withhold on payments of fee income in respect of any Collateral Obligation that is a Letter of Credit and the Issuer has not received Tax Advice to the effect that such withholding should or will not be required, the Investment Manager will advise the Issuer and the Issuer shall transfer funds from the Interest Collection Account in an amount equal to 30% (or such other percentage equal to the withholding rate then in effect) of all of the fees received in respect of such Letter of Credit into a single, segregated non-interest bearing trust account established by the Trustee at the Intermediary, which shall be designated as the "LC Reserve Account." Amounts deposited in the LC Reserve Account will be invested by the Trustee in Eligible Investments as directed by the Investment Manager. The Issuer shall withdraw funds from the LC Reserve Account to pay (or to provide for the payments of) the related withholding taxes when due. The Issuer may also withdraw funds from the LC Reserve Account and apply them as Interest Proceeds (a) if the Issuer receives Tax Advice to the effect that the Issuer should or will not be subject to U.S. withholding tax with respect to the letter of credit fees from which such funds were reserved or (b) to the extent such amounts will not be due after such date, (i) at Stated Maturity or (ii) on a Redemption Date in connection with an Optional Redemption (other than pursuant to a Refinancing) or a Tax Redemption. The Issuer shall provide to S&P a copy of any opinion obtained pursuant to the Tax Advice referred to above.

(g) (h) Each Account described in this Section 10.3 shall (i) be in the name of the Trustee for the benefit of the Secured Parties, (ii) consist of a securities account and all subaccounts related thereto and (iii) be maintained by the Issuer with the Intermediary in accordance with the Account Agreement.

Section 10.4 <u>Hedge Counterparty Collateral Account</u>. If and to the extent that any Hedge Agreement requires the Hedge Counterparty to post collateral with respect to such Hedge Agreement, the Issuer shall (at the direction of the Investment Manager), on or prior to the date such Hedge Agreement is entered into, direct the Trustee to establish in the name of the Trustee a segregated, non-interest bearing trust account which shall be designated as a Hedge Counterparty Collateral Account (each, a "<u>Hedge Counterparty Collateral Account</u>") shall consist of a securities account and all subaccounts related thereto. The Trustee (as directed in writing by the Investment Manager on behalf of the Issuer) shall deposit into each Hedge Counterparty Collateral Account all collateral required to be posted by a Hedge Counterparty and all other funds and property required by the terms of any Hedge Agreement to be deposited into such Hedge Counterparty Collateral Account, in accordance with the terms of the related Hedge Agreement. The only permitted withdrawals from or application of funds or property on deposit

in any Hedge Counterparty Collateral Account shall be in accordance with the written instructions of the Investment Manager.

### Section 10.5 Reinvestment of Funds in Accounts; Reports by Trustee.

By Issuer Order (which may be in the form of standing instructions), the Issuer (or the Investment Manager on behalf of the Issuer) shall at all times direct the Trustee to, and, upon receipt of such Issuer Order, the Trustee shall, invest all funds on deposit in the Collection Account, the Ramp-Up Account, the Expense Reserve Account, the Interest Reserve Account and the Hedge Counterparty Collateral Account as so directed in Eligible Investments having Stated Maturities no later than the Business Day preceding the next Payment Date (or such shorter maturities expressly provided herein). If prior to the occurrence of an Event of Default, the Issuer shall not have given any such investment directions, the Trustee shall seek instructions from the Investment Manager within three Business Days after transfer of any funds to such accounts. If the Trustee does not thereafter receive written instructions from the Investment Manager within five Business Days after transfer of such funds to such accounts, it shall invest and reinvest the funds held in such accounts, as fully as practicable, in an investment vehicle (which shall be an Eligible Investment) designated as such by the Investment Manager to the Trustee in writing on or before the Closing Date (such investment, until and as it may be changed from time to time as hereinafter provided, the "Standby Directed Investment"), until investment instruction as provided in the preceding sentence is received by the Trustee; or, if the Trustee from time to time receives a standing written instruction from the Investment Manager expressly stating that it is changing the "Standby Directed Investment" under this paragraph, the Standby Directed Investment may thereby be changed to an Eligible Investment of the type described in clause (ii) of the definition of Eligible Investments maturing no later than the Business Day immediately preceding the next Payment Date (or such shorter maturities expressly provided herein) as designated in such instruction. After an Event of Default, the Trustee shall invest and reinvest such Monies as fully as practicable in US Bank National Association Eurodollar Sweep Deposit or, if no longer available, such similar investment of the type set forth in clause (ii) of the definition of Eligible Investments maturing not later than the earlier of (i) 30 days after the date of such investment (unless putable at par to the issuer thereof) or (ii) the Business Day immediately preceding the next Payment Date (or such shorter maturities expressly provided herein)the Standby Directed Investment. Except to the extent expressly provided otherwise herein, all interest and other income from such investments shall be deposited in the Interest Collection Account, any gain realized from such investments shall be credited to the Principal Collection Account upon receipt, and any loss resulting from such investments shall be charged to the Principal Collection Account. The Trustee shall not in any way be held liable by reason of any insufficiency of such accounts which results from any loss relating to any such investment; provided that the foregoing shall not relieve the Bank of its obligations under any security or obligation issued by the Bank or any Affiliate thereof.

(b) The Trustee agrees to give the Issuer immediate notice if the Trustee becomes aware that any Account or any funds on deposit in any Account, or otherwise to the credit of an Account, shall become subject to any writ, order, judgment, warrant of attachment, execution or similar process. All Accounts Each Account shall remain at all times with a financial institution (which may be the Trustee) (a)(x) having a long-term debt rating at least equal to "A2" and a short-term debt rating of "P-1" by Moody's and having combined capital and

surplus of at least U.S.\$200,000,000 and (y) that is a federal or state chartered depository institution that has a long term debt rating of at least "A+" by S&P or a long term debt rating of at least "A-1" by S&P, or (b) in segregated trust accounts with the corporate trust department of a federal or state-chartered deposit institution subject to regulations regarding fiduciary funds on deposit similar to Title 12 of the Code of Federal Regulation Section 9.10(b); provided, however, that (1) if cash is being held in a trust account, the related institution is also required to meet the ratings requirements set forth in clause (a), (2) if only assets other than cash are being held in a trust account, the related institution must have a long term rating of at least "Baa3" from Moody's and (3) if such institution's ratings fall below the ratings set forth in clauses (x) or (y) the assets held in such account will be moved to another institution that satisfies such ratings within 30 calendar daysan Eligible Account.

Investment Manager, and each Rating Agency any information regularly maintained by the Trustee that the Co-Issuers, the Rating Agencies or the Investment Manager may from time to time request in writing with respect to the Pledged Obligations, the Accounts and the other Assets and provide any other requested information reasonably available to the Trustee by reason of its acting as Trustee hereunder and required to be provided by Section 10.6 or to permit the Investment Manager to perform its obligations under the Investment Management Agreement. The Trustee shall promptly forward to the Investment Manager copies of notices and other writings received by it from the issuer of any Collateral Obligation or from any Clearing Agency with respect to any Collateral Obligation which notices or writings advise the holders of such security of any rights that the holders might have with respect thereto (including, without limitation, requests to vote with respect to amendments or waivers and notices of prepayments and redemptions) as well as all periodic financial reports, and other communications received from such issuer and Clearing Agencies with respect to such issuer.

## Section 10.6 Accountings.

- (a) Monthly. Not later than the tenth Business Day of each calendar month, excluding each month in which a Payment Date occurs, commencing in August 2013, the Issuer shall compile and make available (or cause to be compiled and made available) (including, at the election of the Issuer, via appropriate electronic means acceptable to each recipient) to each Rating Agency, the Trustee, the Investment Manager, the Initial Purchaser and the Irish Stock Exchange (so long as any Securities are listed on the Irish Stock Exchange) and, upon written request therefor, to any Holder and, upon written notice to the Trustee in the form of Exhibit D, any beneficial owner of a Security, a monthly report (each a "Monthly Report"). The Monthly Report will be determined as of the last Business Day of the prior calendar month. The Monthly Report shall contain the following information with respect to the Collateral Obligations and Eligible Investments included in the Assets (based, in part, on information provided by the Investment Manager):
  - (i) Aggregate Principal Balance of Collateral Obligations and Eligible Investments representing Principal Proceeds.
    - (ii) Adjusted Collateral Principal Amount of Collateral Obligations.

- (iii) Collateral Principal Amount of Collateral Obligations.
- (iv) A list of Collateral Obligations, including, with respect to each such Collateral Obligation, the following detailed information:
  - (A) The obligor thereon (including the issuer ticker, if any);
  - (B) The CUSIP, LoanX ID or security identifier thereof;
  - (C) The Principal Balance thereof (other than any accrued interest that was purchased with Principal Proceeds (but noting any capitalized interest));
  - (D) The percentage of the aggregate Collateral Principal Amount represented by such Collateral Obligation;
    - (E) The related interest rate or spread;
    - (F) The stated maturity thereof;

- (xx) (xxi) The identity of the Tax Subsidiary and the identity of each Collateral Obligation, Equity Security or Defaulted Obligation, if any, held by such Tax Subsidiary.
  - (xxi) The amount of Cash, if any, held in any Tax Subsidiary.
- (xxii) Each of the limitations and tests specified in clauses (i) through (vii) of Section 12.2(b), (1) the result, (2) the related minimum or maximum test level and (3) a determination as to whether such result satisfies the related test.
- (xxiii) On a dedicated page captioned "Volcker Rule Information," the percentage of obligations or securities (other than Eligible Investments) purchased by the Issuer prior to the report determination date that are owned by the Issuer as of the report determination date and that are (A) loans and (B) non-loan assets.
- (xxiv) The identity, Principal Balance, trade date and price (expressed as a percentage of par) of each Collateral Obligation that is purchased or sold in any

transaction with the Investment Manager or its Affiliates (including accounts managed by the Investment Manager).

- (xxvii) For any Collateral Obligation for which the stated maturity has been extended while held by the Issuer after the Reinvestment Period, the original stated maturity and the current stated maturity (as extended) of such Collateral Obligation.
- (xxviii) The name of each Intermediary and the long-term debt rating and the short-term debt rating of such Intermediary by S&P.
- (xxix) A statement with respect to whether the Issuer owns any Structured Finance Obligations.
- (xxx) (xxiii) Such other information as the Trustee, any Hedge Counterparty, any Rating Agency or the Investment Manager may reasonably request.
- (xxiv) With respect to any reinvestment pursuant to Section 12.2(b), satisfaction of the criteria regarding reinvestment set forth in clauses (A) through (G) of Section 12.2(b).

Upon receipt of each Monthly Report, the Trustee shall, if the Trustee is not the same Person as the Collateral Administrator, compare the information contained in such Monthly Report to the information contained in its records with respect to the Assets and shall, within three Business Days after receipt of such Monthly Report, notify the Issuer, the Collateral Administrator, the Investment Manager, and the Rating Agencies if the information contained in the Monthly Report does not conform to the information maintained by the Trustee with respect to the Assets. In the event that any discrepancy exists, the Trustee and the Issuer, or the Investment Manager on behalf of the Issuer, shall attempt to resolve the discrepancy. If such discrepancy cannot be promptly resolved, the Trustee shall within five Business Days cause the Independent accountants appointed by the Issuer pursuant to Section 10.8 to review such Monthly Report and the Trustee's records to determine the cause of such discrepancy. If such review reveals an error in the Monthly Report or the Trustee's records, the Monthly Report or the Trustee's records shall be revised accordingly and, as so revised, shall be utilized in making all calculations pursuant to this Indenture and notice of any error in the Monthly Report shall be sent as soon as practicable by the Issuer to all recipients of such report.

(b) <u>Payment Date Accounting</u>. The Issuer shall render (or cause to be rendered) a report (each a "<u>Distribution Report</u>"), determined as of the close of business on each Determination Date preceding a Payment Date, and shall make available such Distribution Report (including, at the election of the Issuer, via appropriate electronic means acceptable to

each recipient) to the Trustee, the Investment Manager, the Initial Purchaser and the Rating Agencies and, upon written request therefor, any Holder and, upon written notice to the Trustee in the form of Exhibit D, any beneficial owner of a Note not later than the Business Day preceding the related Payment Date. The Distribution Report shall contain the following information (based, in part, on information provided by the Investment Manager):

- (i) the information required to be in the Monthly Report pursuant to <u>Section</u> 10.6(a);
- (a) the Aggregate Outstanding Amount of the Secured Notes of each Class (ii) at the beginning of the Interest Accrual Period and such amount as a percentage of the original Aggregate Outstanding Amount of the Secured Notes of such Class, the amount of principal payments to be made on the Secured Notes of each Class on the next Payment Date, the amount of any Deferred Interest on each Class of Deferred Interest Notes, and the Aggregate Outstanding Amount of the Secured Notes of each Class after giving effect to the principal payments, if any, on the next Payment Date and such amount as a percentage of the original Aggregate Outstanding Amount of the Secured Notes of such Class, (b) the Aggregate Outstanding Amount of the each Class of Subordinated Securities at the beginning of the Interest Accrual Period and such amount as a percentage of the original Aggregate Outstanding Amount of the Subordinated Securities, the amount of payments to be made on the Subordinated Securities in respect of Subordinated Note Redemption Price on the next Payment Date, and the Aggregate Outstanding Amount of the Subordinated Securities after giving effect to such payments, if any, on the next Payment Date and such amount as a percentage of the original Aggregate Outstanding Amount of the Subordinated Securities;
- (iii) the Interest Rate and accrued interest for each applicable Class of Secured Notes for such Payment Date;
- (iv) the amounts payable pursuant to each clause of the Priority of Payments on the related Payment Date;
- (v) the amount of the Senior Investment Management Fee to be deferred by the Investment Manager pursuant to Section 11.1(g) on the related Payment Date and the aggregate Deferred Senior Fee after giving effect to any deferrals and any payments of the Deferred Senior Fee on the related Payment Date;

#### (vi) for the Collection Account:

- (A) the Balance on deposit in the Collection Account at the end of the related Collection Period (or, with respect to the Interest Collection Account, the next Business Day);
- (B) the amounts payable from the Collection Account to the Payment Account, in order to make payments pursuant to the Priority of Payments on the next Payment Date (net of amounts which the Investment Manager intends to re-invest in additional Collateral Obligations pursuant to <u>Article XII</u>); and

- (C) the Balance remaining in the Collection Account immediately after all payments and deposits to be made on such Payment Date;
- (vii) the aggregate amount of Contributions, if any, made to the Issuer for such Payment Date; and
- (viii) such other information as the Trustee, any Hedge Counterparty or the Investment Manager may reasonably request.

Each Distribution Report shall constitute instructions to the Trustee to withdraw funds from the Payment Account and pay or transfer such amounts set forth in Distribution Report in the manner specified and in accordance with the priorities established in <u>Section 11.1</u> and Article XIII.

On each Distribution Date for so long as any Subordinated Securities are listed on the Irish Stock Exchange, the Trustee shall notify the Irish Stock Exchange of the Aggregate Outstanding Amount of each Class of Subordinated Securities.

- (c) <u>Interest Rate Notice</u>. The Trustee shall make available to each Holder of Secured Notes, as soon as reasonably practicable but in any case no later than the sixth Business Day after each Payment Date, a notice setting forth the Interest Rate for such Notes for the Interest Accrual Period preceding the next Payment Date. The Trustee shall also make available to the Issuer and each Holder of Secured Notes, as soon as reasonably practicable but in any case no later than the sixth Business Day after each Interest Determination Date, a notice setting forth <u>LIBORthe Reference Rate</u> for the Interest Accrual Period (or, for the first Interest Accrual Period, the related portion thereof) following such Interest Determination Date.
- (d) Failure to Provide Accounting. If the Trustee shall not have received any accounting provided for in this Section 10.6 on the first Business Day after the date on which such accounting is due to the Trustee, the Issuer shall use all reasonable efforts to cause such accounting to be made by the applicable Payment Date. To the extent the Issuer is required to provide any information or reports pursuant to this Section 10.6 as a result of the failure to provide such information or reports, the Issuer (with the assistance of the Investment Manager) shall be entitled to retain an Independent certified public accountant in connection therewith.
- (e) <u>Required Content of Certain Reports</u>. Each Monthly Report and each Distribution Report sent to any Holder or beneficial owner of an interest in a Note shall contain, or be accompanied by, the following notices:

The Securities may be beneficially owned only by Persons that (a)(i) are not U.S. persons (within the meaning of Regulation S under the United States Securities Act of 1933, as amended) and are purchasing their beneficial interest in an offshore transaction or (ii) are either (A)(1) qualified institutional buyers ("Qualified Institutional Buyers") within the meaning of Rule 144A and (2) qualified purchasers (as defined in Section 2(a)(51) of the Investment Company Act) ("Qualified Purchasers"), (B) in the case of Secured Notes, institutional accredited investors meeting the requirements of Rule 501(a)(1), (2), (3) or (7)

under the Securities Act ("<u>IAIs</u>") that are also Qualified Purchasers and (C) in the case Subordinated Securities, (1) Accredited Investors who are also either Qualified Purchasers Knowledgeable Employees and (b) can make the representations set forth in <u>Section 2.6</u> or the appropriate Exhibit to this Indenture. Beneficial ownership interests in the Rule 144A Global Securities may be transferred only to a Person that is both a Qualified Institutional Buyer and a Qualified Purchaser and that can make the representations referred to in clause (b) of the preceding sentence. The Issuer has the right to compel any beneficial owner of an interest in Rule 144A Global Securities that does not meet the qualifications set forth in such clauses to sell its interest in such Securities, or may sell such interest on behalf of such owner, pursuant to <u>Section 2.12</u>.

Each Holder or beneficial owner of a Note receiving this report agrees to keep all non-public information herein confidential and not to use such information for any purpose other than its evaluation of its investment in the Note; <u>provided</u>, that any such Holder or beneficial owner may provide such information on a confidential basis to any prospective purchaser of such Holder's or beneficial owner's Securities that is permitted by the terms of this Indenture to acquire such Holder's or beneficial owner's Securities and that agrees to keep such information confidential in accordance with the terms of this Indenture.

- (f) <u>Initial Purchaser Information</u>. The Issuer and the Initial Purchaser, or any successor to the Initial Purchaser, may post the information contained in a Monthly Report or Distribution Report to a password-protected internet site accessible only to the Holders of the Securities, the Trustee and the Investment Manager.
- Availability of Reports. The Monthly Reports and Distribution Reports shall be made available to the Persons entitled to such reports via the Trustee's website. The Trustee's website shall initially be located at http://www.usbank.com/cdo. Persons who are unable to use the above distribution option are entitled to have a paper copy mailed to them via first class mail by calling the Trustee's customer service desk. The Trustee shall have the right to change the method such reports are distributed in order to make such distribution more convenient and/or more accessible to the Persons entitled to such reports, and the Trustee shall provide timely notification (in any event, not less than 30 days) to all such Persons. As a condition to access to the Trustee's internet website, the Trustee may require registration and the acceptance of a disclaimer. The Trustee shall not be liable for the information it is directed or required to disseminate in accordance with this Indenture. The Trustee shall be entitled to rely on but shall not be responsible for the content or accuracy of any information provided in the information set forth in the Monthly Report and the Distribution Report and may affix thereto any disclaimer it deems appropriate in its reasonable discretion. Upon written request of any Holder, the Trustee shall also provide such Holder copies of reports produced pursuant to this Indenture and the Investment Management Agreement. For the avoidance of doubt, the Initial Purchaser shall be entitled to receive or have access to the Monthly Reports and Distribution Reports. Upon receipt thereof, the Trustee shall supply to Intex Solutions, Inc., Bloomberg L.P. and the Information Agent the Distribution Report and the Monthly Report and shall permit Intex Solutions, Inc. and Bloomberg L.P. to access such reports and other data files posted on the Trustee's website. The Issuer consents to such reports and other data files being made available

by Intex to its subscribers provided that Intex takes reasonable measures to ensure that such reports and files are accessed only by users who meet the securities law qualifications for holding Notes.

(h) <u>Irish Stock Exchange</u>. So long as any Class of Securities is listed on the Irish Stock Exchange, the Trustee shall inform the Irish Stock Exchange, if the ratings assigned to such Secured Securities are reduced or withdrawn.

## Section 10.7 Release of Collateral Obligations. (a)

- (a) The Investment Manager may, by Issuer Order delivered to the Trustee no later than the settlement date of any sale of a Pledged Obligation (or, in the case of physical settlement, no later than the Business Day preceding such date), certifying with respect to settlements after the Effective Date that the applicable conditions set forth in <a href="Article XII">Article XII</a> have been met, direct the Trustee to deliver such Pledged Obligation against receipt of payment therefor.
- (b) (b) The Investment Manager may, by Issuer Order delivered to the Trustee no later than the settlement date of any redemption or payment in full of a Pledged Obligation (or, in the case of physical settlement, no later than the Business Day preceding such date) certifying that such Pledged Obligation is being redeemed or paid in full, direct the Trustee to instruct the Intermediary to deliver such Pledged Obligation, if in physical form, duly endorsed, or, if such Pledged Obligation is a Clearing Corporation Security, to cause it to be presented (or in the case of a general intangible or a participation, cause such actions as are necessary to transfer such Pledged Obligation to the designated transferee free of liens, claims or encumbrances created by this Indenture), to the appropriate paying agent therefor on or before the date set for redemption or payment, in each case against receipt of the redemption price or payment in full thereof.
- Subject to Article XII hereof, the Investment Manager may, by Issuer Order delivered to the Trustee no later than the settlement date of an exchange, tender or sale (or, in the case of physical settlement, no later than the Business Day preceding such date), certifying that a Pledged Obligation is subject to an Offer and setting forth in reasonable detail the procedure for response to such Offer, direct the Trustee or, at the Trustee's instructions, the Intermediary, to deliver such Pledged Obligation, if in physical form, duly endorsed, or, if such Pledged Obligation is a Clearing Corporation Security, to cause it to be delivered, in accordance with such Issuer Order, in each case against receipt of payment therefor.
- (d) (d)—The Trustee shall deposit any proceeds received by it from the disposition of a Pledged Obligation in the Collection Account, unless such proceeds are simultaneously applied to the purchase of Collateral Obligations or Eligible Investments.
- (e) The Trustee shall upon receipt of an Issuer Order at such time as there are no Notes Outstanding, and all obligations of the Issuer hereunder have been satisfied, release the Collateral.

- (f) The Trustee shall, upon receipt of an Issuer Order, release any Unsaleable Assets sold, distributed or disposed of pursuant to Section 12.1(i).
- (g) (g)—The Trustee shall, upon receipt of an Issuer Order, release from the lien of this Indenture any Equity Security or Collateral Obligation at the time it is transferred to a Tax Subsidiary and deliver it to such Tax Subsidiary.
- (h)—Following delivery of any Pledged Obligation pursuant to clauses (a) through (c), (e) through (g), such Pledged Obligation shall be released from the lien of this Indenture without further action by the Trustee or the Issuer.
- (i) Satisfaction of the requirements under <u>Section 12.3</u> will be deemed to constitute delivery of an Issuer Order for purposes of this <u>Section 10.7</u>.

### Section 10.8 Reports by Independent Accountants.

- (a) Prior to the delivery of any reports or certificates of accountants required to be prepared to be pursuant to the terms hereof, the Issuer shall appoint one or more firms of Independent certified public accountants of recognized international reputation for purposes of reviewing and delivering the reports or certificates of such accountants required by this Indenture, which may be the firm of Independent certified public accountants that performs accounting services for the Issuer or the Investment Manager. The Issuer may remove any firm of Independent certified public accountants at any time without the consent of any Holder of Securities. The fees of such Independent certified public accountants and its successor shall be payable by the Issuer as an Administrative Expense.
- Neither the Trustee nor the Collateral Administrator shall have any responsibility to make any inquiry or investigation as to, and shall have no obligation in respect of, the terms of any engagement of Independent accountants by the Issuer (or the Investment Manager on behalf of the Issuer) or the terms of any agreed upon procedures in respect of such engagement; provided, however, that the Trustee shall be authorized, upon receipt of an Issuer Order directing the same and is hereby directed, to execute an access letter or any acknowledgement or other agreement with the Independent accountants required for the Trustee to receive any of the reports or instructions provided for herein, which acknowledgement or agreement may include, among other things, (i) acknowledgement that the Issuer has agreed that the procedures to be performed by the Independent accountants are sufficient for the Issuer's purposes, (ii) releases by the Trustee (on behalf of itself and the Holders) of claims against the Independent accountants and acknowledgement of other limitations of liability in favor of the Independent accountants, and (iii) restrictions or prohibitions on the disclosure of information or documents provided to it by such firm of Independent accountants (including to the Holders). Notwithstanding the foregoing, in no event shall the Trustee be required to execute any agreement in respect of the Independent accountants that the Trustee reasonably determines adversely affects it.
- (c) Upon the written request of the Trustee, or any Holder of Subordinated Securities, the Issuer shall cause the firm of Independent certified public accountants appointed

pursuant to <u>Section 10.8(a)</u> to provide any Holder of Securities with all of the information required to be provided by the Issuer or pursuant to <u>Section 7.16</u> or assist the Issuer in the preparation thereof.

Section 10.9 Reports to Rating Agencies. In addition to the information and reports specifically required to be provided to each Rating Agency pursuant to the terms of this Indenture, the Issuer shall provide to each Rating Agency all information or reports delivered to the Trustee hereunder (excluding any Accountants' Certificate), and such additional information as any Rating Agency may from time to time reasonably request (including, with respect to credit estimates, notification to Moody's and S&Peach Rating Agency of any material modification that would result in substantial changes to the terms of any loan document relating to a Collateral Obligation or any release of collateral thereunder not permitted by such loan documentation) and notification to S&P of any Specified Event or Specified Amendment (such notice shall include a brief description of such Specified Event or a copy of such Specified Amendment, as applicable). The Issuer shall notify Moody's Fitch and S&P of any termination, modification or amendment to the Investment Management Agreement, the Collateral Administration Agreement, the Account Agreement or any other agreement to which it is party in connection with any such agreement or this Indenture and shall notify S&P and Moody's each Rating Agency of any material breach by any party to any such agreement of which it has actual knowledge. Prior to the Effective Date and together with each Monthly Report, the Issuer shall provide to S&P the S&P Excel Default **Model Input File.** 

Section 10.10 Procedures Relating to the Establishment of Accounts Controlled by the Trustee. Notwithstanding anything else contained herein, the Trustee is hereby directed, with respect to each of the Accounts, to enter into an Account Agreement. The Trustee shall have the right to open such subaccounts of any such account as it deems necessary or appropriate for convenience of administration.

#### **ARTICLE XI**

#### APPLICATION OF MONIES

### Section 11.1 <u>Disbursements of Monies from Payment Account.</u>

- (a) Notwithstanding any other provision in this Indenture, but subject to the other subsections of this <u>Section 11.1</u>, on each Payment Date, the Trustee shall disburse amounts transferred, if any, from the Collection Account to the Payment Account pursuant to <u>Section 10.2</u> in accordance with the priorities described below, the Priority of Interest Proceeds, the Priority of Principal Proceeds, the Special Priority of Proceeds and the Priority of Partial Redemption Proceeds (together: the "<u>Priority of Payments</u>").
  - (i) On each Payment Date (other than a Post-Acceleration Payment Date, a Redemption Date or the Stated Maturity), Interest Proceeds with respect to the related Collection Period will be applied in the following order of priority (the "Priority of Interest Proceeds":
    - (A) (1) *first*, to the payment of taxes, governmental fees and registered office fees owing by the Issuer or the Co-Issuer, if any, and (2) *second*, to the payment of the accrued and unpaid Administrative Expenses (in the order set forth in the definition of such term); <u>provided</u>, that amounts paid or deposited pursuant to clause (2) and any Administrative Expenses paid from the Expense Reserve Account or from the Collection Account pursuant to this Indenture on or between Payment Dates, collectively, may not exceed, in the aggregate, the Administrative Expense Cap;
    - (B) to pay to the Investment Manager (i) the accrued and unpaid Senior Investment Management Fee, *plus* (ii) an amount in respect of unpaid Deferred Senior Fees equal to the lesser of (1) the amount of unpaid Deferred Senior Fees elected by the Investment Manager to be paid on such Payment Date and (2) the excess of (x) the amount of Interest Proceeds available for distribution pursuant to this clause (B) on such Payment Date less (y) the amounts payable pursuant to clause B(i) and clause (C) below *plus* the current interest payments on the Class A-1 Notes and the Class A-2 Notes, or if no Class A-1 Notes or Class A-2 Notes are Outstanding, the Controlling Class;
    - (C) to the payment on a *pro rata* basis of the following amounts based on the respective amounts due on such Payment Date: (1) any amounts due to a Hedge Counterparty under a Hedge Agreement other than amounts due as a result of the termination (or partial termination) of such Hedge Agreement; and (2) any amounts due to a Hedge Counterparty under a Hedge Agreement pursuant to an early termination (or partial termination) of such Hedge Agreement as a result of a Priority Hedge Termination Event;

- (D) to the payment of accrued and unpaid interest on the Class A-1 Notes (including any defaulted interest);
- (E) to the payment of accrued and unpaid interest (including any defaulted interest) on the Class A-2a Notes and the Class A2-b Notes, allocated in proportion to the amount of accrued and unpaid interest (including any defaulted interest) on each such Class;
- (F) if either of the Class A Coverage Tests is not satisfied on the related Determination Date, to make payments in accordance with the Note Payment Sequence to the extent necessary to cause both Class A Coverage Tests to be met as of the related Determination Date on a pro forma basis after giving effect to any payments made through this clause (F);
- (G) to the payment of accrued and unpaid interest (other than any Deferred Interest) on the Class B Notes;
- (H) if either of the Class B Coverage Tests is not satisfied on the related Determination Date, to make payments in accordance with the Note Payment Sequence to the extent necessary to cause both Class B Coverage Tests to be met as of the related Determination Date on a pro forma basis after giving effect to any payments made through this clause (H);
  - (I) to the payment of any Deferred Interest on the Class B Notes;
- (J) to the payment of accrued and unpaid interest (other than any Deferred Interest) on the Class C Notes;
- (K) if either of the Class C Coverage Tests is not satisfied on the related Determination Date, to make payments in accordance with the Note Payment Sequence to the extent necessary to cause both Class C Coverage Tests to be met as of the related Determination Date on a pro forma basis after giving effect to any payments made through this clause (K);
  - (L) to the payment of any Deferred Interest on the Class C Notes;
- (M) to the payment of accrued and unpaid interest (other than any Deferred Interest) on the Class D Notes;
- (N) if either of the Class D Coverage Tests is not satisfied on the related Determination Date, to make payments in accordance with the Note Payment Sequence to the extent necessary to cause both Class D Coverage Tests to be met as of the related Determination Date on a pro forma basis after giving effect to any payments made through this clause (N);
  - (O) to the payment of any Deferred Interest on the Class D Notes;

- (P) to the payment of accrued and unpaid interest (other than any Deferred Interest) on the Class E Notes;
- (Q) if the Class E Coverage Test is not satisfied on the related Determination Date, to make payments in accordance with the Note Payment Sequence to the extent necessary to cause the Class E Coverage Test to be met as of the related Determination Date on a pro forma basis after giving effect to any payments made through this clause (Q);
  - (R) to the payment of any Deferred Interest on the Class E Notes;
- (S) if Effective Date Ratings Confirmation has not been obtained, to the payment of the Rating Confirmation Redemption Amount (without duplication of any payments received by any Class of Secured Notes under clauses (D) through (R) above or under clause (A) of the Priority of Principal Proceeds, in accordance with the Note Payment Sequence;
- (T) during the Reinvestment Period only, if the Interest Diversion Test is not satisfied on the related Determination Date, the lesser of (x) 50% of the Interest Proceeds then available and (y) the amount required to cause such test to be satisfied shall be applied to the purchase of additional Collateral Obligations or for deposit into the Collection Account as Principal Proceeds for investment in Eligible Investments pending the purchase of additional Collateral Obligations at a later date;
- (U) to the payment of any accrued and unpaid Subordinated Investment Management Fee to the Investment Manager, except to the extent that the Investment Manager elects to treat such current Subordinated Investment Management Fee as Deferred Subordinated Fees, plus any unpaid Deferred Subordinated Fee that has been deferred with respect to prior Payment Dates which the Investment Manager elects to have paid on such Payment Date;
- (V) to the payment of (1) first, any Administrative Expenses not paid pursuant to clause (A)(2) above due to the limitations contained therein (in the priority stated in clause (A)(2) above), (2) second, pro rata based on amounts due, any amounts due to any Hedge Counterparty under any Hedge Agreement not otherwise paid pursuant to clause (C) above;
- (W) to the Holders of the Subordinated Securities in accordance with the Subordinated Securities Allocation in an amount necessary to achieve the Target Return;
- (X) to the Investment Manager to pay the Investment Manager Incentive Fee Amount in an amount equal to 20% of all Interest Proceeds remaining after application pursuant to clauses (A) through (W) above on such Payment Date; and

- (Y) any remaining Interest Proceeds will be paid to the Holders of the Subordinated Securities in accordance with the Subordinated Securities Allocation.
- (ii) On each Payment Date (other than a Post-Acceleration Payment Date, Redemption Date or the Stated Maturity), Principal Proceeds (other than Principal Proceeds which have previously been reinvested in Collateral Obligations or which the Investment Manager has committed to invest or intends to invest in Collateral Obligations during the next Collection Period) on deposit in the Collection Account that are received on or before the related Determination Date and that are transferred to the Payment Account shall be applied in the following order of priority (the "Priority of Principal Proceeds"):
  - (A) in accordance with clauses (A) through (R) of the Priority of Interest Proceeds, in each case (a) solely to the extent not paid in full thereunder, and (b) subject to any applicable cap set forth therein, <u>provided</u>, that (1) payments under clauses (G) and (I) will be made only to the extent that the Class B Notes are the Controlling Class, (2) payments under clauses (J) and (L) will be made only to the extent that the Class C Notes are the Controlling Class, (3) payments under clauses (M) and (O) will be made only to the extent that the Class D Notes are the Controlling Class and (4) payments under clauses (P) and (R) will be made only to the extent that the Class E Notes are the Controlling Class;
  - (B) If such Payment Date is a Special Redemption Date, the Special Redemption Amount in accordance with the Note Payment Sequence;
  - (C) at the sole discretion of the Investment Manager, (1) during the Reinvestment Period, to the Collection Account as Principal Proceeds to invest in Eligible Investments and/or to the purchase of additional Collateral Obligations or (2) after the Reinvestment Period, so long as no Event of Default has occurred and is continuing, Principal Proceeds received with respect to Credit Risk Obligations and Unscheduled Principal Payments to the Collection Account as Principal Proceeds to invest in Eligible Investments and/or to the purchase of additional Collateral Obligations;
  - (D) after the Reinvestment Period, to make payments in accordance with the Note Payment Sequence after taking into account payments made pursuant to the Priority of Interest Proceeds and clauses (A) and (B) above;
  - (E) after the Reinvestment Period, to the payment of the Administrative Expenses, in the order of priority set forth in clause (A) of the Priority of Interest Proceeds (without regard to the Administrative Expense Cap), but only to the extent not previously paid in full under clauses (A) and (V) thereof and under clause (A) above;

- (F) after the Reinvestment Period, to the payment on a *pro rata* basis based on amounts due, of any amounts due to any Hedge Counterparty under any Hedge Agreement not previously paid in full under clauses (C) and (V) of the Priority of Interest Proceeds and under clause (A) above;
- (G) after the Reinvestment Period, to the payment of the Deferred Senior Fee, in the order of priority set forth in clause (B) of the Priority of Interest Proceeds, but only to the extent not previously paid in full under such clause (B) and under clause (A) above;
- (H) after the Reinvestment Period, to the payment of the accrued and unpaid Subordinated Investment Management Fee to the Investment Manager (less any portion thereof waived or deferred at the election of the Investment Manager pursuant to the Investment Management Agreement) *plus* any unpaid Deferred Subordinated Fee that has been deferred with respect to prior Payment Dates which the Investment Manager elects to have paid on such Payment Date to the extent not previously paid in full under clause (U) of the Priority of Interest Proceeds;
- (I) after giving effect to clause (W) of the Priority of Interest Proceeds, to the holders of the Subordinated Securities in accordance with the Subordinated Securities Allocation in an amount necessary to achieve the Target Return;
- (J) to the Investment Manager to pay the Investment Manager Incentive Fee Amount in an amount equal to 20% of all Principal Proceeds remaining after application pursuant to clauses (A) through (I) above on such Payment Date; and
- (K) any remaining Principal Proceeds will be paid to the Holders of the Subordinated Securities in accordance with the Subordinated Securities Allocation.
- (iii) On each Post-Acceleration Payment Date, Redemption Date (other than a Partial Redemption Date) or on the Stated Maturity, all Interest Proceeds and Principal Proceeds (except for any Principal Proceeds that shall be used to settle binding commitments (entered into prior to the Determination Date) for the purchase of Collateral Obligations) in the following order of priority (the "Special Priority of Proceeds"):
  - (A) to pay all amounts under clauses (A) through (C)(1) of the Priority of Interest Proceeds in the priority and subject to the limitations stated therein;
  - (B) to the payment of any amounts due to a Hedge Counterparty under any Hedge Agreement pursuant to an early termination (or partial termination) of such Hedge Agreement as a result of a Priority Hedge Termination Event;

- (C) to the payment of accrued and unpaid interest on the Class A-1 Notes (including any defaulted interest), until such amounts have been paid in full:
- (D) to the payment of principal on the Class A-1 Notes until such amount has been paid in full;
- (E) to the payment of accrued and unpaid interest (including any defaulted interest) on the Class A-2a Notes and the Class A-2b Notes, allocated in proportion to the amount of accrued and unpaid interest (including any defaulted interest) on each such Class, until such amounts have been paid in full;
- (F) to the payment of principal on the Class A-2 Notes (*pro rata*) until such amount has been paid in full;
- (G) to the payment of, first, accrued and unpaid interest and then any Deferred Interest on the Class B Notes until such amounts have been paid in full;
- (H) to the payment of principal of the Class B Notes until such amount has been paid in full;
- (I) to the payment of, first, accrued and unpaid interest and then any Deferred Interest on the Class C Notes until such amounts have been paid in full;
- (J) to the payment of principal of the Class C Notes until such amount has been paid in full;
- (K) to the payment of, first, accrued and unpaid interest and then any Deferred Interest on the Class D Notes until such amounts have been paid in full;
- (L) to the payment of principal of the Class D Notes until such amount has been paid in full;
- (M) to the payment of, first, accrued and unpaid interest and then any Deferred Interest on the Class E Notes until such amounts have been paid in full;
- (N) to the payment of principal of the Class E Notes until such amount has been paid in full;
- (O) to the payment of (1) *first*, any Administrative Expenses not paid pursuant to clause (A) above due to the Administrative Expense Cap (in the priority stated therein), (2) *second*, any Deferred Senior Fees not otherwise paid pursuant to clause (A) above, and (3) *third*, *pro rata* based on amounts due, any amounts due to any Hedge Counterparty under any Hedge Agreement pursuant to an early termination (or partial termination) of such Hedge Agreement not otherwise paid pursuant to clause (B) above;

- (P) to the payment of the accrued and unpaid Subordinated Investment Management Fee to the Investment Manager (less any portion thereof waived or deferred at the election of the Investment Manager pursuant to the Investment Management Agreement) *plus* any unpaid Deferred Subordinated Fee that has been deferred with respect to prior Payment Dates which the Investment Manager elects to have paid on such Payment Date;
- (Q) to the Holders of the Subordinated Securities in accordance with the Subordinated Securities Allocation in an amount necessary to achieve the Target Return;
- (R) to the Investment Manager to pay the Investment Manager Incentive Fee Amount in an amount equal to 20% of all Interest Proceeds and Principal Proceeds remaining after application pursuant to clauses (A) through (Q) above on such Payment Date; and
- (S) any remaining Interest Proceeds and Principal Proceeds to the Holders of the Subordinated Securities in accordance with the Subordinated Securities Allocation.
- (iv) On any Partial Redemption Date, Refinancing Proceeds and Partial Redemption Interest Proceeds will be distributed in the following order of priority (the "Priority of Partial Redemption Proceeds"):
  - (A) to pay the Redemption Price, in accordance with the Note Payment Sequence, of each Class of Secured Notes being refinanced, without duplication of any payments received by any such Class pursuant to the Priority of Interest Proceeds or the Special Priority of Proceeds; and
  - (B) any remaining proceeds from the Refinancing will be deposited in the Collection Account as Principal Proceeds.
- (b) On the Stated Maturity of the Notes, and after payment of all amounts specified in Special Priority of Proceeds, the Trustee shall pay the net proceeds from the liquidation of the Assets and all available Cash, after the payment of (or establishment of a reserve for) any remaining fees, expenses, including the Trustee's fees and other Administrative Expenses, and interest and principal on the Secured Notes, to the Holders of the Subordinated Securities in final payment of such Subordinated Securities.
- (c) If on any Payment Date the amount available in the Payment Account is insufficient to make the full amount of the disbursements required by the Distribution Report, the Trustee shall make the disbursements called for in the order and according to the priority set forth under the Priority of Payments to the extent funds are available therefor.
- (d) In connection with the application of funds to pay Administrative Expenses, in accordance with Priority of Payments, the Trustee shall remit such funds, to the extent available, as directed and designated in an Issuer Order (which may be in the form of

standing instructions) delivered to the Trustee no later than the Business Day prior to each Payment Date.

- (e) In the event that the Hedge Counterparty defaults in the payment of its obligations to the Issuer under any Hedge Agreement on the date on which any payment is due thereunder, the Trustee shall make a demand on such Hedge Counterparty, or any guarantor, if applicable, demanding payment by 12:30 p.m., New York time, on such date. The Trustee shall give notice as soon as reasonably practicable to the Holders, the Investment Manager and each Rating Agency if such Hedge Counterparty continues to fail to perform its obligations for two Business Days following a demand made by the Trustee on such Hedge Counterparty, and shall take such action with respect to such continuing failure as may be directed to be taken pursuant to Section 5.13.
- Investment Manager may waive or defer all or a portion of the Senior Investment Management Fee, the Subordinated Investment Management Fee and/or the Investment Manager Incentive Fee Amount on any Payment Date by providing notice to the Trustee and the Issuer of such election on or before the Determination Date preceding such Payment Date. On any Payment Date on which the Investment Manager has elected to defer all or a portion of the Senior Investment Management Fee or the Subordinated Investment Management Fee or such fee was not paid because funds were not available in accordance with the Priority of Payments, such Deferred Management Fee will be added to the cumulative amount of Deferred Management Fees. On any subsequent Payment Date on which funds are available for such purpose under the Priority of Payments, the Investment Manager may elect to receive all or a portion of the Deferred Management Fee that has otherwise not been paid to the Investment Manager by providing notice to the Issuer and the Trustee of such election on or before the related Determination Date, which notice shall specify the amount of such Deferred Management Fee that the Investment Manager elects to receive. Deferred Management Fees will not accrue interest.

Section 11.2 Expense Disbursements on Dates other than Distribution Dates. Provided that no Event of Default has occurred and is continuing, the Investment Manager, on behalf of the Issuer, may direct the Trustee to disburse Interest Proceeds in the Collection Account or the Expense Reserve Account, from time to time on dates other than Distribution Dates for payment of the items described in Section 11.1(a)(i) and (ii) (subject to the Administrative Expense Cap).

Section 11.3 Contributions. At any time during or after the Reinvestment Period, any Holder of Subordinated Securities (a "Contributing Holder") issued in the form of a Certificated Security may (i) direct the Issuer to transfer any portion of Interest Proceeds that would otherwise be distributed on its Subordinated Securities to the Principal Collection Account or (ii) make a cash contribution to the Issuer (each, a "Contribution"), provided that no such individual Contribution may be in an amount less than \$1,000,000. Such Contribution will be applied to a Permitted Use by the Investment Manager on behalf of the Issuer as directed by the Contributing Holder at the time such Contribution is made (and which direction may not subsequently be amended). No Contribution or portion thereof will be returned to the Contributing Holder at any time.

#### **ARTICLE XII**

# SALE OF COLLATERAL OBLIGATIONS; PURCHASE OF ADDITIONAL COLLATERAL OBLIGATIONS

Section 12.1 <u>Sales of Collateral Obligations</u>. Subject to the satisfaction of the conditions specified in <u>Section 12.3</u> and provided that no Event of Default has occurred and is continuing (except for sales pursuant to <u>Sections 12.1(a)</u>, (c), (d) and (i), unless liquidation of the Assets has begun or the Trustee has <u>exercised any</u>commenced exercising certain remedies of a <u>Secured Party</u> pursuant to <u>Section 5.4(a)(iv)</u> at the direction of the Controlling Class), the Investment Manager on behalf of the Issuer may in writing direct the Trustee to sell and the Trustee (on behalf of the Issuer) shall sell in the manner directed by the Investment Manager any Collateral Obligation or Equity Security if, as certified by the Issuer, such sale meets the requirements of any of the clauses below, subject in all cases, to the Operating Guidelines. For purposes of this <u>Section 12.1</u>, the Sale Proceeds of a Collateral Obligation sold by the Issuer shall include any Principal Financed Accrued Interest received in respect of such sale.

- (a) <u>Credit Risk Obligations</u>. The Investment Manager may direct the Trustee to sell any Credit Risk Obligation at any time during or after the Reinvestment Period without restriction.
- (b) <u>Credit Improved Obligations</u>. The Investment Manager may direct the Trustee to sell any Credit Improved Obligation at any time during or after the Reinvestment Period without restriction.
- (c) <u>Defaulted Obligations</u>. The Investment Manager may direct the Trustee to sell any Defaulted Obligation at any time during or after the Reinvestment Period without restriction.
- (d) <u>Equity Securities</u>. The Investment Manager may direct the Trustee to sell any Equity Security, including any Equity Security held by a Tax Subsidiary, at any time during or after the Reinvestment Period without restriction; <u>provided</u>, that the Investment Manager shall use commercially reasonable efforts to dispose of any Equity Security, regardless of sale price, within three years of receipt of such Equity Security by the Issuer. In addition, pursuant to the

Investment Management Agreement, the Issuer (and the Investment Manager on behalf of the Issuer) is prohibited from acquiring (through conversion or otherwise) certain Equity Securities that would cause the Issuer to be subject to U.S. federal income tax. As a result of such prohibition, the Investment Manager (on behalf of the Issuer) may be required to dispose of certain Defaulted Obligations prior to the conversion of such Defaulted Obligations into Equity Securities.

- (e) Redemption by Liquidation. After the Issuer has notified the Trustee of a Redemption by Liquidation or Clean-Up Call Redemption, the Investment Manager shall direct the Trustee to sell (which sale may be through participation or other arrangement) all or a portion of the Collateral Obligations if the requirements of Article IX (including the certification requirements of Section 9.2(c)) are satisfied. If any such sale is made through participation, the Issuer shall use reasonable efforts to cause such participations to be converted to assignments within six months of the Any sale of an Asset in connection with a Redemption by Liquidation will be on arms' length terms and, in the case of a sale of any Asset to the Investment Manager, its Affiliates or any account managed by the Investment Manager or its Affiliate, at a price not less than the Market Value of such Asset as of the date that the Issuer commits to such sale.
- (f) <u>Discretionary Sales</u>. The Investment Manager may direct the Trustee to sell any Collateral Obligation (a "Discretionary Sale") at any time-other than during a Restricted Trading Period if, after giving effect to such Discretionary Sale, the Aggregate Principal Balance of all Collateral Obligations sold in Discretionary Sales during the preceding period of twelve calendar months (or, for the first twelve calendar months after the Closing Date, during the period commencing on the Closing Date) is not greater than 2025% of the Collateral Principal Amount as of the beginning of such twelve calendar month period (or as of the Closing Date, as the case may be); provided that, for purposes of determining the percentage of Collateral Obligations sold during any such period, the Aggregate Principal Balance of any Collateral Obligations sold shall be reduced to the extent of any purchases of Collateral Obligations of the same obligor (which are pari passu or senior to such sold Collateral Obligations) occurring within 45 Business Days of such sale (determined based upon the date of any relevant trade confirmation or commitment letter) so long as any such sale of a Collateral Obligation was entered into with the intention of purchasing such Collateral Obligation of the same obligor (which would be pari passu or senior to such sold Collateral Obligation).
- (g) <u>Mandatory Sales</u>. The Investment Manager shall use commercially reasonable efforts to sell each Equity Security, Collateral Obligation and any other security held by the Issuer that constitutes Margin Stock not later than 45 days after the later of (x) the date of the Issuer's acquisition thereof and (y) the date such Equity Security, Collateral Obligation or other security held by the Issuer became Margin Stock.
- (h) <u>End-of-Life Sales</u>. Notwithstanding the restrictions of clauses (a) through (f) above, if the Aggregate Principal Balance of the Collateral Obligations is less than \$10,000,000, the Investment Manager may direct the Trustee, at the expense of the Issuer, to sell (and the Trustee shall sell in the manner specified) the Collateral Obligations without regard to such restrictions.

- (i) <u>Unsaleable Assets</u>. After the Reinvestment Period (without regard to whether an Event of Default has occurred):
  - (i) Notwithstanding the restrictions of clauses (a) through (f) above, at the direction of the Investment Manager, the Trustee, at the expense of the Issuer, shall conduct an auction of Unsaleable Assets in accordance with the procedures described in clause (ii).
  - (ii) Promptly after receipt of such direction, the Trustee shall provide notice (in such form as is prepared by the Investment Manager) to the Holders and each Rating Agency of an auction, setting forth in reasonable detail a description of each Unsaleable Asset and the following auction procedures:
    - (A) Any Holder may submit a written bid to purchase one or more Unsaleable Assets no later than the date specified in the auction notice (which shall be at least 15 Business Days after the date of such notice).
    - (B) Each bid must include an offer to purchase for a specified amount of cash on a proposed settlement date no later than 20 Business Days after the date of the auction notice.
    - (C) If no Holder submits such a bid, unless delivery in kind is not legally or commercially practicable and subject to any transfer restrictions (including minimum denominations), the Trustee shall provide notice thereof to each Holder and offer to deliver (at no cost) a *pro rata* portion of each unsold Unsaleable Asset to the Holders of the Highest Ranking Class that provide delivery instructions to the Trustee on or before the date specified in such notice. To the extent that minimum denominations do not permit a *pro rata* distribution, the Trustee shall distribute the Unsaleable Assets on a *pro rata* basis to the extent possible and the Trustee shall select by lottery the Holder to whom the remaining amount will be delivered. The Trustee shall use commercially reasonable efforts to effect delivery of such interests.
    - (D) If no such Holder provides delivery instructions to the Trustee, the Trustee shall promptly notify the Investment Manager and offer to deliver (at no cost) the Unsaleable Asset to the Investment Manager. If the Investment Manager declines such offer, the Investment Manager (on behalf of the Issuer) shall direct action to dispose of the Unsaleable Asset, which may be by donation to a charity, abandonment or other means, and the Trustee shall take such action as so directed.
- (j) Notwithstanding anything contained herein to the contrary, pursuant to Section 7.16(k) hereof, the Issuer may cause any Tax Subsidiary Asset or the Issuer's interest therein to be transferred to a Tax Subsidiary in exchange for an interest in such Tax Subsidiary.
- (k) Volcker Rule Sales. Notwithstanding anything contained herein, the Investment Manager may at any time direct the Trustee to sell any Pledged Obligation that is not a Senior Secured Loan and the ownership of which the Investment Manager reasonably

determines is inconsistent with the Issuer's status as a "loan securitization" under the Volcker Rule. Any supplemental indenture executed to permit compliance with the Volcker Rule may not result in the forced sale of any Senior Secured Loans.

- (1) Bankruptcy Exchange. The Investment Manager may direct the Trustee at any time without restriction to consummate a Bankruptcy Exchange or sell any asset that is an exchanged obligation or received obligation acquired in connection with a Bankruptcy Exchange.
- (m) Notwithstanding anything contained in this Article XII to the contrary but subject to the Operating Guidelines and Section 7.8(c), the Issuer shall have the right to effect the sale of any Asset or purchase of any Collateral Obligation (x) that has been separately consented to by Holders evidencing at least 75% of the Aggregate Outstanding Amount of each Class, (y) in the case of a purchase, that satisfies the definition of Collateral Obligation as of the date of the commitment to purchase and (z) of which each Rating Agency and the Trustee has been notified.
- (n) Stated Maturity. Notwithstanding the restrictions of the preceding clauses of this Section 12.1, the Investment Manager will, no later than the Determination Date for the Stated Maturity, on behalf of the Issuer, arrange for and direct the Trustee to sell (and the Trustee shall sell in the manner specified) any Collateral Obligations scheduled to mature after the Stated Maturity and cause the liquidation of all assets held at each Tax Subsidiary and distribution of any proceeds thereof to the Issuer.
- (o) Warrants. At any time during or after the Reinvestment Period, at the direction of the Investment Manager, the Issuer may direct the payment from amounts on deposit in the Interest Collection Account any amount required to exercise a warrant held in the Assets so long as any Equity Security to be received in connection with such exercise is disposed of prior to receipt by the Issuer.
- Section 12.2 <u>Purchase of Additional Collateral Obligations</u>. On any date during the Reinvestment Period or after the Reinvestment Period, so long as no Event of Default has occurred and is continuing and subject to <u>Section 12.2(b)</u>, the Investment Manager, on behalf of the Issuer, may, but shall not be required to, direct the Trustee to invest Principal Proceeds (and accrued interest received with respect to any Collateral Obligation to the extent used to pay for accrued interest on additional Collateral Obligations) in additional Collateral Obligations, and the Trustee shall invest such proceeds.
- Obligation Obligations may be purchased by the Issuer unless each of the following conditions is criteria are satisfied as of the date it Investment Manager commits on behalf of the Issuer to make such purchase or on the date of such purchase, in each case after giving effect to such purchase and all other sales or purchases previously or simultaneously committed to but which have not settled; provided that the conditions set forth in clauses (ii), (iii) and (iv) below need only be satisfied with respect to purchases of Collateral Obligations occurring after the Effective Date: (such criteria, the "Reinvestment Period Investment Criteria"):
  - (i) such obligation is a Collateral Obligation;

(ii) (A) each Coverage Test will be satisfied or, if not satisfied, such Coverage Test will be maintained or improved, and (B) if each Coverage Test is not satisfied, the Principal Proceeds received in respect of any Defaulted Obligation or the proceeds of any sale of a Defaulted Obligation will not be reinvested in additional Collateral Obligations;

(iii)

- (A) in the case of additional Collateral Obligations purchased with the proceeds from the saleSale Proceeds of a CollateralCredit Risk Obligation pursuant to Section 12.1(a) or Section 12.1(c) hereof, the Investment Manager shall use commercially reasonable efforts to ensure that after giving effect to such purchase or a Defaulted Obligation, either:
  - (1) the Aggregate Principal Balance of all additional Collateral Obligations purchased with the proceeds from such sale shall at least equal the Sale Proceeds from such sale;
  - (2) the Aggregate Principal Balance of the Collateral Obligations shall be maintained or increased (by comparison to the Aggregate Principal Balance of the Collateral Obligations immediately prior to such sale); or
  - (3) the Aggregate Principal Balance of the Collateral Obligations (excluding Collateral Obligations being sold but including, without duplication the Collateral Obligations being purchased and the anticipated cash proceeds, if any, of such sale that are not applied to the purchase of such additional Collateral Obligations) shall be greater than or equal to the Reinvestment Target Par Balance; or
  - (4) the Adjusted Collateral Principal Amount is maintained or increased; and
- (B) in the case of any other purchase of additional Collateral Obligations, the Investment Manager shall use commercially reasonable efforts to ensure that purchased with the Sale Proceeds of any other Collateral Obligation, after giving effect to such purchase, either:
  - (1) the Aggregate Principal Balance of the Collateral Obligations shall be maintained or increased (by comparison to the Aggregate Principal Balance of the Collateral Obligations immediately prior to any related sale); or
  - (2) the Aggregate Principal Balance of the Collateral Obligations (excluding Collateral Obligations being sold but including, without duplication the Collateral Obligations being purchased and the anticipated cash proceeds, if any, of such sale that are not applied to the

purchase of such additional Collateral Obligations) will be greater than <u>or equal to the Reinvestment Target Par Balance; or</u>

(3) the Adjusted Collateral Principal Amount is maintained or increased; and

## (iv) either:

- (A) each requirement or test, as the case may be, of the Concentration Limitations and the Collateral Quality Test (except, in the case of an additional Collateral Obligation purchased with the proceeds from the sale or other disposition of a Credit Risk Obligation or a Defaulted Obligation or an Equity Security, the S&P CDO Monitor Test) shall be satisfied or (B) if any such requirement or test was not satisfied immediately prior to such reinvestment, the level of compliance with such requirement or test shall be maintained or improved after giving effect to the reinvestment, provided that if an additional Collateral Obligation is purchased with the proceeds from the sale of a Credit Risk Obligation or a Defaulted Obligation, the S&P CDO Monitor Test will be excluded for purposes of any determination under this clause (iv); provided that the requirements with respect to the Collateral Quality Test in clause (iv)(A) above will not apply with respect to a Defaulted Obligation acquired in a Bankruptcy Exchange;
- (b) Investment after the Reinvestment Period. After the Reinvestment Period, Principal Proceeds received with respect to(x) the sale of Credit Risk Obligations and (y) Unscheduled Principal Payments may be reinvested in accordance with the requirements of this Indenture. After the Reinvestment Period, so long as no Event of Default has occurred and is continuing, the Investment Manager may, but will not be required to, invest up to 100% of the Principal Proceeds that were received with respect to Unscheduled Principal Payments and the sale of Credit Risk Obligations within the longer of (i) 3045 days of the Issuer's receipt thereof and (ii) the last day of the related Collection Period;

provided that the The Investment Manager may not reinvest such Principal Proceeds unless the Investment Manager reasonably believes that direct the purchase of Collateral Obligations after the Reinvestment Period unless after giving effect to any such purchase the following criteria are satisfied (such criteria, the "Post-Reinvestment Period Investment Criteria"):

(i) (A) the Minimum Fixed Coupon Test, the Weighted Average Life Test, the Minimum Floating Spread Test, the Moody's Diversity Test, the Moody's Minimum Weighted Average Recovery Rate Test and the S&P Minimum Weighted Average Recovery Rate Test will be satisfied, the Concentration Limitations and each requirement or test, as the case may be, of the Collateral Quality Test (other than the Maximum Moody's Rating Factor Test and the S&P CDO Monitor Test) will be satisfied or, if not satisfied, will be maintained or improved as compared to such failing teststest level prior to the sale of the related Credit Risk Obligation or the receipt of the Unscheduled Principal Payment or the sale of the related Credit Risk Obligation;

- (ii) (B) the Coverage Tests will be satisfied; (C) the Maximum Moody's Rating Factor Test and clause (xii) of the Concentration Limitations and the Coverage Tests will be satisfied;
  - (iii) (D) the Restricted Trading Period is not in effect;
- (iv) (E) the additional Collateral Obligation purchased will have (1) the same or higher S&P Rating, (2) the same or earlier maturity and (3) the same or higher Moody's Rating, as such Credit Risk Obligation or prepaid Collateral Obligation as to which Unscheduled Principal Payments are received after the Reinvestment Period;
- (v) (F) the aggregate principal balance solely with respect to the proceeds from the sale of a Credit Risk Obligation, the Aggregate Principal Balance of all additional Collateral Obligations purchased with the proceeds from the sale of such Credit Risk ObligationCollateral Obligations will at least equal the related Sale Proceeds; and
- (vi) (G) solely with respect to the Unscheduled Principal Payments, either (A) the Aggregate Principal Balance of the Collateral Obligations will be maintained or increased (by comparison to the Aggregate Principal Balance of the Collateral Obligations immediately prior to such payment)—, (B) the Aggregate Principal Balance of the Collateral Obligations (excluding the Unscheduled Principal Payment but including, without duplication the Collateral Obligations being purchased and the cash proceeds of the Unscheduled Principal Payment, if any, that are not applied to the purchase of such additional Collateral Obligations) will be greater than or equal to the Reinvestment Target Par Balance or (C) the Adjusted Collateral Principal Amount is maintained or increased; and
- (vii) the stated maturity of the Collateral Obligations purchased is equal to or earlier than the stated maturity of the related Credit Risk Obligation or Collateral Obligation as to which Unscheduled Principal Payments are received after the Reinvestment Period.

The criteria regarding reinvestment after the Reinvestment Period may not be amended without the written consent of a Majority of each Class of Notes.—At any time after the Reinvestment Period, if a Restricted Trading Period is in effect, the Investment Manager may not designate Principal Proceeds for reinvestment until such time as the Restricted Trading Period is no longer in effect.

- (c) <u>Purchase Following Sale of Credit Improved Obligations and Discretionary Sales.</u> Following the sale of any Credit Improved Obligation or any Discretionary Sale of a Collateral Obligation during the Reinvestment Period, the Investment Manager shall use its reasonable efforts to purchase additional Collateral Obligations within 3045 Business Days after such sale.
- (d) <u>Investment in Eligible Investments</u>. Cash on deposit in any Account may be invested at any time in Eligible Investments in accordance with <u>Article X</u>.

(e) <u>Post Reinvestment Period Settlement Obligations</u>. The Issuer shall be prohibited from purchasing a Collateral Obligation <u>during the Reinvestment Period</u> if such purchase is not scheduled to settle prior to the end of the Reinvestment Period (such Collateral Obligation, the "<u>Post Reinvestment Period Settlement Obligation</u>") unless such purchase is made with Principal Proceeds received with respect to <u>Credit Risk Obligations</u> or <u>Unscheduled Principal Payments or the sale of Credit Risk Obligations</u>;

provided, however, that, notwithstanding the foregoing, the Issuer may, prior to the end of the Reinvestment Period, commit to purchase such Post Reinvestment Period Settlement Obligations and, after the end of the Reinvestment Period, settle the purchase of such Post Reinvestment Period Settlement Obligations, if:

- (i) in the reasonable determination of the Investment Manager, the purchase of each Post Reinvestment Period Settlement Obligation is expected to settle no later than 30 Business Days after the date that the Issuer commits to purchase it; and (ii) the sum of:
  - (A) the amount of funds in the Principal Collection Account as of the date that the Issuer commits to the purchase of each Post Reinvestment Period Settlement Obligation *plus*
  - (B) the expected aggregate sale proceeds from all Collateral Obligations with respect to which the Issuer has previously entered into written trade tickets or other written binding commitments to sell, which sales are also not expected to settle prior to the end of the Reinvestment Period plus
  - (C) Principal Proceeds as a result of Scheduled Distributions of principal or Unscheduled Principal Payments that will be received by the Issuer from Collateral Obligations with respect to which the obligor has already delivered an irrevocable notice of repayment or which are required by the terms of the applicable Underlying Instruments (provided that only that portion of such principal proceeds that the Investment Manager expects will be received prior to the end of the Reinvestment Period may be used to effect such purchase)

is equal to or greater than the principal amount of all Post Reinvestment Period Settlement Obligations intended to be so purchased (the "Reinvestment Period Settlement Condition").

If the Issuer has entered into a written trade ticket or other written binding commitment to purchase a Post Reinvestment Period Settlement Obligation and any of the Reinvestment Period Settlement Conditions are Condition is satisfied, such Post Reinvestment Period Settlement Obligation shall be treated as having been purchased by the Issuer prior to the end of the Reinvestment Period for purposes of the Investment Criteria, and Principal Proceeds received after the end of the Reinvestment Period may be applied to the payment of the purchase price of such Post Reinvestment Period Settlement Obligation. No later than 15 Business Days after the end of the Reinvestment Period, the Investment Manager will send to the Trustee a schedule of sales and purchases of Collateral Obligations for which the settlement date has not

yet occurred as of the end of the Reinvestment Period and will certify to the Trustee that sufficient Principal Proceeds will be available to effect the settlement of the purchases of such Collateral Obligations.

(f) For purposes of calculating compliance with the Investment Criteria during the Reinvestment Period each proposed investment will be calculated on a *pro forma* basis after giving effect to all sales and purchases, based on outstanding Issuer orders, confirmations or executed assignments;

<u>provided</u> that such requirements need not be satisfied with respect to one single reinvestment if they are satisfied on an aggregate basis for a series of reinvestments occurring within a <u>seventen</u> Business <u>Days Day</u> period (provided that such time period may not include a Determination Date) so long as:

- (i) the Investment Manager identifies to the Trustee the sales and purchases (the "<u>Identified Reinvestments</u>") subject to this proviso;
- (ii) only one series of Identified Reinvestments is identified on any day and only one such seven10 Business Day period may be running at any one time;
- (iii) the <u>aggregate principal balance Aggregate Principal Balance</u> of such identified purchases does not exceed <u>55.0</u>% of the Aggregate Principal Balance of the Collateral Obligations;
- (iv) the Investment Manager reasonably believes that the Investment Criteria will be satisfied on an aggregate basis for such Identified Reinvestments; and
- (v) after the Reinvestment Period, no series of Identified Reinvestments may result in the purchase of a Collateral Obligation that would mature less than six months after its date of purchase;
- (v) if the Investment Criteria are not satisfied with respect to any such Identified Reinvestment, the S&P Rating Condition will be provided, further, that (A) the Investment Manager may amend any such series of reinvestments and such series will not be deemed to be a failure to satisfy such requirements on an aggregate basis and (B) if the requirements set forth in clauses (i) through (v) of the foregoing proviso are not satisfied on an aggregate basis for a series of reinvestments during the ten Business Day period referred to above, the Investment Manager will give notice of such failure to the Trustee and each Rating Agency and may not enter into any subsequent series of reinvestments on an aggregate basis unless the Global Rating Agency Condition is satisfied for each subsequent reliance on this provisoseries of Identified Reinvestments or until a subsequent use of this provisoseries of Identified Reinvestments (for which the S&PGlobal Rating Agency Condition wasis satisfied) is successfully completed.

# Section 12.3 <u>Conditions Applicable to All Sale and Purchase Transactions.</u>

(a) (a) Any transaction effected under this Article XII shall be conducted on an arm's length basis and in compliance with the Operating Guidelines and, if effected with a Person Affiliated with the Investment Manager, shall be effected in accordance with the

requirements of Section 5 of the Investment Management Agreement on terms no less favorable to the Issuer than would be the case if such Person were not so Affiliated, provided, that the Trustee shall have no responsibility to oversee compliance with this clause (a) by the other parties.

- (b) Upon any acquisition of a Collateral Obligation pursuant to this <u>Article XII</u>, all of the Issuer's right, title and interest to the Pledged Obligation or Pledged Obligations shall be Granted to the Trustee pursuant to this Indenture, such Pledged Obligations shall be Delivered to the Trustee.
  - (c) Notwithstanding anything contained in this Article XII to the contrary but subject to the Operating Guidelines and Section 7.8(c), the Issuer shall have the right to effect any sale of any Pledged Obligation or purchase of any Collateral Obligation (x) that has been separately consented to by Holders evidencing at least 75% of the Aggregate Outstanding Amount of each Class of Notes, and (y) of which the Trustee and each Rating Agency has been notified.
- (c) (d)—Any trade confirmation provided to the Trustee by the Investment Manager will be deemed to be an Issuer Order stating that the applicable conditions specified in Sections 12.1, 12.2 and 12.3 are satisfied with respect to such purchase or sale.

Section 12.4 Consent to Extension of Maturity. During and after the Reinvestment Period, the Investment Manager may vote in favor of a waiver, modification, amendment or variance of the stated maturity date of any Collateral Obligation only if, (a) after giving effect to such amendment, (i) the Underlying Asset Maturity of the Collateral Obligation is no later than the latest Stated Maturity of any Class of Notes, provided that this clause (i) is not required to be satisfied if, after giving effect to such amendment, (i) the stated maturity of the Collateral Obligation is no later than the Stated Maturity of the Notes, the Aggregate Principal Balance of all Long-Dated Obligations held by the Issuer will not exceed 2.5% of the Collateral Principal Amount, and (ii) the Weighted Average Life Test is satisfied or, if not satisfied, is maintained or improved (unless (a) a portion of the principal balance of the original Collateral Obligation is repaid in connection with such amendment and (b) the stated maturity date of such in each case after giving effect to Identified Reinvestments), or (b) such amendment or modification is consummated in connection with an actual or imminent insolvency, bankruptcy, reorganization, debt restructuring or workout of the obligor thereof and the following conditions are satisfied: (i) after giving effect to such amendment, the Underlying Asset Maturity of the Collateral Obligation is not extended by more than two years), and (iii) the Class A Overcollateralization Ratio Test is satisfied no later than the latest Stated Maturity of any Class of Notes and (ii) no more than 10.0% of the Aggregate Ramp-Up Par Amount of all Collateral Obligations held at any time since the Amendment Date by the Issuer may be amended or modified pursuant to this clause (b).

### **ARTICLE XIII**

### NOTEHOLDERS' RELATIONS

# Section 13.1 Subordination.

- (a) (a) Anything in this Indenture or the Notes to the contrary notwithstanding, the Holders of each Class of Notes that constitute a Junior Class agree for the benefit of the Holders of the Notes of each Priority Class with respect to such Junior Class that such Junior Class shall be subordinate to the Notes of each such Priority Class to the extent and in the manner set forth in Article XI of this Indenture. On any Post-Acceleration Payment Date or on the Stated Maturity, all accrued and unpaid interest on and outstanding principal of each Priority Class shall be paid pursuant to the Special Priority of Proceeds in full in Cash or, to the extent 100% of Holders of the Class A Notes and a Majority of each such Class of Secured Notes consents, other than in Cash, before any further payment or distribution is made on account of any Junior Class with respect thereto, to the extent and in the manner provided in the Special Priority of Proceeds.
- (b) On or after a Post-Acceleration Payment Date or on the Stated Maturity, in the event that notwithstanding the provisions of this Indenture, any Holder of Notes of any Junior Class shall have received any payment or distribution in respect of such Notes contrary to the provisions of this Indenture, then, unless and until all accrued and unpaid interest on and outstanding principal of each Priority Class with respect thereto shall have been paid in full in Cash or, to the extent a Majority100% of each Holders of such Class of Secured Notes consents, other than in Cash in accordance with this Indenture, such payment or distribution shall be received and held in trust for the benefit of, and shall forthwith be paid over and delivered to, the Trustee, which shall pay and deliver the same to the Holders of the applicable Priority Classes) in accordance with this Indenture; provided, however, that if any such payment or distribution is made other than in Cash, it shall be held by the Trustee as part of the Assets and subject in all respects to the provisions of this Indenture, including this Section 13.1.
- (c) Each Holder of Notes of any Junior Class agrees with all Holders of the applicable Priority Classes that such Holder of Junior Class Notes shall not demand, accept, or receive any payment or distribution in respect of such Notes in violation of the provisions of this Indenture including, without limitation, this <u>Section 13.1</u>; <u>provided</u>, <u>however</u>, that after all accrued and unpaid interest on and outstanding principal of a Priority Class has been paid in full, the Holders of the related Junior Class or Classes shall be fully subrogated to the rights of the Holders of such Priority Class. Nothing in this <u>Section 13.1</u> shall affect the obligation of the Issuer to pay Holders of any Junior Class of Notes.
- (d) The Holders of each Class of Securities agree, for the benefit of all Holders of each Class of Securities, not to cause the filing of a petition in bankruptcy against the Issuer, the Co-Issuer or any Tax Subsidiary until the payment in full of the Notes and payment of any amounts payable to the Fiscal Agent pursuant to this Indenture for distribution to Shareholders in accordance with the Fiscal Agency Agreement and not before one year (or, if

longer, the applicable preference period then in effect) plus one day has elapsed since such payment.

Section 13.2 Standard of Conduct. In exercising any of its or their voting rights, rights to direct and consent or any other rights as a Holder under this Indenture, a Holder or Holders shall not have any obligation or duty to any Person or to consider or take into account the interests of any Person and shall not be liable to any Person for any action taken by it or them or at its or their direction or any failure by it or them to act or to direct that an action be taken, without regard to whether such action or inaction benefits or adversely affects any Holder, the Issuer, or any other Person, except for any liability to which such Holder may be subject to the extent the same results from such Holder's taking or directing an action, or failing to take or direct an action, in bad faith or in violation of the express terms of this Indenture.

### **ARTICLE XIV**

### **MISCELLANEOUS**

Section 14.1 Form of Documents Delivered to Trustee. In any case where several matters are required to be certified by, or covered by an opinion of, any specified Person, it is not necessary that all such matters be certified by, or covered by the opinion of, only one such Person, or that they be so certified or covered by only one document, but one such Person may certify or give an opinion with respect to some matters and one or more other such Persons as to other matters, and any such Person may certify or give an opinion as to such matters in one or several documents.

Any certificate or opinion of an Officer of the Issuer, the Co-Issuer or the Investment Manager may be based, insofar as it relates to legal matters, upon a certificate or opinion of, or representations by, counsel, unless such Officer knows, or should know that the certificate or opinion or representations with respect to the matters upon which his certificate or opinion is based are erroneous. Any such certificate of an Officer of the Issuer, Co-Issuer or the Investment Manager or Opinion of Counsel may be based, insofar as it relates to factual matters, upon a certificate or opinion of, or representations by, the Issuer, the Co-Issuer, the Investment Manager or any other Person, stating that the information with respect to such factual matters is in the possession of the Issuer, the Co-Issuer, the Investment Manager or such other Person, unless such Officer of the Issuer, Co-Issuer or the Investment Manager or such counsel knows that the certificate or opinion or representations with respect to such matters are erroneous. Any Opinion of Counsel may also be based, insofar as it relates to factual matters, upon a certificate or opinion of, or representations by, an Officer of the Issuer or the Co-Issuer, stating that the information with respect to such matters is in the possession of the Issuer or the Co-Issuer, unless such counsel knows that the certificate or opinion or representations with respect to such matters are erroneous.

Where any Person is required to make, give or execute two or more applications, requests, consents, certificates, statements, opinions or other instruments under this Indenture, they may, but need not, be consolidated and form one instrument.

Whenever in this Indenture it is provided that the absence of the occurrence and continuation of a Default or Event of Default is a condition precedent to the taking of any action by the Trustee at the request or direction of either Co-Issuer, then notwithstanding that the satisfaction of such condition is a condition precedent to such Co-Issuer's right to make such request or direction, the Trustee shall be protected in acting in accordance with such request or direction if it does not have knowledge of the occurrence and continuation of such Default or Event of Default as provided in Section 6.1(d).

#### Section 14.2 Acts of Holders.

(a) (a) Any request, demand, authorization, direction, notice, consent, waiver or other action provided by this Indenture to be given or taken by Holders may be

embodied in and evidenced by one or more instruments of substantially similar tenor signed by such Holders in person or by an agent duly appointed in writing; and, except as herein otherwise expressly provided, such action shall become effective when such instrument or instruments are delivered to the Trustee, and, where it is hereby expressly required, to the Issuer. Such instrument or instruments (and the action or actions embodied therein and evidenced thereby) are herein sometimes referred to as the "Act of Holders" signing such instrument or instruments. Proof of execution of any such instrument or of a writing appointing any such agent shall be sufficient for any purpose of this Indenture and conclusive in favor of the Trustee and the Co-Issuers, if made in the manner provided in this Section 14.2.

- (b) The fact and date of the execution by any Person of any such instrument or writing may be proved in any manner which the Trustee deems sufficient.
- (c) The principal amount or notional amount, as the case may be, and registered numbers of Notes held by any Person, and the date of his holding the same, shall be proved by the Register or, in the case of Preferred Shares, the Share Register. With respect to any request, demand, authorization, direction, notice, consent, waiver or other action by the Holder, each Holder or proxy will be entitled to one vote for each U.S. \$1.00 principal amount of the interest in a Note (or, in the case of Preferred Shares, 1,000 votes for each share) as to which it is the Holder or proxy.
- (d) Any request, demand, authorization, direction, notice, consent, waiver or other action by the Holder of any Securities shall bind the Holder (and any transferee thereof) of such Security and of every Security issued upon the registration thereof or in exchange therefor or in lieu thereof, in respect of anything done, omitted or suffered to be done by the Trustee or the Co-Issuers in reliance thereon, whether or not notation of such action is made upon such Security.

## Section 14.3 Notices, etc., Certain Parties.

- (a) Except as otherwise expressly provided herein, any request, demand, authorization, direction, notice, consent or waiver or other documents provided or permitted by this Indenture to be made upon, given or furnished to, or filed with any of the parties indicated below shall be sufficient for every purpose hereunder if made, given, furnished or filed in writing to and mailed, by certified mail, return receipt requested, hand delivered, sent by overnight courier service guaranteeing next day delivery or by facsimile or email in legible form at the following address (or at any other address provided in writing by the relevant party):

The Co-Issuers also shall furnish such other information regarding the Co-Issuers or the Assets as may be reasonably requested by the Rating Agencies to the extent such party has or can obtain such information without unreasonable effort or expense. Notwithstanding the foregoing, the failure to deliver such notices or copies shall not constitute an Event of Default under this Indenture. Any confirmation of the rating by the Rating Agencies required hereunder shall be in writing.

Any request, demand, authorization, direction, order, notice, consent, waiver or Act of Holders or other documents provided or permitted by this Indenture, including the 17g-5 Information, to be made upon, given or furnished to, or filed with the Rating Agencies shall be given in accordance with, and subject to, the provisions of Section 14.16 hereof and Section 2A of the Collateral Administration Agreement and shall be sufficient for every purpose hereunder

(unless otherwise herein expressly provided) if in writing by email to each Rating Agency addressed to it at (i) in the case of S&P, CDOMonitor@spglobal.com (with respect to (w) any documents or notice related to the CDO Monitor correspondence). - (c) In the event that any provision in this Indenture calls for any notice or document to be delivered simultaneously to the Trustee and any other person or entity, the Trustee's receipt of such notice or document shall entitle the Trustee to assume that such notice or document was delivered to such other person or entity unless otherwise expressly specified herein.
- (d) Notwithstanding any provision to the contrary contained herein or in any agreement or document related thereto, any report, statement or other information required to be provided by the Issuer (except information required to be provided to the Irish Stock Exchange) or the Trustee may be provided by providing access to a website containing such information.

Section 14.4 <u>Notices to Holders; Waiver</u>. Except as otherwise expressly provided herein, where this Indenture provides for notice to Holders of any event,

- (a) such notice shall be sufficiently given to Holders if in writing and mailed, first class postage prepaid, to each Holder affected by such event, at the address of such Holder as it appears in the Register or, as applicable, in accordance with the procedures at DTC, as soon as reasonably practicable but in any case not earlier than the earliest date and not later than the latest date, prescribed for the giving of such notice;
- (b) for so long as any Securities are listed on the Irish Stock Exchange and the guidelines of the Irish Stock Exchange so require, notices to the Holders of such Securities shall also be provided to the Irish Stock Exchange; and
  - (c) such notice shall be in the English language.

Such notices shall be deemed to have been given on the date of such mailing.

The Trustee shall deliver to the Holders any information or notice relating to this Indenture requested to be so delivered by at least 25% of the Holders of any Class (by Aggregate Outstanding Amount), at the expense of the Issuer.

The Trustee shall deliver to any Holder of Securities or any Person that has certified to the Trustee in a writing substantially in the form of Exhibit D to this Indenture that it is the owner of a beneficial interest in a Global Security, any information or notice requested to be so delivered by a Holder or a Person that has made such certification that is reasonably available to the Trustee and all related costs will be borne by the requesting Holder or Person.

Neither the failure to mail any notice, nor any defect in any notice so mailed, to any particular Holder shall affect the sufficiency of such notice with respect to other Holders. In case by reason of the suspension of regular mail service as a result of a strike, work stoppage or similar activity or by reason of any other cause it shall be impracticable to give such notice by mail of any event to Holders when such notice is required to be given pursuant to any provision of this Indenture, then such notification to Holders as shall be made with the approval of the Trustee shall constitute a sufficient notification to such Holders for every purpose hereunder.

Where this Indenture provides for notice in any manner, such notice may be waived in writing by any Person entitled to receive such notice, either before or after the event, and such waiver shall be the equivalent of such notice. Waivers of notice by Holders shall be filed with the Trustee but such filing shall not be a condition precedent to the validity of any action taken in reliance upon such waiver.

Section 14.5 <u>Effect of Headings and Table of Contents</u>. The Article and Section headings herein (including those used in cross-references herein) and the Table of Contents are for convenience only and shall not affect the construction hereof.

Section 14.6 <u>Successors and Assigns</u>. All covenants and agreements in this Indenture by the Co-Issuers shall bind their respective successors and assigns, whether so expressed or not.

Section 14.7 <u>Separability</u>. Except to the extent prohibited by applicable law, in case any provision in this Indenture or in the Notes shall be invalid, illegal or unenforceable, the validity, legality, and enforceability of the remaining provisions shall not in any way be affected or impaired thereby.

Section 14.8 <u>Benefits of Indenture</u>. Nothing in this Indenture or in the Notes, expressed or implied, shall give to any Person, other than the parties hereto and their successors hereunder, the Investment Manager, the Holders of the Securities, the Collateral Administrator and (to the extent provided herein) the Administrator (solely in its capacity as such) and the other Secured Parties any benefit or any legal or equitable right, remedy or claim under this Indenture.

Section 14.9 <u>Records</u>. For the term of the Notes, copies of the Memorandum and Articles of Association of the Issuer, the Certificate of Formation and Limited Liability Company Agreement of the Co-Issuer and this Indenture shall be available for inspection by the Holders of the Securities in electronic form at the office of the Trustee upon prior written request and during normal business hours of the Trustee.

Section 14.10 <u>Governing Law</u>. THIS INDENTURE AND THE NOTES SHALL BE CONSTRUED IN ACCORDANCE WITH, AND THIS INDENTURE AND THE NOTES. <u>AND ANY MATTERS ARISING OUT OF OR RELATING IN ANY WAY WHATSOEVER TO ANY OF THE NOTES OR THIS INDENTURE</u> SHALL BE GOVERNED BY, THE LAW OF THE STATE OF NEW YORK.

Section 14.11 <u>Submission to Jurisdiction</u>. To the fullest extent permitted by applicable law, each party hereto irrevocably (i) submits to the exclusive jurisdiction of any New

York State or federal court sitting in the Borough of Manhattan in The City of New York in any action or Proceeding arising out of or relating to the Notes or this Indenture, (ii) agrees that all claims in respect of such action or Proceeding may be heard and determined in such New York State or federal court and (iii) waives the defense of an inconvenient forum to the maintenance of such action or Proceeding. The Co-Issuers irrevocably consent to the service of any and all process in any action or Proceeding by the mailing or delivery of copies of such process to it at the office of the Co-Issuers' agent set forth in Section 7.2. The Co-Issuers agree that a final judgment in any such action or Proceeding shall be conclusive and may be enforced in other jurisdictions by suit on the judgment or in any other manner provided by law.

Section 14.12 <u>Counterparts</u>. This instrument may be executed in any number of counterparts, each of which so executed shall be deemed to be an original, but all such counterparts shall together constitute but one and the same instrument. Delivery of executed counterpart of this instrument by electronic means (including email or telecopy) will be effective as delivery of a manually executed counterpart of this instrument.

Section 14.13 <u>Acts of Issuer</u>. Any request, demand, authorization, direction, notice, consent, waiver or other action provided by this Indenture to be given or performed by the Issuer shall be effective if given or performed by the Issuer or by the Investment Manager on the Issuer's behalf.

## Section 14.14 Confidential Information.

(a) (a) The Trustee, the Collateral Administrator and each Holder of Securities shall maintain the confidentiality of all Confidential Information in accordance with procedures adopted by the Issuer (after consultation with the Co-Issuers) or such Holder in good faith to protect Confidential Information of third parties delivered to such Person except as provided in the following sentence.

Such Person may deliver or disclose Confidential Information to:

- (i) such Person's directors, trustees, officers, employees, agents, attorneys and affiliates who agree to hold confidential the Confidential Information substantially in accordance with the terms of this <u>Section 14.14</u> and to the extent such disclosure is reasonably required for the administration of this Indenture, the matters contemplated hereby or the investment represented by the Securities;
- (ii) such Person's financial advisors and other professional advisors who agree to hold confidential the Confidential Information substantially in accordance with the terms of this Section 14.14 and to the extent such disclosure is reasonably required for the administration of this Indenture, the matters contemplated hereby or the investment represented by the Securities;
  - (iii) any other Holder;
- (iv) any Person of the type that would be, to such Person's knowledge, permitted to acquire Securities in accordance with the requirements of <u>Section 2.6</u> hereof to which such Person sells or offers to sell any such Security or any part thereof (if such

Person has agreed in writing prior to its receipt of such Confidential Information to be bound by the provisions of this <u>Section 14.14</u>);

- (v) any other Person from which such former Person offers to purchase any security of the Co-Issuers (if such other Person has agreed in writing prior to its receipt of such Confidential Information to be bound by the provisions of this <u>Section 14.14</u>);
- (vi) any Federal or state or other regulatory, governmental or judicial authority having jurisdiction over such Person;
- (vii) the National Association of Insurance Commissioners or any similar organization, or any nationally recognized rating agency that requires access to information about the investment portfolio of such Person, reinsurers and liquidity and credit providers that agree to hold confidential the Confidential Information substantially in accordance with this Section 14.14;

# (viii) Moody's Fitch or S&P;

- (ix) any other Person with the written consent of the Co-Issuers and the Investment Manager;
- (x) any other disclosure that is permitted or required under this Indenture or the Collateral Administration Agreement; or
- (xi) any other Person to which such delivery or disclosure may be necessary or appropriate (A) to effect compliance with any law, rule, regulation or order applicable to such Person, (B) in response to any subpoena or other legal process upon prior notice to the Co-Issuers (unless prohibited by applicable law, rule, order or decree or other requirement having the force of law), (C) in connection with any litigation to which such Person is a party upon prior notice to the Co-Issuers (unless prohibited by applicable law, rule, order or decree or other requirement having the force of law) or (D) if an Event of Default has occurred and is continuing, to the extent such Person may reasonably determine such delivery and disclosure to be necessary or appropriate in the enforcement or for the protection of the rights and remedies under the Securities or this Indenture; and

Notwithstanding the foregoing, delivery to Holders by the Trustee or the Collateral Administrator of any report or information required by the terms of this Indenture to be provided to Holders shall not be a violation of this Section 14.14.

Each Holder of Securities agrees, except as set forth in clauses (vi), (vii) and (x) above, that it shall use the Confidential Information for the sole purpose of making an investment in the Securities or administering its investment in the Securities; and that the Trustee and the Collateral Administrator shall neither be required nor authorized to disclose to Holders any Confidential Information in violation of this Section 14.14. In the event of any required disclosure of the Confidential Information by such Holder, such Holder agrees to use reasonable efforts to protect the confidentiality of the Confidential Information. Each Holder of a Security, by its acceptance of a Note shall be deemed to have agreed to be bound by and to be entitled to the benefits of this Section 14.14.

Notwithstanding the foregoing, the Trustee, the Collateral Administrator, the Holders and beneficial owners of the Securities (and each of their respective employees, representatives or other agents) may disclose to any and all Persons, without limitation of any kind, the U.S. federal, state and local income tax treatment of the Issuer and the transactions contemplated by this Indenture and all materials of any kind (including opinions or other tax analyses) that are provided to them relating to such U.S. federal, state and local income tax treatment.

- (b) For the purposes of this Section 14.14, "Confidential Information" means information delivered to the Trustee, the Collateral Administrator or any Holder of Securities by or on behalf of the Co-Issuers in connection with and relating to the transactions contemplated by or otherwise pursuant to this Indenture; provided that such term does not include information that: (i) was publicly known or otherwise known to the Trustee, the Collateral Administrator or such Holder prior to the time of such disclosure; (ii) subsequently becomes publicly known through no act or omission by the Trustee, the Collateral Administrator, any Holder or any person acting on behalf of the Trustee, the Collateral Administrator or any Holder; (iii) otherwise is known or becomes known to the Trustee, the Collateral Administrator or any Holder other than (x) through disclosure by the Co-Issuers or (y) to the knowledge of the Trustee, the Collateral Administrator or a Holder, as the case may be, in each case after reasonable inquiry, as a result of the breach of a fiduciary duty to the Co-Issuers or a contractual duty to the Co-Issuers; or (iv) is allowed to be treated as non-confidential by consent of the Co-Issuers.
- (c) Notwithstanding the foregoing, the Trustee and the Collateral Administrator may disclose Confidential Information to the extent disclosure may be required by law or by any regulatory or governmental authority and the Trustee and the Collateral Administrator may disclose on a confidential basis any Confidential Information to its agents, attorneys and auditors in connection with the performance of its responsibilities hereunder.

Section 14.15 <u>Liability of Co-Issuers</u>. Notwithstanding any other terms of this Indenture, the Notes or any other agreement entered into between, *inter alia*, the Co-Issuers or otherwise, neither of the Co-Issuers shall have any liability whatsoever to the other of the Co-Issuers under this Indenture, the Notes, any such agreement or otherwise and, without prejudice to the generality of the foregoing, neither of the Co-Issuers shall be entitled to take any action to enforce, or bring any action or Proceeding, in respect of this Indenture, the Notes, any such agreement or otherwise against the other of the Co-Issuers. In particular, neither of the Co-Issuers shall be entitled to petition or take any other steps for the winding up or bankruptcy of the other of the Co-Issuers or shall have any claim in respect to any assets of the other of the Co-Issuers.

## Section 14.16 17g-5 Information.

(a) (a) The Co-Issuers shall comply with their obligations under Rule 17g-5 promulgated under the Exchange Act ("Rule 17g-5"), by their or their agent's posting on the 17g-5 Website, no later than the time such information is provided to the Rating Agencies, all information that the Co-Issuers or other parties on their behalf, including the Trustee and the Investment Manager, provide to the Rating Agencies for the purposes of determining the initial

credit rating of the Secured Notes or undertaking credit rating surveillance of the Secured Notes (the "17g-5 Information"); provided, however, that no party other than the Issuer, the Trustee or the Investment Manager may provide information to the Rating Agencies on the Co-Issuers' behalf without the prior written consent of the Investment Manager. At all times while any Secured Notes are rated by any Rating Agency or any other NRSRO, the Co-Issuers shall engage a third-party to post 17g-5 Information to the 17g-5 Website. On the Closing Date, the Issuer shall engage the Collateral Administrator (in such capacity, the "Information Agent"), to post 17g-5 Information it receives from the Issuer, the Trustee or the Investment Manager to the 17g-5 Website in accordance with Section 2A of the Collateral Administration Agreement.

- (b) To the extent any of the Co-Issuers, the Trustee or the Investment Manager are engaged in oral communications with any Rating Agency, for the purposes of determining the initial credit rating of the Notes or undertaking credit rating surveillance of the Notes, the party communicating with such Rating Agency shall cause such oral communication to either be (x) recorded and an audio file containing the recording to be promptly delivered to the Information Agent for posting to the 17g-5 Website or (y) summarized in writing and the summary to be promptly delivered to the Information Agent for posting to the 17g-5 Website.
- (c) Notwithstanding the requirements herein, the Trustee shall have no obligation to engage in or respond to any oral communications, for the purposes of determining the initial credit rating of the Notes or undertaking credit rating surveillance of the Notes, with any Rating Agency or any of their respective officers, directors or employees.
- (d) For the avoidance of doubt, no report of Independent accountants (including, without limitation, any Accountants' Certificate) shall be provided to or otherwise shared with any Rating Agency.
- (e) Notwithstanding anything to the contrary in this Indenture, a breach of this Section 14.16 shall not constitute a Default or Event of Default.

Section 14.17 <u>Waiver of Jury Trial</u>. THE TRUSTEE AND EACH OF THE CO-ISSUERS EACH HEREBY KNOWINGLY, VOLUNTARILY AND INTENTIONALLY WAIVES (TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW) ANY RIGHTS IT MAY HAVE TO A TRIAL BY JURY IN RESPECT OF ANY LITIGATION BASED HEREON, OR ARISING OUT OF, UNDER, OR IN CONNECTION WITH, THIS INDENTURE, THE NOTES OR ANY OTHER RELATED DOCUMENTS, OR ANY COURSE OF CONDUCT, COURSE OF DEALING, STATEMENTS (WHETHER VERBAL OR WRITTEN), OR ACTIONS OF THE TRUSTEE OR EITHER OF THE CO-ISSUERS. THIS PROVISION IS A MATERIAL INDUCEMENT FOR THE TRUSTEE AND THE CO-ISSUERS TO ENTER INTO THIS INDENTURE.

Section 14.18 Escheat. In the absence of a written request from the Co-Issuers to return unclaimed funds to the Co-Issuers, the Trustee may from time to time following the final Payment Date with respect to the Securities deliver all unclaimed funds to or as directed by applicable escheat authorities, as determined by the Trustee in its sole discretion, in accordance with the customary practices and procedures of the Trustee. Any unclaimed funds held by the Trustee pursuant to this Section 14.18 shall be held uninvested and without any liability for

interest.

### ARTICLE XV

### ASSIGNMENT OF INVESTMENT MANAGEMENT AGREEMENT

Section 15.1 <u>Assignment of Investment Management Agreement.</u>

- Granting Clause I includes all of the Issuer's estate, right, title and interest in, to and under the Investment Management Agreement, including (i) the right to give all notices, consents and releases thereunder, (ii) the right to give all notices of termination and to take any legal action upon the breach of an obligation of the Investment Manager thereunder, including the commencement, conduct and consummation of Proceedings at law or in equity, (iii) the right to receive all notices, accountings, consents, releases and statements thereunder and (iv) the right to do any and all other things whatsoever that the Issuer is or may be entitled to do thereunder; provided, however, that except as otherwise expressly set forth in this Indenture, the Trustee shall not have the authority to exercise any of the rights set forth in (i) through (iv) above or that may otherwise arise as a result of the Grant until the occurrence of an Event of Default hereunder and such authority shall terminate at such time, if any, as such Event of Default is cured or waived.
- (b) The assignment made hereby is executed as collateral security, and the execution and delivery hereby shall not in any way impair or diminish the obligations of the Issuer under the provisions of the Investment Management Agreement, or increase, impair or alter the rights and obligations of the Investment Manager under the Investment Management Agreement, nor shall any of the obligations contained in the Investment Management Agreement be imposed on the Trustee.
- (c) Upon the retirement of the Notes, the payment of all amounts required to be paid pursuant to the Priority of Payments and the release of the Assets from the lien of this Indenture, this assignment and all rights herein assigned to the Trustee for the benefit of the Holders shall cease and terminate and all the estate, right, title and interest of the Trustee in, to and under the Investment Management Agreement shall revert to the Issuer and no further instrument or act shall be necessary to evidence such termination and reversion.
- (d) The Issuer represents that the Issuer has not executed any other assignment of the Investment Management Agreement.
- (e) The Issuer agrees that this assignment is irrevocable, and that it shall not take any action which is inconsistent with this assignment or make any other assignment inconsistent herewith. The Issuer shall, from time to time upon the request of the Trustee, execute all instruments of further assurance and all such supplemental instruments with respect to this assignment as the Trustee may reasonably specify.
- The Issuer hereby agrees that the Issuer shall not enter into any agreement amending, modifying or terminating the Investment Management Agreement except in accordance with the terms of the Investment Management Agreement.

### **ARTICLE XVI**

### **HEDGE AGREEMENTS**

# Section 16.1 <u>Hedge Agreements</u>.

(a) (a) The Issuer may enter into Hedge Agreements from time to time on and after the Closing Date solely for the purpose of managing interest rate and other risks in connection with the Issuer's issuance of, and making payments on, the Notes, and if the written terms of the derivative directly relate to the Collateral Obligations and the Notes and such derivative reduces the interest rate and/or foreign exchange risks related to the Collateral Obligations and the Notes. The Issuer shall promptly provide notice of entry into any Hedge Agreement to the Trustee and Moody'seach Rating Agency. The Issuer shall provide a copy of each Hedge Agreement and any amendment to a Hedge Agreement to each Rating Agency promptly upon entry therein.

Each Hedge Agreement shall contain appropriate limited recourse and non-petition provisions equivalent (*mutatis mutandis*) to those contained in Section 2.8(j) and Section 5.4(d). Each Hedge Counterparty shall be required to have, at the time that any Hedge Agreement to which it is a party is entered into, the Required Hedge Counterparty Ratings unless the applicableGlobal Rating Agency Condition is satisfied or credit support is provided as set forth in the Hedge Agreement. Payments with respect to Hedge Agreements shall be subject to Article XI. Each Hedge Agreement shall contain an acknowledgement by the Hedge Counterparty that the obligations of the Issuer to the Hedge Counterparty under the relevant Hedge Agreement shall be payable in accordance with Article XI of this Indenture.

- (b) In the event of any early termination of a Hedge Agreement with respect to which the Hedge Counterparty is the sole "defaulting party" or "affected party" (each as defined in the Hedge Agreements), (i) any termination payment paid by the Hedge Counterparty to the Issuer may be paid to a replacement Hedge Counterparty at the direction of the Investment Manager and (ii) any payment received from a replacement Hedge Counterparty may be paid to the replaced Hedge Counterparty at the direction of the Investment Manager under the terminated Hedge Agreement; provided that (in the case of any such payment under subclause (i) or (ii) above) the Global Rating Agency Condition has been satisfied with respect thereto.
- (c) The Issuer (or the Investment Manager on its behalf) shall, upon receiving written notice of the exposure calculated under a credit support annex to any Hedge Agreement, if applicable, make a demand to the relevant Hedge Counterparty and its credit support provider, if applicable, for securities having a value under such credit support annex equal to the required credit support amount.
- (d) Each Hedge Agreement will, at a minimum, (i) include requirements for collateralization by or replacement of the Hedge Counterparty (including timing requirements) that satisfy Rating Agency criteria in effect at the time of execution of the Hedge Agreement and

- (ii) permit the Issuer to terminate such agreement (with the Hedge Counterparty bearing the costs of any replacement Hedge Agreement) for failure to satisfy such requirements.
- (e) The Issuer shall give prompt notice to each Rating Agency of any termination of a Hedge Agreement or agreement to provide Hedge Counterparty Credit Support. Any collateral received from a Hedge Counterparty under a Hedge Agreement shall be deposited in the related Hedge Counterparty Collateral Account.
- (f) If a Hedge Counterparty has defaulted in the payment when due of its obligations to the Issuer under the Hedge Agreement, the Investment Manager shall make a demand on the Hedge Counterparty (or its guarantor under the Hedge Agreement) with a copy to the Trustee, demanding payment by the close of business on such date (or by such time on the next succeeding Business Day if such knowledge is obtained after 11:30 a.m., New York time).
- (g) Each Hedge Agreement shall provide that it may not be terminated due to the occurrence of an Event of Default until liquidation of the Collateral has commenced.
- (h) The Issuer may enter into a Hedge Agreement only if the following conditions are Global Rating Agency Condition is satisfied and:
  - (A) the Issuer receivesit obtains an Opinion of Counsel that either (1) the Issuer entering into such Hedge Agreement will not cause it to be considered a "commodity pool" as defined in Section 1a(10) of the Commodity Exchange Act, as amended, or (2) if the Issuer would be a commodity pool, that (a) the Investment Manager, and no other party, would be the "commodity pool operator" and "commodity trading adviseradvisor" and (b) with respect to the Issuer as thea commodity pool, the Investment Manager is eligible for an exemption from registration as a commodity pool operator and commodity trading adviseradvisor and all conditions precedent to obtaining such an exemption have been satisfied;
  - (B) the Investment Manager agrees in writing that, for so long as the Issuer is a commodity pool, the Investment Manager it will take all actionactions necessary to ensure ongoing compliance with the applicable exemption from registration as a commodity pool operator and commodity trading adviseradvisor with respect to the Issuer, and any other actions required as a commodity pool operator and commodity trading adviseradvisor with respect to the Issuer; and
  - (C) the Issuer receives an Opinion written opinion of Counselcounsel that the Issuer entering into such Hedge Agreementhedge agreement will not, in and of itself, cause the Issuer to become a "hedge fund or a private equitycovered fund" as defined for the purposes of Section 13 of the Bank Holding Company Act of 1956, as amended; and (D)—the Issuer has satisfied the Global Rating Agency Condition; provided that if the Global Rating Agency Condition does not apply as provided in the last sentence of definition thereof with respect to any Rating Agency and the Class A-1 Notes are Outstanding, the written consent of a Majority of the Class A-1 Notes will be required. the Volcker Rule.

With respect to clause (B) of this <u>Section 16.1(h)</u>, the Issuer and the Investment Manager shall take all action necessary to ensure ongoing compliance with the applicable exemption from registration under the Commodities Exchange Act (including, without limitation, obtaining financial statements and engaging professionals). The reasonable fees, costs, charges and expenses incurred by the Issuer and the Investment Manager (including reasonable attorneys', accountants' and other professional fees and expenses) in connection with the requirements of <u>clause (g) abovethis Section 16.1(h)</u> will be Administrative Expenses.

# DIVERSITY SCORE CALCULATION

The Diversity Score is calculated as follows:

- (a) (i) An "Issuer Par Amount" is calculated for each issuer of a Collateral Obligation, and is equal to the Aggregate Principal Balance of all the Collateral Obligations issued by that issuer and all affiliates.

  - (p) With respect to a Collateral Obligation that is a Moody's Senior Secured Loan or Participation Interest in a Moody's Senior Secured Loan, if not determined pursuant to clause (a) above, if such Collateral Obligation (i) is publicly rated by Moody's, such public rating, or (ii) is not publicly rated by Moody's but for which a rating or rating estimate has been assigned by Moody's upon the request of the Issuer or the Investment Manager, such rating or the corporate family rating estimate, as applicable;

such Collateral Obligation by Moody's upon the request of the Issuer, the Investment Manager or an Affiliate of the Investment Manager, such rating or, in the case of a rating estimate, the applicable rating estimate for such obligation or (iv) if such Collateral Obligation is a DIP Collateral Obligation, the Moody's Derived Rating set forth in clause (e) in the definition thereof; and

(r) With respect to a Collateral Obligation, if not determined pursuant to clause (a), (b) or (c) above, the Moody's Derived Rating;

provided, that for purposes of calculating a Moody's Weighted Average Rating Factor, each applicable rating, at the time of calculation, (i) on credit watch by Moody's with positive implications will be treated as having been upgraded by one rating subcategory, (ii) on credit watch by Moody's with negative implications will be treated as having been downgraded by two-rating subcategories and (iii) on negative outlook by Moody's will be treated as having been downgraded by one rating subcategory.

  - (iii) if not determined pursuant to clause (i) or (ii) above, if the senior secured debt of the obligor has a public rating by Moody's, the Moody's rating that is one subcategory lower than such rating;
  - (iv) if not determined pursuant to clause (i), (ii) or (iii) above, the Investment Manager may elect to use a Moody's Credit Estimate to determine the Moody's Rating Factor for such Collateral Obligation for purposes of the Maximum Moody's Rating Factor Test;

(v) With respect to a Collateral Obligation, if not determined pursuant to clause (a), (b) or (c) above, the Moody's Derived Rating.if the Moody's Default Probability Rating is not determined pursuant to clause (i), (ii) or (iii) above (and a Moody's Rating Factor is not determined pursuant to clause (iv) above), the Moody's Derived Rating, if any; or

For purposes of calculating a Moody's Rating, each applicable rating, at the time of calculation, (i) on credit watch by Moody's with positive implications will be treated as having been upgraded by one rating subcategory, (ii) on credit watch by Moody's with negative implications will be treated as having been downgraded by two rating subcategories and (iii) on negative outlook by Moody's will be treated as having been downgraded by one rating subcategory.

For purposes of the definitions of "Moody's Default Probability Rating," "Moody's Derived Rating" and "Moody's Rating," any credit estimate assigned by Moody's shall expire one year from the date such estimate was issued; provided that, for purposes of any calculation under this Indenture, if Moody's fails to renew for any reason a credit estimate for a previously acquired Collateral Obligation thereunder on or before such one year anniversary (which may be extended at Moody's option to the extent the annual audited financial statements for the related obligor have not yet been received), after the Issuer or the Investment Manager on the Issuer's behalf has submitted to Moody's all information that Moody's required to be provided for such renewal, (1) for a period of 90 days, the previous credit estimate assigned by Moody's shall be downgraded by one notch and (2) thereafter, the Collateral Obligation will be deemed to have a Moody's rating of "Caa3."

- 5b If Moody's has not issued a CFR, but has a publicly available outstanding Insurance Financial Strength Rating, then the Fitch IDR equivalent is one rating lower.
- 5c If Moody's has not issued a CFR, but has publicly available outstanding corporate issue ratings, then the Fitch IDR equivalent is calculated using the mapping in the table above.
- <u>6a</u> A public S&P-issued Issuer Credit Rating (ICR) is equivalent in terms of definition to the Fitch IDR.
- 6b If S&P has not issued an ICR, but has a publicly available outstanding Insurance Financial Strength Rating, then the Fitch IDR equivalent is one rating lower.
- 6c If S&P has not issued an ICR, but has publicly available outstanding corporate issue ratings, then the Fitch IDR equivalent is calculated using the mapping in the table above.
- 7 If both Moody's and S&P provide a public rating on the issuer or an issue, the lower of the two Fitch IDR equivalent ratings will be used in PCM. Otherwise the sole public Fitch IDR equivalent rating from Moody's or S&P will be applied.

#### **SCHEDULE 5**

#### Section 1. S&P DEFINITIONS

"Adjusted Class Break-even Default Rate" means the rate equal to the sum of:

- (a) (i) the Class Break-even Default Rate *multiplied by* (ii) (x) the Aggregate Ramp-Up Par Amount *divided by* (y) the S&P Collateral Principal Amount; and
- (b) (i)(x) the S&P Collateral Principal Amount *minus* (y) the Aggregate Ramp-Up Par Amount, *divided by* (ii)(x) the S&P Collateral Principal Amount *multiplied by* (y) 1 *minus* the Weighted Average S&P Recovery Rate:

provided that, if the S&P Effective Date Formula Election is in effect, for the purposes of calculating the Adjusted Class Break-even Default Rate, the S&P Collateral Principal Amount will exclude any amounts that may be transferred from the Principal Collection Account or the Ramp-Up Account into the Interest Collection Account as Interest Proceeds as set forth in clause (x) of the definition of Interest Proceeds.

"Class Break-even Default Rate" means, with respect to the Highest Ranking Class, as of any date of determination:

- (a) <u>if either an S&P CDO Formula Election or an S&P Effective Date</u> Formula Election is in effect on such date, the rate equal to:
  - (i) 0.087229 (or such other coefficient provided in advance by S&P to the Issuer, the Investment Manager and the Collateral Administrator in writing); plus
  - (ii) the product of (x) 4.242005 (or such other coefficient provided in advance by S&P to the Issuer, the Investment Manager and the Collateral Administrator in writing) and (y) the Weighted Average Floating Spread; plus
  - (iii) the product of (x) 1.005042 (or such other coefficient provided in advance by S&P to the Issuer, the Investment Manager and the Collateral Administrator in writing) and (y) the Weighted Average S&P Recovery Rate:
- (b) otherwise, the maximum percentage of defaults, at any time, that the Current Portfolio or the Proposed Portfolio, as applicable, can sustain, determined through application of the S&P CDO Monitor chosen by the Investment Manager in accordance with the definition of "S&P CDO Monitor" that is applicable to the portfolio of Collateral Obligations, which, after giving effect to S&P's assumptions on recoveries, defaults and timing and to the Priority of Payments, will result in sufficient funds remaining for the payment of such Class of Notes in full. S&P will provide the Investment Manager with the Class Break-even Default Rates for each S&P CDO Monitor based upon the S&P CDO Monitor Weighted Average Floating Spread (or any other weighted average floating spread selected by the Investment Manager from time to

time) and the S&P CDO Monitor Weighted Average Recovery Rate (or any other weighted average recovery rate selected by the Investment Manager from time to time).

"Class Default Differential" means, with respect to the Highest Ranking Class, at any time, the rate calculated by subtracting the Class Scenario Default Rate at such time for such Class of Notes from:

- (a) if either an S&P CDO Formula Election or an S&P Effective Date Formula Election is in effect on such date, the Adjusted Class Break-even Default Rate for such Class of Notes at such time;
- (b) otherwise, the Class Break-even Default Rate for such Class of Notes at such time.

"Class Scenario Default Rate" means, with respect to the Highest Ranking Class:

- (a) <u>if either an S&P CDO Formula Election or an S&P Effective Date</u> Formula Election is in effect on such date, the rate at such time equal to:
  - (i) <u>0.329915; plus</u>
  - (ii) the product of (x) 1.210322 and (y) the Expected Portfolio Default Rate; *minus*
  - (iii) the product of (x) 0.586627 and (y) the Default Rate Dispersion; plus
  - (iv) the quotient of (x) 2.538684 divided by (y) the Obligor Diversity Measure; plus
  - (v) the quotient of (x) 0.216729 divided by (y) the Industry Diversity Measure; plus
  - (vi) the quotient of (x) 0.0575539 divided by (y) the Regional Diversity Measure; minus
  - (vii) the product of (x) 0.0136662 and (y) the S&P Weighted Average Life.
- (b) (otherwise, an estimate of the cumulative default rate for the Current Portfolio or the Proposed Portfolio, as applicable, consistent with S&P's Initial Rating of such Class of Notes, determined by application by the Investment Manager of the S&P CDO Monitor at such time.

<u>"Current Portfolio" means, at any time, the portfolio of Collateral Obligations, Cash and Eligible Investments representing Principal Proceeds (determined in accordance with the Collateral Assumptions), then held by the Issuer.</u>

"Default Rate Dispersion" means as of any date of determination, the number obtained by (a) summing the products for each Collateral Obligation (other than Defaulted Obligations) of (i) the absolute value of (x) the S&P Default Rate of such Collateral Obligation minus (y) the Expected Portfolio Default Rate by (ii) the outstanding principal balance at such time of such Collateral Obligation and (b) dividing such sum by the aggregate outstanding principal balance on such date of all Collateral Obligations (other than Defaulted Obligations).

"Excel Default Model Input File" means a Microsoft Excel file that provides all of the inputs required to determine whether the S&P CDO Monitor Test has been satisfied pursuant to the Indenture.

"Excepted Current Pay Obligation" means any Current Pay Obligation with respect to which the Market Value thereof is determined in accordance with the provisions of clause (c)(1)(x) of the definition of Market Value; provided that if no Market Value determination is required to designate a Collateral Obligation as a Current Pay Obligation as provided *for* in the definition of S&P Additional Current Pay Criteria, then such Collateral Obligation will not be an Excepted Current Pay Obligation.

"Expected Portfolio Default Rate" means, as of any date of determination, the number obtained by (a) summing the products for each Collateral Obligation (other than Defaulted Obligations) of (i) the outstanding principal balance on such date of such Collateral Obligation multiplied by (ii) the S&P Default Rate of such Collateral Obligation and (b) dividing such sum by the aggregate outstanding principal balance on such date of all Collateral Obligations (other than Defaulted Obligations).

"Highest Ranking Class" means, as of any date of determination, the Outstanding Class of Secured Notes (other than the Class X Notes) rated by S&P that has no Outstanding Priority Class.

"Industry Diversity Measure" means, as of any date of determination, the number obtained by dividing (a) 1 by (b) the sum of the squares of the quotients, for each S&P Industry Classification, obtained by dividing (i) the aggregate outstanding principal balance at such time of all Collateral Obligations (other than Defaulted Obligations) issued by Obligors that belong to such S&P Industry Classification by (ii) the aggregate outstanding principal balance at such time of all Collateral Obligations (other than Defaulted Obligations).

"Information" means S&P's "Credit Estimate Information Requirements" dated April 2011 and any other available information S&P reasonably requests in order to produce a credit estimate for a particular asset.

"Obligor Diversity Measure" means, as of any date of determination, the number obtained by dividing (a) 1 by (b) the sum of the squares of the quotients, for each Obligor, obtained by dividing (i) the aggregate outstanding principal balance at such time of all Collateral Obligations (other than Defaulted Obligations) issued by such Obligor divided by (ii) the aggregate outstanding principal balance at such time of all Collateral Obligations (other than Defaulted Obligations).

"Proposed Portfolio" means the portfolio of Collateral Obligations and Eligible Investments resulting from the proposed purchase, sale, maturity or other disposition of a Collateral Obligation or a proposed reinvestment in an additional Collateral Obligation, as the case may be.

"Regional Diversity Measure" means, as of any date of determination, the number obtained by dividing (a) 1 by (b) the sum of the squares of the quotients, for each S&P region code, obtained by dividing (i) the aggregate outstanding principal balance at such time of all Collateral Obligations (other than Defaulted Obligations) issued by Obligors that belong to such S&P region code by (ii) the aggregate outstanding principal balance at such time of all Collateral Obligations (other than Defaulted Obligations). For purposes of this definition the S&P region codes will be those most recently published by S&P for use pursuant to S&P's non-model methodology for the S&P CDO Monitor Test.

"S&P Additional Current Pay Criteria" means criteria satisfied with respect to any Collateral Obligation (other than a DIP Collateral Obligation) if either (i) the issuer of such Collateral Obligation has made a Distressed Exchange Offer and the Collateral Obligation is already held by the Issuer and is subject to the Distressed Exchange Offer and ranks equal to or higher in priority than the obligation subject to the Distressed Exchange Offer, or (ii) such Collateral Obligation has a Market Value of at least 80% of its par value.

"S&P Asset Specific Recovery Rating" means, with respect to any Collateral Obligation, the corporate recovery rating assigned by S&P (i.e., the S&P Recovery Rate) to such Collateral Obligation.

"S&P CDO Monitor" means each dynamic, analytical computer model developed by S&P used to calculate the default frequency in terms of the amount of debt assumed to default as a percentage of the original principal amount of the Collateral Obligations consistent with a specified benchmark rating level based upon certain assumptions (including the applicable Weighted Average S&P Recovery Rate) and S&P's proprietary corporate default studies available at https://www.sp.sfproducttools.com (or such successor location notified to the Issuer, the Investment Manager and the Collateral Administrator by S&P), as may be amended by S&P from time to time upon notice to the Issuer, the Collateral Administrator and the Investment Manager. Inputs for the S&P CDO Monitor will be associated with an S&P CDO Monitor Weighted Average Recovery Rate.

"S&P CDO Monitor Test" means a test that will be satisfied on any Measurement Date during the Reinvestment Period following receipt by the Issuer and the Collateral Administrator of the applicable input file to the S&P CDO Monitor if, after giving effect to the sale of a Collateral Obligation or the purchase of a Collateral Obligation, the Class Default Differential of the Proposed Portfolio with respect to the Highest Ranking Class is positive; provided that as of any Measurement Date, unless the S&P CDO Formula Election is in effect (i) the Weighted Average S&P Recovery Rate for the Controlling Class equals or exceeds the Weighted Average S&P Recovery Rate for the Controlling Class chosen by the Investment Manager and (ii) the Weighted Average Floating Spread plus the Excess Weighted Average

<u>Fixed Coupon equals or exceeds the Weighted Average Floating Spread chosen by the Investment Manager.</u>

"S&P CDO Monitor Weighted Average Floating Spread" means the spread selected by the Investment Manager (with a copy to the Collateral Administrator) from the "S&P Weighted Average Floating Spread Range" in Section 2 of this Schedule or otherwise as permitted by the Indenture.

"S&P CDO Monitor Weighted Average Recovery Rate" means the recovery rate selected by the Investment Manager (with a copy to the Collateral Administrator) from the "S&P Recovery Rate Range" in Section 2 of this Schedule or otherwise as permitted by the Indenture.

"S&P CDO Monitor Withdrawal Notice": The meaning specified in Section 7.17(f).

"S&P Collateral Principal Amount" means, as of any date of determination, an amount equal to the sum of (without duplication) (a) the Aggregate Principal Balance (including Principal Financed Accrued Interest) of all Collateral Obligations (other than Defaulted Obligations), plus (b) the amounts on deposit in the Principal Collection Account (including Eligible Investments therein) representing Principal Proceeds on such date of determination, plus (c) with respect to all Defaulted Obligations that have been Defaulted Obligations for less than three years, the S&P Collateral Value thereof.

"S&P Collateral Value" means, as of any date of determination, with respect to any Defaulted Obligation, the lesser of (i) the S&P Recovery Amount of such Defaulted Obligation as of such date and (ii) the Market Value of such Defaulted Obligation as of such date.

"S&P Default Rate" means, with respect to a Collateral Obligation, the default rate as determined in accordance with Section 2 of Schedule 6 by reference to the number of years to maturity of such Collateral Obligation; provided that if the number of years to maturity of such Collateral Obligation is not an integer, the default rate will be determined by interpolating between the rate for the next shorter maturity and the rate for the next longer maturity.

"S&P Effective Date Rating Condition" means a condition that is satisfied if (i) an S&P Effective Date Formula Election is in effect and (ii) the Investment Manager (on behalf of the Issuer) certifies to S&P that (a) the Refinancing Effective Date Requirements have been satisfied, (b) the S&P CDO Monitor Test is satisfied, (c) the Collateral Administrator has provided to S&P an S&P Excel Default Model Input File of the portfolio used to determine that the S&P CDO Monitor Test is satisfied and (d) the Effective Date Report indicates that each of the Tested Items is satisfied.

"S&P Industry Classification" means the industry classifications set forth in Schedule 7, as such industry classifications may be updated at the sole option of the Investment Manager (with notice to the Collateral Administrator) if S&P publishes revised industry classifications.

"S&P Rating" means, with respect to any Collateral Obligation (excluding Current Pay Obligations whose issuer has made a Distressed Exchange Offer), as of any date of determination, the rating determined in accordance with the following methodology:

- (a) if there is an issuer credit rating of the issuer of such Collateral Obligation by S&P as published by S&P, or the guarantor which unconditionally and irrevocably guarantees such Collateral Obligation pursuant to a form of guaranty approved by S&P, then the S&P Rating will be such rating (regardless of whether there is a published rating by S&P on the Collateral Obligations of such issuer held by the Issuer, provided that private ratings (that is, ratings provided at the request of the obligor) may be used for purposes of this definition) or (b) if there is no issuer credit rating of the issuer by S&P but (1) there is a senior secured rating on any obligation or security of the issuer, then the S&P Rating of such Collateral Obligation will be one sub-category below such rating; (2) if clause (1) above does not apply, but there is a senior unsecured rating on any obligation or security of the issuer, the S&P Rating of such Collateral Obligation will equal such rating; and (3) if neither clause (1) nor clause (2) above applies, but there is a subordinated rating on any obligation or security of the issuer, then the S&P Rating of such Collateral Obligation will be one sub-category above such rating:
- (ii) with respect to any Collateral Obligation that is a DIP Collateral Obligation, the S&P Rating thereof will be the credit rating assigned to such issue by S&P or if such DIP Collateral Obligation was assigned a point-in-time rating by S&P that was withdrawn, such withdrawn rating may be used for 12 months after the assignment of such rating, provided that if a Specified Event has occurred in connection with such Collateral Obligation, the S&P Rating thereof will be determined pursuant to clause (iii) below;
- (iii) if there is not a rating by S&P on the issuer or on an obligation of the issuer, then the S&P Rating may be determined pursuant to clauses (a) through (d) below:
  - (a) if an obligation of the issuer is not a DIP Collateral Obligation and is publicly rated by Moody's, then the S&P Rating will be determined in accordance with the methodologies for establishing the Moody's Rating set forth above except that the S&P Rating of such obligation will be (1) one sub-category below the S&P equivalent of the Moody's Rating if such Moody's Rating is "Baa3" or higher and (2) two sub-categories below the S&P equivalent of the Moody's Rating if such Moody's Rating is "Ba1" or lower; provided that not more than 15% of the Collateral Principal Amount may have an S&P Rating that is derived from a rating by Moody's:
  - (b) the S&P Rating may be based on a credit estimate provided by S&P, and in connection therewith, the Issuer, the Investment Manager

on behalf of the Issuer or the issuer of such Collateral Obligation will, prior to or within 30 days after the acquisition of such Collateral Obligation, apply (and concurrently submit all available Information in respect of such application) to S&P for a credit estimate which will be its S&P Rating: provided that, if such Information is submitted within such 30-day period, then, pending receipt from S&P of such estimate, such Collateral Obligation will have an S&P Rating as determined by the Investment Manager in its sole discretion if the Investment Manager certifies to the Trustee and the Collateral Administrator that it believes that such S&P Rating determined by the Investment Manager is commercially reasonable and will be at least equal to such rating; provided, further, that if such Information is not submitted within such 30-day period, then, pending receipt from S&P of such estimate, the Collateral Obligation will have (1) the S&P Rating as determined by the Investment Manager for a period of up to 90 days after the acquisition of such Collateral Obligation and (2) an S&P Rating of "CCC-" following such 90-day period; unless, during such 90-day period, the Investment Manager has requested the extension of such period and S&P, in its sole discretion, has granted such request; provided, further, that if such 90-day period (or other extended period) elapses pending S&P's decision with respect to such application. the S&P Rating of such Collateral Obligation will be "CCC-"; provided, further, that if the Collateral Obligation has had a public rating by S&P that S&P has withdrawn or suspended within six months prior to the date of such application for a credit estimate in respect of such Collateral Obligation, the S&P Rating in respect thereof will be "CCC-" pending receipt from S&P of such estimate, and S&P may elect not to provide such estimate until a period of six months have elapsed after the withdrawal or suspension of the public rating; provided, further, that such credit estimate will expire 12 months after the acquisition of such Collateral Obligation. following which such Collateral Obligation will have an S&P Rating of "CCC-" unless, during such 12-month period, the Issuer applies for renewal thereof, in which case such credit estimate will continue to be the S&P Rating of such Collateral Obligation until S&P has confirmed or revised such credit estimate, upon which such confirmed or revised credit estimate will be the S&P Rating of such Collateral Obligation; provided, further, that such confirmed or revised credit estimate will expire on the next succeeding 12-month anniversary of the date of the acquisition of such Collateral Obligation and on each 12-month anniversary thereafter; or

(c) with respect to a Collateral Obligation that is not a Defaulted Obligation, the S&P Rating of such Collateral Obligation will at the election of the Issuer (at the direction of the Investment Manager) be "CCC-"; provided that (i) neither the issuer of such Collateral Obligation nor any of its Affiliates are subject to any bankruptcy, winding-up or reorganization proceedings and (ii) the issuer has not defaulted on any payment obligation in respect of any debt security or other obligation of the issuer at any time within the two year period ending on such date of

determination, all such debt securities and other obligations of the issuer that are *pari passu* with or senior to the Collateral Obligation are current and the Investment Manager reasonably expects them to remain current; provided further, that the Issuer or the Investment Manager on behalf of the Issuer, will use commercially reasonable efforts to provide to S&P the same information regarding such Collateral Obligation as it would be required to provide to S&P if it were seeking to obtain or maintain a credit estimate for such Collateral Obligation; or

(d) with respect to a DIP Collateral Obligation that has no issue rating by S&P or a Current Pay Obligation that is rated "D" or "SD" by S&P, the S&P Rating of such DIP Collateral Obligation or Current Pay Obligation, as applicable, will be, at the election of the Issuer (at the direction of the Investment Manager), "CCC-" or the S&P Rating determined pursuant to clause (iii)(b) above;

provided that for purposes of the determination of the S&P Rating, (x) if the applicable rating assigned by S&P to an obligor or its obligations is on "CreditWatch positive" by S&P, such rating will be treated as being one sub-category above such assigned rating and (y) if the applicable rating assigned by S&P to an obligor or its obligations is on "CreditWatch negative" by S&P, such rating will be treated as being one sub-category below such assigned rating.

The S&P Rating of any Collateral Obligation that is a Current Pay Obligation whose issuer has made a Distressed Exchange Offer will be determined as follows:

- (a) subject to clause (d) below, if applicable, if the Collateral Obligation is and will remain senior to the debt obligations on which the related Distressed Exchange Offer has been made and the issuer is not subject to a bankruptcy proceeding, the issuer credit rating of the issuer published by S&P of the Collateral Obligation is below "CCC-" as a result of the Distressed Exchange Offer and S&P has not published revised ratings following the completion or withdrawal of the Distressed Exchange Offer and:
  - (i) there is an issue credit rating published by S&P for the Collateral Obligation and
    - (A) the Collateral Obligation has an S&P Asset Specific Recovery Rating of 1+, then the S&P Rating of such Collateral Obligation will be the higher of (x) three subcategories below such issue credit rating and (y) "CCC-";
    - (B) the Collateral Obligation has an S&P Asset Specific Recovery Rating of 1, then the S&P Rating of such Collateral Obligation will be the higher of (x) two subcategories below such issue credit rating and (y) "CCC-":
    - (C) the Collateral Obligation has an S&P Asset Specific Recovery Rating of 2, then the S&P Rating of such Collateral Obligation

will be the higher of (x) one subcategory below such issue credit rating and (y) "CCC-":

- (D) the Collateral Obligation has an S&P Asset Specific Recovery Rating of 3 or 4, then the S&P Rating of such Collateral Obligation will be the higher of (x) such issue credit rating and (y) "CCC-":
- (E) the Collateral Obligation has an S&P Asset Specific Recovery Rating of 5, then the S&P Rating of such Collateral Obligation will be the higher of (x) one subcategory above such issue credit rating and (y) "CCC-"; or
- (F) the Collateral Obligation has an S&P Asset Specific Recovery Rating of 6, then the S&P Rating of such Collateral Obligation will be the higher of (x) two subcategories above such issue credit rating and (y) "CCC-"; or
- (ii) there is either no issue credit rating or no S&P Asset Specific Recovery Rating for the Collateral Obligation, then the S&P Rating of such Collateral Obligations will be "CCC-";
- (b) subject to clause (d) below, if applicable, if the Collateral Obligation is the debt obligation on which the related Distressed Exchange Offer has been made, until S&P publishes revised ratings following the completion or withdrawal of the offer, the S&P Rating of such Collateral Obligation will be "CCC-":
- (c) subject to clause (d) below, if applicable, if the Collateral Obligation is subordinate to the debt obligation on which the related Distressed Exchange Offer has been made, until S&P publishes revised ratings following the completion or withdrawal of the offer the S&P Rating of such Collateral Obligation will be "CCC-":
- (d) if multiple Collateral Obligations have the same issuer and such issuer made a Distressed Exchange Offer, the S&P Rating for each such Collateral Obligation will be determined as follows:
  - (i) first, an S&P Rating for each such Collateral Obligation will be determined in accordance with clauses (a), (b) and (c);
  - (ii) second, the S&P Rating for each such Collateral Obligation determined in accordance with clause (d)(i) above will be converted into "Rating Points" equivalent pursuant to the table set forth below:

(iii) *third*, "Weighted Average Rating Points" for each such Collateral Obligation will be calculated by dividing "X" by "Y" where:

"X" will equal the sum of each of the products obtained by multiplying the "Rating Points" of each such Collateral Obligation by the Aggregate Principal Balance of such Collateral Obligation, and

"Y" will equal the Aggregate Principal Balance of all the Collateral Obligations subject to the same Distressed Exchange Offer;

(iv) fourth, the "Weighted Average Rating Points" determined in accordance with clause (d)(iii) above will be rounded to the nearest whole number and converted into an S&P Rating by matching the "Weighted Average Rating Points" of such Collateral Obligation with the S&P Rating set forth in the table in clause (d)(ii) above. The S&P Rating that matches the "Weighted Average Rating Points" for such Collateral Obligations will be the S&P Rating for each Collateral Obligation for which an S&P Rating is required to be determined pursuant to this clause (d).

"S&P Recovery Amount" means with respect to any Collateral Obligation, an amount equal to:

- (a) the applicable S&P Recovery Rate; multiplied by
- (h) the Principal Balance of such Collateral Obligation.
